

#### March 31, 1959

Mr. Friedman met with Mrs. Sarah Goodman on March 30th and discussed the following:

- 1- Mrs. Goodman will continue as Chairman of the Women's Division in 1960.

  Other names that came up as possibilities for the Chairmanship are Mrs. Blaustein,
  Mrs. Hoppe and Mrs. Myrtle Marp.
- 2- Mrs. Goodman said that she would like to have a full scale women's division meeting at the Arrowhead Conference next year. She had in mind inviting the women's division leaders from the western area to attend the Arrowhead Conference. Mr. Friedman indicated his agreement. Later, when I discussed this matter with Mr. Friedman, I pointed out that if we press for the attendance of women's division leaders at the Arrowhead Conference we will be forced to reduce the number of men who are invited because in 1959 the Arrowhead Hotel was absolutely full and no more rooms would be available for additional women. On the other hand, I said that there were a large number of women present at Arrowhead -- mostly with their husbands -- and I thought that many of these women were active in their own women's divisions and that therefore all that should be necessary is a women's division session to run all day including a discussion session. Mr. Friedman agreed that we handle the matter in this way.
- 3- Mrs. Goodman suggested that women be placed on the National Campaign Cabinet. Mr. Friedman informed her that this would not be practical.
- 4- Mrs. Goodman wishes to have a women's division mission visit Israel again in 1959. Mr. Friedman said that it would have to be done in September so that the women's division can be out of Israel before the men get to Israel on or about October 15th. Mrs. Goodman agreed to this.

1960 Western Leadership Institute

This is in reference to your memorandum of March 25th, 1959, regarding the above mentioned subject.

We have decided that the Western Landership Institute in 1960 be held the weekend of February 19th, 20th and 21st. The reason for this, for your information, is that our Missi meeting will almost certainly be held on February 7th and we may hold a small leadership institute in the mid-west the weekend of February 13th and 14th.

Sarah Goodman was in the office on Monday and urged that women's division leaders in your area be invited to a special women's division meeting to be held in conjunction with the Arrowhead meeting in 1960. I made the point that if you were to mount a campaign to bring women's division leaders to the Arrowhead meeting you would have to reduce the number of men who could attend the meeting because, as I recall it, you would have a space problem. It would mean that we might well lose some of our men who are leaders because we wouldn't have room for them. I said that I thought we had a pratty good turnout of women at the Arrowhead meeting last February and that many of these women -- the wives of our leaders -- are active in their own women's divisions and it seemed to me, therefore, that rather than mount a drive to invite women's division leaders to a meeting in connection with the Arrowhead Institute we should set up a full scale women's division session (morning, luncheon and afternoon) at Arrowhead for all the women who happen to be there.

The suggestion was then made that perhaps the Los Angeles members of the National Nomen's Division Board could invite the Momen's division leaders in your area to meet in Los Angeles on February 18th for a separate women's division conference. This would then not interfere with our space problems at Arrowhead and, on the other hand, might even bring us some of our men leaders who would accompany their wives who are important in their communities and who were being invited to the women's division conference in Los Angeles. I said that I had no objection to this and that it might work out pretty wall but that, of course, is something that would have to be taken up with you when you get around to it I would like to have your views.



As a result of your memorandum this subject dated April 2, I have confirmed February 19, 20 and 21 as the dates for our 1960 Western Leadership Institute with both the Arrowhead Springs Hotel and the Los Angeles Welfare Fund.

In reply to the questions raised in your memorandum regarding Women's Division scheduling at the Conference, I would prefer to continue the same pattern followed at our recent meeting, as I believe it was productive in terms of the women present and most helpful in terms of attracting top male contributors and leaders to the Institute. There were many such leaders who were present for the weekend both from Los Angeles and the area only at their wives insistence.

If we attempt to hold a separate Women's Division meeting on the day prior to the Arrowhead meeting in Los Angeles itself, we will detract from the importance of the Arrowhead meeting and lose potential attendees. Further, a meeting in Los Angeles proper will draw people to Los Angeles who will then want to commute to Arrowhead.

However, we can improve the quality of both the WD leadership present and the programming of the WD session or sessions. In 1959, we held a series of meetings in the area for Sara Goodman, which had a limiting influence on regional Women's Division attendance. Further, we permitted the Los Angeles WD to control the programming of the Women's Division session.

In 1960, therefore, I would suggest that we maintain a better control over the Women's Division programming, and that it be held at Arrowhead in conjunction with the rest of the Conference. Secondly, if we try to be as selective with the women as we were with the men, we can bring a quality group together in addition to the wives of top leadership, which need not adversely affect our space limitations.

With regard to the participation of the Women's Division, Irving Bernstein tells me that he would prefer to continue the same pattern followed at our 1959 meeting because he believes it was productive in terms of the women present and most helpful in terms of attracting top male contributors and leaders to the Institute. He says that if an attempt is made to hold a separate Women's Division meeting on the day prior to the Arrowhead meeting. in Los Angeles itself, this will detract from the importance of the Arrowhead meeting and lose potential attendees. Further, he notes that a meeting in Los Angeles proper will draw people to los Angeles who will them want to commute to Arrowhead. He feels, however, that the quality of both the Women's Division leadership present and the program of the Women's Division session or sessions at the Western Leadership Institute at Arrowhead Springs can be improved. He notes, for example, that this year the UJA held a series of meetings in the area for Sarah Goodman which had a limiting influence on regional women's division attendance. Further, the UJA permitted the Los Angeles Women's Division to control the programming of the Women's Division session. In 1960, he suggests that the UJA maintain a better control of the Women's Division planning and that it be held at Arrowhead in conjunction with the rest of the conference. He feels in this connection, however, that it will be necessary to be as selective with the women as the UJA was with the men so that only to quality group will attend. If we are careful with regard to the invitations that are issued and limitethe invitations only to top quality people he feels that this need not adversely affect out space limitations at Arrowhead. I would suggest, therefore, that you keep in touch with Irving Bernstein regarding the project and work out a program with him, along the lines indicated above, bearing in mind, of course, that because of speacelimitations as well as other reasons, final decisions with regard to invitations should be left to him after consultation with you. The closing of the Arrowhead Springs Hotel, therefore, may have been to our advantage, since a conference in Palm Springs offers us a number of advantages not available to us heretofore.

Western Leadership Conference Riviera Hotel, Palm Springs, California -February 19, 20 and 21, 1960

The assignment of leadership to the West Coast Conference which you gave me today presents several serious problems which must be resolved if we are to accomplish our purposes. If we are unable to fit our leadership resources to our needs, then we must know in time so that we can plan accordingly.

#### 1. Charles Jordan

The JDC session at the conference is one of our most important meetings and will be attended by over 300 men and women. Jordan is no doubt effective at parlor meetings, but we, including area professional and lay leadership, know from past experience that he does not nove a large audience.

In previous memorands, MCMN, Mor Leavitt or Sam Maber were requested for this session. Haber particularly is the ideal choice since he can be scheduled into the Big Clifts meetings which follow the conference. We did not ask for Jordan since we were aware of his limitations. I therefore strongly urge this assignment be reconsidered. In the interim, please do not confirm Jordan.

#### 2. Dewey Stone

Stone must attend the conference and the February 22 Los Angeles Big Gifts meeting with HAF, as we are facing serious cuts in the Special Fund from our largest contributors, and Stone is the only one of our top lay leadership with the potential to affect these gifts. Unless he is present, we will not materially change the course of the Los Angeles campaign.

Further, the scheduling of the Denver Initial Gifts meeting in February is also dependent upon Stone's acceptance.

## 3. Avraham Harman

As you know, we are still waiting for word of Harman's acceptance of the February 22 Los Angeles Big Gifts meeting. If he does not accept, we will have both the public relations problem of justifying his refusal, and the additional problem of finding a suitable replacement. Harman fits the need perfectly, as he provides both the draw for attendees and the cover for the

priming efforts of Stone and HAF. The Tucson meeting cannot be used as an excuse, for the Tucson meeting does not conflict with the February 22 meeting in any way.

h. In addition to the above, we are still completely up in the air as to the speakers and lay leadership for the area Rig Gifts meetings scheduled immediately following the conference.

I hope we will be able to confirm this schedule when I see you at our staff meetings next week, for it is essential that we firm up all these dates with the Executive Directors and campaign chairmen concerned. Since we are projecting early campaigns, we must give the communities sufficient time for proper planning.

Dear Steve,

I just want you to know what a great pleasure it was to be with you this past weekend in Falm Springs. The conference was cartainly an excellent one and I know that its success was due in large part to what you put into it.

I have been giving additional thought to our short conversation with regard to the special fund and have been reviewing some of the figures. There does not seem to be any doubt that more money is raised in campaigns where they run a special fund on a separate card or a separate line basis than in communities where no special fund compaign is run. At the beginning of this campaign there was a good deal of feeling in our organization that we should try to get away from a special fund in 1960, but when we went over the figures we found that we would have to lose anywhere from 5 to 10 million dollars, or even more, if we dropped the special fund. Our leadership came to the conclusion that an organization such as the UJA with a primary responsibility for fundraising has no right to give up this kind of money. I think myself that the time will come when the two funds will merge, as they already have in some cities, but meanwhile there is no doubt that the special fund raises a lot of extra money for us. And if ever there should be some great emergency among our people then, as I mentioned to you, I am sure that the American Jews will answer with or without any kind of a special fund.

I want to tell you about the National UJA Study Mission being planned for this year, in the hope that you will be able to join. We plan this year to meet in Rome on October 15th where we can get together with the JDC country directors and go into the details of the JDC operations. We will also meet a group of immigrants, probably from Poland en route to Israel. Perhaps we will even be able to go down to Naples to be present at the embarkation. We will visit some of the most important Jewish institutions and points of Jewish historic significance in and around Rome, and on October 19th, very likely, we will go to Israel where we will remain until October 31st. The detailed program is yet to be worked out but I did want you to have this information so that you can at least note it on your calendar and have it before you.

Once again I want to express my thanks and appreciation for your kind cooperation and your leadership.

This was the largest attendance we have ever had for any of our Western Regional meetings. The quality of the leadership present, however, was much more significant than their numbers. In most instances, delegates represented actual working and giving leadership of their respective communities. Since we were limited by the Riviera Hotel's room capacity, we constantly had to cancel out less important reservations in order to accommodate key givers and workers. Due to the hotel's limitations, and our policy of "attendance by reservation only", we had to reject a good number of weekend reservations, as well as many who came to the door Saturday night for that dinner only. We booked 403 people in 191 rooms of the Riviera Hotel, and an additional 108 in 60 rooms outside of the hotel, for a total of 511 in 251 rooms. The balance of our attendance came from neighboring communities, other hotels, and Los Angeles and area leaders with homes in Palm Springs, and Palm Springs year-round residents. #### Publicity

We were very fortunate in our publicity for the conference. We gave the responsibility for the Los Angeles newspapers to the Los Angeles Welfare Fund, and our office accepted responsibility for publicity in area and Palm Springs newspapers. As a result, we got front-page coverage in practically every Anglo-Jewish paper in the region. In Palm Springs itself, the Palm Springs Desert Sun gave us front-page stories and pictures every day of the week prior to the conference, plus a three-quarters page editorial the day of the conference. In addition, we had radio spots every day, plus an entire news program on the conference, including radio interviews of Consul Ceneral Yaakov Avnon and Dewey Stone, who was vacationing in Palm Springs.

#### Summary

It is difficult to capture on paper the mood and atmosphere of this conference. It was productive both in terms of stimulating leadership and producing pacesetting gifts in many of the communities. As previously indicated, however, the most important factor in making the conference successful was the quality of the leadership present. This was repeated over and over again by many of the key leaders at the Big Gifts meetings in their communities during the week following the conference.

#### Field Activity

The results of the conference would not have been possible if it had not been for the all-out team effort put into the preparation and planning by the staff of the West Coast Office and our area field staff. Above all, they deserve a note of commendation for their part in what has been generally recognized as our firest area meeting.
