Michael Steinhardt should be chairman and you should be president. I'm thinking of naming it: "USA New Century 8-billion Capital Fund for Jewish Education in the United States and Israel." A shorter version will obviously be necessary, but I think it is valuable to revive a 60-year old brand name.

The operation of this plan does not require the conventional methodology. No large staff to manage, no large overhead expense, no large board or committee, no dinners or other fund-raising efforts.

The plan is dependent on the good will and cooperation of a dozen-or-so Federation executives to allow us to access selected individuals who have large deposits in the various endowments funds of their communities. You, Michael, a few lay leaders, and I (to a limited extent) will perform this job with the key Federation executives. John Ruskey and Steve Resiter are already familiar with this approach and have stated their cooperation. In addition to the endowment fund prospects, I have already accumulated a list of additional prospects. All solicitations must be multi-year and seven ^{or eight} figures.

We should know within a year or two whether the campaign has a chance or not. If we see a success, then we turn to the creation of all the educational instruments listed in the proposal.

As the chief executive you will plan everything: where and how 20 day high schools should be built, and 20 more elementary schools, and 20 more Hillel houses; dozens of new summer camps; etc, etc. You will be shaping the future of a much stronger American Jewry and a much more homogenized Israeli Jewry.

I will be here until late September. Let's communicate by letter. Think it over, Darrell. Read the proposal once more. See if the vision grabs you. Ask me questions - make comments.
