ALL EXPENSES WILL BE PAID ARRIVAL IN LOSANGELES SHOULD BE WITHIN TWO WEEKS. This note is being written to confirm the telephone conversation you had with my associate, Mr. Edwin Stillwell of Washington, D. C.

Our organization, with others, has been acting in an advisory capacity to those responsible for the evacuation of the Japanese on the Pacific Coast. As you probably know, there have been many religious leaders who have taken occasion to criticise this evacuation and the handling of the Japanese people. Some weeks ago, we recommended that certain nationally known religious people be invited to visit one of the assembly centers to the end that they might see for themselves first hand the entire situation and be in a position to know the truth if and when they were asked by others.

Our suggestion was accepted and we have been authorized to invite a few outstanding religious leaders to make the trip to the assembly center near Los Angeles. With this thought in mind, we made investigation among various sources and your name was suggested as being one truly representative.

If you can return by the way of Los Angeles, and make the trip there within the next ten days, we would be very happy to underwrite the additional transportation costs involved. One of my associates in Los Angeles will meet you and you will be taken to the assembly center and allowed to make your own personal investigation of things there.

You do not know me personally, but we have a few mutual friends, one of whom is Dr. Henry Neumann of Brooklyn, New York. who is one of the group we have invited. Another is Rabbi Gordon of Salt Lake City, whom I have had the honor to know for the past several months. Please wire me collect as soon as you have made your decision in this matter so that we can arrange to advance the necessary transportation costs to you.

My dear Dr. Silver: Enclosed you will find the first draft of a hurriedly dictated article on the Japanese evacuation. You will find in it nothing new. It is really a compilation of what I saw, heard and read during my recent visit to the West Coast. I shall be greatly indebted to you if you will read this over, check it for accuracy, also for any statements you think it would be indiscreet to publish. You will note it is double-spaced, and you may feel free to write in your suggestions. I should like to know, also, how my conclusions compare with yours, for I know you are a very keen observer. You may be very frank, for I realize the article needs considerable revision before it will be in proper form for publication. Please remember me to Mrs. Silver. September 6, 1942 Dr. Dana Dawson Shreveport, La. My dear Dr. Dawson: I enjoyed receiving your letter and the article on the Japanese Evacuation which you enclosed. I read it with great interest. It is a completely fair account of the evacuation program and of what we saw at Santa Anita. I was myself, as I told you, tremendously impressed with the humanity and the intelligence which the Army used in evacuating the Japanese and in looking after their needs in the various centers. Every provision that could have been made for the care of these people was made, considering the short time in which everything had to be done. I am hoping that in the permanent settlements, the very last vestige of confinement will have been removed, and that the Japanese will be able to carry on a completely normal existence. I feel that as rapidly as possible provision should be made to return those Japanese of whose complete loyalty the authorities will have convinced themselves, to the completely free life to which their American citizenship entitles them. I do not believe that it is necessary for military security to keep all of the Japanese in these permanent relocation centers for the duration. I hope that you will publish your article. I enjoyed so much meeting you and I hope that we will have the pleasure before very long to renew our acquaintance. With all good wishes in which Mrs. Silver joins me.
