Dear Sir:

I have been informed that, largely due to your intervention, open hearings on the neutrality legislation pending have been postponed.

I believe that in this you are not in accord with the policies of the President and the Secretary of State, as clearly pointed out in their recent speeches. You are not acting to the interests of the American people, who want a real peace policy, and are opposed to a policy of support to aggressor nations.

Due to my work in this Committee, I know that the German people are opposed to Hitler and are organizing to rid Germany of the Nazi terror and to establish a truly democratic Germany.

By your deliberate attempt to forestall hearings on peace legislation and the eventual cancellation of the American so-called "Neutrality Act," you are hampering the democratic governments, such as Spain and China in their struggles to maintain democracy, and aiding the aggressor nations, who wish to destroy all democracies, --even our own.

The delay in the hearings on neutrality legislation does not serve the best interests of the American people and the democratic forces of the world.

I therefore urge that you immediately hold open hearings on this question so that the will of the American people can be ascertained and the State Department act in accordance with the will of the majority.

I do not believe that this organization ought to concern itself with neutrality legislation in the American Congress. There are other organizations to do that work. If this Committee plans to embark upon such a program, I should feel myself under the necessity of sending in my resignation as a sponsor. Dear Dr. Silver:

Please pardon the lengthy delay in replying to your letter of April 21st. We moved our offices
to the above address, and were so busy, were unable to
give your letter the attention it deserves.

May we assure you that it is not the Committee as a whole that has embarked on this program, but the action of individual members and sponsors, who, as individuals, felt that peace legislation should be held at open hearings, and that members and sponsors of our Committee be given the opportunity to voice their opinions in this matter.

May we quote from a letter received from Prof. Albert Guerard, of the English Department of Stanford University, which was enclosed with his signed letter to Chairman McReynolds:

beyond 'Anti-Nazi Literature' in the narrower sense of the term. It is only by organizing democratic peace that we shall efficiently check Nazism. The Anti-Hitler battlefront today is in Spain and China as well as in Czechoslovakia."

We also received signed letters from Harriet Stanton Blatch; Prof. Thomas C. Cochran, of New York University; Prof. William H. Kilpatrick, of Columbia University, and Justice Anna M. Kross, among many others.

We sincerely hope that we have in no way given the impression that it is the Committee that has embarked upon a new program. Such is not our intention. We are definitely keeping to our original program, of a press service, publication of our Bulletin,—the last on Education in Germany,—and now we have Heinrich Himmler's secret speech ready for publication. We will be pleased to send you a copy as soon as it is off the press.
