My dear Sir:

The Committee on Manufactures of the Senate, under Senate Resolution, is doing some work on a National Economic Council, or National Council which, I believe, may prove to be one of the most important and fundamental undertakings in generations. I am enclosing a discussion intended to give a measure of general orientation to the work.

Many of the questions involved are comparatively new and we have, therefore, held no hearings to date because we did not think it would add much of value to call witnesses to the stand, as a first step, and ask them questions they possibly had never carefully considered. As opposed to such a method, we are first trying to lay the questions involved before our thinking people and to afford them a real opportunity to consider these questions and to contribute from their experience and judgment to the work.

To better bring to bear the wealth of experience and knowledge in the nation as a whole, we are forming an Advisory Committee from the different fields to cooperate with the Committee on Manufactures of the Senate. Later on, in order to give the members of the advisory group a more convenient opportunity to discuss this with us and with each other, we expect to hold some regional meetings. The progress made so far has been very encouraging.

I think the effort being made to give the best minds and judgment of the nation a real opportunity to consider the matter with ample time to think it over in all its aspects before a bill is introduced or hearings are held is very significant in itself and constitutes a democratic technique meriting the whole hearted support of the more thoughtful.

Recent events in Spain and indeed the whole current of events abroad speak very forcibly of the dangers facing democratic systems and, unless we are to assume that our government is wholly immune from maladies which affect others, I believe the matter of a National Council such as is contemplated far transcends the many other innumerable movements which press upon us for attention. It is a question whether it may not be absolutely essential to the future of our democracy and democracy the world over to provide some mechanism to better bring to bear the general intelligence and judgment available.

I do not believe, as I feel sure you do not believe, in mixing religion and politics. This does not mean, however, as I see it, that we should turn our back upon the significance of the spiritual element in our civilization and it seems to me entirely fitting and proper that the spiritual leaders of the nation should be interested, in an entirely nonsectarian way, in such an undertaking as this proposed National Council. There is in it, it seems to me, much that should appeal to them, because in place of much of the strife and conflict and the concomitant injuries thereof, it envisages the settlement of the problems and disputes of men by a more real understanding and a more real brotherhood and seeks to provide a practical mechanism whereby men can be brought together and from which better understanding and better feeling would naturally flow. Aside from other considerations, it is becoming more generally recognized that grave dangers exist that our civilization and its wonders may destroy itself unless progress in the material field is accompanied by that spiritual progress which alone may avail to prevent such a result. Recent utterances of men such as Charles Lindberg and Admiral Byrd show how keenly they feel about the dangers which the advance of civilization in the field of aviation has brought to the existence of civilization itself and this is only one instance of a very grave and profound problem, at the heart of which lies the problem of spiritual progress.

There is, therefore, it seems to me a very proper place for your interest in this matter and I will be very glad to hear from you regarding it. Senator Bulkley, of Cleveland, is Chairman of the Senate Committee in charge of the work. I will be over to see him sometime soon and will be glad to see you also, if possible, and discuss this with you.


Please pardon the delay in replying to your telegram.

Dear Rabbi Silver:

The aerial bombing of defenseless civilian populations and the cold-blooded murder of hundreds of women and children have now reached a climax, in the Spanish war, with the massacre of the Basque Catholics at Guernica.

It seems to me incredible and impossible for Americans to remain indifferent and speechless before this crime, which is surely one of the greatest outrages of modern times. By our silence we would condone murder of the most revolting sort, and might well doom to brutal assassination an inestimable number of innocent civilians -- perhaps tens of thousands or hundreds of thousands of them.

I am convinced that this question rises far above all politics, or the fortunes of insurgents or loyalists in Spain. With this thought in mind I am submitting to you an "Appeal to the Conscience of the World." Will you join President Angell of Yale, Dr. Harry Emerson Fosdick, Mrs. Carrie Chapman Catt, Mr. Charles P. Taft, Mr. Leland Stowe and myself in raising your voice in defense of the non-combatant aged and the women and children in war-torn Spain? We believe that you cannot fail to share our sentiments of outraged humanity.

If so, will you kindly inform me by collect telegram that you affix your signature to this completely non-partisan appeal? I can extend to you only the unspoken gratitude of utterly defenseless human beings who, tomorrow, may be mowed down from the air like sheep in a slaughter pen.

#### AN APPEAL TO THE CONSCIENCE OF THE WORLD

The ancient Basque city of Guernica has been razed to the ground by Fascist Insurgent airplanes. Unfortified and unarmed, its houses, churches, and defenseless inhabitants -- 10,000 men, women and children including refugees --were bombed and machine-gunned for nearly four hours without ceasing. The toll of slaughtered innocents exceeds 800 persons. This is the crime of Guernica. And this is the unspeakable crime of War on Women and Children, waged with a brutality and callousness unparalleled in modern times.

The massacre of Guernica has been confirmed in all its horror by such survivors as Canon Alberto Onaindia of Valladolid Cathedral and by foreign correspondents. One of them, a distinguished staff member of the London Times, described the machine-gunning of helpless civilians and added: "The only countermeasures the Basques could employ -- for they did not possess sufficient airplanes to face the Insurgent fleet --- were those provided by the heroism of the Basque clergy. The clergymen blessed and prayed for kneeling crowds-socialists, anarchists and communists in addition to the declared faithful--in crumbling dug-outs" (built for safety from air raids).

Will the prayers of Guernica's dead and dying go unanswered? Or will 300,000 civilians, women and children, soon meet a similar fate in Bilbao without the voices of civilized peoples being raised in overwhelming protest?

We refuse to condone such atrocities by our silence. We do not attempt to assess the contending causes which now struggle for mastery in Spain, but we do insist that this ruthless aerial warfare upon women and children stands outside the pale of morality and of civilization. We insist that there is no such thing as partisanship where this kind of mass murder occurs, or is permitted to occur. We denounce the monstrous crime of Guernica in the name of justice and humanity. We demand a revival of that noble world conscience which manisted itself in the days of the persecution of the Jews in Russia and again

when the Amerian people lay prostrate before the Turks.

For these reasons we call upon all men of good will to protest this immense crime in the name of all that is sacred to human morality and human decency--and in the name of Almighty God.

# An Open Letter to 76 Signers of "The Crime of Guernica"

Distinguished American Citizens:

Some several months ago you allowed your names to be used in a pamphlet entitled "The Crime of Guernica."

You subscribed to the following statements:

When you subscribed your name to such serious charges, you did so in good faith. Since that time later news stories about Guernica have reached this country.

One of your members, Ex-Governor Landon, withdrew his name from the statement when these later dispatches were brought to his attention. He writes: "This testimony —(the later reports) produces a reasonable doubt concerning the truth of the report that General Franco's airplanes had wantonly destroyed the city and machine-gunned its helpless inhabitants. In the light of recent developments, common justice and decency would forbid us to accuse General Franco of 'a monstrous crime' against the Basque nation—whatever that may be."

Has not the public—to which you issued your appeal "in the name of justice and humanity" a right to expect that your ardent interest in this affair would continue long enough for you to read subsequent news stories about Guernica? Have you done so? If you have, why have you not withdrawn your name from the statement?

Surely the facts prompting you to withdraw your name are as compelling as those which prompted you to subscribe. Is it that no pressure has been brought to bear upon you as was done by the group who originated the statement? One hardly expects persons who demand the "revival of a neble world conscience" to wait until they are forced to retract a slanderous statement. "Human morality and human decency" demand a voluntary retraction.

Undoubtedly you failed to read any but the very first reports about Guernica. If you had read later reports, your name would have been withdrawn from the statement you signed.

Because it might be difficult for you to refer to later news stories about this much publicized city of the Besques. I submit three statements for your perusal. There are mony others that you might find if you care to investigate the matter further.

(1) "The ancient Basque city of Guernica has been razed to the ground by Fascist Insurgent aeroplanes. Unfortified and unarmed, its houses, churches and defenseless inhabitants—10,000 men. women and children, including refugees—were bombed and machine gunned for nearly four hours without ceasing. The toll of slaughtered innocents exceeds 800 persons. This is the crime of Guernica. And this is the unspeakable crime of war on women and children, waged with a brutarity and callousness unparalleled in modern times."

(2) "We denounce the monstrous crime of Guernica in the name of justice and humanity. We demand a revival of that noble world conscience which manifested itself in the days of the persecution of the Jews in Russia and again when the Armenian people lay prostrate before the Turks."

(3) "For these reasons we call upon all men of good will to protest this immense crime in the name of all that is sacred to human morality and human decency and in the name of Almighty God."

Found Bombing Evidence Lacking (By Wm. P. Carney, New York Times, May 8) GUERNICA, SPAIN, May 4—"This writer found most of the destruction here could have been the result of fires and dynamiting, as the Nationalists claim, because the roofless shells of many buildings are still standing and huge shells dropped from planes do not hollow out buildings, leaving their four walls standing.

"In the street where most of the damage was done particularly around two big arms factories the Talleres de Guernica and the Esperanga works, there are no bomb holes in the streets. It is not likely that bombs dropped in an air raid would all land atop houses or buildings and none fall in the streets.

"In many respects Guernica presents the same picture of desolation that can be seen at Irun and Eibar and in part of Malaga where destruction by incendiary mobs before these cities were abandoned, never has been questioned."

#### From Aug. 5, New York Times

(Wm. P. Carney writing from Salamanca.)

"Several priests whose signatures appear at the bottom of a letter addressed to Pope Pius in May, protesting the destruction of Guernica by German airmen flying for Gen. Franco, have sworn to a statement, now in the possession of the authorities here, in which Pres. Jose Antonio Aguirre and other officials of the Basque government are accused of having threatened the lives of these clergymen unless they signed the letter, which they insist they had no part in drafting."

#### From: Red Propaganda From Spain

By Douglas Jerrold in the American Review, Summer 1937 "Every count in the indictment against General Franco is a lie, but no matter. The 'red' government got their story in first, and that, in the modern world where 'anything goes', is enough. Let us, however, for the benefit of the curious and critical minority, recite a few facts of the case.

"Guernica was bombed in the proper course of the operations against Bilbao, but it was not bombed on the day it was burnt, and it was burnt by the retreating Basque (or more probably by the Asturian) troops and not by the Nationalist forces.

"The correspondents of the Havas agency, of the Times, and of several other newspapers have affirmed positively that most of the damage which they saw was wrought not by bombing but by deliberate destruction by fires from the ground. The statements are explicit. There were only a few bomb holes—(the city had been bombed intermittently for several days before it was given up) and the walls of the houses in the quarter most completely destroyed bear no marks of bomb splinters. Nor can the damage done by a bomb and that done by dynamiters and incendiaries be confused by any competent observer.

"In view of the attitude of the Times correspondent in Bilbao, the testimony of their correspondent with the Nationalist forces, who unlike hit colleague—visited\_ Guernica after the destruction, is to any intelligent person conclusive, once we remember the question, which is not, 'Was Guernica bombed?' but, 'By whom was Guernica burned?'....

"Finally, the question can be cvnically determined by reference to that old question 'cui bono?" When the alleged destruction of Guernica took place it was in the process of being evacuated; an advance had taken place on all fronts and nothing could have saved the town. General Franco had nothing whatever to gain by destroying it. The Basque government, if they could get their story accepted, had everything to gain. the 'incident' would stiffen the resistance of the Catholic Basques. It would influence neutral opinion. . . .

"The Guernica story was invented to stimulate ill-will between the democratic and fascist states."

In the face of the above dispatches, hasn't the public, to which you appealed "in the name of all that is sacred to human morality and human decency," a right to expect you to withdraw your name from the original statement?



#### Letter proposed to be published on July 19, 1937

Sir:

The Spanish Civil War has now been in progress for a full year. For all who have the peace of the world at heart a more tragic anniversary could hardly be recorded.

Each side has stated that for them the struggle is one of life and death. That it is the latter is certain; the Cardinal-Archbishop of Toledo has estimated that the war, before it is concluded, will have cost a million casualties.

The memory of two wars is recent with us. That in the Chaco was ended by exhaustion; that in Abyssinia by conquest. It is, indeed, a melancholy reflection, almost a counsel of despair, to suppose that there are no alternatives beside these.

Nor can we be content with a measure of non-intervention designed simply to localize the conflict. Much more would be necessary to prevent conflagration if, say, a country in a more delicate international position became the scene of such an outbreak. To save civilization a more vigorous moral effort in making peace is required of all of us. It is in order to stir neutral leaders to that end that we make this appeal. Preoccupied as they are with immediate difficulties, we beg them not to forget the larger issues of peace.

We carnestly hope that the early months of the second year of war will see a renewed and steadily maintained effort by neutral groups or governments or parties to formulate terms of settlement which would secure for all classes in Spain more than could possibly be secured by peace through exhaustion, and more than could ultimately be retained through victory by force of arms?

#### An Appeal to the Leaders and Members of American Churches and Synagogues

Have our hearts turned to stone or are they still capable of human feeling? More than 10,000 children have been killed and more than 15,000 wounded in aerial bombings of open cities in Spain. On one day, May 31, in the little town of Granollers, 600 were killed or maimed. Most of the victims were women and children.

Photographs of hundreds of the murdered and maimed have come to this country. Most of them are too horrible for publication. "Most of the victims were women and children." This sentence appears over and over again in the news dispatches. What has happened that men and women can remain silent when confronted with such barbarity?

The answer is - we may as well admit it - that we have become almost accustomed to the horror. We no longer feel the same acute shock and indignation we felt when first we read such dispatches.

Let every humane person search his heart! Are we ready to acquiesce in these things? Does the scream of a child mean nothing to us - any more? Surely we dare not admit that such wanton and cynical destruction of human life must now be accepted as a part of modern life!

Our Secretary of State has publicly expressed his condemnation of this kind of warfare. England and France have lodged protests with General Franco. Three times the Vatican has pleaded for a cessation of the bombings. The bombings continue.

We believe that the voice of the people is more potent than any official gesture. We, therefore, call upon people of every faith to join with us in observing Saturday, July 16 and Sunday, July 17, as days of solemn protest against aerial bombings of defenseless civilians. And we especially invite the clergy of every faith to appeal to the conscience of the world against ruthless and unnecessary destruction of life.



My dear Reverend Powers:

Let me thank you for your letter of April 4 and for your frank statement with reference to my name being included among the sponsors of a reception which was tendered to the Spanish Ambassador, Fernando de los Hios.

I shall be equally frank in my answer. I am opposed to all Fascist, Nazi, and Communist governments and movements because I believe them to be a menace to civilization. I am opposed to them regardless of whether under those regimes Jews are persecuted or not. In the Soviet Union and in Fascist Italy, the Jaws are not being persecuted and yet I am opposed to Russian Communism and Italian Fascism quite as much as I am opposed to German Nazism under whose regime the Jews are inhumanly persecuted.

General Franco has set himself up avowedly as a Fascist dictator. He has announced that to be his program. I am therefore opposed to him and the cause which he represents. I am profoundly moved and distressed at what is undoubtedly a fact, that members of the Catholic Clergy have in some instances, been made to suffer unjustly at the hands of the Loyalist Government. There can be no excuse for it. But this fact does not establish, in my mind, the righteousness of General Franco's cause. My information is that Catholic Priests have also in some instances been made to suffer unjustly at the hands of General Franco. This, too, is unpardonable. I am enclosing herewith an article from the New York Times of Tuesday, April 12, which gives the other side of the story.

Let me assure you, my dear Reverend Powers, that my sympathies with the cause of the Loyalist Government are in no way influenced by ill will towards J. M. Powers



My dear Rabbi Silver:

Since I received your answer to my former letter, I have been wavering between two impulses - the desire to answer, and the fear that my answer might appear to seek to draw you into a controversy. My desire has at last overcome my fear, therefore this letter.

I frankly cannot understand how you could construe anything in my letter as indicating allegiance to - or a plea for, General Franco, or his cause. I am, like you, opposed to both facist or communist dictators. Aside from this I feel we have too many real problems in our own country, the solution of which should have our deepest study, to the exclusion of foreign problems.

If I had any desire to espouse either cause (which I have not), I would not dare to do so, because my study of the matter has led me to feel that practically every report is either unreliable or positively prejudiced.

May I call to your attention the fact that the persecution and slaughter of priests, nuns and lay Catholics, was largely carried on with the assistance, or at least without the opposition, of the government years before Franco's rebellion was ever thought of, and that this was probably the greatest contributing cause to the starting of the rebellion.

Referring to the clipping of New York Times, which you enclosed, I question the integrity of the writer, when I have information of unquestionable reliability to the contrary. Pope Pius has recently issued a statement that thirteen hundred seventy (1370) priests and nuns, belonging to religious orders, have been executed. This does not include secular priests who are more numerous.

I am enclosing a clipping announcing four Christian Easter services held in the city of Madrid - a town that is ninety per cent Catholic, and these four were held by four Protestant Denominations.

I fear the time is fast approaching when your people and my people will be called on to present a united front to a common enemy, and will have the right to demand of leaders like you and me proper direction.

Maybe I am over serious, but I assure you I have no other motive in seeming to pursue this matter.

## Insurgents Capture Two Villages, Drive On

HENDAYE, France (at the Spanish Frontier)—April 17.—(AP)—A slashing attack from the south today brought Spanish Insurgents nearer Tortosa, important highway center blocking Generalissimo Francisco Franco's campaign to broaden his coastal wedge in government Spain.

Insurgent commanders reported capture of two villages from stubbornly resisting government mountain troops placed them almost within striking distance of Tortosa, a city of 20,000 at the delta head of the Ebro River.

The captured towns were Mas De Barberans, ten miles to the southwest and La Galera, twelve miles due south.

MADRID, April 17. — (AP) — Easter was celebrated today in four war-scarred Protestant churches by about 1,000 persons who the pastors reported had regularly attended unmolested services since the war began 21 months ago.

Lutheran and Baptist services were held in the regular chapels which, although marked by machine-gun bullets, were still serviceable. Episcopal and Presbyterian services were held in temporary chapels adjacent to the regular churches.

The main Presbyterian chapel had been ruined and windows of the Episcopal chapel had been shattered by a bomb about a year ago.

All four churches lie within a mile of the actual front and rifle or machine-gun bullets often land in the church grounds.
