Dear Dr. Silver:

You will wish to be brought up to date on the Founders of the America-Israel Society. There is now a total of fourteen acceptances--Governors Knight of California and Herter of Massachusetts; Senators Ferguson, Douglas, Ives and Lehman; writers and editors: John Cowles, Dr. Daniel A. Poling and Robert Sherwood; from the field or religion: Bishop Bernard J. Sheil of Chicago, Dr. Norman Vincent Peale, Dr. Louis Finkelstein and yourself. We have been assured of other acceptances but these are the official ones that have come in. I will keep you informed in regard to others.

The Society will be officially launched at a dinner in the Executive Mansion on the evening of Thursday, January 21 at 7:30 P. M. This will be a meeting of great significance, for at that time the purpose, constitution and by-laws and the project program of the Society will be approved before public announcement. We need your advice and counsel. This will be the only administrative meeting in which the Founders as such will participate. A car will meet you either in Baltimore or Washington. Details will be arranged later.

Please put the date on your calendar and let me know at your earliest convenience if you can come.

Any help which you can give me in convincing Mr. Hoover that he should become a Founder will be greatly appreciated. A carbon copy of my letter to him is enclosed.

AMERICA-ISRAEL SOCIETY

Its Purpose*

The America-Israel Society is a non-profit, non-political, non-sectarian association of Americans interested in promoting inter-cultural relations between the United States and Israel. It will help Americans to a new appreciation of the culture of Israel, and encourage the people of that nation to a better understanding of America and its way of life. The Society will seek to interpret the spiritual tradition and democratic heritage that binds the two nations together and to give added meaning to the unity of purpose that characterizes freedom-loving peoples.

Its Projected Program

The Society's activities will be centered in the following general spheres of service:

Cooperation in a cultural interchange as represented by persons—students, professors, lecturers and artists—providing platforms and occasions for Israel's leaders and making appropriate introductions of Americans going to Israel.

Assistance in a cultural interchange as represented by creative expressions—books, journals, exhibitions, motion pictures and the arts with the development of a comprehensive library of such materials as a continuing means of understanding.

Sharing in extending hospitality to visitors from Israel—sponsoring special occasions, such as luncheons and dinners, in honor of distinguished persons; assisting others in their contacts and plans; arranging informal teas, not only in Washington, but throughout the country to facilitate personal acquaintance.

Encouragement of scholarly research in such fields as history and archeology.

Preparation of multigraphed and printed materials designed to serve the purposes and interests of the Society.

Encouragement of travel in Israel by Americans as the best means of knowing the country, its people and its culture, with assistance in making plans and arranging contacts.

Within these general areas the Society will seek to supplement, not duplicate, the work of other organizations.

Membership

Membership in the America-Israel Society is open to residents of the United States and to American organizations and corporations in sympathy with the Society's objectives.


Dear Dr. Silver:



Please mark the date of April 26, 1955 on your calendar as a special appointment.

On that date, the Society will hold its annual membership meeting and its Second National Dinner. Both events will take place in the Willard Hotel, Washington, D.C. The membership meeting will be held at 3 P.M. in the Crystal Room. The Dinner will be held at 6:30 P.M. in the new Grand Ballroom.

Those who attended last year's Dinner considered it one of the most rewarding events in their experience. Mrs. Franklin D. Roosevelt, Attorney General Brownell and Ambassador of Israel Eban delivered major addresses. David Bar-Illan, the brilliant young Israeli pianist, whose debut later in Carnegie Hall was such a success, gave a preview of his artistry, and Walter Cassel of the New York City Opera, sang.

It is expected that our 1955 Dinner, to be held on the eve of the seventh anniversary of the establishment of the State of Israel, will be even more notable. Arrangements are being made now for an unique program. Governor McKeldin again will preside. We hope you will be able to attend both events.

You will receive details later. I am writing this informal letter so that you can make your plans in advance.

Your Society, during the past year, has builded carefully and, we think, soundly. General Yigael Yadin's lecture on the Dead Sea Scrolls and its publication by the Society brought about a much wider appreciation of Israeli archeology, even to the extent of bringing the subject to radio and TV. Thus many persons were reminded again that Israel is truly the Land of the Bible.

Lectures on the evolving law of Israel sponsored by the Society here in the Library of Congress and in New York with the cooperation of the Association of the Bar of the City of New York were hailed by lawyers and others as real contributions to comparative law. You soon will receive a reprint of Judge Cheshin's article, based on the lectures, that has been published in The Record of this eminent Bar Association.

Arrangements are well underway for a series of public lectures by five outstanding experts at Columbia University on the general theme of Culture in Israel, beginning Monday evening, March 14. I will report further on this project to you in my next letter and also upon others now in negotiation.
