## B'NAI B'RITH

Dear Mr. Rosenberg:

As President of B'nai B'rith, I have the honor to invite you to a preliminary conference to be held at the William Penn Hotel, Pittsburgh, Pennsylvania, beginning Saturday evening, January 23, 1943, at 8 P.M. and continuing Sunday, January 24.

American Jewry, which will be required, in large measure, to assume the responsibility of representing the interests of our people at the Victory Peace Conference, must be ready to voice the judgment of American Jews along with that of the other Jewish communities of the free countries with respect to the post-war status of Jews and the upbuilding of a Jewish Palestine. Every thoughtful Jew interested in the present critical situation with which we are confronted, must be profoundly concerned with the distressing conflicts which threaten to impede concerted action. The purpose of the conference is to bring together the representatives of major national Jewish membership organizations, in order that they may consider what steps should be taken to bring about some agreement on the part of the American Jewish community.

Your organization is invited to designate one or more representatives, not exceeding three, to attend this conference. If you will advise the office of B'nai B'rith, 1003 K Street, N.W., Washington, D. C., the names and addresses of your representatives, we shall make all necessary arrangements for hotel accommodations.

Will you be good enough to advise that office promptly of your acceptance of this invitation.

## APPENDIX C

## SUMMARY

## CONFERENCE OF JEWISH ORGANIZATIONS HELD AT WILLIAM PENN HOTEL, PITTSBURGH, PENNSYLVANIA January 23 and 24, 1943

## INTRODUCTION

With the avowed purpose of producing a common program of action concerning the status of Jews in the post-war world and the implementation of the rights of the Jewish people with respect to Palestine, representatives of thirty-two national Jewish membership organizations met in Pittsburgh on January 23 and 24 in response to the invitation of Henry Monsky, President of B'nai B'rith.

The conference was distinguished by lively discussion through which ran a deep note of understanding of the tragedy which has overtaken the Jewish people, and of the responsibility which rests upon the Jews of America through such united action as can be agreed upon.

The proposals emanating from the conference and attached hereto represent the unanimous will of the delegates present, subject to the right of any organization to participate in the activities resulting from the conference or to withdraw from participation if it so chooses without regard to the position taken by its representatives.

The unanimous vote in favor of the proposals, the deep sense of responsibility that the delegates felt, the fervent, spiritual tone that pervaded the sessions, augur well for a united expression by the American Jewish community of its point of view.

The list of the organizations and delegates present at the conference is attached.

## ORGANIZATION OF THE CONFERENCE

In opening the sessions; Henry Monsky, who acted as Chairman, pointed out that thirty-two of the thirty-five national Jewish membership organizations invited, had sent representatives. He stated as the purpose of the conference:

> "...to take such preliminary steps, as will result in a course of action and procedure, calculated to accomplish the single objective, devoutly to be desired, of some basis of agreement between the

diverse and conflicting groups that constitute the American Jewish community. American Jews, in collaboration with other Jewish communities of the free countries, will be required to assume a greater measure of responsibility than at any previous time in the long dark history of the Jewish people, for the preservation of the remnant of Israel in the war devastated lands and for the establishment of an acceptable post-war status of Jews, after the United Nations shall have purged the world of the evil forces that have so sorely threatened the values - yes - the very existence, of our whole civilization."

Mr. Monsky drew an analogy between the measures which were taken to obtain cooperation of all Jewish groups twenty-five years ago when the Jews of America were called upon to assume responsibility with respect to the defense of Jewish rights and the support of the program for the rebuilding of Palestine. He indicated how history repeats itself - that then there was also divisiveness of opinion and various organizations made several attempts to compose the disputes. These efforts culminated in a conference of Jewish national organizations calling for what was known at that time as an American Jewish Congress in which Louis Marshall took a leading role.

The Chairman submitted several procedural recommendations which were adopted to assure fullest adherence to the democratic process: that a Committee on Guidance be selected by the conference, that this Committee on Guidance would designate a larger committee of the conference to be known as the Committee on Proposals which would report such proposals to the conference. Both committees would be considered dissolved with and upon the adjournment of the conference. For voting purposes, each organization was to have one vote regardless of the number of delegates present. Mr. Monsky also outlined the procedure aforementioned with reference to the complete freedom of delegates in voting without committing their respective organizations.

The conference then voted to accept the recommendations of the Chairman with slight changes as to the number to serve on the committees. Sidney G. Kusworm, Judge Louis E. Leventhal, and Robert P. Goldman were selected to submit names of nominees for the Committee on Guidance and the Secretariat. Subsequently the Committee on Guidance was elected as follows:

Eugene Strassburger of Pittsburgh presided at the Sunday Morning Sessions.

The Invocation at the opening session of the conference was given by Rabbi Solomon B. Freehof, and at the Sunday morning Session by Rabbi Herman Halperin. The Benediction at the conclusion of the conference was pronounced by Rabbi Bernard L. Leventhal.

The following special resolution, offered by Rabbi James G. Heller was unanimously adopted:

"This meeting, called in the hope of creating a greater degree of Jewish unity, cannot adjourn without adding the voice of its delegates representing thirty-two national Jewish organizations, to those crying aloud in horror and in protest against the massacres of Jews by Nazi Germany. The tragedy of our people does not stand alone. It is but one instance, even if the darkest and most extreme, of the persecution and slaughter of peoples in the Orient and in the Occident. To the last man and woman Jews are united in grief for the guiltless dead, in prayer for those still in mortal peril, and in petition to the United Nations to exert every effort to save those who can yet be saved. We have been enheartened by the expressions of sympathy and of a determination to help that have come from the leaders of the democratic peoples. It is our hope that the revulsion of the whole civilized world may yet serve to deter the tyrant, his allies and followers; that their own peoples may be impelled by justice and by the retribution that may be visited upon them to revolt and to put an end to this reign of terror; that the United Nations will aid refugees to escape and to find harbor; and that, wherever and whenever it can be done, they shall send food to starving Jewish and non-Jewish communities. Especially is it our prayer that victory may soon rest upon the banners of those who believe in and fight for justice

and brotherhood among men, and that millions of our brethren may be rescued out of the Valley of the Shadow of Death."

The Committee on Proposals labored from eight-thirty Sunday morning throughout the day, resubmitting their recommendations upon amendments suggested by the conference, and the proposals when finally acted upon received a unanimous vote.



## APPENDIX D

The proposals follow:

## PREAMBLE

This conference of delegates of thirty-two national Jewish organizations, representing the largest segment of organized American Jews, meeting in a time of war and of danger to our country, pledges all its resources without reserve to the support of the war effort and the victory for the United Nations.

We are living through the most tragic days in all of Jewish history. The world is engulfed in/global war which has threatened the destruction of our civilization. The annals of history contain no record as black as that inscribed on its pages by the barbarians of the Axis Powers. Many peoples have suffered the profanation of their sacred altars, the destruction of their hopes, the devastation of their way of life, the loss of liberty, but, it was against the Jewish people and the Hitler war of extermination was first declared. It was pursued with relentless inhumanity, in every land the aggressor was able to occupy. Whole Jewish communities were devastated; men, women and children were driven like cattle into alien fields and there humiliated, tortured and done to death.

Elaborate plans were developed for the complete extermination of the Jews. Perhaps one-third of the Jews in Nazi-occupied territory have found their peace in a welcome death. Those who survive, even though stripped of their rights, denuded of all they possess, await the coming of the day when it will once again be possible to speak of freedom, justice and reparation. We reaffirm our purpose to do everything humanly possible to alleviate their sufferings and to restore their rights. The free democratic nations have been roused to resist the aggressors and would-be destroyers of our civilization. They are locked in a four continent struggle, determined to defeat and to destroy the enemy and all the evil for which he stands.

As Americans and as Jews, the cause of the United Nations is doubly ours. All that we possess must be dedicated without reserve to that cause. Every sacrifice which the needs of the war effort may demand of us must be made. When victory comes the day is not now far off - it will, we hope, also see the dawn of a new day for the Jewish people.

We have a vital stake in the peace that is to come. Not only have we suffered appalling destruction of Jewish life, but much of that which was achieved after the first World War, in respect to the position of the Jew in the afflicted lands, has been lost. There has been a progressive deterioration of that position and of our rights as free men; there has been in many lands complete extinction of those rights, as a consequence of the Nazi-Germany stimulated world-wide anti-Semitic propaganda and the evil consequences that have resulted therefrom. There is crucial need for the restoration of that lost position and for its fortification upon enduring foundations of equality and justice.

There is imperative need also to unite on a program relating to the rights of the Jewish people with respect to Palestine.

Since the primary purpose of this conference is to provide a method of procedure for unified expression of the point of view of the American Jewish community, we submit the following proposals:

### PROPOSALS

In view of the desirability of creating a basis of agreement on a program of common action to deal with post-war Jewish problems.

This conference resolves to take the initiative in the summoning of an American Jewish Assembly, organized on democratic lines, to establish a common program of action in connection with post-war problems and to elect a delegation to carry out said program, in cooperation with the duly accredited representatives of Jews throughout the world.

The American Jewish Assembly shall be convened within five months from the date of this conference.

This conference shall establish an executive committee of thirty-eight of whom thirty-two members shall be elected at this conference. Six places shall be reserved for other national Jewish membership organizations not now represented. The executive committee shall have the power to coopt additional members, not exceeding twelve, making a total of fifty.

The executive committee shall act under the following directions:

1. It shall formulate a call for the convening of an American Jewish Assembly. This call shall be submitted to all organizations invited to this conference and such others as may be designated by the executive committee. When approved by a majority of the organizations present at this conference, the executive committee shall issue such call. A time limit of thirty days from the time when notice is sent to the organizations is fixed for securing such approval. The executive committee may, however, within its discretion extend this time limit.

2. A. The American Jewish Assembly shall consist of not more than 500 delegates. The cooperating national organizations shall name 125 delegates. The Jewish communities, through local or regional conferences called for such purpose, shall elect 375 delegates. The distribution of delegates shall be on the basis of Jewish population. The national organizations shall elect their delegates in accordance with their own rules. Representation in the local or regional conferences shall be based on organization membership.

B. It is recommended to the executive committee that the representation of the national organizations in the American Jewish Assembly shall be on the basis of parity, in so far as possible.

C. The principle of proportional representation shall be observed in the local or regional conferences in order to assure minority representation.

3. The executive committee shall have the authority:

- A. To fix the date of the election of delegates.
- B. To appoint a national board of elections.
- C. To fix the date and place of the American Jewish Assembly.

D. To raise such funds as may be required for the organization and holding of the American Jewish Assembly.

It shall render its final report to the American Jewish Assembly when it is convened.

4. The call for the American Jewish Assembly shall contain a statement of program as follows:

- A. To consider and recommend action on problems relating to the rights and status of Jews in the postwar world.
- B. To consider and recommend action upon all matters looking to the implementation of the rights of the Jewish people with respect to Palestine.
- C. To elect a delegation to carry out the program of the American Jewish Assembly in cooperation with the duly accredited representatives of Jews throughout the world.

Full freedom of discussion and action by the Assembly shall not be impaired.

5. The executive committee shall have full power and authority to do any and all things necessary and proper to carry out the purpose and intent of the above program prior to the convening of the Assembly.

It shall have power to organize itself and to provide for representation by alternates under such conditions as the executive committee may deem proper.

Dear Mr. Rosenberg:

We are enclosing herewith a summary prepared by the Secretariat, of the proceedings at the Conference held in Pittsburgh, on January 23-24, 1943, at which your organization was represented.

You will note the proposals attached to the enclosed summary, which deal with the calling of an American Jewish Assembly to be composed of 500 delegates as follows: 25 per cent selected by national membership organizations and 75 per cent elected by democratically convened local and regional conferences comprising delegates of organizations in communities or regions. You will also note that a time limit of thirty days from the time when notice is sent to the organizations is fixed for securing approval of such organizations.

The Conference, before adjourning, elected an Executive Committee consisting of one representative from each of the participating organizations. Additional members of the Executive Committee will be selected in accordance with the proposals.

We enclose also a tentative draft of the Call which according to the proposals will be signed by the participating organizations.

We hope that the spirit of unanimity which prevailed at the Pittsburgh Conference will be followed by the prompt approval of these proposals.

We would appreciate receiving a report of the action of your organization.

HENRY MONSKY Temporary Chairman Executive Committee Having approved the proposals of the preliminary conference of national Jewish membership organizations held in Pittsburgh on January 23 and 24, 1943, as contained in the official report of its proceedings; and believing that there is urgent need for American Jews to establish a program of common action to deal with the post-war problems of Jews the world over;

The undersigned join in a call to the Jewish communities of the United States to cooperate in the organization of an American Jewish Assembly for the following purposes:

- I. (a) To consider and recommend action on problems relating to the rights and status of Jews in the post-war world.
  - (b) To consider and recommend action upon all matters looking to the implementation of the rights of the Jewish people with respect to Palestine.
  - (c) To elect a delegation to carry out the program of the American Jewish Assembly in cooperation with the duly accredited representatives of Jews throughout the world.
- II. The Assembly will consist of not more than 500 delegates; the cooperating national organizations will be entitled to 125 delegates selected according to their own rule; and the local communities to 375 delegates elected through local or regional conferences.
- III. The date and place of the holding of said Assembly shall be determined by the Executive Committee named by the preliminary conference, but the said Assembly shall be held not later than five (5) months from January 24, 1943.
  - IV. The Executive Committee shall be authorized to formulate rules for communal or regional elections, to set up the formula for the distribution and allotment of delegates to communities, regions and national organizations; and shall have full power to do all things necessary to carry out the purpose of organizing the said Assembly, prior to its convening.
  - V. The Executive Committee shall act, in general, as the organizing committee of said Assembly, and it shall issue under its own name all further communications and instructions bearing upon the organization of the Assembly.

Submitted with this call is a copy of the proposals adopted by the preliminary conference. Instructions as to procedure will be issued as and when formulated by the Executive Committee.

Dear Rabbi Silver:

As you are probably aware, the American Jewish Conference represents the most significant step in the direction of American Jewish unity in the history of this country. At this critical time, it can be the means of joining all sections of the Jewish people and of formulating policies designed to help them in winning the war and assuring democratic settlement of the post-war Jewish problems.

It is unfortunate, therefore, that at its last meeting, the Executive Committee of the Conference, yielding to forces more interested in disunity than in unity, has denied thirteen Jewish organizations in the United States. the right to participate in the Conference. Among those denied are HIAS, The American-Jewish Section of the International Workers Order, the Jewish People's Committee.

We cannot but feel that this policy of exclusion represents a serious obstacle to the achievement of the objectives which the American Jewish Conference has set itself to achieve and to the fulfillment of the hopes and wishes of American Jews. It cannot but play into the hands of the enemies of the Jewish people and of the democratic forces in this country. We feel that the interests of the American Jews demand the forging of nation-wide unity of all the Jews.

The Presidium elected by the Executive Committee, consisting of Rabbi Stephen S.Wise, Mr. Henry Monsky and Judge Joseph Proskauer, is empowered to act on the admission of various organizations to the Conference.

We ask you to send us a statement urging the Presidium to rescind its action and to admit all Jewish organizations to a participation in the Comference.

May we have such a statement by return mail?

Dear Rabbi Silver:

We the undersigned are addressing this letter to you as a delegate of the American Jewish Conference.

You have received or will soon receive a letter from the office of the American Jewish Conference describing a procedure under which every delegate may affiliate himself with one of a number of listed groups, or if he prefers to remain unaffiliated with any one of these groups he is asked to register "Designation Reserved." According to this plan, unaffiliated delegates will be able to be represented in the membership of committees only by organizing themselves into a unit of 10 or more.

Unless such a unit is created, unaffiliated delegates will have no opportunity of taking part directly or indirectly in the work of the various committees, will even be circumscribed in the plenary meetings of the Conference and so be greatly restricted in expressing their views, whatever they may be, and in exerting an influence on the Conference.

The undersigned delegates entertain various points of view but come to the Conference open-minded. We urge you to join us and thus make your participation in the Conference effective, because if you are an independent delegate this is the only way for you to participate in the work of the Committee.

It is of vital importance that the decisions of the Conference shall reflect the composite sentiments of American Jewry and not those of any particular ideological or political group. With this in mind the larger the active participation of independent delegates the greater the promise of such results. If you are an independent delegate, register "Designation Reserved" and immediately inform Mr. Edgar J. Kaufmann, 400 Fifth Avenue, Pittsburgh, Pa., to that effect.

A meeting of the unaffiliated delegates will be held on Saturday evening August 28. Upon receipt of your reply Mr. Kaufmann will advise you of the exact time and place of the meeting.



Dear Dr. Silver:

We wish to submit hereby to your Conference the findings and resolutions of the Emergency Conference to Save the Jewish People of Europe, held in New York from July 20th to the 25th.

Although we realize that the program of your Conference is limited to creating a representation of American Jewry and to the study of postwar Jewish problems, we still believe that the question of saving the Jews of Europe from total extermination by the Germans is a problem that transcends, in urgency and importance, any postwar issue. Indeed, we fear that if nothing is done about it, the Germans may exterminate the remnants of European Jewry in a final flare up before their collapse, and most of the postwar problems on your agenda would be solved automatically.

Therefore, we wish to respectfully suggest that your Conference specifically, include, the problem of the immediate rescue of the Jewish people of Europe in its agenda. We also respectfully suggest that your Conference study and endorse the findings of the Emergency Conference to Save the Jewish People of Europe.

As you are probably aware, the Emergency Conference was called by and consisted mostly of important Gentile personalities, experts in the various fields relevant to the problem dealt with. These men and women were motivated solely by their humanitarian desire to stop the unholy massacre in Europe. Their findings represent a very considerable amount of serious and painstaking study of all the aspects of this problem. The endorsement of these findings by your Conference would thus give them the approval of a highly authoritative official Jewish body, which they still lack. We feel that the work done by the Emergency Conference merits the commendation and support of every Jew.

The Emergency Conference came to the conclusion that there are a number of ways to rescue many of the Jews remaining in Europe. The Conference advocated the immediate formation of a special governmental agency to deal <u>explicitly</u> with the problem of saving the Jewish people of Europe. Indeed, all the existing agencies, including the Inter-Governmental Committee set up at Evian and revived after Bermuda, are concerned solely with helping, refugees, which means helping those Jews or non-Jews who have already succeeded in escaping from the Nazis. Such agencies have nothing to do with the problem of stopping the massacre in Europe. The creation of such a governmental agency, as recommended by the Emergency Conference, is the prerequisite to any kind of action because, until it is created no one is able to undertake any adequate steps in the direction of wholesale rescue. And, even those officials of the government who feel that such steps should be undertaken are powerless to do more than to send messages of sympathy. In other words, the United States and the United Nations have to recognize the existence of the Jewish problem in Europe and create a machinery to cope with it.

The Emergency Conference suggested several steps which might be undertaken by such a governmental agency. These steps resolve themselves mainly into the following two proposals:

- 1. To impress upon the Germans, and especially upon their minor satellites, the fact that the United Nations will not stand for the continuance of the massacre. This can be done by propaganda, by threats of reprisals and by actual reprisals.
- 2. To create reservations outside of German-dominated Europe in which those Jews who might succeed in fleeing from Europe may be allowed to take temporary sanctuary for the duration. The present situation is such that a Jew in German-dominated Europe does not have any place which he can escape to. It is as if the United Nations had bolted the doors to the slaughter house of Europe from the outside.

It was the general feeling of the Conference that anything done by the United Nations for the European Jews would in itself be enough to modify, to a great extent, the attitude of both the Germans and their satellites to the massacre of the Jews. Today they are told that they can continue the massacre with impunity. The threat of punishing those responsible for the massacre after the war is naturally ineffective, for these people have already committed crimes and their punishment will not be the greater for any additional horror they may commit. It is only by impressing upon the governments and the peoples of the various enemy countries that they will be held accountable, as a whole, for the continuation of the atrocities, that they can be induced to stop. As the matter stands today they all feel certain, as far as the United Nations are concerned, that it does not matter one way or the other.

We are addressing ourselves to your Conference because we know that all the delegates, and the Conference itself, will be vitally interested in the problem with which we are concerned and we believe that much can be achieved by a common, coordinated effort.

We are enclosing a copy of the findings of the Emergency Conference. Should you so desire, we shall be happy to let you have any number of additional copies for the officers and the delegates to your Conference.

The American Jewish Conference, the democratically elected representative body of organized American Jewry, issues the following declarstion of principles on the relation between the Jewish people, the Jewish Homeland in Palestine and the world need for post-war reconstruction:

The Jewish problem, in its substance and as a symbol, has been made one of the central elements in the present assault on civilization. Its exploitation in a world wide Nazi-fascist conspiracy constituted the initial phase of the assault. Its solution is recognized as an integral part of the conditions needed for an enduring peace.

In the first world war, the consensus of the civilized nations pointed to a solution of the Jewish problem through the reconstruction of the Jewish Homeland in Palestine with which the Jewish people has been bound up historically and religiously throughout the centuries. This consensus was expressed in the Balfour Declaration issued by the British Government, after consultation between the Allied and Associated Powers, on November 2, 1917, and in the Mandate for Palestine accorded to Great Britain in 1922, with the consent of the fifty-one constituent nations of the League of Nations and with the unamimous approval of the Congress of the United States.

On the basis of this international covenant the Jewish people set itself to the task of recreating its historic Homeland in Palestine. In the course of twenty-five years, it has demonstrated a constructive capacity which has already had a profound effect both on the hopes and outlook of the Jewish people, and on a country which had for centuries been regarded as one of the derelict areas of the world. The progress of all sectors of Palestine, Arab as well as Jewish, under the stimulus of the developing Jewish Homeland is one of the most notable phenomena of our time; the contribution of democratic Jewish Palestine to the victories of the United Nations Armies of the Near East has been a significant vindication of the policy initiated by world opinion and carried out in the labors and sacrifices of the Jewish people.

This period of reconstruction, however, has co-incided with a general deterioration of world order and international morality. Chief among the victims of this deterioration have been the millions of Jews living in Europe. Yet despite the fact that the conditions which made the re-establishment of the Jewish Homeland imperative a quarter of a century ago have been intensified beyond the darkest forebodings, the rights internationally guaranteed to the Jewish people with respect to Palestine have been progressively whittled down on grounds of administrative and political expediency until, with the promulgation of the White Paper of May 1939, the solemn promise made to the Jewish people was virtually annulled and the last hope of millions of homeless Jews threatened with extinction.

Meeting at a time when the policies of the peace are in the making, the American Jewish Conference, conscious of its historic responsibility and of its position as spokesman for the silenced Jewish communities of Europe, calls for the loyal and faithful fulfillment of the covenant entered into between the nations of the world and the Jewish people.

It calls for the fulfillment of the Balfour Declaration, and of the Mandate for Palestine whose intent and underlying purpose, based on the "historical connection of the Jewish people with Palestine", was to reconstitute Palestine as the Jewish Commonwealth.

It demands the immediate withdrawal in its entirety of the Palestine White Paper of May, 1939, with its arbitrary restrictions on Jewish immigration and land settlement. The White Paper constitutes a violation of the rights accorded to the Jewish people under the Mandate of Palestine. It has been characterized as a "breach and a repudiation of the Balfour Declaration" by Mr. Winston Churchill. Its moral and legal validity have been denied by the Permanent Mandate's Commission of the League of Nations.

The Conference demands that the gates of Palestine be opened to Jewish immigration, and that the Jewish Agency, recognized under the Mandate as the authorized representative of the Jewish people, be vested with full authority to regulate and direct immigration into Palestine, to develop to the maximum the agricultural and industrial possibilities of the country, and to utilize its uncultivated and unoccupied lands for Jewish colonization and for the benefit of the country as a whole.

The measures here urged constitute the essential rerequisites for the recreation of the Jewish Commonwealth.

In the pursuit of its objective of a Jewish Commonwealth, the Jewish people has steadfastly held before it the ideals which shall integrate Jewish Palestine within the new democratic world structure. The Fewish people pledges itself to the scrupulous observance of the religious, linguistic and cultural rights of the Arab population of

Palestine, and to the equadity of all its inhabitants before the law. It reaffirms its readiness and desire for full cooperation with its Arab neighbors in Palestine, and, in the work of its own national redemption, it welcomes the economic and political development of the Arab peoples of the Near East.

On the basis both of the part it has played in the history of civilization, and its present achievement in Palestine, the Jewish people believes that the Jewish Commonwealth to be established will represent another fundamental contribution to the social and political ideals of the world. Such a Jewish Commonwealth will finally answer the agonized need of the most martyred of peoples, and take its rightful place in the progressive order of mankind which it is prayerfully hoped will issue from the present struggle.

## PALESTINE RESOLUTION

The American Jewish Conference calls upon the United Nations to fulfill the pledge given to the Jewish pople, as expressed in the Balfour Declaration, in the mandate for Palestine and in the Joint Resolution of the House of Representatives and the Senate of the United States, approved by the President on September 21, 1922, to facilitate the establishment in Palestine of a national home for the Jewish people, without prejudice to the civil and religous rights of existing non-Jewish communities in Palestine, or the rights and political status enjoyed by Jews in any other country. Intermational recognition having been given, as stated in the Mandate, " to the historical connection of the Jewish people with Palestine and to the grounds for reconstituting their national home in that country", it urges the United Nations to implement this solemn obligation and assure the growth of the Jewish community. through the adoption of the following immediate measures:

- 1. The revocation of the Palestine White Paper.
- 2. The fadlitation of large-scale Jewish immigration and colonization under the supervision of the Jewish Agency for Blestine, which shall be vested with such authority in regard to economic, social and other matters, including the development of its unoccupied and uncultivated lands, as shall be requisite to increase the absorptive capacity of the country, and to assure its upbuilding and development upon a modern, Bound, productive economy.
- 3. To extend to the Jewish Agency for Palestine such lend-lease and other aid as may be rendered to other communities for relief and rehabilitation.
- 4. To prepare for the establishment of a Jewish Commonwealth

integrated in the structure of the new democratic world, with constitutional guarantees, implemented by appropriate international sanctions, to safeguard the following rights, which shall be forever inviolate in Palestine:

(a) The right to acquire, hold and cultivate land and other natural resources, and to engage in commerce, industry and the professions, without discrimination by reason of race, religion or language.
(b) The right of each community to maintain its own system of education, religious, social and communal institutions.

(c) Hebrew and Arabic shall both be official languages.

(d) The rights of the various religious communities to the Holy Places shall be preserved.

(e) The right of all persons to civil equality shall be fully recognized.

(f) The right to freedom of speech, press, assembly, worship, and other civil rights set forth in the American Federal and State Bills of Rights shall be fully assured.



## PROGRAM OF THE RELIGIOUS NATIONAL ORTHODOX BLOC OF THE AMERICAN JEWISH CONFERENCE

## PREAMBLE:

At this time, when the greatest effort in history is being made to right the wrongs committed against small and weak peoples and to guarantee their protection in the future, we the Jews of America, demand the immediate cessation of the wanton slaughter of our fellow Jews throughout Nazi-occupied Europe and elsewhere and that immediate steps be taken to rescue the helpless victims who can and must be saved; we demand that the injustice done the Jewish people centuries ago by devastation of their land and dispersion of their people throughout the world be righted. To this end we submit the following for consideration;

#### ERETZ ISRAEL:

The demand that Eretz Israel be returned to the Jewish people not only proclaims the historic yearning of our people to return to nationhood, but also is the very foundation of the Jewish religion. God has assured us through the Prophets in clearest terms that Eretz Israel will again belong to the Jews. The daily prayers of the Jew are replete with supplications and hopes for the return to Eretz Israel. The Jews have waited 1874 years that God's promise to suffering Israel be fulfilled, and now, when the opportunity is here for the establishment of freedom and justice on earth, under the inevitable victory of the United Nations, we ask that this be the historic moment when justice to an ancient people, suffering without cause or reason, be accomplished. Eretz Israel is the only hope of millions of persecuted Jews, victims of Nazi barbarism; the only solution to the homelessness of our people. With the establishment of a Jewish Commonwealth on its own ancient soil of Eretz Israel, will the Jewish people have the fullest opportunity for the complete observance of the tenets of the Jewish religion and traditions. Eretz Israel as a Jewish Commonwealth, therefore, is the only solution to the all inclusive centuries-old problem of the Jewish people.

The historic connection between Eretz Israel and the Jewish people was legally recognized by the League of Nations in the Mandate for Palestine. Since then the Jewish people succeeded in reconstructing Eretz Israel as a prosperous land with a Jewish population of nearly 600,000 now already representing the beginnings of a Jewish Commonwealth on its own soil. We, therefore, demand in the name of the Jewish people

(A) the issuance of a declaration by the United Nations expressing assurance that Eretz Israel be declared a Jewish Commonwealth

(B) the control of immigration into Eretz Israel shall be vested wholly in the hands of the Jewish Agency for Palestine

(C) the immediate abolition of the White Paper which is a contradiction of the Balfour Declaration. It is totally opposed, in word and spirit, to the Mandate of the League of Nations. In fact, the authoritative body of the League of Nations itself declared the White Paper illegal.

### DIASPORA:

As the solution of the problems confronting Jewry in the Diaspora we request that the democratic countries open their doors <u>now</u> to Jewish refugees who may yet be saved from the sword of mankind's enemy and we demand (A) that all Jews, who so desire, shall be repatriated to their countries from which they were uprosted; reparations made for all their losses and their return to former positions guaranteed

(B) that full reparations be made to the Jewish people for all property confiscated from and losses sustained by those of our people who were brutally murdered

(C) that full reparations be made to the Jewish people for all losses sustained by the confiscation or destruction of public Jewish institutions and communal properties

(D) that full equality, including linquistic rights, be granted to all inhabitants of every country without distinction between Jew and non-Jew

(E) that wherever there are minority rights no laws shall be in existence abridging the right for the fulfillment of religious principles, including the observance of the Sabbath and the dietary laws.

(F) that anti-Semitism, forerunner and concomitant of Nazism, injustice and lawlessness, which poisons the consciences of nations and is the most serious hindrance to freedom, democracy, and civilization, be declared unlawful and criminal in nature, that all organized and official government means be employed to combat it.



The American Jewish Conference, meeting at a time when the policies of the peace are in the making, and conscious of its historic responsibility and of its position as representative of American Jewry and spokesman for the silenced Jewish communities of Europe, calls for the loyalty and faithful fulfillment of the covenant entered into between the nations of the world and the Jewish people.

#### Demands Are Set Forth

We call for the fulfillment of the Balfour Declaration and of the mandate for Palestine whose intent and underlying purpose, based on the "historical connection of the Jewish people with Palestine," was to reconstitute Palestine as the Jewish Commonwealth.

We demand the immediate withdrawal in its entirety of the Palestine White Paper of May, 1939, with its unwarranted restrictions on Jewish immigration and land settlement. The White Paper is a violation of the rights accorded to the Jewish people under the Mandate for Palestine. It was characterized by Mr. Winston Churchill in the House of Commons as "a breach and a repudiation of the Balfour Declaration." The Permanent Mandates Commission of the League of Nations refused to recognize its legality or its moral validity. The conference demands that

#### **Cooperation With Arabs**

It will finally answer the agonized cry of the most martyred of peoples and enable it to take its rightful place in that progressive order of mankind which, we pray, may issue from the present struggle.

The American Jewish Conference, the democratically elected representative body of organized American Jewry, issues on its behalf the following declaration of principles on the relation between the Jewish people, the Jewish Homeland in Palestine and the world need for post-war reconstruction:

The Jewish problem, bath in its substance and as a symbol, has been made one of the central elements in the present assault on civilization. Its exploitation in a world wide Nazi-fascist conspiracy constituted the initial phase of the assault. Its solution is recognized as an integral part of the conditions needed for an enduring peace.

In the first world war, the consensus of the civilized nations pointed to a solution of the Jewish problem through the reconstruction of the Jewish Homelend in Palestine with which the Jewish people has been bound up historically and religiously throughout the centuries. This consensus was expressed in the Balfour Declaration issued by the British Government, after consultation between the Allied and Associated Powers, on November 2, 1917, and in the Mandate of for Palestine accorded to Great Britain in 1922, with the consent of the fifty-one constituent nations of the League of Nations and **Expression** with the unanimous approval of the Congress of the United States.

On the basis of this international covenant the Jewish people set itself to the task of recreating its historic Homeland in Palestine. In the course of twenty-five years, it has demonstrated a constructive capacity which has already had a profound effect both on the hopes and outlock of the Jewish, and on a country which had for centuries been regarded as one of the derelict areas of the world. The progress of all sectors of Palestine, Arab as well as Jewish, under the stimulus of the developing Jewigh Homeland is one of its most notable phenomena of our time; the contribution of demostratic Jewish Palestine to the victories of the United Nations Armies of the Near East has been a significant vindication of the policy initiated by world opinion and carried out in the labors and sacrifices of the Jewish people.

Unhappily, however, this period of reconstruction has co-incided with a general deterioration of world order and international morality. #### Brothers and Sisters!

WE POLISH JEWS, united in the Representation of Polish Jewry which embraces the foremost Jewish organizations of Poland-Agudath Israel, Zionist Organization of Poland, Mizrachi, Poale Zion Hitachduth, Hapoel Hamizrachi, Poale Agudath Israel, and WIZO (Women's Organization)—appeal to you, delegates of the American Jewish Conference from the depths of our hearts.

For the past four years our brothers and sisters in Poland have been struggling to survive, have been tortured and have breathed their last in pools of their own blood.

Tens of thousands of Polish Jews have been massacred. Tens and hundreds of thousands of men, women and children have murderously and sadistically been asphyxiated in gas chambers.

Tens and hundreds of thousands of men, women and children are in labor camps, working as slaves and struggling under the whip of their Nazi overseers. They are ill fed, underclothed and gradually pine away from undernourishment and disease.

The sole fare of the Jew in Poland today is a piece of bread—and that in an amount inadequate to keep body and soul together.

Their possessions have been confiscated by the Nazi robber, their homes destroyed, their sources of income taken away from them and their heads bowed in misery and dishonor.

The Jews in Poland, comprising not only native Jews but those who have been deported from their homes in Austria, Belgium, Czechoslovakia, Denmark, France, Germany, Holland, Norway, etc., are perishing of famine and sickness.

Their agonized cries reach our ears daily. Their heroic struggle on the barricades of the Ghettoes will go down in the annals of glorious Jewish history. They demand of us immediate help and rescue. Theirs are the voices of the dying, calls from beyond the grave, the voices of men doomed to extermination.

We Polish Jews appeal to you, delegates of the American Jewish Conference to heed the call of these desperate souls, to save the Jews in Poland from destruction. Do not permit the centuries-old Jewish communities of Poland to perish. Raise your voices in protest against the enormities being perpetrated against your people. Rouse the democratic world and the Allied Nations to a realization of their responsibilities, to their duty to put a stop to this barbaric horror which will leave its ugly stain on the pages of history for centuries to come.

There are still ways to rescue our brothers; it is still possible to sustain them among the living, to breathe renewed life into their blanched cheeks.

It is your and our brotherly duty to open the eyes of the Allied Nations to the possibilities that still exist for the succor of the Jews in Poland. Help must come now, today. Tomorrow may be too late.

It is incumbant upon The American Jewish Conference, representing all of American Jewry, to undertake the following steps immediately:

1. Impel the Allied Nations to issue an immediate categorical warning to the German people that they will be held to strict accountability unless the slaughter of the Jews in Poland is brought to an end.

- 2. Appeal to the Allied Nations to obtain the release of all Jewish women and children from Poland, this to be done with the cooperation of the neutral governments.
- 3. Undertake all the necessary steps to secure and assure immediate shipments of food and clothing to the Ghettoes of Poland.
- 4. Intercede with the Allied Nations for the recognition of Jews in the Ghettoes, the concentration and labor camps as civilian internees, entitled to the same help from the International Red Cross which is granted to all other civilian internees.
- 5. Appeal to American Jewry to send funds to the Jewish Underground movement in Poland, for immediate rescue work among the Jews in the Ghettoes.

The fate of our brothers and sisters lies in your hands. You are in a position to save them from brutal destruction. Destiny so willed it that you, breathing the air of freedom in the United States, may become immortalized as the saviors of your people in the darkest hour of their history.

It is the first and holiest of your duties, as men and as Jews, to save the remnant of our stricken people. The 5,000,000 Jews of the United States must become the big brothers of the Jews in Poland, caring for them in their distress and helping them to make a moral and physical recovery.

We appeal to you as brothers to brothers. We who have escaped from the hell of Nazi terror cannot have peace as long as we know that our near ones are being destroyed.

#### Save them while there is yet time!
