Dear Dr. Silver:

We fully understood the logic and wisdom of your decision in not coming to the Madison Square Garden meeting on Monday evening, February 25.

The decision to hold this meeting was taken at 2:00 P.M. on Friday, February 22. Although we had the obstacle of the holiday weekend (Washington's Birthday) and the Sabbath intervening, with only one working day, we were able to hold a highly successful demonstration. Cooperating, were all the Zionist groups, American Jewish Congress, American Trade Union Council for Labor Israel, Jewish War Veterans of the U.S., The New York Board of Rabbis, and the Metropolitan Council of the Binai Birith. The Garden was packed with a crowd estimated at between sixteen and eighteen thousand. Indeed, the police closed the doors at 7:30 P.M. and turned away a couple of thousand — for what reason I do not know.

Enclosed is a release including excerpts from many of the messages and a few of the addresses. Rabbi Miller set the tone with his opening address which was really very good. Dean Pike delivered an exciting address and had the audience cheering and whistling with enthusiasm. Senators Douglas and Javits delivered fine speeches. There were others, which you will see from the release, of a high order.

Good messages were received from governors, senators, congressmen, the national commander of the American Legion, and many others.

Coverage through all the media of communication was good. The Metropolitan press and the press throughout the country, to a large extent, carried the story. Channels 2,4,5 and 7, on TV, carried the story on their regular Monday night newscasts and sent it out over the networks (CBS actually gave 3 minutes of a 12-minute newscast to the Garden demonstration). All the radio networks carried the story. Indeed, this coverage lasted on Monday and Tuesday. I, myself, listened to CBS radio news broadcast on Tuesday morning, February 26, at 7:45 A.M. On a 15-minute broadcast, the station gave 5 minutes, or one third of its coverage, to the news of the Garden demonstration.
