
I shall be in Washington on October 11th and 12th and would be glad to see you at that time.

MEMORANDUM

November 10, 1943

To: Mr. Montor

From: Kinereth Dushkin

Approximately 70 people - half of them Gentiles - were present at the organizational meeting of the American League For a Free Palestine. The meeting was held in the Continental Ballroom of the St. Moritz Hotel at 8:30 P.M. on Tuesday, November 9, 1943. Speakers were: Mr. Potter, chairman, Lisa Sergio, radio commentator, and Dr. Johan Smertenko, former professor at Grinnell College, now director of the Emergency Committee to Save the Jewish People of Europe.

The meeting was opened by Mr. Potter. "We are gathered in a very solemn and dark hour as far as the Jewish people are concerned", he said. "From reports from our emissaries - like Will Rogers - we can tell you that the situation is just as serious and heartbreaking as it has been before." Mr. Potter turned from the present suffering of the Jews in Europe to Arab activities in the Near East. Concerning Muri Pasha's recent invitation of Arab representatives to Cairo, he stated that the object of that invitation is the discussion of the formation of an Arab Federation, based on the program outlined in a new book by the Prime Minister of Iraq. "The thesis of that book is that Great Britain owes the Arabs a debt because of Arab services rendered in the last war", he said. To combat such activity, Americans of all creeds must band together in an American League For a Free Palestine for the Jewish people.

Mr. Potter listed recent activities which were to the organization's credit: (1)
Roosevelt's letter of rebuke to Argentina concerning the suspension of Jewish newspapers; (2) the establishment of a governmental refugee agency; (3) the Carnegie Hall
"Salute to Dehmark and Sweden"; (4) the "solemn pilgrimage of 500 rabbis to Washington";
(5) the week of compassion declared in 6,000 churches throughout the country.

The most forceful speaker of the evening was Lisa Sergio. Discussing the relationship of the Jewish problem to world peace, Miss Sergio declared that Hitler's persecution of the Jews, "the first match which ignited the powder which blew up the world", need never have come to pass were it not for the element of fear. In order to rid the world of anti-Semitism we must first get rid of that element of fear. Public opinion is the powerful channel through which we can disprove "Hitler's fundamental psychological lie" about the Jews. Public opinion was written into the Moscow Pact which has brought "the people and their free will" to the fore. American public opinion is the freest in the world; it must be made to see that the solution of the Jewish problem lies in Palestine, and that the bilateral treaty between England and the United States concerning Palestine gives us a moral responsibility. "The Senate has just voted itself in on international affairs", she said. "The White Paper is its test case. We shall lose our clear record if on this matter of Palestine we fall down."

The final speaker was Professor Smertenko. "Although there has been a Jewish problem for 2,000 years", he said, "there has never before been a Jewish freedom movement." The American League For a Free Palestine - alias the Emergency Committee to Save the Jews of Europe, alias the Committee For a Jewish Army, alias the American Friends of Palestine - was created to meet a specific need. Its existence is justified as a non-sectarian organization not engaged - as is the Zionist movement - in any of the

factional controversy which is the bane of Jewish life. "Basic to saving the Jews of Europe is Palestine; it alone can take in 600,000 refugees - now", he said. Despite the early whittling down of the Balfour Declaration - "Transjordania became 'Judenrein' long before Hitler appeared on the scene" - we must act now, as the nations of other countries are acting, to attain for the Jews of Europe a Jewish State on both sides of the Jordan. We must learn from the programs of Indian and Korean nationals who say "we are a nation; we have a land which we propose to occupy; we turn to American public opinion for support." That must be the program of action of the American League. Otherwise, whereas at the Peace Conference the small Duchy of Luxembourg will be represented, the millions of stateless and homeless Jews will not.

Smertenko's final appeal:

- (1) "Stand up and be counted." Add your name to a list of names to be sent to Congressmen by the American League.
- (2) Appeal for membership.

Dear Dr. Goldmann:

You are undoubtedly familiar with the fact that at the last meeting of the Zionist Organization of America Executive I presented again the problem of calling a conference for the post-war rehabilitation of Palestine. The major object of this conference should be to dispel the legends and myths which are being circulated among official Washington and non-Zionists that Palestine has no potential capacity for large scale Jewish immigration. If such a conference is held sometime in the latter part of February 1944, or the first part of March, it will be of political significance in our fight against the White Paper. In addition, such conference will help to clarify certain important economic issues and its results may be used as a directive in future planning for Palestine.

At the ZOA Executive meeting Dr. Silver and the other members of the Executive were much impressed with this idea and they have pledged their support. Last Sunday I made a special trip to visit Dr. Silver in Cleveland so that we could elaborate on the nature of the conference and its implications. Dr. Silver stated that the Zionist Emergency Council should call such a conference and asked me to communicate with Mr. Blinken as representative of the American Palestine Institute in Washington and Mr. Neumann as acting chairman of the Palestine Surveys Commission and chairman of the newly created Planning Committee of the Emergency Council.

Broadly speaking, I should like to make the following suggestions:

- The conference should be called under the auspices of the Jewish Agency and the Zionist Emergency Council of America.
- 2. A small Arrangements Committee should be immediately organized which should include:
 - a. A representative of the Jewish Agency. (I may suggest Mr. Weisgal).
 - b. A representative should be designated by the Emergency Council. (In this case if you have no objection, may I suggest Albert K. Epstein.)

-2-Dr. Nahum Goldmann December 7, 1943 A representative of the Palestine Survey Commission, which, of course, is understood to be Mr. Neumann. A representative of the American Palestine Institute. (I suggest Mr. Blinken.) e. A representative of the Palestine Economic Corporation and the Palestine Economic Committee, whichever you deem advisable. Perhaps Mr. Weisgal and a secretary lent by the Emergency Council can take charge of the technicalities of the preparation. This group should be the committee on arrangements and should be responsible for preparing the details of the conference. I am suggesting an Arrangements Committee of this sort in order to avoid any possible misunderstanding between existing groups in this field and friction between personalities. I believe that a Committee so constituted will at least solve this problem. The Conference should be limited in size and should be by invitation only. The maximum we can expect is between 50 and 100 people. The papers read at the discussion should be recorded and become official documents to the various agencies of the Zionist movement and to governmental bodies to whom this matter may be of interest. A tentative suggestion of the subject matter of the papers to be read is as follows: Economic geography of Palestine and the surrounding countries. Present Palestine economy such as the total population and percentage of population in trade, industry, agriculture, commerce, etc. Fuel (hydroelectric power, petroleum, oil shale.) Scientific agriculture: (1) Present status. (2) Potential expansion based on irrigation, canalization, reservoirs, flood control, etc. (3) New crops. Industry. (1) Present status. (2) Possibilities of expansion: chemical, metallurgical, mechanical and textile industry. f. Housing and building. Maritime transportation. g. n. Transportation.

Technical experts of the Palestine Surveys. It is suggested that an economic expert from Palestine be invited, for example Mr. Horowitz, and Mr. Laski from Great Britain. As guests the following may be invited: Official representatives of the U. S. Government, e.g. from the Office of Economic Warmfare, Near East Department. Representatives of the British Embassy and the British Supply Council in the United States. Members of the Near East Institute which met in Chicago a year ago. These gentlemen are primarily academic, connected with various universities in this country in the departments of Political Science and related subjects. Vice-President Wallace and other governmental officials in whom we may be interested, senators, congressmen. Representatives of foreign governments interested in the Jewish problems (Poland, Czeckoslovakia, Russia). It is problematic whether it is advisable to discuss the financiel aspect of rehabilitation of Palestine. Dr. Silver believes that if at the present time it were mentioned, that the project will cost one billion dollars and that we will have to get this money from the United Nations, it may have an adverse political effect. On the other hand, this question will pop up during the discussions. We cannot avoid it. Therefore I believe it would be advisable for someone to discuss the problem of financing this rehabilitation project. I wonder whether a man like Andre Meyer from France could handle this subject in a general way, or whether perhaps Robert Nathan could do justice to it. It is also suggested that the Conference should last two days, with morning and afternoon sessions. No paper should be over thirty minutes and hot more than four papers should be read per session in order to allow time for discussion. It is advisable to assign certain people to the discussion of each paper ahead of time so that the discussions can be carried on in an intelligent manner.

Dr. Nahum Goldmann -4-December 9, 1943 In addition to the problem to be idscussed, I want to add that someone should read a paper on the scientific and technical researchs of Palestine with the object of proving that Palestine is the only country in the Middle East which has the necessary personnel required for an expanded agriculture and industry based upon scientific principle. The above are merely working suggestions. When the Arrangements Committee will be called together, changes may be made in the program, and perhaps the other members of the committee can suggest additional experts to handle certain phases of the conference. I am sending a cooy of this letter to Mr. Neumann, Mr. Blinken, and Dr. Silver. It is important that this work should start immediately as it will take at least two months to arrange the conference. ea cc: Dr. Silver Mr. Neumann Mr. Blinken

Dear Mr. Blinken:

I regret very much that I could not avail myself of your kind invitation to attend the Washington meeting. It was impossible for me to obtain reservations on short notice.

I have received the very interesting memoranda prepared by the members of your Institute, and also Mr. Nathan's splendid outline, which I understand is to serve as a guide for the preparation of a documented memorandum covering various phases of Palestine economics. I shall be thankful to you if you will keep me in touch with the future proceedings of the Institute.

In analyzing your letter of December 13, as well as my correspondence to you of December 7, it is apparent that there is really no great difference between my approach to the problem and the one that you outlined in your letter. In addition, there is really no conflict between the proposed conference on the Economic Rehabilitation of Palestine and the memorandum which Mr. Nathan and his staff are preparing to present to Messrs. Roosevelt, Stalin and Churchill; in fact, they complement and supplement each other. Perhaps we are using a different vocabulary to denote the same ideas, and hence I shall endeavor to clarify some of the issues involved.

You ask the question: "What do you want to achieve?" The members of your Institute, as well as we, recognize that there is opposition from official quarters to a large Jewish immigration to Palestine. Whether the hostility of the experts and the officials is due to "predilection", as you choose to call it, or to created "myths and legends" that the absorptive capacity is limited, as I designated, does not alter the situation. Both you and we desire to disspell this "predilection" or "myth" by presenting objective, scientific economic data with the object, as you state in your letter, to "persuade and influence the leaders" who will ultimately determine the basic political question. It is evident from the memorandum of December 7 that the proposed conference will not be of a political nature, we will not pass political resolutions, we will simply endeavor to present economic evidence that Palestine has a large potential absorptive capacity. Although you state in your letter, Page 2, Par. 3, "We do not consider the target of disspelling the legends and myths as being the propose."

If you reduce the problem to its simplest form, it amounts to the following: We must prove by objective, scientific evidence that Palestine can support and additional one million Jews, and it is hoped that the sincere leaders of the democracies will examine this evidence and will be convinced of the justification of our claims and that they will give us the political power to implement this program in practice.

Another important question is raised: "There shall me take the objective facts to present to the proposed economic conference since the data in proper scientific form has not yet been assembled." This point requires some clarification. A large amount of fundamental research work on the economic problems of Palestine has been carried on for a long period of time by the Palestine Government and published in a number of official bulletins, gazettes, etc., by the Economic Research Institute of the Jewish Agency for Palestine (Jerusalem), published periodically in bulletins, Palestine and the Near East, and in the publications of the Chevroth Ovdin (Histadruth Cooperatives). Compilations of this scientific data have been published also in the yearly reviews of the "Economic Annuals of Palestine", and in the excellent compilation of Horowitz and Hinden, Rupin, Gurawitch, and others.

Fortunately, we have this scientific data on hand, but what we have failed to do is to bring this data to the attention of Jews and non-Jews. Our entire Zionist literature in this country for the past years has been political in character. We have failed to familiarize the statesmen and the experts with the created economic realities of the Yishuv and with its future potentialities.

The value of your Institute lies in the fact that its staff is endeavoring to compile and abstract the already existing literature on the subject and reinterpret same in terms of the pressing problem of the day. This is an excellent piece of work. As a matter of fact, the five excellent papers already prepared by the members of the Institute, if presented at the conference, would constitute approximately 50% of the program as outlined in the members of December 7. These papers cover various economic problems of the past.

We also have material on hand in connection with the expansion of agriculture and industry since 1939. There is no doubt that Dr. Lowdermilk and the engineers of the Commission on Palestine Survey could make an excellent contribution by reading papers on expansion of irrigation and electrification of Palestine, and point out the potential possibilities for large immigration, as well as the effect of such a program on the Near East. Dr. Bergmann could write a very fine paper on the potentialities of the chemical industry. A short paper perhaps could be prepared by the writer on some phase of the problem which has a bearing upon the future of Palestine. Undoubtedly other members of your Institute, such as the very capable Mr. Nathan, could read a preliminary paper on some phases of the problem, which is outlined under Heading 3 and 4 of his memorandum.

Mr. Abraham Dickenstein, Credit Manager of the Workers Bank in Palestine, is a specialist in Palestine banking and in the cooperative movement,

I wired you today as follows:

This delegation should be able to impress forcefully upon Eaton the desirability of his sponsoring wholeheartedly the resolution in question.

Newcorn became active in this connection because of his interest in the White Paper fight. I am sure he would never have been involved if from the first we had insisted upon the Commonwealth concept. Although I have no doubt in my own mind that if the labels were not used he would not object to taking the medicine. As time has passed and he has been brought more closely in touch with Zionist thought I think he resents the labels less and less. He is a member of the American Jewish Committee. It would be politic for those of you who accompany Judge Newcorn and the delegation to present the matter particularly from the point of view of American interest in the question. You should in advance of the meeting indicate to Newcorn exactly what you wish hims to do and how you wish him to do it. I am confident that he will follow your every suggestion.

Please let me know how the meeting turns out.

I have asked Judge Newcorn to wire you, after he has made reservations on the train, when you may expect him at your office.

At the Emergency Conference held in New York, on July 20-26, 1943, experts from all parts of the United States formulated a program of effective action that can and must be taken now to save the Jewish people of Europe. They urged the governments of the United States and the United Nations to adopt a plan embracing the following outstanding measures:

- *1. To create a Governmental agency specifically charged with the task of saving the Jewish people of Europe.
- 2. To seek guarantees from the Axis-satellite countries, through the International Red Cross, neutral countries, or the Vatican, to insure Jews the same treatment given to other nationals.
- 3. To relieve the starvation and disease which are decimating the Jewish people in Axis-held territory.
- 4. To insist that the Axis-satellite countries, which now want to gain the goodwill of the victorious Allies, withhold their Jews from Hitler's slaughter-houses and permit them to leave their borders.
- 5. To urge neutral countries—Sweden, Ireland, Portugal, Spain, Switzerland, and Turkey—to grant the Jewish people temporary asylum.
- 6. To request neutral countries to grant transit facilities to all Jewish people passing from Axis-controlled lands to any United Nations territory, regardless of whether the persons involved be refugees, immigrants, or repatriates.
- 7. To obtain from the Governments of the United Nations temporary asylum, with the understanding that after the war these refugees will be removed from their territories if they are not wanted.
- 8. To insist that Great Britain, pending this tragic emergency, open the doors of Palestine, where 600,000 Jews have expressed their desire to share their homes and food with their suffering brothers, thus putting an end to the discriminatory immigration laws that exclude only Jews from their own country.

This Committee Was Created to Speed the Rescue of the Jews of Europe . . Let's Look at the Record?

Our first achievement is the fact that we have proven to the world that the Jewish people in occupied Europe can be saved. It was for this purpose that the Emergency Conference of experts in diplomatic, military, economic and transportation fields was called. The participants, the most distinguished representatives and experts of all shades of American thought, reached the unanimous conclusion that the Jewish people of Europe could be saved.

This conviction was later confirmed when the epic story of how the Danish-Jewish population was saved came to the open. The majority of the Danish Jews were rescued by the noble and humanitarian action of Sweden, who declared her shores open to the Jews escaping from nearby Denmark. What small Sweden did, certainly the great and mighty democracies could do on a hundred times larger scale.

We brought the problem of the Jewish disaster to the masses of American people by nation-wide advertising in the leading newspapers in this country, and through national radio-broadcasts, books, periodicals and leaflets.

We organized mass expressions of public opinion demanding immediate action, through a mass petition movement, mass rallies and dramatic pageants.

We organized the pilgrimage of five hundred Rabbis to Washington.

We obtained the cooperation of all faiths. A Week of Compassion and Prayer by the six thousand Christian Churches was organized.

We initiated the movement to pay tribute to Sweden and Denmark.

We organized the protest against the omission of the Jewish disasters from the Moscow statement, on atrocities.

Now, we are able to state with satisfaction that the President, at his press conference on November 6th, of last year, and Secretary Hull, in his last historic appearance before the joint session of Congress, specifically mentioned their concern with the Jewish tragedy: The ring of silence around the catastrophe of the Jewish people was broken.

Our offices and representatives in Washington and in London, in Palestine and in Turkey, are urging the respec-

tive governments to undertake large-scale action to save the four million Jews in Europe's death trap.

More than that: in all our activities, we put forward as the first and most immediate demand, the creation of a specific Governmental Agency with the task of effectuating the rescue of the millions of Jewish people still alive in Europe.

A bi-partisan resolution recommending such an agency was passed in the Senate Foreign Relations Committee. This resolution was introduced by leaders of both parties: in the Senate by Senator Guy M. Gillette and eleven of his colleagues; in the House by Congressmen Will Rogers, Jr., (D) of California, and Joseph Clark Baldwin (R) of New York.

Prominent men from all walks of American life testified before hearings of the Foreign Affairs Committee of the House urging this resolution's passage.

The nation's press was unanimous in demanding the immediate passage of the resolution. The Senate Foreign Relations Committee unanimously approved it.

Now, the great news breaks in Washington that the President has appointed a special War Board to deal with, we quote, "this difficult but important task." The Secretaries of State, War and Treasury, were appointed on it. This composition of the Board emphasizes the extreme importance that the President attaches to it. A special full time Administrator will be appointed for this most important job. This job is defined by the President in unequivocal terms:

"It was urgent that action be taken at once to forestall the plan of the Nazis to exterminate all the Jews and other persecuted minorities in Europe."

Thus a great moral victory has been scored by the United States. This time it is not upon the field of battle but on a front even more bloody—where a godless enemy is engaged in the total massacre of the Jewish people of Europe. The President is to be congratulated for his timeliness and for his great humanity.

It is our duty to organize public opinion directly behind this new body so that its important humanitarian work may be strengthened and speeded.

Ben Grauer of "Information Please" is the announcer on all the programs.

All of which must indicate to you that Zionism is due to be presented to the public with the best means of mass education at our command. Furthermore, we have worked out the details of a plan for each city to use the programs for membership, propaganda and education. Of course you realize the importance of such activity at this time.

I am very much interested in the radio project which the ZOA has launched and I hope that it will be successful. As you probably know, the Emergency Council, of which the ZOA is a member, has also initiated a national broadcasting program covering a period of thirteen weeks, beginning in August, to carry the message of Palestine to the American people during three critical months during which time our resolutions in Congress are likely to come up for action and vital decisions affecting our Movement are likely to be announced. The Emergency Council does not propose to continue its radio program beyond those thirteen weeks. I do not think that the ZOA program should be initiated before the expiration of the Emergency Council national broadcasting series. It would be unwise duplication. I furthermore believe that your committee ought to delay its appeal for special funds in the communities until the Emergency Council will have completed its solicitation. Communities which have already been approached both by the Emergency Council and the ZOA are greatly confused. It appears as if there are two competitive agencies at work. I would therefore strongly urge that you delay your trip for a little while until the Emergency Council radio broadcasting program gets under way. I am sure that if its program is successful the Zionists of America will wish to continue it indefinitely after the expiration of the Emergency Council's limited broadcasting period. DR. SILVER HAILS PALESTINE PLANK IN DEMOCRATIC PARTY

It is now the declared purpose not of one political party or another, but of the entire American people, which has come to regard this constructive solution of the basic Jewish problem in the world today as one of the important objectives of a just world peace which is to follow this war."
