My dear Rabbi Silver:

I am not given to the habit of adding to the burdens of the Post Office by making my contribution to fan mail, but I cannot resist making this instance an exception in connection with your address delivered before the National Conference of Jewish Social Welfare, which appears in the current issue of the New Palestine. I shall forego the temptation to indulge in adjectives, difficult as it is to repress them. There is just one that I cannot keep down altogether, which perhaps sums it all up, namely, superb.

One part of the paper registered perhaps more deeply than others. It is that portion of the paper which deals with our failure to save as many as might have been and the utter ineptness in utilizing precious weeks and months in the most ghastly period of Jewish extermination in Hitler Europe. This particularly so because throughout that period I did my utmost to go allout in an endeavor to stir public opinion and save lives. There were many evening meals uneaten or undigested following hectic meetings where it seemed impossible to obtain that "measure of wisdom, vision and competence" needed in such a dire hour.

I have drawn heavily upon your thinking in the talks I have made since reading it. You have given elequent and unanswerable expression to what is or should be in our minds and hearts.



Dear Dr. Silver:

In your letter of the 17th, addressed to Mr. Arthur Lourie, you inquired about Irving Zieman of Boston.

As a Bostonian, I can give you full information on this gentleman. He is undoubtedly the person you have in mind, who has sent vicious anti-Zionist communications to English periodicals. He has been doing this thing for sometime. He is rabid on the subject and has not only sent letters to the Jewish Advocate of Boston, but has also succeeded in inserting quite a bit of nasty, anti-Zionist material in that paper, as paid advertising.

He also started to make trouble in Boston with a radio station which was carrying a program of the Rabbinical Association because, during several of the broadcasts, Rabbi Herman H. Rabinovitz and other Rabbis have spoken favorably of Zionism. He complained to the radio station that, since Zionism was a controversial subject, he must be given an equal amount of time to that given to the Rabbinical Association in order to answer it. In this he was not successful.

He is a man of considerable means, a real estate man, and he and one other person have been financing some agitation for the Council of Judaism.

Among other things, he was responsible for getting a hearing for Lessing Rosenwald before the Brotherhood of Temple Israel of Boston. However, to counteract this, our people arranged to have Lessing Rosenwald's lecture followed by Dr. Nahum Goldmann, and from the reports I have heard, Rosenwald didn't make a particularly good impression, - the attendance being made up largely of people who wanted to see what a millionaire looked like, while Dr. Goldmann made a very fine impression.

With all that I gather, Mr. Zieman is not taken very seriously in Boston, but so long as he has means and is willing to spend, he will be able to fill up some space in the local Jewish Advocate, and of course there is nothing to prevent him from sending out the kind of thing which you received.

Enclosed please find the letter and the article sent by Mr. Zieman.

MEMORANDUM relative to interview with Charles Gradke, Foreign Editor Christian Science Monitor, regarding item in Christian Science Monitor, June 28th.

To Harry L. Shapiro

From Adolph Hubbard

I saw Mr. Gradke and showed him the article which appeared as a report from their Washington correspondent on June 28th and also a subsequent article which appeared on July 25th as coming from their Cairo correspondent. The first item purported to represent the views of the American State Department and was the item denied by the State Department. The general tone of the second article was much the same as the first one and made the point that Lord Gort was in for a lot of trouble but that the whole matter might come to naught because it is quite possible that there will be no Jewish immigration to Palestine after the war.

Mr. Gradke made the point that since the first item originated in this country it was really something that did not come out of his department and that it being so near his work, he would check into it. I showed him the photostat of the letter of the State Department denying the matter in the item but he tried to minimize the statement saying that he had information that it represented the real view of the State Department.

In the course of the discussion an additional fact came out to confirm the idea that I expressed in my report of the former interview that Gradke is a "meshumed" or a son of a "meshumed". He said that his solution of the Jewish problem is that the Jew should not be segregated but should be assimilated among the other nations of the world and that he had written considerable material in his paper to help in this line, although it had not appeared editorially.

He did make note of the dates of the two items involved and took the photosat of the letter and said he would check into the matter. This is the final word which can be amplified verbally as to the details of the conversation had with him.

It is therefore obvious that we cannot do much with Gradke, as he is clearly an opponent and not a very scrupulous one.

As you are probably aware Elihu Stone has another contact in the Christian Science Monitor. I have reported to Elihu and he will follow up his contact this week.

I am handing on to you a suggestion made by Judge Levinthal in a recent letter to me:

"It occurs to me that it would be worthwhile considering the advisability of advertising in key newspapers of the country both the Republican and Democratic Party planks on Palestine (exclusive of the last sentence of the former). The Emergency Committee might sponsor the advertising, or it might be done in the name of the American Palestine Committee. The ad. need not be very large. It might quote Roosevelt or Dewey, the American Jewish Conference Resolution, and the pending resolution in Congress. The Philadelphia Palestine Open Door Committee is planning to advertise along these lines in all the Philadelphia newspapers."

In reply to Judge Levinthal, I stated as follows:

"As to your suggestion to advertise the planks, I am not sure that I can see any special purpose in it. After all, our next step is the Congress Resolution and the Congressmen certainly are aware of the Palestine planks. I am, however, handing on your suggestion to Dr. Silver."

MEMORANDUM

To DR. ABBA HILLEL SILVER.

Date August 8, 1944.

From Mr. Hubbard.

Subject: Relative to interviews with Charles Gradke, Foreign Editor of the CHRISTIAN SCIENCE MONITOR.

I have had two interviews with Mr. Gradke, both of them rather lengthy. The first was brought about because of a discussion that I had in this office with the Christian Science Advertising Representative relative to the attitude that the Monitor is taking towards the Zionist Movement. This first interview was rather general in its nature, in which I discussed our Movement with Mr. Gradke. It appeared that he was very familiar with all the Arab arguments and he presented them. I believe I met every one of them. The impression that I came away with at that time was that he was either a "meshumed" or the son of a "meshumed", although there is nothing about his appearance or his accent to give this impression.

The second interview which I had on July the 29th dealt with the statement that appeared in the Christian Science Monitor on June 28th, purporting to be the view of the State Department. First, I pointed out to him that the facts were incorrect, and then showed him the letter of Mr. Stettinius on the subject. At the same time I spoke to him about an article, in the same strain, that appeared in the paper on July 25th, under the heading, "Arab-Jew Tension Increases Over Palestine as Homeland" by William Stringer, as the Cairo Correspondent. The second article was similarly antagonistic and dealt with the problem that Lord Gort would have to face in Palestine. This Cairo article raises some doubt on the Lowdermilk project, which it refers to as statements by "American development experts".

Mr. Gradke insisted that this article of the 28th represented the view of the State Department, and he was not affected by the Stattinius letter.

I asked whether he would print any material that we would send in and he refused to make any commitments, saying that whatever would be sent in would have to be submitted to various tests as to whether it was correct and whether it conformed to the policy which the paper had set up.

During the course of the discussion he made the remark that he was quite ready to agree that our people suffered terrible injustices in Europe and when he advanced this, I answered him by saying that since he agreed to that point, and if he did not agree that the Jew should be sent to Palestine, what did he have to offer in place of it - and ruling out anything like Madagascar, Uganda and British Guiana, which I characterized as pure conversation to confuse the issue, - his answer was that he felt, and he had written to this effect in the Christian Science Monitor, that the Jew should not be segregated in any one place but that they should be assimilated among the other nations of the world. Of course my answer to this is the obvious one, but this has confirmed the view that I have taken about him as being a "meshumed". It is very evident that he is an anti-Zionist and all of the trouble in the paper stems from him. I have looked into the American Who's Who, and while in Boston, into the Massachusetts Who's Who and the New England Who's Who, and do not find him listed in any of these documents so that I am not in position to give his background. TO: DR. ABBA HILLEL SILVER.

When I realized that nothing could be accomplished with him, I ceased to be aggressive so as not to create a difficult situation for Elihu Stone, who has another contact of a person higher up in the Christian Science Monitor.

Immediately after leaving Mr. Gradke, I reported in detail to Mr. Stone and suggested to him that he make immediate contact with this Mr. Richardson, to whom he spoke on the train to Chicago, and who has represented himself as being the Chief Editor of the Christian Science Monitor. Mr. Shapiro has written to Stone, in accordance with the enclosed letter, to follow up on this matter.

My Dear Dr. Silver,

I am sorry to disturb your vacation by bringing to your attention the enclosed booklet issued by the British Information Service, 30 Rockerfeller Plaza, New York City, -- "Fifty Facts About The Middle East."

In fact 30, speaking of Palestine, the InformationService mentions that Palestine is smaller than Maryland in area, has a unique place in the history of Judaism, Christianity and Islam. Under the Balfour Declaration, made in 1917, while Britain was liberating Palestine from Turkish rule, Britain stated it favored the establishment in Palestine of a Jewish National Home. etc. This Home was established.

According to my interpretation, and I believe you will agree with me, it was the intention of the Information Service:

1) To point out the limited area of Palestine.

2) That Palestine is sacred to two other Religions-Christianity and Islam.

3) That the Balfour Declaration did not intend Palestine as a Jewish State, but that in Palestine a Jewish Homeland sould be established.

4) That the said Declaration was issued during a time when Britain was engaged in a war against Turkey. Therefore it should be considered as a war measure to win the sympathy of the Jews.

5) Which is most significant, that the Home was established.

In fact 32, it regates the proposal of Partition in 1937 which failed and as a consequence the British Government put forward a plan for a self-governing Palestine setting 75,000 as limit for further Jewish immigration without Arab consent.

Finally, in fact 33, the Information Service states that

MEMORANDUM ON MEASURES OF RELIEF AND RESCUE OF JEWS SURVIVING IN AND DEPORTED FROM HUNGARY

We welcome with gratitude the announcement by the Governments of the United States and the United Kingdom that "they have accepted the offer of the Hungarian Government for the release of Jews and will make arrangements for the care of such Jews leaving Hungary who reach neutral or United Nations' territory, and also that they will find temporary havens of refuge where such people may live in safety."

We express our appreciation for the untiring efforts of the War Refugee Board, which led to the offer made by the Hungarian Government and its acceptance.

It is our conviction that steps must be taken without delay to implement this announced policy for the following reasons:

1. The offer of the Hungarian Government may be countermanded at any time by the Nazis and the deportation of Jews from Hungary, which we understand is still continuing, may be resumed on a large scale. Such a course is likely in the light of past experience and because of the danger that the Nazis may launch reprisals against the Jews as Allied successes mount.

2. Evacuation of a number of Jews from Hungary will not only mean salvation for those who are removed, but will make it clear to the people of Hungary and other countries in Axis dominated Europe that the Allied powers are determined to protect the Jewish people from further Nazi excesses, and thus ameliorate the conditions of the Jews who cannot be brought out.

3. Any indication on the part of the United Nations that they are not prepared to take full and immediate advantage of the Hungarian offer would have a disastrous effect, for it would negate the warnings and the appeals which have been directed to the people of Hungary since the beginning of the Nazi occupation, and it would discourage neutral nations who have repeatedly demonstrated their willingness to come to the assistance of the victims of Nazi persecution. We therefore urge the immediate adoption of the following measures of rescue:

I. RESCUE OF CHILDREN

At the outset, we stress the urgency of transferring children from Hungary inasmuch as a number of neutral and Allied governments have expressed a willingness to grant havens to them.

Since the Swedish Government has offered to receive 10,000 children from Hungary, we urge that a number of airplanes be placed at the disposal of the Swedish authorities and that the children be flown from Hungary to Sweden. Planes might also be placed at the disposal of Switzerland, Spain and Turkey should they be willing to undertake similar action.

The fullest cooperation of the International Red Cross should be enlisted to guarantee these planes safe transit.

It is our conviction that public opinion would hail these flights of mercy with gratitude. Moreover, the psychological effect on the people of occupied Europe would be overwhelming, for this would impressively signify the intention of the United Nations to liberate the victims of Nazi tyranny and persecution.

II. RESCUE OF ADULTS

The possibilities offered by the available Palestine certificates should be utilized to their fullest extent. Roumanian and Bulgarian efforts to win the favor of the United Nations, Turkey's non-belligerency, the reported withdrawal of the German armies from the Turkish-Bulgarian border, call for the utilization of land routes as lifelines of escape. However, transportation should not be limited to railroads. All available vehicles should be employed.

Steps should also be taken at once to provide sea transportation facilities for escaping refugees by placing suitable boats at the disposal of rescue organizations.

III. THOSE WHO REMAIN IN HUNGARY

As for the Jews who remain in Hungary and who are deprived of their freedom of movement, we urge that the United States and the United Kingdom join in making available to the International Red Cross the necessary means for providing them with food and clothing. In a cable dated August 4, 1944, which has been communicated to us, the International Committee of the Red Cross complains that "for months past" it "has submitted to Allied governments, especially with view to relief measures, concrete proposals which for economic reasons could in part not yet meet with approval." May we recall that on November 26, 1943, Mr. Bre dkinridge Long, Assistant Secretary of State, informed the House Committee of Foreign Affairs that the United States and Great Britain would each contribute four million dollars to finance the rescue program of the International Committee of the Red Cross? We request that this proposal soon be carried into effect.

IV. THOSE DEPORTED FROM HUNGARY

The Jews already deported from Hungary must not be written off. According to the Agence Telegraphique Suisse, of July 13, 1944, the Budapest government has contended that no Jews have been deported from Hungary to Germany and Poland, but that actually Jewish manpower has been placed at the disposal of the Reich in accordance with a recently concluded German-Hungarian agreement. May we urge that the Hungarian government be requested by an official note, presented through the protecting power, to state what action it has taken and intends to take to insure that this Jewish manpower will be entitled to the same care and protection as the Hungarian workers of Christian faith who have been sent to Germany. At the same time, suggestions should be made that in the light of the physical danger of Jews in Germany, Jewish manpower be returned from Germany and be utilized for public work in Hungary proper.

This memorandum is submitted by the American Jewish Conference, in behalf of the national membership affiliates listed below, and by the following non-affiliated organizations:

Dear Rabbi:

You have probably already thought of it, but I should like to suggest a piece of strategy with regard to the Congressional resolutions. The time is growing very short, Congress is talking about recessing in a few days and there may not be a chance to carry through all of the negotiations with the War and State Departments. What would you think of getting in touch with Leo Sack and having him sound out Congressman Sol Bloom as to whether or not he might be willing to take unilateral action with regard to the resolution. Sack might base his discussion with Bloom on the following points:

- 1. It would be a fine thing for him personally to get the resolution through his committee and the House of Representatives before election. It would make him a hero in the eyes of the Jews of America and would make a fine New Year present which he could present to them.
- 2. If the resolution does not go through now quickly, it will be dead as far as this session of Congress is concerned. That will necessitate our introducing the resolution at the next session and this time we will present it in exactly the same language as the democratic platform. This will mean that he will have all that trouble to go through again and he might as well get it over with now.
- 3. Sack might also tell Bloom that we intend to poll all candidates for Congress with regard to their standing on the resolution. If he sees that we are determined to keep the thing alive it might persuade him to take action.

If the resolution is to be acted on at this session, it is my opinion that there should be no tampering with its phraseology. If we start monkeying around, it will open the door to all kinds of amendments and then you can never tell what will come out. At this session of Congress it seems to be much safer to stand on the wording as it is. It seems to me it would be a distinct gain even if we could only get the resolution through the House of Representatives.





Dear Rabbis

In order to take every possible precaution, may I suggest the following procedure.

We ought to contact some of our influential people through the country immediately. We ought to take five or six Republicans and five or six Democrats, preferably from states from which the members of the Foreign Affairs Committee come. We ought to arrange with them to hold themselves in readiness to come to Washington. As soon as we ascertain definitely when Bloom is going to call his meeting of the Foreign Affairs Committee to consider the Resolution, we ought to invite these men to come to Washington two or three days prior to that date and make a final contact with the members of that committee. This may not be in the least necessary but I think it would be a wise precaution.

Dear Judge Fisher:

Following our telephone conversation last night, I am writing on behalf of the Zionist Emergency Council to invoke your good offices in connection with the Aviation Conference taking place in Chicago. I understand that the key official in the British delegation is a Mr. T. E. Gore-Booth. Probably some member of the British delegation is specifically charged with Colonial possessions and Mandated territories.

Our interest is to see that Palestine is included as a stop on one of the main trunk routes that will presumably be determined upon at the conference.

I have asked Mr. Oscar Gass of Robert Nathan's office in Mashington, to prepare some material for you for the purpose of any written memoranda that you may find it necessary to submit, and he will be sending you this direct in the course of the next day or two. The general line of our argument is that Palestine has a larger per capita trade than any neighboring country. It is an area with an increasing population and a rapidly developing industry and agriculture. With the great improvement in world communications it is likely both because of its biblical and historical associations and because of the great interest in developments there of Jews abroad to become an over more important center of the tourist traffic.

I am afraid this is a little sketchy, but I hope it will provide you with something to work with.

I look forward to hearing whether you have been able to make any contact with members of the conference.

Note on Telephone Conversation with Judge Fisher Re International Aviation Conference in Chicago, November 16, 1944.

Judge Fisher telephoned me from Chicago to report on further action with regard to the Aviation Conference. Following his conversation with the Secretary-General of the Conference (Dr. Telsner?), he had sent him a copy of the memorandum on Palestine's needs. He had now had a reply from the Secretary-General in which he excused himself for delaying to answer earlier and stated that the question as to whether any group should be heard had been discussed, but the answer had been in the negative. The Conference was limited to representatives on a national basis.

Judge Fisher then got into touch with Lord Swenton, the head of the British Delegation. Lord Swenton, who was Secretary of State for the Colonies in 1933-34 and accordingly has some knowledge of Palestine, suggested that Judge Fisher send him a note on the subject in writing and that if there was anything that required further discussion, they would take it up again in another meeting. Judge Fisher subsequently sent Lord Swenton a copy of the memorandum.

Judge Fisher also had occasion to meet the Chairman of the Mexican Delegation with whom he discussed our problem. The latter doubted if the subject matter of the memorandum would be treated by the present Conference, which was concerned more with questions of general policy and the kind of organization that is to be set up. It was his view that such questions as routes and stops on the main trunk lines would be taken up by the new organization to be established, rather than by the present Conference.

Thank you for your letter of November 13th, I am glad that you think the article for the <u>New Leader</u> will be all right.





Dear Dr. Hoffman:

During the I.L.O. Convention which met in Philadelphia last May or June, the head of the Australian delegation,, the Honorable P. J. Clarey, President of the Australian Council of Trades Unions, got in touch with me as he wanted to know something about the various trends and tendencies in the Labor Movement in the United States.

We dined together on three different occasions and talked intimately on all sorts of matters. Inasmuch as Mr. Clarey was one of the leading sponsors of the so-called Kimberley Project and addressed one or two important groups in New York on the subject, at the request of Mr. I. N. Steinberg who is the projector of the Freeland League for Jewish settlement in Australia, I naturally subject Mr. Clarey - a truly humane and lovable man - to a catechism. Suffice it to say that on the strength of what Clarey had to say to me - and he was so sanguine about the possibility of the Kimberley Project - I concluded that the whole thing was another one of those Utopian schemes which could not possibly be realized. A mere phantasmagoria, if you please. I did not argue the matter with Clarey but merely asked a number of questions and formulated my opinion on the basis of his replies.

In a recent article Dr. Steinberg stated that among the sponsoms of the Kimberley Project are such British Jews as Sir Robert Waley Cohen, Lt. Colonel Stanley Cohen, the Hon. Mrs. Franklin and others. Long ago I have ceased to attach any importance to big names.

All this is written in view of your article in the Forward of Saturday, November 25th, regarding the Kimberley Project which we now know is not favored by the Australian Government.

Let me say in passing that I read your articles occasionally with great appreciation.

After the opening of Congress next month, legislation will be introduced immediately on the proposed compulsory military training program, and it will be the main subject of domestic discussion through all channels.

In addition to the other valid reasons for such a program, I think we should take into consideration the fact that a well-organized international military force would be the best protection for world Jewry. I do not know of any other way that the United States can contribute its allotment to this international army except through a compulsory military training program.

As you know, the Secretaries of War and the Navy, as well as the President of the United States, have already approved such a program. I think it would be very helpful and desirable for several of our leading Rabbis to take an affirmative stand on this matter, and I am wondering if you would not be good enough to let me have a statement which the Jewish War Veterans could use when appearing before Congress and for its other releases in behalf of the subject.

Emanuel sent me a copy of his December 22nd letter to you.

I am frankly torn between two conflicting emotions. Cn one hand, as a friend, I do not like to see you embark on a campaign which is bound to be so disturbing to your peace of mind and perhaps, aggravating to your health. As it is, I feel sort of responsible for what you have gone through during the past few months, because I urged you last summer to remain instead of going through with your resignation, as you wanted to. On the other hand, as a Zionist, I am terribly disturbed about the progressive corruption of the movement under its present leadership, which is as "rotten" as it can be. It is a movement which has to be purged from top to bottom and quickly, and I know, looking at it realistically, that it can only be done if you take the active leadership.

I am not going to advise you one way or the other, but if you do decide to make a fight of it, you know that I am in it with both feet.

If you decide to go ahead, may I suggest that it is not necessary to go in for any of Emanuel's elaborate and fantastic schemes. I think the direct method is the best one, namely, that of waging a frontal campaign to capture control of the Zionist Organization. The specific plan, however, is for you to decide and to let us know what you want us to do.

My dear Abba:

I am terribly distressed by your resignation from the chairmanship of the Zionist Emergency Committee. A lot of gossip has reached me as to what has gone on "behind the veil". The whole order adds up to me to a somewhat vicious bureaucracy that has grown up in and about the Z.O.A.

For a long time I have felt that there are a number of things that are rotten in that situation. Amongst those I would count also what I suspect is a certain moral and financial irresponsibility, a desire to feather their nests not only by dipping into the Zionist trough, but also playing politics in terms of secular political plums, such as judgeships, etc.

I am wondering whether the time has come for some thorough housecleaning, and I am wondering how that housecleaning may be effected.

Frankly, I feel keenly enough on the subject to resign my membership in Z.O.A. and to urge others to do likewise, to do our Zionist work through some other medium. I have the feeling that the bunch in New York and Washington is essentially a cowardly group, and that an effective demonstration of dissent on the part of many of us might quickly bring them to terms.

At any rate, you have the great satisfaction of knowing that in a very critical hour in our history, you, and you alone, despite the back-biting and sniping of the cheap politicians in the organization, have placed Palestine in the center, not only of Jewish life, but have made the whole country aware of Palestine and of the Jewish claims to and need of Palestine.


My dear Mr. Ginsburg:

Please pardon the delay in answering your kind letter. I have been away from the city a good deal of the time and my correspondence has lagged.



Dear Dr. Silver:

I returned just the other day from a visit to several colleges in Missouri, among them the Negro State University at Jefferson City. There I met a member of the faculty who gave me a glowing report of your address at the dinner meeting in St. Louis, of the American Palestine Committee. He was quite thrilled by the whole experience and felt that your address was the highlight of the evening.

I am deeply distressed by the turn of events in the Zionist Emergency Council. It is very difficult for one at such a distance from the hub of events to gather an accurate picture of the situation. However I want you to know that my impression of the recent conflict is that you are entirely in the right and that you have acted clearly within the limits of propriety as well as your responsibility as co-chairman of the Council and chairman of the executive.

I regret the whole nasty business, particularly the inevitable personal differences that were aired. Frankly, I fail to see how the present course of the Council differs from the actions for which you were rebuked. But then, I suppose politics, even Jewish politics, require a special frame of mind and a distinct set of standards. I hope that in any case you will continue to exercise your influence toward the achievement of our all important goal.

Dr. Abba H. Silver The Temple Cleveland,Ohio. ADDRESS BY HON. NATHANIEL L. GOLDSTEIN ATTORNEY GENERAL OF THE STATE OF NEW YORK, BEFORE THE UNITED PALESTINE APPEAL, ON JANUARY 28th 1945, AT THE BILTMORE HOTEL NEW YORK CITY.

Palestine has ceased to be a Jewish problem. It lives as part of a world problem, for peace is indivisible and can only be preserved on a global plan.

We are in the first truly world war in history. All civilization is in flames. This is the first conflict that concerns the life and the happiness of every being on the face of the earth. Our greatest reward in victory will be to establish patterns of a fruitful, decent and harmonious interchange between all peoples. No generation of men are offered so great an opportunity to think justly and nobly as are those who will frame the peace.

The full implementation, in letter and in spirit, of the Balfour Declaration, of the Mandate, of the Resolution of 1922 of the Congress of these United States, of the Anglo-American Convention of 1925, of the platform pledges of the Democratic and Republican parties, of the President himself, is an act of faith. The reconstitution of Palestine rests upon the conscience of the United Nations - upon the international conscience of America, of England and of Russia.

Palestine is vibrant, potent and exciting. Its 50,000 in 1918 becomes 650,000 in 1945. To its cities have been given new life and new color. The dead soil has been revitalized - out of the dirt, neglect and stagnancy, there

has arisen a new life, molded by the sweat, blood and tears of these pioneers. Experts have increased its fertility machinery has multiplied its productivity. Side by side with its agricultural rebirth, Palestine has progressed industrially and in this great world war has already proven itself as the military arsenal for democracy. The waters of the Jordan have been harnessed and electrified; great chemical plants draw minerals from the Dead Sea - life has been breathed into the dead. The vista is wide open. If humanity is to progress, this rebirth must continue, unabated, with all the support and force of democratic government.

I cannot conceive that those valiant Russians who fought at Stalingrad, who fought for their own liberty, would deny to others the right to live. I cannot conceive that the brave English who bled at Dunkerque, bled for a cause they held so holy, would deny to others the right to live. I cannot conceive that those of our own, Americans, who so gallantly fought at Bastogne, who tonight are dying on all of the battle fronts of the world, to preserve our way of life, would deny to others the right to live.

Yes, they also have a right to live; they, who are wandering over the highways and byways of Europe, who are unwanted, who cannot turn back, but look with pitying eyes toward Palestine. Are they to be denied the right to live?

The answer rests in the conscience of the Great Powers. And in appealing to their conscience we must invoke the moral law - the law that is recognized by all races and religions the world over as the Esparanto of the universe. When Moses brought the Ten Commandments from the Mount, he promulgated a rule of justice that has endured for more than three thousand years. In a later generation, Christ proclaimed that he had come not to destroy but to fulfill that law, and it is still graven on the hearts of His believers. The Mohammedans likewise acknowledge the supremacy of the

moral principles in life.

In the East, the Chinese accept the teachings of Confucius who impressed the standards of morality, indelibly upon the face of Chinese civilization, and even the Buddhists treat their moral code as a sacred part of their way of life. When we ask fidelity and justice to our aspirations for Palestine, we speak in the universal language of all mankind the law of morality. The right to dictate peace must come not from power, but from a desire to make a peace based upon the principles of justice, grounded in the moral law. Power and law that are independent of the immutable principles of morality cannot long endure.

Before all humanity, lies an adventure, a quest to make the whole world safe, now and forever - and in that quest America must take the lead. The America which was founded by those who fled from tyranny and oppression - the America which gave to us the Declaration of Independence, which "hold these truths to be self-evident that all men are created equal, that they are endowed by their Creator, with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness. That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed, . . ."

As Wendell Willkie well said in his conclusion to the "One World" - People are waiting for us to accept the most challenging opportunity of all history - the chance to help create a new society in which men and women the world around can live and grow invigorated by independence and freedom.

On the planning boards and blueprints of the architects who are to draw the peace - there must be the free and democratic Jewish Commonwealth of Palestine. Just as frontiers all over the World will be moved, so must the Great Nations return to its own, those fertile coastlands of the blue Mediterranean, where forty centuries ago, the Jews built a nation dedicated to the worship of God and the practice of His moral laws.

There is room in this great wide world for all. Free people are fighting to safeguard its security and ensure its future peace; they are fighting to give democracy another chance to develop a finer culture. If we fail this time, we may never get another chance. Aviation with its terrifying future possibilities has already destroyed any geographic immunity from attack.

As a result of the radio, the electronic and the other technological miracles, the earth has shrunk. If the democracies refuse to accept the implication of modern invention, if they refuse to fuse its economic life with that of other countries or to assist in far reaching international rehabilitation, then a large segment of the post war world will again fester in strife, ruin and stagnation.

In this pattern of things to come, in which there will be major changes in social and political geography, the masters of the world are being asked to provide free passage to the promised land, to the refugee, to the wayfarer who wants to relive and rebuild.

The framers of the peace must look for their solution in the minds and the hearts of all the free people of the world. Out of their courage, good sense and fundamental decency, the all important answers will be forged. It is there they will find the guiding star; the road to the international conscience; the way to the law of morality.

Dear Emanuel:

This is in reply to your letter of February 15th and also to give you a report of my visit to Detroit. I had conferences with Phil Slomovitz and Leon Kay. The result of these conferences and my size-up of the situation is as follows:

1. As everywhere, mass sentiment is pro-Silver but needs to be crystallized.

(COPY)

- 2. Fram is with us, but is personally too wishy-washy to push the matter. He was out of town but I had talked to him on the telephone the day before. He told me that he would call a meeting of the Executive Board in the near future and invite me to address it. I was not clear as to whether he meant that I was to appear alone or along with a representative of the Administration. I am inclined to think that the latter would be the case because Crohn would probably insist on it and he has Fram somewhat scared.
- 3. Slomovitz wants to push the issue and said that he would put pressure on Fram to have a meeting of the Executive Board and put through some kind of Resolution similar to those which have been passed by other Districts. Failing to get such a meeting he said that he would try to do the same thing through the medium of the Detroit Zionist Council. My impression of Slomovitz from this conversation is that he is heartily with us but I do not think that he occupies a sufficient position of influence in the community to assume any active leadership or to get any tangible results.
- 4. My conference with Leon Kay was on a little more productive and sensible level. It was his opinion that it would not be prudent to have a showdown in the Executive Board of the District at the present time, that it would be much better to get pro-Silver sentiment crystallized, a pro-Silver block organized and then have a showdown. I said that I was inclined to agree with him but that I thought immediate steps should be taken to do this crystallizing. I also told him that we wanted some money out of Detroit. He therefore agreed to have a private meeting in his home some time within the next two or three weeks. To this meeting he would invite those leading Zionists of whom he was confident and such others who he thought might be switched from a neutral to a pro-Silver position. I am to address this group, present our side of the story and our program and at the same time make an appeal for funds with which to carry on our work.

As the result of all this, I feel that the situation in Detroit can be turned in our favor if we follow the proper strategy and take our time. I think it would be very important for you to follow me in Detroit after I have done the preliminary spade work, particularly if there is to be any kind of a controversial public discussion.

Dear Rabbi:

I am enclosing an additional check. Within the next week or so, I am meeting with another small group from whom I expect to get pretty good results. I think we will raise a fair amount of money in Toledo.

When I received the invitation to go to England it immediately occurred to me that something of the strategy was being employed which you suggest in your letter, of dividing our forces at a time in our campaign which is likely to be crucial. That is why I asked you whether you thought I ought to go. Thus far I have been somewhat non-committal about the invitation. Т wrote to Montor that it might be difficult for me to get away for any length of time, no more than six weeks, the early part of the summer. The invitation which I received asked me to arrive in England around the first of June and to remain for ten weeks. Such a protracted visit, I told Montor, was definitely out of the question and that if the people in England felt that it was not worthwhile for me to come over for a shorter time, they better pass me up. So thus far nothing definite has been decided.

I am enclosing herewith copy of a report which I sent to Emanuel Neumann on the visit I made to Detroit last week, which I think you will find of interest.

One nail after another is being driven into the coffin in which the enemies of the Jewish Commonwealth hope to be able to bury it. The latest is the announcement on March 29th of Lord Devonshire, Parliamentary Under-Secretary for Colonial Affairs, that the Colonial Office has rejected a demand of the Jewish Agency immigration certificates in addition to the White Paper quota now exhausted. Lord Devonshire's gratuitously malicious addendum to his statement, that the British government has information to the effect "that a great many Jewish refugees do not want to proceed to Palestine", indicates as brutally clearly as anyone would want that Great Britain has no present intention of changing or even slightly amending the White Paper policy. Except to the wishful thinkers, the statement should not come as a shock. After the amazingly arrogant frankness of the Arab notables last month in Cairo about throwing out of Palestine the Jews who are already there, it could have been anticipated as being just around the corner. As an aside, it might be commented that it should put an end, but probably won "t, to the shallow argument that we ought to soft pedal political demands in favor of immigration demands.

Thus the outlines of the political future of Zionism are being rapidly sketched in, and the picture which is beginning to take shape is darkly foreboding. Churchill, the self-styled "architect of Zionism", has postponed the solution of the Falestine problem to some hypothetical peace table after the war. And, of course, until after American military power, influence and interest in the New East have waned considerably and Arab opposition has had a good chance to organize, orystallize and vocalize. Perhaps there was a little more than Zionist spokesmen were willing to admit to the Churchillian threat that the Moyne murder might make him change his mind about Zionism. Roosevelt learned about the Jewish problem in Falestine from Ibn Saud, but he seemingly taught that gorgeously accoutred worthy little in return. Importuned for a crumb of consolation by Zionist leaders who now find themselves and their policies in the soup, the President naturally reiterated his pre-election promise. After the insensitive ad lib remark in his report to Congress, could he say that he hadn't meant it? But how simple for him to say later -- and this is not suggested cynically - "I tried my best to get it for you, boys, but you know what tough hembres the British are." There is a rumor, probably unfounded, that he has already hinted it.

We are on the eve of the San Francisco Conference. The delegates of the fair weather allies will be there, Iraq, Egypt, Saudi, Arabia, (perhaps even of Syria and Lebanon) jewelled and berobed and turning on the well advertised Oriental charm and suavity for the assemblage. "We are terribly sorry for the poor Jews. But after all, this is a United Nation problem which all of us must share in solving. Falestine is a poor, tiny and overcorowded country which has already admitted more than its share of refugees. Besides, it is an Arab country. Have we not recognized it as such in the Constitution of our new Arab League?" The Zionist representatives will be there too, pounding the lobby floors, knocking on doors and paging diplomats, the ghostly spokesmen of five million Jewish dead. Even this status they will have to share with a variety of delegations ranging from the American Council on Judaism to the Hebrew Committee on National Liberation.

A Zionist surely has the right to ask, where now is Zionist statesmanship and courage? What is being done besides hoping, praying and publishing whistling-inthe dark editorials in The New Palestine. In his farewell statement before leaving Palestine, Dr. Weizmann declared that there were grounds neither for optimism nor for pessimism. That sounded like a fair enough inventory of the situation, but was it? The grounds for pessimism are obvious enough. Where are the grounds for optimism? After a year of aggressive and startingly successful political progress under a courageous and uncompromising leader, the American Zionists -- not the rank and file, but the bureaucrats -- lost their nerve, reversed the policy of attack and purged the leader. Their strategy was to suspend the offensive in sight of the goal, and to leave the rest of the struggle to the President. Why, no one will ever know? They have offered no satisfactory explanation. The first and seemingly

only tangible result has been the tragic and perhaps irrecoverable loss of a Zionist political momentum which had been gaining speed, dynamism - and power. What else has happened during the last four months? Flenty, all setbacks. What have they been doing about it except fetching their little valises back and forth between New York and Washington? There has been no agitation, no organizing of public opinion, no exertion of pressure, no carrying on of the fight. To put it boldly, there has been no leadership. What <u>can</u> they do? They burned their bridges behind them when they adopted or rather reverted to their old policy of 'no pressure' on the Administration. This is not and never has been a policy, but a hiding behind partisan skirts. Being no policy, it has borne no fruits.

We should begin to face some simple but starkly realistic facts which are implicit in the present political situation. The Yeshub is in a dreadfully difficult position. It is literally "on the spot". As of the moment Palestine Jewry can take no overt action. It can only stand fast and hope that the efforts of world Jewry will swing the pendulum in a favorable direction. Russian Jewry may be sympathetic, but it is not likely to put any heat on Marshall Stalin. The English Zionists are too few in number and not in the strongest bargaining position. Dr. Weizmann is doing his best but he desperately needs the weight of mass effort behind him. That puts the issue squarely up to American Zionism, from every point of view the most powerful section of our movement in the world. The job remains what it was a year ago, two years ago and six years ago, in 1939 -- to marshall behind us the solid and unwavering support of the American people and its leaders and spokesmen of both major parties. That support is our best, it may be our only card. The United Nations in general and Great Britain in particular are not likely to cross the United States if it takes a firm stand on this issue, particularly since so much of public opinion and even of official expression of political parties in their countries are favorably disposed to the recognition of a Jewish State. Without that support, or if it is lukewarm, we are in a precarious situation. To get it means working night and day to retrieve the ground lost since December. It means bringing the question back to life on the agenda of public discussion. It means doing even



more intensively and more speedily what was being done last year -- and is not being done now. The San Francisco Conference is being held on our home grounds. That fact alone should be the key to our tactics. The voice of America insistent upon justice for the Jewish people must be made unmistakably clear there.

The present official leadership can neither adopt nor execute such a policy. It has not been accustomed to working that way in the past. It is incapable by the very temperament of the individuals who compose it of working that way. Their commitments will not permit them to reverse themselves in that fashion. We must have a leadership which has no commitments except to our cause. That means the immediate recall of Dr. Silver to political leadership. Besides restoring the energy, skill and undeviating purpose which are characteristic of his work, it will serve at least one immediate and very important psychological purpose. It will put our government on notice that we intend to fight for a favorable decision without pulling any punches or caring where the chips fall; that an unfavorable decision will not make us fold up. It will spur us on to fight more fanatically.

The hour is late. But no Zionist of faith and courage can admit that it is too late. Our enomies may be readying the crypt. But it is our business to deprive them of the pleasure of attending the funeral.
