Dear Rabbi Silver:

As an active Zionist in our area, I have been very much interested in the recent emergency controversy. As a publisher of the only Jewish paper in the Connecticut Valley, I felt that our people should know what is going on. The result of our activity in the Ledger can be found in thelast two or three week's copies of our paper, which have been mailed to you under separate cover. I, of course have been accused of being a Silver follower and I don't deny the accusation because for over a year and a half I have been active in the Emergency Committee and was very influential in getting favorable resolutions passed by veteran's groups throughout Connecticut.

I looked upon you as our political leader and I couldn't understand the steps taken by heads of the Z.O.A. to embarrass you to the extent that you had to resign. I know the temper of the Zionist membership and I know that a majority of them sympathized with the stand you have taken. However, I also know that a long drawn-out fight will eventually hurt the Zionist movement. It's a peculiar thing about our Jews. You don't have to give them many excuses to be refused Zionist membership and it therefore is plain to see that if the controversy between you and the Z.O.A. continues for any length of time, the membership of the Z.O.A. will show a considerable drop and that is something I know you don't want to happen.

I have a feeling that at the next convention of the Z.O.A. there will be a change of administration. The rank and file will remember the injustice done to you and I therefore feel that your fight should be within the movement and not publicized in the press as much as it has been up to date. I'd like to see you visit some of the major districts in the country and speak to the Jewish people directly. It certainly would be easy to pack any auditorium in any community in the country. I think it is your duty to go to the people direct and tell yourstory. I know it will have the desired effect. If you think I am right and would like to speak in Hartford within the next month or two, please write me and I'll arrange for a meeting at the Bushnell Memorial which seats 3300 people. I speak only for myself but I know that there are plenty of others that feel as I do. If you feel that there is anything that I can do to help you in our area, please do not hesitate to call on me.

Dear Dr. Silver:

Many thanks for your very kind note of July 6th, anent my column on Stettinius and his offer of Libya. You are perfectly right about the marrowless bones that are being thrown to us and which are being picked up and widely advertised as the veritable gifts from God by people who should know better. I share with you the fear that as Election Day approaches we may have more of that bone throwing and public jubilation over it. What is to be done? -- that is the great question. There are so many things to consider.

I had lunch the other day with Attorney General Goldstein who told me a great many things he did in connection with the Palestine resolution in the Republican platform. He seems a nice chap and could and should be used for our national purpose, as indeed everybody and everything in public life should be used with the sole idea of victory for our cause in mind. He had a number of suggestions to make, but I referred him to you. Plainly, I told him that I would play along only under your leadership. I understand he will try to approach you personally after the 19th.

I intend to continue along the line of the Stettinius column, that is showing up worthless promises for what they are. I am watching the situation and you can rest assured that I shall not miss an opportunity when it arises. I wonder, in this connection, whether I could print your letter of July 6th. Occasionally, I print letters I receive from important people who comment on my column, just to show who sides with me. May I assume, if I don't hear from you to the contrary, that you have no objection to my printing your letter?

I am returning herewith another letter of yours, addressed to Mrs. Schanfarber, which, by mistake of course, was sent to me. To be sure, this error in putting the wrong letter in the wrong envelope has not led to any scandal, personal or communal, in this particular case, but I can imagine other cases in which it might. So your secretary had better be careful.

I am disturbed over the releases issued by the American Zionist Emergency Council, published in the Jewish press, that "Louisiana is the 19th State to urge unrestricted Jewish immigration into Palestine" and "joins in demand for Jewish Commonwealth." I believe that these headlines do not express the real contents of the Louisiana resolution. I have read the release, and nowhere do I find that the State joins the demand for the Jewish Commonwealth.

Manifestly, it is our duty to tell the American people that we are interested in the development of Palestine as a self-governing Jewish Commonwealth. I regard it as most dangerous for our political interest at this time to ask for a Palestine self-governing commonwealth that does not mention the word "Jewish." Even if we do overcome the danger of realizing the third paragraph of the 1939 White Paper, concerning self-government in Palestine, this formulation of developing Palestine as a self-governing commonwealth may be considered to mean a bi-national state or an easy step to partition. Such State Legislature resolutions are not only useless, but very dangerous for our fight for a Jewish Commonwealth. It is not a useful instrument to us when the majority of the State resolutions are not in favor of a Jewish Commonwealth. I am sure you will agree with me that it is better not to have them at all.

The Louisiana resolution came after a similarly worded Palestine resolution was accepted by the recent Republican Convention. The Zionist Emergency Council has not yet indicated this "mistake" or "inaccuracy" to the Republican Party or to Mr. Dewey, and if so, what his answer was. If they have not done so, I would suggest that this be done before the Democratic Convention. I reiterate that this kind of resolution for unrestricted Jewish immigration into Palestine, while favorable from the point of view of Jewish immigration, nevertheless would have the effect of obstructing our attempts for an immediate Jewish Commonwealth.

The last dispatch from Palestine, concerning MacMichael's retirement from his duties as High Commissioner, compels me to repeat and strengthen my request and suggestions made at the last meeting of the Emergency Council, Dr. Stephen S. Wise and Rabbi Abba Hillel Silver - 2 - July 12, 1944.

that the Council's Co-Chairmen proceed to London immediately. It is now clearer than before that the two most significant problems which will be decided in London within the next two weeks will be

1. the problem of partition

2. the immediate administration of Palestine.

Even if President Weizmann and the Zionist Executive have not yet invited the Zionist Emergency Council to participate in the clarification of the situation, I am sure that the change of the High Commissioner is of such importance that the presence of the co-chairmen of the American Zionist Emergency Council at the present time, is absolutely necessary.

I trust that you will regard these two problems as very urgent and that you will bring them to the attention of the Zionist Emergency Office.

My dear Friend:

Thank you for your kind letter of July 13 with reference to the press release of the American Zionist Emergency Council on the action of the State of Louisiana. I, too, regret that the release stated that the State of Louisiana "joins in demand for Jewish Commonwealth." The resolution of the Louisiana State Legislature contains no such phrase. I am calling this to the attention of our Press department with the admonition not to engage in such generous commentaries or wishful thinking in the future.

It is, of course, highly desirable that all the resolutions which are adopted by non-Jewish bodies -- ministerial associations, state legislatures, municipal councils, etc. should contain the phrase "Jewish Commonwealth" but I am not prepared to say that it is not a useful instrument for us to have resolutions passed which while not mentioning the term "Jewish Commonwealth" nevertheless by calling for unrestricted Jewish immigration and land purchase and the fulfillment in letter and spirit of the Balfour Declaration and the Mandate, help materially in building up a proper "Stimmung" for our propaganda in behalf of the Jewish Commonwealth in the United States. I am not at all prepared to agree with you - if that is your thought -that it were better not to have had at all a resolution such as was included in the Republican Party Platform, which is as warm and whole-hearted a Zionist resolution as was ever passed by a major political body representing some twenty-five millions of our citizens. I am only hoping that the Democratic Party will include a plank at least as good as the Republican plank.

As far as the retirement of MacMichael is concerned, and the need of our going to London, this matter will be fully discussed at the forthcoming meeting of the Council next Monday.

Dear Dr. Silver:

I have your letter of August 14th, expressing your appreciation of my acceptance of the Chairmanship of the Pennsylvania Chapter of the American Palestine Committee.

No person in the United States has been more shocked by the crimes committed by Hitler and the Nazis against the Jews, Poles, Greeks and Czech-Slovaks and other peoples made subject to his wicked will than I have been. Long before this World War began I advocated both in my writings and in my public addresses both the preparedness and the will on the part of the United States to stay Hitler's hand. The enclosures show how I reit about the world situation in 1939 and 1940. I made similar statements even before 1939. Please return these enclosures to me promptly.

As a young man I read of the barbarities of Genghis Khan and Tamerlane, but I never believed that in the Twentieth Century which we expected to be one of great enlightenment and humanitarianism that atrocities of these medieval conquerors would be equalled or surpassed by the rules of Germany and by the German people who give such scoundrels their support. I have never been given to vindictiveness, but I hope that when this war is over at least 100,000 of the Nazis, including particularly Hitler, Himmler and the Gestapo will be hanged. Such punishment will be totally inadequate for the crimes they have committed, but it is about the best we can do within the limits of civilized usages. Of course, this punishment will not bring back to life the millions of men, women and children who have been murdered by this madman Hitler and those who help him formulate and carry out his sadistic plans. The establishment of a Jewish National Home in Palestine has brought and will bring some relief to tens of thousands of Jews who have been driven from their homelands. I will count myself fortunate if I will be able to contribute in any way to the relief of the brutally persecuted European Jews.

I have pleasant recollections of hearing you speak in Scranton several years ago.

I am compelled to draw your attention to a very painful and disgusting matter. Some leaders of Jewish (mainly Zionist) organizations have descended, in their hatred of our ideologies and activities, to the depth of trying to influence governmental officials in this country to take steps of persecution against us, and especially against our chairman, Mr. Peter H. Bergson. The repercussions of this disgraceful act on the part of Zionist bureaucrats are being felt in every endeavor we make on behalf of our martyred people.

I am not talking about the general shameless acts of sabotage in a quasi-ideological or political or tactical field; as, for instance, the endeavors by Rabbi Wise and his associates to kill the rescue resolution in Congress, or his communications to such high-standing officials in the Government as the Honorable Harold L. Ickes, asking them to withdraw their support of the cause of Jewish rescue and casting doubt on our personal honesty and management of finances.

Of these obnoxious acts of Rabbi Wise and other Zionists we have ample proof. (Mr. Bergson has called Rabbi Wise before the Rabbinical Tribunal of the Union of Orthodox Rabbis to answer these charges but, in spite of having been summoned twice Rabbi Wise failed to appear.)

However, I am not referring to this kind of sabetage but to the more direct and nastier kind which constituted one of the most simister pheonomenon in Jewish dispersion - the acts of personal, hidden "mesirah" against individuals. For such steps of "mesirah" there is never complete evidence to substantiate. Their very character consists in being secret, back door and oral. But I am ready to swear, under any oath, that this "mesirah" campaign is a permanent and integral part of Zionist activities in this country.

In order to illustrate my statement, pregnant with such weird implications, it is enough to inform you that against Mr. Bergson all kinds of administrative steps have been taken, such as an effort to deport him from this country. And it is only due to our very influential connections and the sense of justice of the governmental department which dealthwith the case that the deportation orders were withdrawn. (Several accounts of the deportation proceedings appeared in the Metropolitan press as well as in the Washington papers, and upon request we shall be glad to send you elippings. Although the proceedings of deportation against Mr. Bergson were on the basis that he is a foreigner with no status of permanent residence in the United States, the Selective Service is unprecedentedly sealous to indust him on the basis that he is not a foreigner visiting this country on a mission for a foreign people, but is a permanent resident and, to boot, in spite of the fact that he is thirty-four years old (you certainly know that practically no men over twenty-eight have been industed for the past six months) and that he is suffering from ulcers, a fact to which five of the most prominent specialist physicians in this field have officially testified.

All this ugly work is being done by Godless Zionist Rabbis and bureaucrats with the hope that if Bergson is eliminated, the whole campaign of rescue of the remnants of our people and the restoration of the Hebrew Nation to dignity and political status will reach a dead end and subside.

I am writing to you about this situation not only to tell you that the Zionists will achieve none of these intentions; that though Mr. Bergson is the leading and protal figure of our activities, his temporary elimination from our ranks will not stop our fight but will add to it impetus and enthusiasm if indeed more impetus and enthusiasm can be added.

We are accustomed to having key men of our movement pulled out by force from our ranks. In all the lands of Europe where we have struggled, as well as in Palestine, it was never the cause for failings or even weakening. But I am writing you all this in order to draw your attention to a shameful and dangerous matter of partisan conflict which was practiced by Zionist bureaucrats over there and was not one of the lemst of the causes which brought about the disaster which has befallen our people. We had hoped that in this country this tradition of "mesirah" was done with.

Since it has been inaugurated also in this country, the detrimental effects upon the general endeavor of every organisation, group and trend on behalf of our people will be so great that one cannot foresee the inner decay and outer demoralisation. One knows where such obnoxious activities begin but one can never tell where they will end and who they will affect. It is enough to tell you that already the daily parading before government officials of Jewish "mosrim" is the most pathetic sight, which irritates to the utmost even the best friends the Jews have in government circles.

Before these activities on behalf of the Zionist demagogues began, there was definitely a greater respect for everyone who was a representative of a certain point of view and activities on behalf of the Jews. There was, if not an official diplomatic status, at least a certain practical respect for such individuals and groups dealing with Jewish interests.

I am telling you that because of Zionist activities this attitude has deteriorated, and I want to stress most emphatically that I cast no doubt upon the honesty and integrity of any governmental agency or upon the Selective Service, for I am sure that were any one of us in their place and all sorts of Jewish leaders were to come to us, steadily and persistently, to draw attention to the fact that a certain man was dangerous, dishonest, anti-American, Anti-United Nations, we would probably take their word for it. If we still have great friends in the American Government, both in the Executive and Legislative branches, it is because of the high degree of integrity, ability, understanding and statesmanship of these officials.

In concluding, I should like to remind you that for the four years we have been active in this country, never once have we succumbed to the temptation to resort to polemics and never in all our propaganda, publicity and educational campaigns have we taken the opportunity to answer with one word any of these attacks. This fact, however, should not be understood as an indication that we never will take up the challenge. I beg to assure you that if nothing is undertaken by influential men like yourself to prevent the continuance, at this late hour, of this obnomious Zionist trend of activities and an end is not put to this "Chilul Hashem", we will have no choice but to expose to the public at large the whole character of the reactionary, ruthless and disgraceful machinery of Zionist burequerats.

Being informed of this situation, you will know where and with whom the responsibility lies. I leave the rest to your own imagination and appreisel.

My desire is to, in anyway I possibly can, help the unfortunate people of conquered Europe who are being subjected to the most vicious persecution in the history of mankind. This particularly applies to people of Jewish blood in their unfortunate and heartrending plight. I thoroughly agree with you and Dr. Wise in the paramount importance of the establishment of a free and democratic community in Palestine. However, if I can help along any other lines of even a lesser nature that will aid these persecuted persons I am only too glad to do so.

My first interest is the Resolution placing Congress on record as favoring the immediate establishment of the free and democratic community of Palestine; my second interest is to try to get the persecuted Jews of Hungary and Rumania and any place else to a haven of safety; my third interest is a Resolution which you referred to in your letter and which you and Dr. Wise feel is not desirable, or any other Resolution that will help these human beings.

I have repeatedly stated, and I stand on this ground, that the plight of these people, particularly the Jews of Europe is a challenge to decent mankind.

My dear Mr. Morgenthau:

Following up our conversation of yesterday, I am enclosing herewith a clipping from The Cleveland Press which appeared ten days ago. This correctly represents my position. Everything else that you have heard is mischievous gossip. I was surprised when you told me how widespread was the impression in Administration circles that I was actively campaigning for Governor Dewey and against the President. Some enemy of mine must have been deliberately spreading this falsehood in order to make my work more difficult.

I came to you because of my high admiration for you and because I regard you, as I have so frequently stated in public, as the finest Jew in Washington. I wanted you to know the facts, and perhaps through you, help to correct the false impression which has been spread.

My position in this campaign is a very simple one, and I have stated it publicly time and again, as recently as last week at the convention of the Zionist Organization of America in Atlantic City. As Executive Chairman of the American Zionist Emergency Council, I cannot publicly take sides in a political campaign without endangering the position of neutrality which our Movement must maintain with reference to the American political scene. Our cause has powerful friends in both political parties. We have succeeded in getting a friendly hearing from both parties because of the absolute non-partisan character of our Movement. I have publicly praised the support which both parties gave our congressional resolutions. I hailed both parties for the planks which they introduced in their platforms. I praised Governor Dewey for the statement which he issued on the Jewish Commonwealth, and I released to the press a most warm message of thanks which I telegraphed to the President on the occasion of his historic pronouncement on October 15th. I obtained the statement of Governor Dewey on October 12th. Dr. Wise and I wrote to the President on September 26th asking for an interview. Th interview was granted on October 11th, and to Dr. Wise alone a blunder or worse, I believe, on the part of someone.

I have been scrupulously impartial. I have not in any way identified myself with the campaign activities of the Republican Party. The leaders of the Republican Party understand my position fully, and I am wondering why the leaders of the Democratic Party fail to understand it. The American Zionist Emergency Council fully approves of this non-partisan line which I have pursued right through the year, ever since I took over the chairmanship, and is severely critical of the action of Zionist Leaders who seek to give the impression that the Zionist Movement is somehow identified with one political party in the United States or another.

You and I may differ as to whether such an attitude of neutrality on the part of a movement which embraces both Republicans and Democrats is justified in the present political campaign, but surely you will agree with me th t if one feels morally obligated to take a position of neutrality, his action should not be misinterpreted as being violently partisan. Four years ago, when I was not the responsible head of the political activities of the Zionist Movement, of America, I felt free to endorse the candidacy of Mr. Willkie, just as eight years ago, and again twelve years ago I endorsed and advocated the election and re-election of President Roosevelt. Tod y I feel under the moral restraint not to exploit the responsible position which I occupy to take sides publicly in an election campaign. Perhaps after the strain and tension of these election days are over the soundness and wisdom of this position will be vindicated.

In any case, please be assured of my highest esteem for you, and when you have an opportunity, tell those people who bring you the choice morsels of gossip such as "Dr. Silver wants to be the leader of the Republican Jews of America" that they are talking "shtuss" and arrant nonsense.

MEMORARDUM.

The Jewish Deportees in Mauritius.

A. Background.

1 . . . 4

In November, 1940, several groups of Jewish refugees fleeing in desperation from Hitler Europe, arrived after a harrowing journey through the Mediterranean in Haifa harbor. The Falestine Government announced that it would deport all these refugees forthwith to the island of Mauritius -- a small tropical island in the Indian Ocean, off the east coast of Madagascar. Many of these refugees had already been transferred to the <u>S.S. Patria</u> for deportation when an explosion occurred on board the ship, which sank in Haifa harbor. 257 of the refugees were drowned. Nearly 1,600 others who had not been transferred to the <u>Patria</u> were landed in Falestine and placed in a detention camp near Haifa.

Despite the <u>Patria</u> disaster, the Administration persisted in its determination to deport these Jews whose crime had been to seek safety from persecution and death by entering the Jewish National Home. Early in December the detention camp was surrounded by the police and amid scenes of brutal violence the refugees were carried, beaten and driven into large army lorries, placed on board ship and deported to Mauritius. There they arrived on Christmas Bay, 1940. There they have remained ever since.

B. On the Island.

In Mauritius the men were placed in an old stone prison, the cells of which became their home. The women were separated from the men and huts or barracks of corrugated iron were built to receive them. As soon as they arrived an epidemic of typhus broke out and raged for two months. No sooner was this epidemic checked than malaria began to take a heavy toll. The island is infected with other tropical diseases. The climate, particularly in the lowlands where the camp is located, is extremely hot and moist. There is a great scarcity of fresh foods, in particular of fresh vegetables. Avitaminosis and gastro-intestinal diseases are general. Four years of enforced idleness in these conditions has tended to break the spirit and ruin the health of large numbers of the internees. The local administration has sought in some measure to relieve their plight, but the circumstances are such that they have been able to do little. The people are literally rotting away. The population of the camp totalled originally 1,579, comprising 640 Austrians, 294 Czechs, 172 Poles, 151 Danzigers, 84 Germans, and the rest Stateless. Of these by June, 1944, 93 had died.

All efforts to obtain the release of the refugees, many of whom have relatives in Palestine, the United States and elsewhere, have failed. An exception is that of some 90 Czechs and Poles who were allowed to volunteer for the Allied armies. Representations have been made at different times to the British authorities in London, Palestine and Washington and also th the State Department, with a view to revising what is in fact a brutal sentence imposed on innocent people. guilty of nothing save the attempt to avoid death and torture by joining their own people in the home internationally guaranteed them. The time for their release and restoration to a normal existence is long overdue.





FOR IMMEDIATE RELEASE December 15, 1944.

The responsibility for the shelving of the Palestine resolution by the Senate Foreign Relations Committee must be laid not only to the opposition of the State Department, but also to the ineffective and vacillating manner in which the Zionist Organization in this country has conducted the action on its behalf.

While Dr. Silver made a valiant effort to secure the passage of that resolution, strong elements in the Zionist leadership opposed and sabotaged the move from the very beginning, and others served as messengers of the State Department and the President to Zionist circles rather than as emissaries of the Zionist movement to the State Department and the President.

We charge that this lack of determination and indecision, as well as the contradictory and confusing attitudes expressed by the various Zionist representatives, led to the defeat of the resolution in the Senate Committee when it was of the essence that this body adopt a strong and determined stand against the pressure of the State Department.

In an endeavor to create a semblance of Jewish unity and in the hope that the Zionists would this time overcome their political inertia and defeatism, we have given our moral support to their undertakings on behalf of the resolution and refrained from any interference. Our good intentions, however, were misdirected. Divided as they are between the Weizmann adherents of a do-nothing policy and the supporters of Dr. Silver, the Zionists do not possess the basic prerequisites for successful political action.

Realizing that the political campaign for Zionism in this country must be strengthened and intensified, we declare that the New Zionist Organization will embark upon a campaign stronger than ever before to move the American people and government to take active measures on behalf of a Jewish Palestine.





Enclosed herewith you will find our booklet containing the political statements made by Senator Owen Brewster, Senator Edwin C. Johnson. William B. Ziff, Louis Bromfield, Congressman Emanuel Celler, and Colonel John Henry Patterson at the thirtieth anniversary dinner of the creation of the Jewish Legions sponsored by our organization.

Those who were present at this Dinner will remember the applause of the guests when the Toastmaster announced that these speeches would be published. And, indeed, the enclosed booklet becomes a very important political document which, we are certain, will contribute greatly to the clarification of the Zionist and Palestine situation and to the furtherance of the cause for which we fight.

This Dinner marked the beginning of a bold and concerted political campaign which our organization undertook in connection with the San Francisco conference. It was accompanied by special radio broadcasts over stations WMCA, WINS and WHN. It was followed by full page political advertisements in the New York Post of April 10th and the Washington Post of May 9th.

To bolster our position in connection with the Peace Conferences, of which San Francisco is only the first, we submitted a Declaration on Jewish aims and demands to thousands of leading Americans for their endorsement and support. Many Senators, Congressmen and other distinguished public figures have already signed this Declaration which will scon be made public.

As for the San Francisco Conference, a strong delegation of the New Zionist Organization, officially recognized and assured cooperation by the State Department, left a few days ago for San Francisco. The dangerous campaign and maneuvers by Arab representatives and the inneffective counter action by various Jewish organizations have made our presence there imperative. The head of our delegation is Professor A. S. Yahuda, an internationally acknowledged authority on Arab problems and a forceful advocate of our cause. We have cabled the heads of all Governments to support our position and some have already in-

Dear friends,

We want to give you an account of the recent developments in our Camp:

In March and April various questions were raised in the British House of Commons, regarding the refugees in Mauritius, and the replies were evasive or very unpromising as to our future. From these answers was to be seen that the responsible quarters do not consider at all our transfer or release, holding our actual position for satisfactory and good.

Great despair and resentment arose in the Camp and it was clear that the statements of the central authorities had been based upon the official reports of the local authorities here, which, as we knew ourselves from firsthand experience, pictures the material and general situation of the camp in very rosy colours.

The first and spontaneous reaction of the Camp was that the hitherto existing "Advisory Committee" resigned as a sign of protest. Thus ended the so-called "co-operation" which had consisted in the existence of representative of the camp, entitled to give advice. This advice, however, could be taken, but needed not to be taken and the whole system was calculated to araise the impression of autonomy outside and very often also to put the blame upon for camp-use. The advisors, however, could neither make decisions nor have a real influence upon the decisions of the authorities. This system could neither prevent the humiliating restrictions of August last, nor achieve even merely administrative improvements like better food, repair of leaking roofs etc. It must be admitted, of course, that some of the advisors tried their best and achieved even minor results, but on the whole, this system was thoroughly discredited.

Now the Camp elected a new "Executive Committee" the task of which is to work for our freedom and release, without prejudice to the activities of the Zionist Association, of course. This new Committee was not elected for administrative tasks like the former "Advisory Committee" but only for the fight for our freedom which is to be undertaken by purely legal means. The authorities tried to undermine and to weaken the position of this Committee, which however perhaps for this reason grew stronger and stronger in the Camp.

On the other hand, the Colonial Secretary and the Commandant kept negotiating with them, trying also to harness them for purely administrative matters, contrary to their mandate. The Camp requested on May 14th the Government of Mauritius through this Executive Committee that they might make representations with the British Government for our being transferred from Mauritius, because our state of health is dangerous and the coming fifth summer in the tropics justifies the greatest apprehensions. If this request be granted and these interventions be made, the Camp would be again prepared for a co-operation in all mdministrative matters, provided, of course, that such a co-operation is a true co-operation, granting us also some rights beside the responsibility. A detailed memorandum was also drawn up containing various legal points and a list of our grievances. Meanwhile high officials of the Colony could get convinced from personal visits in the Camp how despaired and critical the mood of the camp was, how unbearable our situation after 42 months of imprisonment.

On June 5th, the answer of the Governor of Mauritius was communicated to the Camp: It was bluntly and flatly refusing. It did not deal with any point of our memorandum, it did not concede the intervention with the British Government, and moreover, it refused to deal with the Committee, with whom the authorities had dealt for $2\frac{1}{2}$ months because it has not been "legally constituted. The reaction of the Camp was a

24 hours hunger strike and work-stop as protest against this unyielding and callous attitude.

It is difficult to foresee the further developments. The authorities persist in their absolutely negative attitude to any constitutional efforts for our release, their sole answer being that we have to "co-operate" with the authorities according to the well known pattern - and then we would get "further amenities". The Camp of course, cannot but insist upon the demand that, in view of the alarming situation the Government here ought not to hinder to assist our efforts for freedom.

At present is a complete deadlock, caused by the uncompromising attitude of the authorities. In the camp, an atmosphere of despair prevails and owing from this tension and the unbearable imprisonment, we are all suffering more or less from a veritable prison-psychosis.
