My dear Mr. Manson: Please get copies of the statement which the Emergency Council is to issue on the League for Free Palestine ready, with a covering note. This statement is to be sent to all the Yiddish and Anglo-Jewish Papers, to the presidents of all the Zionist districts and to the chairmen of all the Community Contact groups, to the Congressmen and Senators. A full statement should appear in all Zionist publications. The Hadassah, Mizrachi and Poale Zion should be asked to circularize that statement in a way that is most effective to them among their constituencies. It should also, of course, be released to the English press. Please have all things ready by next Monday or Tuesday. I will give you the signal for the release. My dear Mr. Manson: Mr. Mereminski wrote me calling attention to our release on the resolution adopted by the Louisiana State Legislature in which it is stated "that Louisiana joins in demand for Jewish Commonwealth." There is of course no such statement in the Louisiana Resolution and we ought to be careful in putting our own interpretation upon an official document. If the Louisiana Legislature wanted to say "Jewish Commonwealth" in its resolution, it certainly could have done so. It did not, and we ought not give to the public the impression that it did. Dear Dr. Silver:

Due to the illness of Mr. Isreeli, I have been handling publicity in the Yiddish press during the past few days.

Zivion's remarks in the Jewish Daily Forward were quite shocking, especially since the alleged Alfange statement that he had never authorized us to announce his resignation had been repudiated by Alfange. This information was contained in a dispatch in the Jewish Day, (which was the only Yiddish paper to carry as a news item the Bergson boys' release containing the phoney Alfange statement).

When Mr. Weinberg was confronted with the real facts and informed by the Independent Jewish Press Service that the dispatch carried by The Day was libelous, he hastened to correct matters by printing on the following day another story reporting that Dean Alfange had authorized the American Zionist Emergency Council and the Independent Jewish Press Service to announce his resignation and that his statement, as reported in our release, was absolutely accurate.

As soon as I read the Zivion item, I 'phoned Mr. Rogoff at the Jewish Daily Forward and expressed our extreme displeasure over Zivion's highly inaccurate and damaging piece. Mr. Rogoff was most apologetic and suggested that perhaps Zivion was unaware of the last dispatch in The Day which set matters right. I replied that it was Zivion's business as a journalist to check his facts before writing an article, and that we would regard such an excuse as very lame indeed. Mr. Rogoff then said that The Forward will be glad to print any statement on our part which would correct the impression created by Zivion.

I have telephoned to Mr. Isreeli and have asked him to prepare such an answer. I assume that it will be carried within the next few days. In addition, I have urged Mr. Teller of the Independent Jewish Press Service to protest in the strongest terms against the manner in which the Independent Jewish Press Service was treated in Zivion's article. Mr. Teller has written to The Forward and feels that the paper will publish the true facts.

Hoping that this and other matters having to do with obstructionism in our midst will be straightened out. I am

PROJECTED RADIO SERIES Today, I 'phoned Mr. Charles Higgins, sales executive at the Mutual Broadcasting System, to receive final word on the status of our projected radio series. Mr. Higgins informed me that the executive board of Mutual had arrived at a unanimous decision, to the effect that it would be "unwise to accept a program of this nature." Mr. Higgins told me once again that a program which would avoid the "controversial" features of the Palestine question probably would be passed, but that a program such as the one we had outlined, dealing quite openly with the obstacles to the fulfillment of the Jewish Fational Home pledge, is not acceptable. Mr. Higgins emphasized that the executive board of the Mutual Broadcasting System is anxious to be of service to us in other ways.
He said that Mutual probably could give us time for a "one shot" broadcast with important stars, which would conform to current radio policies. HPM: HP

My dear Mr. Manson: I am returning herewith the draft of the release which you kindly showed me. It is very good. I have added a few corrections. I would suggest that the statements of senators and congressmen be put at the end of the release and that the description of the book should be given completely before you begin quoting. I don't think you ought to give the complete list of members of Congress who contributed to the volume. It is too long and will not be printed in newspapers or weeklies. You might add, in place, the names of the twenty State Legislatures who passed the resolutions. It will not be possible for me to have a newspaper conference in Washington. As you know, we are to have a meeting of the Executive Committee on Thursday, October 12, in place of Monday, which is a holiday. I would therefore suggest that the press conference, for the general press, be held in the morning, and the one for the Yiddish and Jewish press be held at dinner that same day. You might wish to talk over this release for a final touch-up with Mr. Shapiro and Emanuel Neumann. with all good wishes, I remain Very cordially yours. AHS: BK Enc. P.S. Dear Dr. Silver:

I have received a letter from Mr. Barbarash, ZOA Publicity Director, in which he requests an advance outline or text of the address you will deliver at the forthcoming ZOA Convention. Mr. Barbarash would like to receive this material by October 11th, so that it may be incorporated in the advance publicity sent out by his office.

The material you requested on the work of the individual departments of the Emergency Council has been assembled. I am now boiling it down so that this section of your address will not take up too much time. In my opinion, this information need not be included in any advance outline you may prepare for Mr. Barbarash's handout.

It would seem that our chances of having answers to the anti-Jewish Brigade piece which appeared in the "Topics of the Times" column printed in the New York Times are very slim. A good letter sent to the Times by Elias Ginsburg, head of the Legionnaires, was returned with the comment that the Times is unable to "make use of it."

I have sent copies of Mr. Ginsburg's letter and the Times' reply to the newspaper PM, which makes a practice of playing up items which other papers refuse to print, and believe that we have an even chance of debunking the Times column in this manner.

I have your memorandum of November 2nd conveying the observations of Attorney General Goldstein. You do not specify who it was at the Carnegie Hall meeting that made remarks to which exception can be taken, but you do say something about Zionist leaders speaking as heads of Zionist organizations.

I am sure Dr. Wise will be able to speak for himself.

I do not recall having made any remarks to which exception can be taken. Indeed, I have looked through the manuscript from which I read. (You will recall that I delivered my address from the manuscript and I did so quite deliberately in order to avoid the very thing which now is being raised as an issue). I do not find anything in my manuscript which might be construed as an effort to use the Zionist organization "as a political endorsement of the Democratic Party". On the contrary, I do find favorable references to the Republican platform and to the Republican dandidate.

Will you please convey this memorandum to Attorney General Goldstein.

Wash. Evening Sta Moyne Death Inquiry May Show Disturbing **Palestine Situation** By PERTINAX. American Newspaper The searching inquiry ordered by the British government into the "origin and associations" of Lord Moyne's assassins will throw muchneeded light on the disturbing state of affairs which, for many months, has obtained in Palestine. The best-informed authorities are as one in seeing Irgun Zvai Leumi (the National Army of the S People) at the center of the pic- i ture. Within the framework of Irgun Zvai Leumi gather all the militant elements in the Jewish settlements of Palestine—no fewer than 50,000 men and women of some 500,000. At the outset, the "National Army of the people" which, by resorting to violent deeds, tries to overcome British governmental opposition to the fulfillment of the Zionist program, stopped short of actual murder. Destruction of buildings, kidnapings and other vicious acts were fairly common practice, but killing t not included in its means of action. Stern Overstepped Line. However, a group led by Abraham Stern, an immigrant from Poland, overstepped the line that had been deliberately drawn by the older leaders, and now there is little to choose between the doings of the Sternists and of the others. 1939, provision was made for an additional influx of 75,000 immigrants. By now, that quota has nearly been exhausted-the slender balance left is 14,000. Clearly, the Jewish problem outstrips what the British government can achieve on its sole responsibility.

It is worth noticing that the Russian government is decidedly critical of the Zionist policy: Affiliation to Zionism is not tolerated in Soviet territory. The government of Moscow is now fully represented in the Middle East. Lately, Russian minis-Middle East. Lately, Russian minis-ters were appointed to Bagdad, Beirut and Damar, and a Russian consul general has taken up quarters in Jerusalem.

January 29, 1945 Mr. Harold P. Manson 5 Prospect Place New York, N.Y. My dear Harold: I am returning herewith the material which you sent me. I am also sending along another Yiddish article written by Spizman with two paragraphs marked off for inclusion; also an item from the Detroit News. I am also including the resolution which was adopted by the Hartford Zionist Region. I would suggest that you do include the quotation from the article in the Brooklyn Jewish Center Review by Gribetz. In your foreword, you might state, among other things, that what are included in the booklet, are extracts. I note that you did not sent along the resolutions adopted by the Pittsburgh, Baltimore, Brownsville, etc. Zionist Districts. If you do not have them, please obtain them immediately. I think that it would be well, if in connection with each resolution, you would indicate the number of registered Zionists in each district. Brooklyn, for example, has ten thousand members. The ZOA membership report, presented at the Atlantic City Convention, which is easily obtainable, gives, I believe, the membership of each district. I am also sending along the resolution which was adopted by The Cleveland Zionist Society. I have not been able to locate the resolution from Maine. My impression is that there was such a resolution. You might contact Israel Bernstein or someone else in Portland Maine. Someone has told me there was a meeting of Jewish editors in Chicago about two or three weeks ago, and that they passed a resolution asking for my return to leadership. As far as the format is concerned, I would suggest that we use the same size and type that we used for my report, "A Year's Advance." I'd like a neat and impressive job. Dear Dr. Silver:

Following is a report on my activities with the press in connection with the Testimonial Dinner:

Two preliminary announcements have already been carried by the Yiddish and Anglo-Jewish press. Another release, highlighting the complete list of honorary sponsors, goes out tomorrow to all papers, including the general press.

Material for feature stories and editorials has been sent to all the Anglo-Jewish wire services, and I have been assured by both Mr. Teller (I.J.P.S) and Mr. Ziprin (Seven Arts Features) that their next bulletins will carry editorials incorporating the information supplied by me. These editorials, which will be sent to a major protion of the Anglo-Jewish press, will deal not only with your Zionist activity, but with your various activities as a champion of labor and social progress as well.

A translation of the material in the above will be sent to the Yiddish press tomorrow. In addition, I am urging our friends on the Yiddish newspapers to write special articles during the coming week.

I have spoken to friends on P M about a "Hats Off" column devoted to you and believe that, barring unforeseen developments, such a column, together with your picture will appear early next week.

There will be an exceptionally large press representation at the Dinner and we have reason to hope that the occasion will attract widespread and favorable attention in the general press, as well as in the Yiddish newspapers. Of Course, the real groundwork must be laid within the next few days.

I received a copy of Milton Steinberg's sermon from Emanuel Neumann. Unfortunately, however, we have not been able to put it in the works. Our small and considerably overworked office staff has been working feverishly on matters connected with the dinner. The pamphlet will be sent to the printer tomorrow, and a copy of the typewritten draft will go forward to you then.

March 15, 1945 Dr. Abba Hillel Silver Page #2 Marvin Lowenthal's superb article was sent to the Independent Jewish Press Service today. Teller has promised to play it up nicely, and simultaneously with its appearance in his bulletin, we will wire the important Anglo-Jewish papers and call their attention to the piece. Following its publication in the Anglo-Jewish Press, it will reappear in the form of a pamphlet issued by us. The printer will begin to set we type for the pamphlet tomorrow. Incidentally, Milton Steinberg's sermon was not covered by the press at his own request. Neumann told me that Steinberg had decided against giving his remarks publicity for a bit. #### MEMORANDUM

In accordance with your request, I am submitting a memorandum containing the facts on Israel Mereminski's role in the present Zionist controversy. This startling information was supplied by Max Zaritsky, who urges that his name be kept out of the story - if you should decide to write an article on the subject.

As you know, the A.F. of L. Convention, which met in New Orleans in November, adopted a magnificent Palestine resolution, as well as a strongly-worded committee report on the Palestine question. High-lighting both documents was a demand for speedy and favorable action by Congress on the then pending Palestine Resolution.

The resolution was brought to the Convention by Mr. Zaritsky who, with the assistance of other outstanding A.F. of L. leaders, brought about its passage. (As an interesting sidelight, I might a dd that Mr. Mereminski has, in private conversation, claimed credit for the A.F. of L. resolution.)

Mr. Zaritsky now informs us that, far/having achieved the passage of the measure introduced at the Convention, Mr. Mereminski fried to bring about the elimination of all reference to the Palestine Resolutions pending in Congress. Fortunately, Mr. Zaritsky and the others rejected his counsel in this matter.

Bear in mind that this was taking place in November, at a time when the American Zionist Emergency Council was bending every effort to clear the way for action on the Palestine Resolutions. (But as your own articles indicate, Dr. Silver's opponents were already busily engaged in "playing down" the Resolutions and in evoling methods to tie Dr. Silver's hands.)

Mr. Mereminski's behavior at the A.F. of L. Convention becomes all the more astounding when we recall that American Labor Zionists had taken an unequivocal position in favor of action on the Palestine Resolutions. Poale Zion's representatives on the Council spoke out time and again in support of the course of action proposed by Dr. Silver. - And here was the spokesman for Palestine Labor in the U.S., taking a line diametrically opposed to that of his American chaverim.

Mr. Mereminski owes the Labor Zionists of America an explanation.
