





WE, THE UNDERSIGNED, A MINYON (10 JEWS) FROM THE RANKS OF THE PEOPLE IN NEW YORK PLEASE THAT YOU PRESENT THE FOLLOWING TO THE EXTRAORDINARY SESSION OF THE ZIONIST LEADERS IN AMERICA, TO BE HELD IN WASHINGTON FEBRUARY 17, 1947. 
