Memorandum

To: Mr. Silver

From: Mr. Emanuel Neumann

I am enclosing a copy of memorandum sent to Harry Shapiro which speaks for itself.

The Bevin statement has keyed up our people all over again to a great pitch of excitement. I am inclined to think that the movement or ~~our~~ organization should capitalize on it immediately. I would have the ZOA ask its members and friends to contribute at once, \$1,000,000 if not more, for intensifying our work. I think we could get some of our own people to contribute large sums. Sugerman contributed \$50,000 to the U.J.A.; Abe Goodman, \$30,000, Edmund Kaufman ~~and~~ business associates, \$250,000. There is certainly lots more money where all that came from. I do not think we could get it just for the Expansion Fund, but a special appeal may work and incidently put the ZOA in a really powerful position all round. I would call it frankly, a Political Fund and I would get one or two of our best campaigners to handle the job even if we have to take them away from the U.J.A. or U.P.A.. I may sound one or two of our people on this in a preliminary way.

Memorandum

To: Mr. Harry Shapiro
From: Mr. Emanuel Neumann

I am sending you herewith memo received from Ralph Bass and a copy of my reply. I believe this is the moment for securing a much larger fund for political action either from the National Funds or by direct appeal to the public. Perhaps the ZOA should appeal for a large amount in order to build up political action.

I would also call your attention to the launching of an Institute for Near East Affairs by our enemies in Washington. They are erecting a building for the purpose starting a quarterly journal, etc.. I can think of no other way of countering than by organizing quickly an Institute of our own which may lead to an eventual merger, giving us some foothold.

Milton Handler just phoned me to say that he has talked with Dr. Wise on the telephone and told him that he was beginning to revise his attitude with regard to the British loan. Wise replied that he was calling a meeting of the Executive Committee Monday afternoon.

Handler thought we should stimulate an anti-Bevin campaign throughout the country, one that would make him as unpopular as Samuel Hoare has been made, so that he might be driven out of office. I told him that I agreed to the anti-Bevin campaign but did not believe for a moment that he could be driven from office. I said that to my mind the question to which we should address our best thought now is this: What shall we say to our own government? They may ask us what we would have them do if they continue to press the British and the latter are adamant? I have been thinking along these lines - that we should say to our government, "If you really mean business, you must do something drastic. You must first declare that you regard the present British position as being contrary to the Mandate and therefore unlawful; that the British Government has repudiated its own Committee of Inquiry; that it is violating its international obligations and its obligations toward the United States." Therefore in view of this, our government agrees that the Jews who are striving to get to Palestine with or without certificates are entitled to get there; that this government will extend to them every facility within its power and that directives will be issued to the representatives of the U.S. in Europe and the Near East to assist the further migration of the Jews to Palestine; that American ships and money will be provided for this purpose. Mr. Handler says he would like to think this over. So do I, but I believe that a campaign along this line should be started in some of the newspapers. There are innumerable ways in which American government can embarrass the British government by openly cooperating with the movement of European Jews to Palestine without certificates.


Dear Abba:

I have your letter of July 8th with the attached correspondence.

- 1) With regard to Hadoar, I am afraid that the truth is that our funds are very low. At a recent meeting of the Inner Committee we requested the Treasurer, the Assistant Treasurer and the Chairman of the Finance Committee to arrange for a bank loan to tide us over the summer, but I don't think it has been arranged as yet. We gave \$5000 to Mr. Segal and are committed to another \$5000 which is to be given to Mr. Gerson, and he is now hot on my trail. I will write to Ribalov to assure him that we will make further remittances as soon as possible.
- 2) With regard to the appointments of American Jewish Conference, I will check over our list of representatives there to make sure that they are making no mistake in these appointments.
- 3) I am very doubtful whether we can concentrate on the Expansion Fund at this moment as we did on the elections for the following reasons: (a) It is mid-summer; (b) Our people, including our staff in particular, have been driven hard in the past few weeks and need to recuperate a bit. Sidney Marks, for example, has gone away for a week's vacation; (c) Everybody's mind is on the political situation, the Hagana, etc.; (d) Personally I am scarcely in a position to undertake to head a summer drive for the Expansion Fund. I will try to have a meeting of our Inner Committee as soon as possible to see what we can plan.
- 4) In view of the fact that the British are not issuing visas for Palestine at the moment, I suppose the question of Monsky's going is academic.

I hope you are enjoying a much needed rest.



Memorandum

To: Dr. Abba Hillel Silver
From: Mr. Emanuel Neumann

I am enclosing copy of a telegram which I have sent in your name to Mr. and Mrs. Israel Matz. As you may have seen in the newspaper, their son Sidney, who is their only son, was killed in an airplane crash. He was piloting the plane himself. I also sent telegrams in my name and one signed by Sidney Marks as Executive Director. Am also having some notices inserted in the obituary column. The funeral is tomorrow. Mr. Matz's address is 1522 Albemarle Road, in case you should want to drop him a personal note.

Under separate cover I am sending you a set of carbon copies of reports rendered by Miss Dorothy Adelson to Dr. Nahum Goldmann on her talks with various United Nations personalities. As you are probably aware, she is working for the Jewish Agency. She sent these copies to me privately and confidentially, at the suggestion of Shalamuth Schwartz who is very friendly with her. I consider these reports important enough for you to see and I would suggest that when you are through with them that you please have them returned to Miss Adelson at 520 West 110th Street New York 25, N.Y., - unless you want Akzin or anyone else to see them first. In any case I promised to have them returned to her since they are her own personal copies.

I had a telephone call from Mr. Lakin of Detroit, who is, I believe, chairman of the local Emergency Committee. He told me he has had many telephone calls from Zionists who do not know all the facts with regard to the bomb outrage, and who feel that something ought to be said in the Press. I understand that you are opposed to any statement being issued by the Council. I think the least we ought to do is to send out to all our Emergency Committees certain material including the statement made by the Jewish Agency and the statement of the Haganah; perhaps also a memorandum which our friends could use in their efforts to guide and influence press reactions.

I just had a telephone call from James G. McDonald who will be in Washington tomorrow and expects to see Ben Cohn, Secretary Snyder and perhaps others. He told me he was feeling quite gloomy and fears that the British will use the outrage to our disadvantage. He asked me what I thought President Truman ought to do. I told him of course. I also suggested to him that he write a letter to the New York Times in answer to Anne O'Hare McCormack's column which appeared today, - a letter which would take a balanced and reasonable view of the whole situation, pointing out the provocation, etc.. He said he would consider the idea and I am going to suggest to Akzin that he prepare a preliminary draft for McDonald's consideration. I still feel that we cannot leave the press uncovered. We have certain things to say and we should say them, otherwise public opinion will be influenced against us by the British and the Arabs.

I had a telephone call from Dr. Buchspan. Among other things he told me of the conversation he had with Ben-Gurion, in the course of which, BG let fall some remarks about a coming re-organization of the political work in America, which left Buchspan with the impression that BG intended to have

the Jewish Agency, (i.e., himself perhaps) take over completely in U.S. Buchspan assumes that this question will be taken up at the meeting of the Jewish Agency in Paris and perhaps decided there. Of course he may be mistaken.

I have about made up my mind not to go to Europe. They tried to get passage for me on the Queen Mary, without success. I am told that I can get passage by air early next week but I am not inclined to do it.

Frisch spoke to me yesterday about a conversation he had with Goldstein who is apparently not going across and who, according to Frisch, suggested that Frisch might go in his stead.

I have received a cable from Sam Segal and Zvi Hermann from Paris saying that they would like to take advantage of the presence of leaders of General Zionists in Paris, for important consultations on the future of the Confederation and that my presence was indispensable. They asked for a cable reply.

I received your hand-written letter of course, and I have before me now, a draft article written by M.Z. Frank which I will look over soon. It is intended to be published in the Day (under a pseudonym). He is also writing or has written an article for the Indianapolis Post. We got an editorial on the English page of the Day, Sunday, treating with the same subject. It was written with my suggestion, by Carl Alpert and was good as far as it went.

I hope that despite the terrible things that are happening, you have been profiting by your stay in Maine.

You will be glad to know that we finally got the \$100,000 from Keren Hayesod for gradual transmittal to Palestine, and that I am in telegraphic communication with our friends there on this matter. In due course we will publicize the fact that ZOA is sending this money to Palestine.


Yesterday we had a little meeting of Barbarash, Israeli, Carl Alpert, Dr. Bernstein, M.Z. Frank, Abe Fuvim and myself, to plan the press campaign, of which we spoke on the telephone. Abe Fuvim will watch it and push it, with my advice and guidance. Today's Morning Journal had a good editorial, critical of the Jewish Agency's tactics and even Fishman, in his column, criticized the Jewish Agency for not keeping the public informed.

Last Sunday Meir Grossman, in his weekly broadcast, Station WEVD, criticized the Agency and the partition plan and wound up with a rather friendly comment regarding your position. He said that it was quite understandable that you, as a good and disciplined Zionist had no alternative but to resign from the Executive. I thought it was worth while to follow this up and I lunched with Grossman yesterday. We agreed that there ought to be some rapprochement, at least unofficially. He has, of course, his grievances over the treatment he received at your hands in the past, but we agreed that personal differences must give way where fundamental Zionist principles are involved. I have asked him for a copy of the part of his radio speech attacking the partition plan and propose to publish it in the next number of our News Reporter. We can do other little things to sweeten him up a bit and get more active support from his group, his little paper, the Trend of Events, and his pen, as a writer. Incidentally he plans to go to Europe within a few weeks to attend an International meeting of the Revisionist Party. I am inclined to go so far as to help his little paper, with a few hundred dollars. I understand from Weinberg that there was some talk of a series of articles by Grossman, in the Day. Most of the other American Revisionists are behind you and it is important that Grossman's past hostility to you should give way to cooperation. We expected Lipsky yesterday- perhaps he will come today.

I am returning the letter from Professor Yahuda which I have read with great interest.


Dear Abba:

I am enclosing copy of a letter I have written to Henry Montor which speaks for itself.

As I told you on the phone, he reported at a meeting of the UPA, giving the line that the most responsible people in the Yishuv and the Mapai in particular wanted Partition. If I am not mistaken, he said that failing Partition, many of them would accept a Federalization plan because they want a period of peace and stability.

It might be a good idea for you to invite Rosenbloom, Sonnenborn, Montor and perhaps also Sincoff, who also visited Palestine, for a chat with you the next time you are in New York. Even before that you may wish to communicate with Montor. He did say at the UPA meeting that he will not say in public what he ~~will~~ say in the confidence of that room; but if in his private talks with Zionists in New York and in the country he spreads the Goldmann line or the Kaplan line, it is just as bad as doing so in public speeches.




I am arranging to have a private talk with the new Philadelphia President, William Silk.

I heard about the visit of Mrs. Tourover, who addressed the Hadassah Board to sell the Hadassah line and am enclosing copy of a memo I have sent to Sidney Marks which speaks for itself.

I learned that there was a long meeting of the Executive Committee of the American Jewish Committee during the past week-end, at which Proskauer made a strong plea for supporting the present policy of the Jewish Agency. There was a long discussion in which strong opposition was voiced by some to Proskauer's new line. It was finally decided that a representative of the American Jewish Committee should attend the London Conference, if invited and if the Agency decides to participate.

On the other hand, Lipsky in his conversation with me the other day let slip a hint that things were not quite smooth in the American Jewish Committee and I am now trying to find out what's what. Judge Levinthal also told me that he had a talk with Monsky who is all burnt up about Nahum Goldmann, and he will probably get things off his chest at the meeting of the Interim Committee on Friday. If you have not done so, it would be well for you to talk with Monsky on the phone, if you are not going to be here. I have written a letter to Lipsky regarding the position of the American Jewish Conference, copy of which I am enclosing.

MEMORANDUM

To: Dr. Sidney Marks
From: Emanuel Neumann

Last night's meeting in Philadelphia was a great success. There were present more than 200 of the officers and leading workers of all districts. There was installation of officers and short speeches by various Activities Chairmen. I gave a talk which was well received.

While there I learned that Mrs. Denise Tourover had been there addressing the Executive Board of the Hadassah Chapter in defense of Dr. Goldmann and the policy of the Agency Executive.

I think it is most important that between now and the Convention we plan a little campaign of our own, getting our field workers and speakers to address at least the Executive Committees of the most important of our groups throughout the country, telling them our story and explaining the position of the ZOA Administration. The first step will probably be a conference of field workers and speakers, to be addressed preferably by Dr. Silver himself.

There will probably be a number of Regional Conferences between now and the Convention. I would like you to ascertain when and where such Conferences will take place so that we can arrange to have a representative of the National Administration present at each one of them. This is most important.

I am also drafting a new circular letter to go to our key men. I hope the last one was well received though I haven't had any reports concerning it.

Dear Lipsky:

I assume that the question of participation in the London Conference will be discussed at the meeting of the Interim Committee of the American Jewish Conference on Friday. I understand that Mr. Monsky will have a few things to say regarding the treatment accorded to him as the Chairman of the Conference.

Obviously we are in something of a dilemma. On the one hand we do not want to forego such support as we may have from Judge Proskauer and the American Jewish Committee; on the other hand we do not want to undermine the position and authority of the American Jewish Conference. That it has been undermined to a certain extent there can be no question and it is important that the Jewish Agency do something to fortify the position of the Conference.

I intend to attend the meeting of the Interim Committee and would like to have an understanding between the representatives of the ZOA on the Interim Committee regarding the line which we should follow at the meeting. 

Dear Bob:

It has been reported to me that you have repeatedly criticized and attacked our efforts to secure financial assistance for the constructive activities and projects of the General Zionists in Palestine. I don't know whether that represents your own personal views or whether it is a reflection of the views of the Administration of the UPA as a whole. In any case I am greatly disturbed by such expressions of opposition to a well considered policy of the ZOA since the London Zionist Conference a year ago.

It is also difficult for some of us to understand why good General Zionists like yourself should be willing to tolerate a condition in which the Parties should have the advantage of special funds to strengthen their activities and institutions in Palestine while the efforts of the General Zionists there should be handicapped or frustrated by a total lack of financial help. It is unfair, unjust, harmful to the General Zionists and to the proper and balanced development of all the elements in the Yishuv. I hope that upon reflection you will come to see this matter as we do. In any case I think that as a loyal and disciplined Zionist you ought to see your way to supporting the efforts of the ZOA even if you are not in full agreement with the policy.

Dear Abba:

I am enclosing copy of a letter that I sent to Robert Silverman which speaks for itself.

I don't see how we can ignore the repeated evidences of unfriendliness coming from UPA circles. Last night in a conversation I had with Mark Sugarman he told me of a run-in he had with Rudolph Sonnenborn months ago in connection with the proposed purchase of a building for the ZOA. He said that Sonnenborn had used a word that struck Sugarman as so outrageous that he bristled up and told Sonnenborn that he resented it and asked how he dared talk to him that way. Thereupon Sonnenborn apologized.

I understand that Charles Rosenbloom refused to attend the Pittsburgh dinner although you were the guest of honor. - I have no doubt that Rosenbloom, Sonnenborn and others are well meaning but are apparently being systematically indoctrinated by Montor and others with whom they are in most frequent contact.

There doesn't seem to be a single one in our circle who feels happy about the present UPA setup. Our boys keep talking to me about it. They feel that it is a dangerous mistake to leave so powerful an instrument completely in the hands of persons who have clearly demonstrated their unfriendliness to this Administration and its policies. Something will have to be done about it.

Moreover we have to decide on the new setup for the Keren Hayesod. Rosenblatt plans to leave for abroad soon and to spend seven or eight months of the year in Palestine with his family. Under those circumstances someone else will have to be designated as President of the KH - preferably a person strong enough to exercise a considerable influence in the UPA. I don't know whether you feel that Rosenbloom should be continued as National Chairman but if you do, some arrangement will have to be worked out whereby the whole works will not be dominated by elements hostile to us.

It is also necessary to discuss the Convention program prior to the meeting of the Executive Committee on Monday night.

I discussed with Sugarman the matter of the Special Fund and finally persuaded him to be back in town next Monday afternoon and stay over for the meeting of the Executive Committee in the evening. I think you should devote half an hour or an hour to him so that we can secure a definite and substantial contribution from him, which will then I am sure be matched by Abe Goodman. Perhaps in addition we should call in a few people immediately following your




We are to get \$5,000 from the Region itself for political fund; in addition, he is to raise with our help, another \$10,000 or \$15,000 from individuals, so that we ought to get between \$15,000 or \$20,000 from Long Island for this purpose.

In addition I have also boosted them up on their contribution to the Expansion Fund. During the past year they gave us \$20,000 and he has agreed that we should receive at least \$35,000, a 75% increase.

I am now more hopeful for the possibility of our reaching at least \$100,000 for the political fund prior to the Convention. Of course I had to take an hour's time to talk with Doft about many other matters, but that is the price one has to pay.



A wave of indignation is being expressed by some of our friends over the way in which the UPA Conference was arranged. Very little was said about the UPA or fund-raising, most of the time being devoted to political addresses, especially Dr. Wise's.

We have had a little discussion about the future setup of the UPA and opinions are divided between those who think that there is no remedy in the situation short of appointing a new National Chairman, and those who think that Rosenbloom might be retained but under a new setup which would give adequate power to other officers to run the works.

Another idea which is being advanced is that a new person be engaged as the Executive Director of the UPA while Montor would remain as Executive Vice-Chairman of the UJA and devoted himself exclusively to the UJA campaigns. This idea carries considerable appeal because it is felt that only by control of the administrative apparatus of the UPA can we make it responsive to the policies of the ZOA. I intend to have a private talk with Harry Shapiro who knows something about the men who may be available and see what he thinks.

Another development: Mark Sugarman had lunch with Montor and came away with the impression that Montor was feeling him out about taking the Chairmanship of the UPA. Of course this may only be an attempt on Montor's part to find out what's in the wind and whether Mr. Sugarman is a candidate. We must give further thought to this whole problem, which is becoming acute. We will be making ourselves ridiculous if we allow the UPA, which we are in a position to control, to be used as an instrument against the ZOA.

No doubt you have been reading Torczyner's cables and the other correspondence from abroad. On the other hand, Israel Goldstein is urging that we have a joint meeting with Hadassah representatives with regard to the problems of General Zionism and see whether we can get together on a minimum program. Have you any thoughts on that?


I suppose we will have to have another meeting of the ZOA Executive Committee and I am drafting a memo as a basis for discussion regarding the stand to be taken at the Convention and ultimately at the Congress, and I will send it to you with this letter or by separate mail.

I deeply regret that all requests to meet you personally have been rejected. I had contemplated discussing with you in detail the functions of the Asirai Zion Fund.

The purpose of this fund is, as you are undoubtedly aware of, to sustain the families whose breadwinners have been detained in keeping with the Emergency Regulations in force in Palestine according to which individuals can be held without trial.

I am one of the directors of the Asirzi Zion Fund in this country and in Palestine and I must say that I was indeed shocked to learn through contacts in Chicago, Philadelphia and other cities, that they have been advised by you not to take part in our activities. May I ask you how you have the moral right to criticize our campaign?

a) For your information I wish to state that the following prominent personalities in Palestine participate actively on the work of the Asirai Zion Fund: Professor Joseph Klausner, who is head of the Committee in Palestine; Chief Rabbi Herzog, with whom I am in constant contact, and who has given me letters of introduction to important people in America; Mr. I. Rokach, Mayor of Tel-Aviv, Mr. Saphir, Mayor of Petach Tikvah, Mr. O. Ben-Ami, Mayor of Natanyah and Mr. Krinitzy, Mayor of Ramat Gan are also lending the Committee their full support.

b) While it is true that there are small settlements in Palestine who support the families of their own detainees, the destitute families of detained breadwinners residing in larger colonies and in the cities, are being supported directly and only from the Asirai Zion Fund.

c) At a meeting held in Palestine between Mr. D. Remez, chairman of the Va'ad Leumi (prior to his detention) and members of this committee, Mr. Remez explained that neither the Va'ad Leumi nor the Jewish Agency has organized funds for the purpose which we are serving, and he therefore advised us to continue with our campaigning abroad, to do our utmost to carry on our urgent and important work on behalf of the families of the detainees.

- d) Although the Jewish municipalities in Palestine would like to contribute toward this cause, their expenditures are unfortunately strictly controlled by the British government and needless to say, it does not permit the allocation of funds for such purposes.
- e) Recently the Deputy Chief Rabbi of England, Rabbi H.M. Lazarus, was appointed Vice-Chairman of the Palestinian Committee.
- f) You have advised people in the United States that those who have lent their names to the Asirai Zion Committee have done so without carefully examining the functions of that body. For your information this contention is not only groundless, but is in direct contradiction to the facts. Those people have identified themselves with our Committee, have done so with full knowledge of the situation in Palestine, and after careful consideration. They have acted with great courage and enthusiasm.

I still cannot comprehend the negative attitude which has prompted you to do your utmost to disrupt our campaigning.

Today, in this country, many campaigns are being sponsored by different organizations with various aims, and are being supported by numbers of people. I have not heard of your organization interfering with the work of any of these groups. I should also like to emphasize that those parties and funds which get substantial allocations from the United Jewish Appeal are also conducting separate campaigns of their own, for example the Histadruth.

Regrettably and unwillingly I have been forced to the conclusion that your attitude is beyond understanding and I am impelled to state that your behavior in our case has been extremely unfair. Although I am not an American and am a stranger in this country, I will find ways and means within the framework of the Zionist Organization and Congress to bring this matter to the attention of the proper people.

Attempts will undoubtedly be made by the opposition to confound the judgment of the Yishuv of what actually took place.

I have read Mr. Israeli's memorandum to you based on his talk with Mr. Z. Schuster and what it contained with regard to the attitude of Proskauer and the American Jewish Committee, is of vital import. If what Schuster said is true, and I believe it is, then it is time that we established a different relationship with Proskauer and the Committee. This is necessary on objective grounds, and of course also to avoid a situation where the American Jewish Committee will, as it were, come into the Zionist fold under Goldman's tutelage.

I think there ought to be a meeting between yourself and Judge Proskauer and perhaps others of their leaders. Of course the ground would have to be prepared, and someone ought to be assigned to that task. Again I believe it is most important that such steps be taken now, before our departure for the Congress.


Dear Abba:

I have a problem which I do not quite know how to handle. Mrs. Lowenthal has been telephoning to my office and I am enclosing a note which my secretary had made, of the last conversation she had with her. Obviously this is something which ought to be handled by our people in the Emergency Council, but apparently Mrs. Lowenthal does not want to have it discussed with Shapiro - at any rate, not for the present, until "the air has been cleared" between them. It seems that she recently spoke to Harry who put her on to Tuvim, and Tuvim apparently has not warmed up. I know that she is not altogether easy to handle and work with, but in the present state of affairs I do not suppose we can afford to neglect any possibility. On the other hand, there is no use my starting anything with her because it would have to be done in the final analysis, through our boys in the office. Again I think we should not neglect it.

While I am at it, I do think that the idea of a collection of essays to be published by the ZOA is so important that no time should be lost. There is no one in the ZOA of sufficient caliber to secure the right kind of contributions and I would therefore suggest that one or two persons in the Emergency Council be instructed to cooperate with the ZOA to secure the articles. I could help here and there, by writing or signing letters to certain individuals with whom I have contact, but the job should be done largely by the people in the Council who could help to plan the book and to secure the articles. I mean particularly, Shalamith Schwartz, Gerold Frank and Ben-Horin. If you agree with me, would you issue the necessary instructions?



It seems to me that there is urgent need for a special publication discussing various aspects of the present situation which might serve as background material for newspapers, commentators, publicists, etc., and guide them with regard to their line. It might be done either in the form of a pamphlet or as a special issue of the magazine "Palestine".

Such a pamphlet would include a summary review of British policy and tactics in the past year and a half, including the Anglo-American Committee, the London Conference, etc., policy in Palestine and an appraisal of the new move for a reference to the United Nations.

We should discuss the latter, also the problem of an interim policy, etc., etc.. To make the pamphlet timely and ensure its being read, it should be directly tied up with the question of the United Nations and the words "United Nations" should appear in its title, e.g., "Palestine Issue Before the United Nations". It should be published in fairly large quantities and made available to all leading Zionist speakers and workers throughout the country as well as to non-Jews.


Inasmuch as Senator Arthur Vandenberg appears to be another Machiavelli, perhaps some use can be made of the inclosed.

My dear Mr. Dann:

This will acknowledge your letter of April 11th with its voluminous documentation. I am putting this aside for more intimate study at my first free opportunity.

First I want to thank you for your generous personal references. Certainly there can be no question about the sincerity of my interest in the Zionist problem in Palestine. There is no way that anyone can raise this question in the General Assembly or the Security Council of the United Nations except as it is officially presented to the Secretary General by official action of a member government. In other words, I could not do such a thing on my own personal responsibility. Therefore, for the time being, our problem resolves itself into urging the President and his Secretary of State to take appropriate action. They will take no action, however, until the report of the Joint Commission (currently at work upon the problem) is available. Whether we like it or not this is the reality which we confront. I assume that this report will be available in the near future. In the meantime, I also assure you that I am entirely familiar with the report made by the late Senator Copeland and ex-Senator Hastings and Senator Austin. The latter still remains in the Senate and I am in constant collaboration with him on this subject. You may depend upon every possible effort I can make in behalf of this great enterprise.

Under the pressure of the moment, I cannot respond to your letter in the detail which it deserves; but I have wanted you to have this immediate acknowledgment.

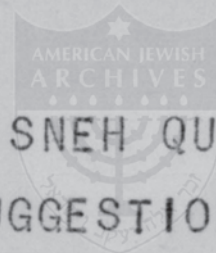

Dear Abba:

I am enclosing copy of the last letter I have had from Sumner Welles. I had written him about several matters including the possibility of his delivering a public address in New York, and above all appearing before the Committee of Inquiry, whether here or abroad. I still think it would be a great thing if he would testify before the Committee, since he still commands great prestige, particularly among Latin-Americans. If you do plan to be in Washington next week, and such a visit seems indicated, I would suggest that you communicate with Welles, in advance, to fix an appointment. Perhaps we ought to invite him also to address the Convention. He might accept if you put it to him that it is a Jubilee Convention and a really important occasion.

2. In the course of a conversation I had with Israel Goldstein the other day, he referred again to the Weizmann matter and said that there will be a meeting of the UPA Executive Committee next week to discuss the program of the UPA Conference to be held in the middle of October. He said that the question of inviting Dr. Weizmann is bound to be raised and that it would be difficult to put it off. Dr. Weizmann is planning to come here in September and on what ground can we object to his being invited to address the UPA Conference, together with yourself and other Zionist leaders. I told Goldstein that you would be in New York early next week and that the matter ought to be discussed with you privately. I am afraid we may find ourselves in an awkward position at the UPA Executive meeting if the matter is pressed by some of the people.
