



# A CALL TO AMERICANS

## Boycott—An American Institution

*I*N 1768, Sons of Liberty committees were established throughout Colonial America to boycott British goods as a means of stopping British tyranny and oppression.

Now, in 1948, a Sons of Liberty committee is being formed for the same purpose. We invite you to join. A number of distinguished Americans have already signified their desire to participate in the formation of this organization. The list is growing. Let us add your name.

## Why the Boycott?

At a time when the American tax-payer is contributing billions of dollars to stop war and international aggression, the British Government is guilty of the most flagrant and cynical aggression against peace and justice. Although this aggression is directed against Palestine, its greatest victims are not the Jewish people to whose martyrdom of twenty centuries Britain now seeks to add the *coup de grace*. The chief victims are international law, the Four Freedoms, and the United Nations.

For Palestine is a test of our future. If Great Britain succeeds in achieving her ends in Palestine, we shall again be playing the game of power politics that leads inevitably to world war.

The most outrageous aspect of this situation is that Great Britain is able to carry out her imperialist policy solely through the aid she gets from the United States. With the money collected from the American taxpayer, with millions of dollars contributed by the American purchaser of British goods and services, Great Britain is now subsidizing her imperialist

war in Palestine. With these funds Britain arms the Arabs, trains their Legions, and pays them to fight.

## **The Last Effort**

The war against Israel—and the British-made “truce” as well—represents the last, desperate effort of British imperialists to win possession of Palestine. Violating the solemn treaty by which Great Britain and fifty-one other nations recognized the right of the Jewish people to their ancient homeland, these men negated and sabotaged every provision of the League of Nations Mandate for the establishment of an independent Jewish State.

When the United Nations authorized the establishment of an independent Jewish State in a small segment of the territory originally allotted to the Jewish people, the British Government formulated the scheme of an Arab invasion of Palestine at conferences held in the British War Office. There, the “concentric attack” by Arab armies was planned on April 21 and May 5, and was approved by Field Marshal Montgomery. Arab forces, armed, trained, commanded, and paid by the British, were brought into action.

Today, thousands of Jews and Arabs are dying in Palestine to serve the interests of British imperialism. The new-born State of Israel is threatened with destruction. The Arab masses of Palestine and of the Near East are also facing the threat of a return to that Oriental feudalism which enslaved them and desolated “the land flowing with milk and honey.”

## **Action Now**

This outrage can be stopped. We have the means in the United States with which to defeat British imperialism. We can do so by having the American Government withhold the millions of dollars of ERP funds upon

which Great Britain is counting to re-establish her national life but which her Foreign Office is using to destroy lives in Israel. We can do it also by a nationwide boycott of British goods and services.

*Decent men and women of Great Britain have been outraged and disgusted by the imperialist policy of their Government. Their efforts to change this policy have been defeated by the imperialist interests that control the Foreign Office. In Great Britain, as elsewhere, justice and decency lose out in the struggle against greed and lust for power.*

But, if the United States Government makes it clearly understood that no ERP funds will be allocated to Great Britain until the British Foreign Office abandons its piratical adventure in Palestine, if Americans adopt an immediate and effective boycott, they will add the powerful element of economic self-interest to the force of morality. They will strengthen the hands of the British people who oppose the iniquity of their Government.


*Great Britain needs American dollars. Her very life depends upon it. If the Government of Great Britain finds that its losses in the United States more than outweigh its expected gains in Palestine, it will call off the invasion of Israel in twenty-four hours.*

## Profits and Politics

To cite one example of the importance of boycotting a British-owned company in America, let us take the case of Lever Brothers. The annual sales of this firm in the United States in 1937 were \$64,000,000; in 1946, \$180,000,000. In 1944, the American company sent back to the British parent organization, Lever Brothers and Unilever Ltd., £13,827,546. This was more profit than the British company had earned in that year from its 500 subsidiaries in Great Britain, the British Dominions, and in other countries.

But even more important than the fifty million dollars which Americans thus contributed to England is the fact that the British Board of Directors of this company has two members in the House of Lords, Viscount Leverhulme and the Marquess of

Carisbrooke. It also has three members in the House of Commons including Clement Davis, the leader of the Liberal Party. Judge for yourself what effect a boycott of Lever Brothers' goods will have on the political opinions of these men in regards to the British Palestine policy.

This is not an isolated example. Most British firms have members of Parliament on their Boards of Directors. All of them will begin to think of British aggression in Palestine in terms of losses rather than in terms of profits if a successful boycott affects their business.

Lever Brothers' products include Lifebuoy Soap, Lux Soap and Lux Flakes, Gold Dust, Hedy Home Permanent, Rayve Shampoo, Lipton's Tea, Continental Soup Mixes, Harriet Hubbard Ayer Cosmetics, Pepsodent tooth paste, tooth powder and mouth wash, Rinso, Spry, and Swan Soap. All of these are popular items bought unwittingly by many people who would be shocked to know that they are buying British goods.

**George Washington advocated a boycott of British goods too, six years before the American Revolution. . . . Read these excerpts from a letter to his friend Colonel George Mason.**

*Mount Vernon, April 5, 1769*

*. . . At a time when our lordly Masters in Great Britain will be satisfied with nothing less than the depreciation of American freedom, it seems highly necessary that something should be done to avert the stroke and maintain the liberty which we derived from our Ancestors; but the manner of doing it to answer the purpose effectually is the point in question. . . .*

*Addresses to the Throne, and remonstrances to parliament, we have already, it is said, proved the inefficacy of; how far then their attention to our rights and privileges are to be awakened or alarmed by starving their Trade and manufactures, remained to be tried. The northern Colonies, it appears, are endeavouring to adopt this scheme. In my opinion it is a good one, and must be attended with salutary effects, provided it can be carried pretty generally into execution; . . .*

*That there will be difficulties attending the execution of it everywhere, from clashing interests, and selfish designing men (ever attentive to their own gain, and watchful of every turn that can assist their lucrative views, in preference to any other consideration) cannot be denied; . . .*

*The more I consider a Scheme of this sort, the more ardently I wish success to it. . . . And that a scheme of this sort will contribute more effectually than any other I can devise to immerge the Country from the distress it at present labours under, I do most firmly believe, if it can be generally adopted.*



Dear Dr. Silver:

Barney Balaban is in Chicago for a few days. He asked me to express to you his gratification concerning your proposed exchange of letters with Mr. Blumberg of Universal Pictures on the subject of the boycott of British films. When he returns he will want to do so personally.

This action on your part comes at a highly propitious moment. Mr. Balaban, as National Chairman of the Motion Picture Division of the United Jewish Appeal, is now engaged in soliciting contributions from the parent companies in the motion picture industry. These should amount to more than a quarter of a million dollars -- a most substantial sum when you realize that these companies are public corporations and that their Boards of Directors are essentially non-Jewish.

Apart from the clear merit of the position you take in your proposed letter, it helps us eliminate any reservations about the United Jewish Appeal which may be entertained because of the boycott.

There is but one minor deletion from your proposed letter which we would suggest. In no way does it alter the sense of your letter or detract from its validity. The deletion suggested is the phrase through which I have run a line on the enclosed copy as given to me by Harry Shapiro. Mr. Blumberg is concerned that this phrase might give added currency to the fact that some of the Universal stock is held by British interests. He feels that no purpose is served by its inclusion, and that some harm might result. We, therefore, urge that you give every consideration to concluding the pertinent sentence with the word "Company".

Harry Shapiro suggested that I bring this matter to your attention directly and that you would understand the reasons for Mr. Blumberg's request.


