Dear Sir:

The Anti-Defamation League has contracted for a special edition of "The Jew and American Ideals" by John Spargo, which will be published by Harper & Brothers, early in March. In this book anti-Semitism is called to a severe accounting. The book gives the inquiring American public a chance to learn the facts concerning the vicious anti-Semitic propaganda which is as anti-American in its policy as it is anti-Jewish in effect. The book is no partisan defense of the Jew, much less a pro-Jewish argument. It is, however, an independent and original investigation of the facts, a defense of American ideals and institutions as opposed to anti-Semitism, and a plea for Christian civilization. The League intends to present a copy of this book to all moulders of public opinion throughout the country.

The book will carry greater weight than any similar publication which has thus far appeared. Noone is better fitted than Mr. Spargo to write a book of this character. He is one of the very few Americans who can write from intimate personal knowledge of the role of Jews in the Russian movement. He is a Socialist who is not afraid of avowing his Socialist faith but who cannot possibly be under suspicion of being pro-Bolshevist. In fact, he is one of the leaders of the anti-Bolshevist forces throughout the world. Finally, he is not a Jew. Mr. Spargo, you will remember, took the initiative in mobilizing non-Jewish public opinion against the organized anti-Semitic campaign. The Protest which was given wide publicity in the press early last month, copy of which I am enclosing herewith, was prepared by him and the signatures thereto secured through his personal endeavor.

There are in your community a certain number of men and women who should have a copy of this book; e.g. some of your clergymen, the editors of your local papers, the secretary of your local Y.M.C.A. and perhaps some others because of their position in the community. A copy should also be in the Public Library.

We are therefore, sending you under separate cover 125 copies of Mr. Spargo's book for free presentation to the non-Jewish leaders of your community.

In our opinion, the books should be presented by individuals rather than by an organization. We would suggest that a committee be appointed, consisting of the leading Jewish citizens of your community, to prepare a list of persons to whom the books should be sent, and that the books be presented with the card of some member of the committee who is personally acquainted with the person to whom the book is to be presented. Do not include members of Congress. Copies will be sent to them direct from this office.

We desire to keep on file in this office a card index of the names, addresses and positions in the community, of those who receive these copies, so that additional literature may be sent to them from time to time. Please send us this information at your earliest convenience.

The books are sent to you without charge. If ADDITIONAL copies are desired for distribution in your community, we can supply them to you at the rate of 75¢ per volume. (\$6.50 per ten copies, \$55 per hundred.)

Please give this matter your prompt attention.

Dear Rabbi Silber:

"Papini's Life of Christ" has been more thoroughly advertised and exploited than any other book published in recent years. Hence it is that there has been much bidding for the rights to film the book. We are informed that these rights have now been acquired by the First National Films, Inc., (383 Madison Avenue, New York City) under conditions whereby the film company is bound "to follow the book closely."

Many sections of the book have a distinctly antiSemitic trend and unless the producers attach a very elastic interpretation to the above provision, the effect of the film on public
opinion may well be serious. Thus far, no final arrangements have
been made, but the film company intends, we are told, to make "a
most ambitious production."

You have undoubtedly read the book and have no doubt formed definite ideas of the effect that the film version of the story if closely adhered to might have upon relations existing between Jews and non-Jews in America.

We are sending this letter to a group of representative American rabbis whose judgment, in our opinion, will have a definite influence upon the officers and directors of the film corporation. We believe that a letter from you addressed to the film company will be certain to have a great effect in moulding the plans for the production.

This letter has been multigraphed to save time, but we hope you will regard it as a personal communication and favor us with an acknowledgment, and, if possible, a copy of your letter to the film company, in the event you decide to write them in reference to this matter.

My dear Rabbi Silver:

The further we go in the investigations of the League the more seriously do many of our problems present themselves. The Chicago Advisory Council has for some time now faced the realization that the Anti-Defamation League must continue its heroic efforts to preserve a proper state of the public mind. It is hardly necessary for me to give you the program of the League, for I know how informed you keep upon these movements.

The work of our Speakers Bureau is being extended tremendously. Thousands of addresses will be delivered before service clubs, Legion posts, and other groups. We have listed hundreds of willing speakers, Jews and non-Jews. While no compensation is granted to ordinary speakers, the actual expenses are defrayed in every case where speakers leave communities of their residence.

We plan, in addition, to place in libraries at strategic points some of those worth-while books which may present new viewpoints. We have already placed many hundreds of copies of Professor Moehlman's "Christian-Jewish Tragedy." We believe Professor Ewald Banse's "Germany Prepares for War" will likewise be an eye-opener to many of those inclined to give ear to Hitler's specious representations of his pursuit of peace. We have also placed several thousands of Fox's brochure, "Democracy and Naziism." Many additional brochures and pamphlets are being worked up at this time all of which have very definitely in contemplation the enlightenment of masses of people in connection with various phases upon which their thinking has been perverted.

The budget of the League calls for an expenditure of \$225,000 for this year. Part of this is supplied by the Wider Scope campaign of B'nai Brith. That portion which goes for administration and educational activities can be incorporated in the Wider Scope budget. That very important part which calls for "fact-finding" cannot well be included in the regular budgets. Until now it has been financed by groups of well-to-do men in the several communities who have been in confidence, familiarized with the value of our work. A substantial sum is being raised now by some of the outstanding Jews of Chicago. We have not approached Cleveland, for we are not unmindful of the grave problems which your city has faced.

The general situation is now extremely tense. We must not relax our vigilance, nor can we for a moment consider such a contingency as permitting lack of finance to frustrate our ultimate purpose. I recently wrote to Al Benesch requesting permission to sit down with a limited group of say twelve or fifteen men of your city who still

5/16/34 Rabbi Abba HillelSilver -2have means. There I would like to convey the importance of our work and the quiet, but we believe effective, course which we have pursued. We would not expect a vast sum of money, but surely there are a few men in Cleveland who will feel a sense of obligation for that which the League has already accomplished in their behalf and that which it has dedicated itself still to achieve. Al Benesch suggested that I write to you, for he feels that you and he together could furnish me such a group. Indianapolis, St. Louis and Pittsburgh between them raised approximately \$30,000 for this work. Chicago has already given us almost \$20,000 and the rich men have organized themselves into a committee to secure further substantial commitments. All this is done quietly, for we do not want this work publicized. In view of these facts, do you not believe it possible for us to assemble a limited group such as is proposed? Would it not, in your judgment, enable us to secure at least a few thousands by which we may further carry on this very essential effort. The Cleveland Jewish community is at the moment engaged in its Jewish Welfare Campaign. The Anti-Defamation League is one of the beneficiaries in this campaign as well as the Hillel Foundation. The campaign is not moving as it should. All our energies are being concentrated upon it at the present time. It would therefore not be advisable in my judgment to arrange any special meeting for the Anti-Defamation League now. But I am convinced that the matter is of sufficient importance to bring it to the attention of a select group of people in the community in a few months.     - X Investigation and disclosure of all Anti-Semitic propaganda and movements.

    - [c] Defamation on stage
    - [d] Proper use of word "Jew"
    - [e] Summer Resort Advertising.

"I hope that all America will catch the spirit of B'nai B'rith in campaigning against ignorance, intolerance and defamation, against all the movements aimed to rend the concord of American citizenship.
