A JEWISH FRIEND OF LANDON SPEAKS

Radio Address

Jacob A. Harzfeld, Kansas City, Mo.
WINS 7 - 7:30 PM, Thursday, Oct.- 15, 1936

I have come tonight to talk to you about a subject that is very near to my heart, and one that I have studied intensively. The time is now here when every lover of liberty, and especially every Jewish lover of liberty must be wide awake.

In the last three years there has been a mushroom growth of Anti-semitism, of such extraordinary vigor that its growth indicates the backing of powerful groups and an abundance of financial assistance. This growth is not confined to any single portion of our country, but if one were to put colored pins in a map the color on the map would run from the Atlantic Seaboard to the Pacific Coast and from Boston to Florida. That you may be awake to the situation, pardon me if I take you on a trip across the country and indicate to you the publications and the organizations that are preaching this Jew hatred.

If you love statistics be assured that there are 104 organizations that are either frankly and fiercely Anti-Jewish or sailing under the false colors of some patriotic name, and are aiding in the distribution of Anti-semitism.

Let us begin then in New York City. Right here there are 8 organizations that either publish or are engaged in the dissemination of Anti-Jewish propaganda.

The most notorious, of course, is Robert Edward Edmondson. He has issued about 110 separate bulletins, each one of them violently Anti-Jewish. He claims that he has circulated 5,000,000 copies. In addition, he publishes a weekly - News Bulletin - wherein he comments upon every scrap of Anti-Jewish news that he can pick up from any part of the world. Recently he published a solution for the Jewish problem and his solution is as follows: (quote) "Jews are not wanted

anywhere on earth. The alternatives are - 1, to kill, 2, to sterilize, 3, to segregate and our policy is the last one, - conducted at their own expense." (end of quote). The headlines on several of his bulletins are interesting, let me read you a few - (quote) "Jews bring on world wars and Jewish wealth and power gain after war" - "Jew-Free Germany recovers despite World Boycott". (end of quote) Another head line - "United States Immigration policy Jews dictated". Another bulletin reads - "Who Rules Russia, Answer Communistic Jews", and the sub-headlines of this bulletin tell you that Russia has 59 Jews vs 3 Gentiles executives, 41 Jews vs 8 Gentiles Commissars, 8 Jewish Ambassadors", still another of the bulletins states, "Roosevelt Supreme Council Jew Controlled" and the sub-head to this one reads "When Will America Again Be Ruled by Americans for Americans". A bulletin dated Sept. 24, 1936 says - "Jewism before Americanism", and the Edmondson statement in this last one is that Jews are - "Organized to further the interests of American Jewry, but not to promote American ideals, that we are residents of all countries and patriotic citizens of none". And many other of his pamphlets falsely assert that we control 98% of the money system, 69% of the food, 99% of clothing industry, 100% of entertainment, 99% of the press of our country, and that the truth cannot be obtained by the average citizen concerning our nefarious acts except by reading the Anti-Jewish literature that is so freely circulated in these days.

Another leader in New York City is Mrs. A. Tellion, who published what is known as the American Bulletin, a ten page weekly which contains excerpts from the Protocols, and all the other lies that have gained circulation in Germany.

Proceeding southward to the very Capital of our country in Washington, we have James True, associates, who publishes a weekly four page bulletin. It was formerly an economic service bulletin. Now it is devoted entirely to Anti-Jewish propaganda. There are three or four other organizations located in Washington.

Further south at Charleston, S. C. there is a new magazine, just issued, one of the five new publications that have been started in the last six months, called - The White Knight - they call their opening issue the "Jew Deal Issue". The leading article is under the headline - "Who Controls Our Government, or the Jews behind the Jew who tells Mr. Roosevelt what to tell you", and then follows the pictures of some thirty Jewish individuals, who are supposed to control our Government. Included in that list are the pictures of several men who are not Jews. Another article pretends to suggest that if we have our way the women of this country will be nationalized.

Again southward to Florida a new magazine has just been issued, No.1, Vol.1, called "Nation and Race", edited by a man named Blanchard. In the first issue he states that Hitler is the greatest man that Germany has ever produced, and that Hitler's solution of the Jewish question should be emulated by the United States, that Jews have brought the country to such a pass that we are bringing programs down upon our own heads, and that the youth of America must prepare and organize the militia to bring about this happy pogrom day. A little further westward we have the notorious Pelly, who continues to publish at Ashville, N. C. the Pelly's Weekly. In August of this year in a speech delivered in Los Angeles, Mr. Pelly solved for us the Jewish question - suggesting that a pogrom is now due, that Hitler is the greatest man that Germany produced.

Pelly will lead Silver Legion of Storm Troopers. At Chattanooga, Tenn. we have the Crusader White Shirts, which is a militant organization, claiming to have 150,000 members, it is headed by a man names George W. Christians. On June 17th, 1936 in a letter to a friend of mine, he made this interesting statement: (quote) "We have been flooding this country from one end to the other for five years, with the most inflammable revolutionary literature, some of the boys like the Black Legion in Detroit - have been getting a little too impatient for their own good.

Before this thing is over, the Black Legion may have reason to be ashamed of themselves for being such pikers.

In Chicago there is a Bi-monthly magazine called "The American Gentile". The July, 1936 issue contains an article about Zionism - another that Litvinoff was made President of the League of Nations as part of the Jewish conspiracy, - it has a red scare headline running across two pages that reads: "Let us take America away from the Jews" - it contains a false quotation from Benjamin Franklin and asserts that in the Constitutional Convention, Franklin urged that the Constitution exclude the Jews from the United States, otherwise in less than 200 years they will have swarmed in such great numbers, that they will dominate our form of Government". Needless to say Benjamin Franklin never made any such statement. The Librarian of the Congressional Library has stated that a most careful search has been made and that from all that can be found, Franklin's thoughts about Jews was precisely contrary to the indicated false quotation. It is interesting to note that this magazine reprints one of the most vicious articles that appeared in the Dearborn Independent in 1921. Another red headline running across two pages reads: "Russia under Jewish yoke" - then follows a list of 96 alleged Jews who were supposed to control Soviet Republic. Another feature of this magazine is contrasting pictures of a starving mother with a starving child in her arms stated to be Gentiles in Russia and immediately under that gruesome picture another of a banquet table loaded with food - those seated around the banquet board are pictured fat and healthy and are, according to this magazine, all Jews. The paper contains ten vile cartoons, most of them being taken from Streicher's newspapers in Germany. The American Gentile advertises a new edition of the Protocols for 50¢ and three new editions of the Protocols have been published in the last six months.

On the West Coast at Los Angeles is a man named Harry Allen. He has issued what is called - A Proclamation - printed in red, white and blue. This Proclamation is 18 inches long by 9 inches wide. 250,000 of these have been posted on

telegraph poles and other public places on the West Coast. The Proclamation is in the nature of an indictment with 23 counts and contains most of the false allegations against the Jews, from ritual murder to Jewish planned seduction of Gentile girls.

There are many other magazines that time allotted will not permit me to mention. Many of these magazines claim enormous circulation, probably exaggerated two or three times. In addition to the magazines pamphlets with irregular publication dates have been recently issued and flooded the country. Booklets, so many of them that I have lost track of the number, each vieing with one another in the viciousness of their Anti-Jewish statements.

It is not difficult for a man with any knowledge to see that never before in the history of our Country has there been an Anti-Jewish movement comparable to this. Never before has such a movement been so boldly launched. This very week in Washington, a meeting will be held and an attempt will be made to form a union, a coalition of all these Anti-Jewish organizations. My judgment is that they will not proceed very far until after election. They are expecting a vigorous leadership to assume control. In a recent bulletin with a scare headline - "Wake Up, Wake Up, for God Sake Wake Up, Your Country Needs You" - Edmondson states that the time has come for action, that they have been waiting for leadership, that that leadership is ready, and only needs the cooperation of his readers. Whom did he mean? Who are these leaders that are ready? Is it that powerful orator with a sweet voice, who claims several million adherents? Is it another one of the leaders of the minority party whose persuasive power as an orator has been compared to that of Billie Sunday and Bryan? The near future will tell. But that there are men whose words make the front page of the daily newspapers, whose thoughts are in accord with the bulletins that I have outlined, - that, I regret to say is only too evident. These excerpts indicate the enormous growth and the financial strength of these Anti-Jewish movements.

Hitler's recent Nuremburg speech, in which he boasted of the progress made by Germany without a single Jewish contribution, and in which he stated that Democracy was a worn-out, out-moded theory and that all the countries of the world must either become Nationalized or become Communistic. He said that there was no room for Democracy, - his words are a challenge to all those who believe in Democracy. We know that Democracy and Liberalism go hand in hand, and that intolerance can only find a foothold where a dictatorship is in power.

Wake-up my fellow citizens before it is too late. Do nothing that will lend aid and comfort to those who attack the principles which have been part of the tradition of America since our Constitution was adopted.

Perhaps you are thinking what has all this to do with the present political campaign. Briefly this: there has been an active campaign made attempting to impute to Governor Landon, Anti-Semitic feeling. The basis of this false allegation and the only basis, has been a letter that was written by Dr. Carmichael, formerly a superintendent of the State Hospital for the Insane in Kansas. In Kansas, in each state hospital, and many other state institutions, Governor Landon, by the law of the State and by virtue of his office, is the Chairman of the Board of Trustees. This Dr. Carmichael had been in charge of the hospital for the last twenty years. Carmichael is a Southern Democrat. As Superintendent he wrote a letter to several medical schools stating that there was an opening for the appointment of an interne in the hospital, but he stated - (quote) "all applicants must be Gentiles". (end of quote) Of course, neither Governor Landon nor any other member of the Board, knew about the letter, nor did they ever hear about it, until Joseph Cohen, a lawyer from Kansas City, Kansas, and a friends of the Governor, and a friend of mine called his attention to it. Landon was furious and Dr. Carmichael was at once discharged. Somehow or other a facsimile copy of Carmichael's letter was secured and printed in a large number of newspapers and magazines, and the letter appeared thus in facsimile in

reputable and disreputable papers throughout the land. In no instance, did the news article state that Carnichael was a Democrat appointed by a Democrat, and held office for twenty years prior to Landon's election. In no instance did the papers state that Governor Landon and the other members of the Board had, no knowledge that any such letter had been written. In fact in no instance did they state that Carnichael was promptly discharged. The imputation these papers desired to convey was that Governor Landon connived at the writing of this letter.

Such a charge to any of us, who come from the middle west, would be perfectly absurd - what one of your distinguished citizens would call pure boloney or rather impure boloney. We of Kansas and Missouri know Landon's record. We know that back in 1924 when the Ku Klux Klan was flourishing, the Klan managed to nominate both the Democratic and Republican candidates for Governor in Kansas. It angered William Allen White, one of the most lovable, tolerant, and liberal minded men in the Nation. Late in September 1924, he determined to announce his candidacy for Governor on an Independent ticket with only one issue in his platform and that issue was - "Out With The Klan". When William Allen White came down to the county adjoining Landon's home, Landon met him and conducted him throughout that county, and through Landon's home county, introducing him everywhere and getting him a large number of votes. When Landon and White came to the City of Independence, Kansas, Landon's home town, Landon financed and presided at the huge Anti-Klan meeting which White held there. This happened twelve years ago. On July 25th, 1935, the Washington Post sent telegrams to the fortyeight governors, asking for an expression from each of them on what was occurring in Germany. Only six governors wired answers, that could be used, the others side-stepped and pussyfooted, so the Post could not publish the answers and no story ever appeared in the Washington Post. One of the six governors whose answer could have been used was that of Alf Landon. After he sent the telegram, Landon gave copies to the reporters of the Kansas City Star and the Topeka Capitol

and in those two papers his telegram which reads as follows was published. (quote)

"The doings and the sufferings of the people who make up the German community are so shocking as to convince me that the leaders, who dominate the German people by force of arms, have forgotten all teachings of justice and love.

"The intolerant and drastic treatment of minorities in Germany should cause Americans, before casting stones to ask ourselves whether we, too, have not been following false gods in neglecting our churches too frequently and in failing to pay sufficient attention to religious precepts and principles.

"No people can prosper, no nation can live and no civilization can exist, that ignores the Christian principles of justice and love and moral conduct. When they are forgotten, the natural result is a dictatorship and the end of all aims of a free people.

"Germany is the latest illustration of the well known fact that a free church and a free democracy go hand in hand. Whenever religious freedom is threatened, individual rights are trampled by force, and the clanking of swords and the flash of bayonets shock civilized people in their brutality." (end of quote)

Recently Alf Landon made a classical statement on the subject of intolerance. It will be remembered for years to come, as one of the finest, bravest, clearest declarations ever made on the subject. (quote)

"My attention has recently been directed to the activities of several agencies which, for selfish purposes or political reasons, are endeavoring to exploit prejudice between groups of American citizens.

"I have no use for any elements who are endeavoring to bring racial prejudices and religious bigotries into American life, and state frankly that I disclaim the support of any such organizations or groups.

"If ever the day should come in this country that would see persecutions of any racial group or sect because of race or religion, contrary to the bill of

rights, I would stand among their defenders." (end of quote)

From the Middlewest where Landon's record is known and where he has many intimates, telegrams of appreciation and thanks immediately poured in. I quote from a few as follows:

Harry Friedberg, vice-president of the Zionist organization of America wired: "Regardless of political affiliations every member of any minority group will see in your recent statement on minority rights that you will continue to maintain your record made through many years that the bill of rights to you means what it says and that those who attempt to violate it are not true Americans!"

Rabbi Gershon Haddas of Kansas City wired: "I am sure that not only I but men of all parties are grateful to you for your fine statement denouncing the actions of those who attempt to raise racial or religious prejudice in America. We know that your record is in accord with this statement."

Louis H. Ehrlich - President of the Jewish Welfare Federation of Kansas City - wired: "You are to be congratulated on your statement denouncing those who try to exploit prejudice between groups of American citizens. Your fine record on this did not need your words to emphasize your position."

Some of my listeners are perhaps in the Cloak and Suit Industry and know my brother, Sieg. Harzfeld of Kansas City, who sent Landon the following telegram:

"Had I not known of your public record for a dozen years on the subject of tolerance your splendid statement on that subject would have thrilled me as it is just what we expected of you."

Some of you, are acquainted with Isaac Katz, the head of the Katz Drug Stores in Kansas City. He sent a telegram which reads as follows:

"I and my friends appreciate your fine stand against racial and religious bigotry. Your record in this respect as well as your words deserve our appreciation."

Numerous other telegrams of congratulations and thanks came from Kansas City. From your own state came telegrams from some of your well known men - from Roger W. Straus, from William Weiss, President of the Union of Orthodox Jewish Congregations, from former Congressman Isaac Siegel, from Lewis Strauss, from Harry F. Guggenheim and from many other distinguished Jewish leaders here - from Cleveland, from Pittsburgh, from Boston, from Cincinnati, from St. Louis, from Indianapolis, from Chicago - in fact from all over the United States telegrams poured in.

So much for the record. If one dared to make the allegation anywhere near Kansas, charging Landon with Anti-Semitism, our citizens would look at you with amazement and astonishment beyond words - they know Alf Landon out there. I know Alf Landon. I have known him for twenty years and intimately enough so that he calls me by my first name. I have also known his fine old father for twenty years. I personally know the splendid character, the fair dealings, the honorable careers of each of them. They are liberals of the broadest type. They supported Theodore Roosevelt in 1912 - they were Bull Moosers. Religious or racial intolerance is absolutely foreign to their life and manner of thinking. It is as far from them as the stars are from the earth. They cannot even understand how such intolerance can exist anywhere. Alf Landon is intolerant of only one thing and that is intolerance itself. He is only prejudiced against one thing and that is prejudice itself. He abhors nothing more than he does bigotry. The men whom he admires, from whom he seeks advice and those that he leans upon most heavily are also men of the same liberal type. His intimate friends, out our way, are William Allen White of Emporia, Harry Haskell, Editor of the Kansas City Star who received the Pulitzer prize for journalism in 1934, for his articles on Germany, in which Haskell denounced Hitler's treatment of Jews. Haskell is not welcome in Germany since publication of those articles. Haskell is also one of my friends and also an intimate friend of Jacob Billikopf.

whom many of you know. Lacy Haynes, Kansas Editor of the Star, is the man closest to Landon and the first to advocate his candidacy. When we are traveling on Landon's train, Haynes' compartment is always next to Landon's - Haynes is a brother-in-law of William Allen White and shares his liberal views. Roy Roberts, one of the owners and Managing Editor of the Star, is next to Lacy Haynes the man who did most to start and accomplish the nomination of Landon. These are the men upon whom Alf Landon leans most heavily. These are true liberals who know no distinction between men based upon race or religion.

All of this would not deserve so much of your time if there were not now a distinct danger to every Jew in consequence of this false charge of anti-semitism against Landon. The purpose of this vicious fabricated story and of these whispered words is clear. The attempt is being made to drive all of the Jewish voters away from Landon. If you are for Mr. Roosevelt because you believe in his party's principles, of course, you should vote for him. But if you are going to vote for Mr. Roosevelt because you believe that Landon is Anti-Semitic, you are not only doing a gross injustice to Alf Landon, but you are doing an irreparable injury to Jews everywhere. I have always been taught by representative leaders that Jewish people never vote as a group, that we are Americans and that there is no such thing as a Jewish vote. That Jewish Republican Clubs or Hebrew Democratic Clubs are as harmful and dangerous as any of the professional anti-Semites. If any considerable number of us should be misled by this vicious propaganda against Landon, then indeed would these professional anti-Semites - the Edmondsons, Trues, Pelleys, Jungs, dance with glee because at last they would have us where they want us, in a position where they could say (quote) "See, we told you" - These Jews are not citizens, they are not Republicans, they are not Democrats, they are a group that are in every country but patriots in none. These Jews should be exterminated, they should be deported, they should be disfranchised.

High would leap the flames of Anti-Semitism, fed with the fuel, that we voted as a group for the first time in American history - deep would be the resentment of American citizens, and accelerated would be the day when they would be ready to listen to the voice of an American Hitler.

Would that the great departed leaders of recent years, such as Oscar Straus, Louis Marshall, Dr. Lee K. Frankel, Judge Otto Rosalsky and many others of that type, were here alive today to repeat in clarion tones what they preached in life, which is that we are Americans, in all things and above all, we are Americans when we cast our votes and to do otherwise is to lead an attack against our own Americanism.



Gerald Smith To Head a New Anti-Red Front

Huey Long Ally Announces He's a Nationalist Now, Backed by \$1,500,000

Bankers Put Up Money

Rally Here Tuesday Night to Start 22-City Machine

WASHINGTON, Oct. 17.—The Rev. Gerald L. K. Smith, associate of the late Senator Huey P. Long in the Share-the-Wealth movement, will launch a \$1,500,000 "Nationalist front against Communism" from New York on Tuesday, Harry Costello, his personal representative, announced here today.

Mr. Costello said the new anti-Communism organization was the result of an intensive eleven-week tour of the country by Mr. Smith during which "more than 400 financial leaders in twenty-two major cities pledged a war chest of \$1,500,000 for a Nationalist front against Communism."

Deserting Union Party

"He has changed his idea of his own role before the public," Mr. Costello said of Mr. Smith, "declaring he took to the Union party only for a forum. He now sets himself up as a Nationalist and as spokesman for a new force against Communism."

"While Smith will attack the New Deal very violently, he will clearly indicate that this Presidential campaign is only one incident of his fight."

He said Mr. Smith was in New Orleans at present, negotiating with James A. Noe, a former Long ally, for dual control of Louisiana's Share-the-Wealth clubs.

The Nationalist movement will get under way, Mr. Costello says, at a mass meeting of New York and New Jersey patriotic societies in New York on Tuesday night, with an address by Mr. Smith entitled "The New Deal's Contribution to World Communism."

Twenty-two Key Cities

Mr. Smith's key units, Mr. Costello said, were in the twenty-two cities of New York, Philadelphia, Boston, Washington, Chicago, Sioux City, Bismarck, Boise, St. Louis, Kansas City, Spokane, Seattle, Portland (Ore.), Los Angeles, Atlanta, Birmingham, Memphis, New Orleans, Jacksonville, Shreveport, Dallas and Houston.

The meeting yesterday and today with Mr. Noe, who succeeded the late Oscar K. Allen as Governor of Louisiana, was described by Mr. Costello as an attempt to gain control of the Long political machine.

"Last week," he said, "Richard Lesche, now Governor, disowned Smith in the name of what he said was Louisiana's Share-the-Wealth Clubs. Smith countered that it was a case of himself disowning Lesche and declared himself and Noe the only remaining allies still loyal to Huey Long's principles."


No doubt you are aware of the Nazi activity for Landon, and the outspoken recommendation for Landon by the Nazi official organ in this country.


My dear Rabbi Silver:


My dear Rabbi Silver:

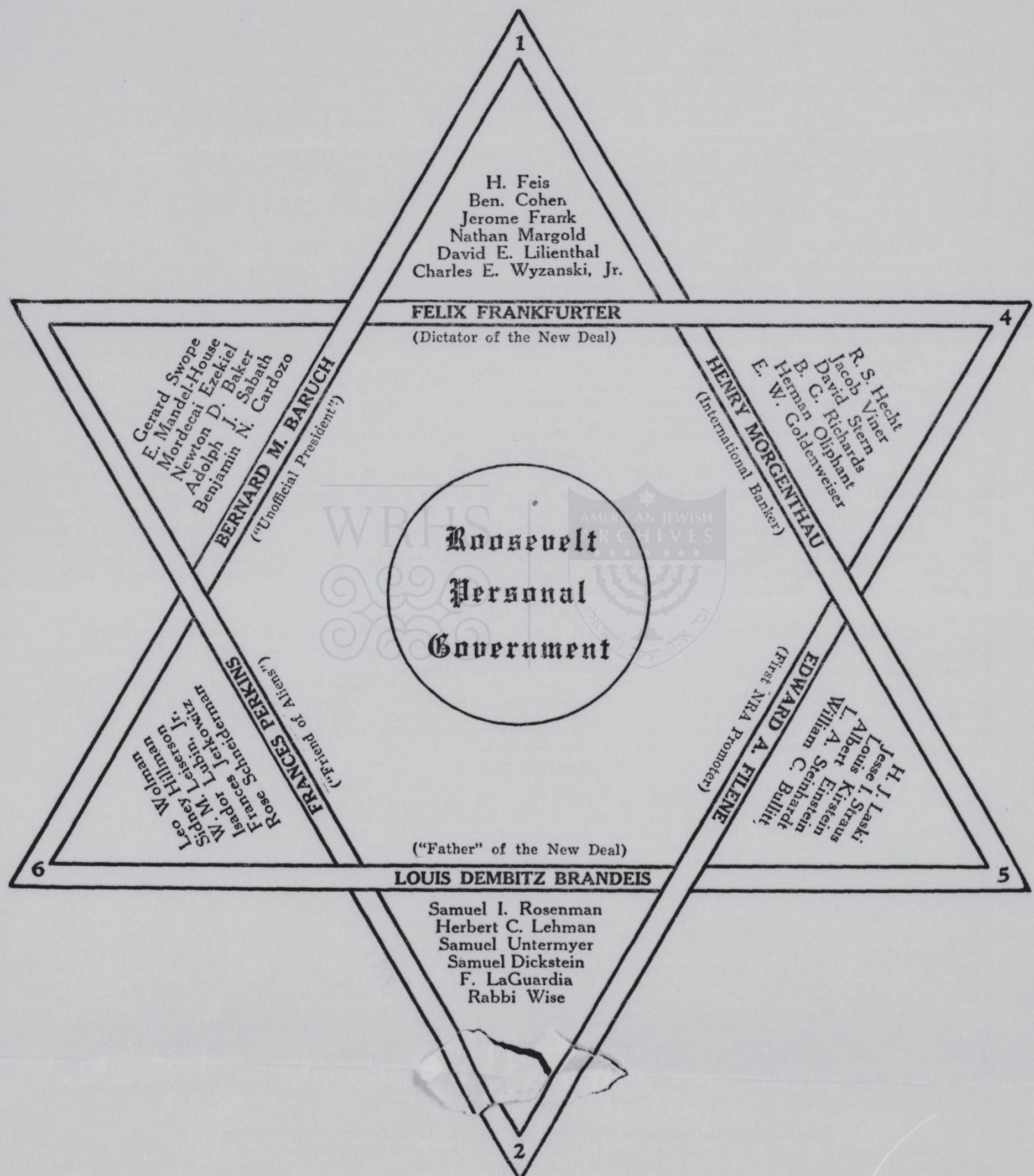

FELIX FRANKFURTER of Mass., *foreign-born*; "Unofficial Presidential Advisor"; listed in "Red Network" as a member of the Civil Liberties Union, legal advisor of Communists; known as Harvard University's "Karl Marx" (Communist) Professor; called Legal-Master-Mind of New Deal in Simon-Schuster 1934 book, "The New Dealers"; branded as *Bolshevist* by late President THEODORE Roosevelt for defending Communist Mooney, still in prison for San Francisco bomb-killing; placed 100 "key-men" in Roosevelt jobs. "He has more influence than any other single person in the U. S." says Gen. Johnson in the Saturday Evening Post of Oct. 26, 1935. Frankfurter has never been elected to any public office. He was nominated in 1932 for the Massachusetts Supreme Court, but defeated by 500,000 protests. He is said to be Roosevelt's choice for the next U. S. Supreme Court vacancy.

"Allies"—Herbert Feis of Mo., Asst. Secy. of State. Benj. Cohen of Mass., wrote Security and Utility Laws. Jerome Frank of Ill., General Counsel of RFC. Nathan Margold of N. Y., Interior Dept. Legal Advisor. David E. Lilienthal of Wis., Director of TVA. Charles E. Wyzanski, Jr., of Mass., Labor Dept. Legal Advisor.

GROUP NO. 2

LOUIS DEMBITZ BRANDEIS of Mass., "Unofficial Presidential Advisor"; Justice of U. S. Supreme Court; "Father" of *Communitistic New Deal*. He is named in "Red Network" as supporter of *Communitistic Commonwealth College of Arkansas*. Highly praised by Albert Einstein, expelled from Germany as a *Communist*. The Chicago Tribune of Sept. 22, 1934, printed this statement by Gen. Hugh S. Johnson: "During the whole of this intense experience (building up the illegal NRA) I have been in constant touch with Justice Brandeis." The N. Y. Times of Jan. 28, 1934, said: "The underlying philosophy of the New Deal is the philosophy of Justice Brandeis."

"Allies"—H. C. Lehman, Governor of N. Y., International Banker. Samuel I. Rosenman, Judge of New York State Supreme Court, whom Roosevelt called his "Right Arm." Lawyer Samuel Untermyer of N. Y., "Unofficial Presidential Public Ownership Advisor," listed in "Red Network" as endorsing the anti-patriotic article, "Professional Patriots," published in the Communist paper, "The Daily Worker." Samuel Dickstein, N. Y. Congressman, who radioed on March 18, 1934: "We Americans must change our laws so they (GERMAN COMMUNISTIC JEWS) can come here at once." N. Y. Mayor F. LaGuardia, "Unofficial Presidential Advisor" listed in "Red Network" as running for Congress on 1924 Socialist Ticket. Rabbi Stephen S. Wise, foreign-born, of N. Y. City, listed in "Red Network" as with the ACLU.

GROUP NO. 3

BERNARD M. BARUCH of N. Y., called "Unofficial President" by Rabbi Gross' Brooklyn Jewish Examiner; *Wall Street speculator and associate of International Bankers*; Wilson-Roosevelt Economic Advisor; admitted to Congress Committee: "I probably had more power than any other man during the World War." He called National pride (patriotism) "A lot of nonsense" (see Chicago Tribune, Sept. 25). Ford's "Dearborn Independent" of July 25, 1925, said: "The Baruch interest, with others, has planned the *Communitistic State*. It will not be necessary to stage a revolution. Upon commencement of war, the U. S. goes under Communism in one day."

"Allies"—Gerard Swope of N. Y., Roosevelt "Industrial Advisor." Col. E. Mandel-House of Mass., Wilson-Roosevelt International Political Advisor, helped to form The League of Nations. Mordecai Ezekiel of N. Y., Asst. Secy. of Agriculture, one of AAA Law authors. Newton D. Baker of Ohio, "Unofficial Presidential Advisor," listed in "Red Network" as "Communist-recommended author"—who urges U. S. to join League of Nations. Adolph J. Sabath, Illinois Congressman, Roosevelt "Special Investigator." N. Y. U. S. Supreme Court Justice Cardozo, reported in Chicago Tribune of April 26, 1934, as having, with Brandeis, "led the Supreme Court from conservatism."

GROUP NO. 4

HENRY MORGENTHAU, SR., of N. Y., *foreign-born*; "Unofficial Presidential Advisor"; related to *International Bankers Seligman and Lehman*. His son is Secretary of the U. S. Treasury and Dictator of the Two Billion Dollar "Stabilization Fund." Sigmund Solomon "superintends" \$5,000,000,000 gold bars in N. Y. Assay Office.

"Allies"—R. S. Hecht of La., *foreign-born, ex-President of American Bankers' Assn.*; "Official Presidential Financial Advisor." Jacob Viner of N. Y., Tax Expert of U. S. Treasury. David Stern of N. Y. and Pa., Member of Federal Reserve Board of Philadelphia and Publisher N. Y. Post; "Unofficial Presidential Advisor." B. G. Richards of N. Y., *foreign-born*; Assistant to National Emergency Council. Herman Oliphant of N. Y., General Counsel to Secretary of Treasury. E. W. Goldenweiser of N. Y., *Russian-born*; Federal Reserve Director.

GROUP NO. 5

EDWARD A. FILENE of Mass., "Unofficial Presidential Advisor; listed in "Red Network" as member of American-Russian Chamber of Commerce. His "20th Century Fund" financed NRA's importation from Europe. Filene was in Moscow during the last *Communitistic International Congress*.

"Allies"—Louis Kirstein of Mass., National Advisory Board member. Jesse I. Straus of N. Y., "Official Presidential Advisor"; promoted Roosevelt Presidential campaign; now Ambassador to France. H. J. Laski, Director of Fabian Socialist Society of England; "Unofficial Foreign Advisor." L. A. Steinhardt, Minister to Sweden. Albert Einstein, expelled from Germany as *Communist*; listed in "Red Network" as conferring with Roosevelt. W. C. Bullitt, "Official Soviet Advisor"; Ambassador to Russia; listed in "Red Network."

GROUP NO. 6

FRANCES "PERKINS" of N. Y., Secy. of Labor.—As Americans are entitled to know public servants' background; noting conflicting data supplied various "Who's Who"; having repeatedly heard "Russian Jewess origin-reports," Robert Edward Edmondson wrote Secy. Perkins personally as follows on Jan. 29, 1936: "Will you tell me for publication when and where you were born; names, nationality and religion of your parents?" Over two months later Miss Perkins replied as follows on April 1, 1936, without proof of assertions: "I was born in Boston, April 10, 1882, daughter of Fredk. W. and Susan Perkins. My parents were both native-born citizens of English and Scotch descent. They and their forebears were Protestant Christians. My father's name was never Lazanski; he was born and died Fredk. W. Perkins. I was not known as Rachel Lazanski; I was known as Frances Perkins, and was married in Grace Church, N. Y. City, Sept. 26, 1913, to Paul Caldwell Wilson, also of American parentage of English and Scotch descent." On April 5 in the N. Y. Herald Tribune denouncing the "utter un-Americanism of a racial whispering campaign," she added: "If I were a Jew, I WOULD BE PROUD TO ACKNOWLEDGE IT." In this connection, does her radical "all-Jewish staff" as below suggest an "utterly un-American" RACIAL PREJUDICE in favor of a minority? (On April 7, 1936, the writer received the following reply to inquiry: "There is no record at the Boston Birth Registry of the birth of a Frances Perkins on April 10, 1882, or during the year specified.") David J. Saposs, *Russian-born*, listed in "Who's Who in American Jewry," was recently appointed Chief Economist of the National Labor Relations Board, on recommendation of Secretary Perkins, according to the American Vigilant Intelligence Federation of Chicago.

"Allies"—Prof. Leo Wolman of N. Y., Labor Strike Board Chairman; listed in "Red Network" as director of Garland Fund (Communitistic). Sidney Hillman, *foreign-born, of N. Y.*; Labor Advisory Board member; President of "Red" Amalgamated Clothing Workers' Union; listed in "Red Network" as Garland Fund director. W. M. Leiserson, *Russian-born*; Labor Board Secretary; listed in "Red Network" as member of Socialist Berger Foundation. Isidor Lubin, Jr., of N. Y., Labor Delegate to League of Nations. Frances Junkowitz of N. Y., Asst. to Secy of Labor; Rose Schneiderman of N. Y., *Russian-born* Labor Dept. Asst.; in "Red Network" as ACLU member.

Roosevelt Congratulates COMMUNISTS on 18th Soviet Anniversary

As reported in the N. Y. Times on Nov. 8, 1935, President Roosevelt cabled Soviet President Kalinin at Moscow on Nov. 7 on "the 18th anniversary of the Socialist (Communist) revolution in Russia," saying: "I am happy to extend sincere felicitations on THIS MEMORABLE ANNIVERSARY with my best wishes for Your Excellency's health and happiness." (Thirty Million Christian Russians have been killed and starved to death by Soviet.)

Look at This Record, Patriots of America, AND WAKE UP!

THEN: "The Revolutionary Council which took over Russia in 1918 was composed of 565 members, of whom 469 WERE JEWS."—From the Overman Report to Congress.

NOW: "The Moscow Central Committee of the Communist Party (which rules Russia) has 59 members, of whom 56 ARE JEWS. The remaining three, Stalin, Lobow and Ossinsky, ARE MARRIED TO JEWS."—From the February (1936) issue of "The Defender of the Faith," a religious magazine of Wichita, Kansas.
