Address until September 1st Rogers Park Hotel, Chicago June 28, 1937 Mr. George Furth 1387 East Blvd. Cleveland, Ohio Dear Mr. Furth: As a result of discussions with Menry Consky of Omaha, Richard Cutstadt of Chicago and Dr. Louis Cershenfeld of Philadelphia, I wish to subvit to you a project to be sponsored in the fall in your community by B'nai B'rith with the cooperation of az many other Jewish agencles as can be enlisted. The attenment of citizenship rights by young people when they reach the age of 2 is not accompanied, in our country, by any impressive ceremony. Young men and women slip into the responsibilities of citizenship almost unconsciously, and the privilege of living in one of the few countries in the world where democratic traditions are theroughly entranched is taken for granted. Fascist and formunist countries to not make this mistake. In a country like Italy, youngsters are initiated into the Balilla, or the avanguardisti, with such impressiveness that the ceremony leaves an unforgettable memory. In that the ceremony leaves an unforgettable memory. In Russia, young people are brought into the Komsomal with such pageantry that they, too, are permanently affected. here are not many things to be learned from dictatorship countries. -ut we can learn not to take for granted the privilege of democracy. the attainment of the age of 21, which brings with it the right of voting and all the responsibilities of sharing in American life, should be marked by dignified, but impressive ceremonies. This, then, is our suggestion. We have selected forty communities in the United States where there is efficient B'nai B'rith organization and dynamic leadership. We suggest that in each of these communities an impressive rally be arranged to which should be invited all the Jewish young people of the community who have, this year, at-

tained the age of 21. The rally should be carefully planned to avoid flag-waving and ballyhoo, but to include inspirational coremony and a fine address by some out-

Mr. George Furth - Page Two 6/28/37 standing personality. The total effect must be such to make the young people feel the exaltation of life in a democratic state. You will note that the suggestion limits the first rally to Jewish sponsorship and Jewish young people. This is done because of its experimental nature. Perhaps, in time, such a celebration can become national, and, if it does, it will be the gift of B'nai B'rith to American life. I need hardly add that such an affair must in no way be associated with political partisanship. There is no better time for inaugurating such a program than in 1937, which marks the 150th and versary of the adoption of the Constitution of the United States. Perhaps, therefore, late October or Tovember would be the best time for such an affair. But should it be held simultaneously in each companity? I would appreciate it very much if you would call into consultation some of the B'nai B'rith leaders in your community who can be relied upon for efficient service and perhaps also other Jewish leaders in the institutional life of your community. One task must be undertaken at once, the task of corraling the names of all the young people in the community who become First oters in 1937. This will involve checking lists submitted by B'nai B'rith parents, Temples, young pople's leagues, Zionist groups, etc. It would help me to get your reactions and, if you have tangible plans for the program, to send them to me as well. I would then pool them and from all of them distil the most worthwhile suggestions which could then go back to all the communities for service there. Dear Dr. Silver:

Many delegates to the District No. 2 convention of B'nai B'rith in Cleveland have told me of the inspiring address you made at that convention. The printed report of the proceedings has reached me, and I have had an opportunity to read what you said.

The November issue of the B'nai B'rith Magazine will be devoted almost entirely to an account of the various ways in which B'nai B'rith functions, and will contain a record of the Order's achievements. It is intended that this issue will be used extensively throughout the country to build an increased B'nai B'rith membership.

Before I read your address at the Cleveland convention, I had conceived the idea of asking you to write a special article for that issue, not glorifying B'nai B'rith, but expressing your opinion of the potentialities of such a lay Jewish organization in American Jewish life at this time, provided such organization were backed by the masses of American Jewry.

After reading your address, I was happy to see that you approached that very thought in it. In fact, toward the end of your address, you specifically say that B'nai B'rith ought to lead the way in America "to a tranquilizing of Jewish life".

I hope I can induce you to use the text of that very address as the basis for a special article for our November issue. The address in its present form is about the right length but if you could condense some of the political paragraphs of it and expand on the specific paragraphs devoted to B'nai B'rith, it would be just what we would want and would, I am sure, be of great value generally.

I realize that this is perhaps the busiest time of the year for you. I therefore would not expect you to do anything on this until after the holidays. In fact, I would not expect the manuscript from you until October 8, but I am forced to write this early because it is my job to plan and integrate the issue, and I cannot do that unless I have assurances from the various contributors that I may expect their material. I make bold to address this request to you at this busy time because I feel an editing of your convention address will take very little time as compared to the writing of a totally new article.

I would, therefore, be grateful for a word from you at your earliest convenience to the effect that I will receive what I have asked for by October 8.

I am glad to note that the war in many respects seems to have improved the Jewish situation in Palestine, particularly with regard to buying more land for colonization.

While I do not for a moment think that Germany will triumph over Great Britain and France in the present conflict, it seems, nevertheless, that in planning for the future of Palestine, the possibility of a Nazi victory must be considered in the light of how such a disaster would affect the future of the Jews in Palestine.


I have no doubt that the Jewish agency is studying the effects of such a tragic situation and is planning a course of action, under such circumstances. I wonder if you can throw some light on the point

Dear Rabbi,

I am not sure whether this letter addressed to the office of the United Palestine Appeal will reach you personally but if it does I would appreciate a response during some spare moment in your very active and useful life.

Your letter under date of December 29 relative to proposing my name as a member of the National Council for Palestine is received and, of course, you have my consent.

For the past year I have had the desire to write with reference to the matters hereinafter set out, but I have always hesitated because of a desire not to interfere in your undivided effort toward Palestine. As you can tell by the stationery, I am one of the officers of District Grand Lodge No. Two and I am, therefore, giving most of my time at present to this work. I am a Past-president of the Terre Haute Zionist District and I still devote a good portion of my time to that work. You are also acquainted with the fact that the B'nai B'rith is vitally interested in the Palestine cause. There are thousands of us in B'nai B'rith who are devoting a great deal of our time in the same program. I recall at the Z.O.A. Convention in Cincinnati of meeting a great number of men active in B'nai B'rith. Our interest in Palestine starts with Henry Monsky and ends with individuals in practically every community. We cannot say the same for the leadership represented by your group.

The most aggravating problem that we have in District No. Two is Cleveland. The leadership of B'nai B'rith has discussed this problem without success until it has become threadbare. The most important reason we are given by Clevelanders for the failure of B'nai B'rith to penetrate the Cleveland community is the refusal of the outstanding leadership of that community, represented by yourself and Rabbi Brickner, to cooperate. It has become an established fact that if both of you were to lend your names and your influence to our group that we should be able to accomplish more in our membership campaigns. have discussed this matter with you. This letter, therefore, may be just another far cry in the wilderness.

I am now in charge of membership this Spring and next Fall and I shall leave no effort undone to accomplish my work whether it proves successful or not; hence this letter to you.

The time has come when each recognized Jewish organization must recognize the work and effort of the other as the first step essential to national unity. That, I believe, has more or less been achieved. The second step is to encourage the success of the other groups --- not disparage their efforts. Our cultural and spiritual strength in American life lies in the strength of each organization which helps to contribute toward the source of that strength from the Synagogue on down. The B'nai B'rith like the Synagogue and the Zionist Movement is a strong flowing tributary.

Your devotion to our Order for a month during our campaign would be a source of inspiration to the untapped reservoir of Cleveland. Will you please favor me with your reactions to this plea?

As my letter to you came as a surprise so did your letter to me come as a surprise.

One of the excuses which the B'nai B'rith leaders in Cleveland have constantly given as the failure for our campaign, I repeat, is the fact that the real Jewish force in Cleveland is expended in other activities. By this I do not mean that men like yourself should become an active solicitor for membership, but I do believe if during the membership campaign, large meetings of prospective members were held, in which men like yourself and Rabbi Brickner took an active interest, either by way of speech or publicity, that our membership would increase. If it did not increase, we should then know that the reason for the failure of B'nai B'rith to penetrate Cleveland is due to the lack of a dynamic leadership amongst those of our own group.

I take it from your letter that in the event you are called upon to serve the B'nai B'rith in Cleveland, that you will not refuse if the time is appropriate. With your kind permission I should like to convey these sentiments to the active B'nai B'rith men in Cleveland.

At some moment when you are not covered up with your tremendous responsibilities, I would appreciate your composing a letter in which you encourage association with the B'nai B'rith, which I might have incorporated in our publicity program. I want you to know that I am one of those who believe that the voice of the rabbinate must be thundered in every corner of this country, especially presenting to the American Jew the affirmative aspects of Jewish life. I am using the rabbis of this district wherever possible, making it emphatic that in this way only, can we strengthen our forces.

Under the terms of the UJA Agreement, the Jewish National Fund is not authorized to carry on any campaign activities for other than its traditional collections. The Jewish National Fund shares on a 50-50 basis with the Keren Hayesod the total income of the UPA from the UJA. The UPA will receive in 1942 from the UJA about \$3,300,000, which means that the JNF will get from the UPA this year \$1,650,000. The JNF receives no direct allocations from the UJA. There has been considerable criticism in some other communities about JNF campaign activities, in some cases justified, and in others, not. The JNF Council in your community is probably the best judge of this matter. It knows what the tradtional collections are, and it should not go beyond them. Of the numerous tasks with which our people will be confronted

upon the liberation of the world from the Nazi rule, the Convention singles out the care for the physical and spiritual rehabilitation of the children and the vouth, both of those who succeed in escaping to Palestine and of those who will have to remain in the Diaspora for a shorter or longer period, as one of immediate urgency for Palestinian B'nai B'rith to tackle. 1. In Palestine it will be necessary to establish homes and asylums for refugee children, particularly for orphans. It will be necessary

to provide greater facilities than have been available hitherto for voca-

tional training and for the education of such refugees in Jewish values. Careful psychological supervision of the young people, particularly after they completed their vocational training, will also be among the pressing educational needs. 2. In the Diaspora. survive the ordeal of the war. A new content will have to be given to their lives and their Jewish self-expression be promoted. Schools, training farms, and community centres will have to be established. The Palestinian lodges, jointly with the Junior B'nai B'rith, in cooperation with other bodies and working in harmony with the Supreme Lodge in the United States, will undertake the preliminary research and the preparatory practical work which will be required

to pave the way to a successful realization of this heavy programme. 3) Junior B'nai B'rith The Convention regards Junior B'nai B'rith as an important nucleus

for the formation of a movement that will consider it as its pioneer

2-000 (helutz) task to train its members for the guidance and education of Palestinian youth and a pedagogic and constructive effect amongst the children of the Diaspora in the spirit of Zionist and B'nai B'rith ideals. The campaign against illiteracy and the care for the spiritual and moral welfare of children of certain sections of the community deprived of the advantages of elementary education are essential prerequisites for the realization of our endeavour to make all sections of the Yishuv active partners in the life of the nation and in the upbuilding of the country. In these countries lodges are in existence which united the finest local Jews, and perhaps they will serve to exercise a good influence on the general conditions of the communities, and accept a certain number of Jewish refugees from the inferno of Europe. We shall perhaps, succeed in making such connections as will be a considerable help in solving the Jewish-Arab problem. The Convention sends its sincerest greetings to the District Lodges and the various other lodges of B'nai B'rith in the Near-East countries and calls on them to cooperate with the Palestinian Lodges in the rehabilitation of the Jewish nation in the New World of the post-war period. The year 1943 brought increasingly gloomy news of the condition of European Jewry. The plan of destruction of Hitler and his satelites extended to new barbaric extremities. The entire Jewish Community placed itself at the disposal of the rescue project, the Recruiting Fund served both recruitment and also rescue, its contributions being chiefly devoted to saving the Iews of Europe, and thus obligating the active participation of members of B'nai B'rith in Palestine. 1943 was, however, also a year of important events in the history of B'nai B'rith itself. The Grand President visited Egypt in January of that year and there laid the foundations for close co-operation between the two Grand Lodges of Egypt and Palestine in accordance with the resolution to encourage such contact with the Centres of Jewry in Oriental countries. The lamentable decease of the Grand President of the District Lodge, No. 16. Mr. Michel Berman, interrupted this activity, but with the election of Brother Castro as Grand President it had been resumed. The principal project to which attention was devoted on the part of the District generally was the foundation of the Children's Home, an Institution for immigrant children and also of residents who have been affected psychologically by their experience as refugees, who have suffered from Nazi tyranny, hunger or disease, or as a result of bad social or difficult family conditions in Palestine. This Home, established upon the special request of Miss H. Szold has accommodation for 36 children some of whom are refugees who came here via Teheran, and some from local social organizations. The Children's Home already fulfills a very valuable function in restoring to the children a balanced mind, and preventing dangerous impairment of their growth and normal development. It is at present temporarily housed in a part of the building used as the Immigrants' Home of the B'nai B'rith, and is now seeking a permanent building, a difficult problem during war conditions owing to restrictions on building and purchase of building materials. The annual budget totals P.4.000 about half of it being provided by public institutions. A special appeal among members of the B'nai B'rith for the maintenance of the Home has so far produced about LP.3.000 \$11,000. Another project of this type is the School for immigrant children and technical courses established by the Benjamin de Rothschild Lodge of Rishon-le-Zion, with the assistance of the Grand Lodge. This Institution provides elementary education and technical tuition suited for immigrant children of the Oriental Communities who have arrived here during the past year from Yemen and Turkey, and who unfortunately lack elementary instruction. This School which is still in its early stages, already provides for 50 children and meets, although only partially, the painful problem of providing education for the immigrant youth of Oriental Communities. In the same year the Rabbi Akiba Lodge of Tiberias established an Institution for penurious convalescents taking the waters of the Tiberias hot springs. The Tel Aviv Lodge established a Club with reading-room for children and also a second tea-room in another quarter of Tel Aviv. 1943 was a peak year in respect to the number of new members who ioined the Order. Credit must be given for this activity to the Membership Committee under the chairmanship of Brother A. H. Frankel. Professor at the Hebrew University, which is now working on a plan for the establishment of several additional Lodges in the various towns and villages. Mention must also be made of the Central Cultural Committee and its work in drawing up cultural programmes for the Lodges. under the chairmanshin of Brother Professor Hugo Bergman. The Committee for the children's project under the chairmanship of the Grand President with the participation of Professor Rabbi S. Asaf, is occupied in organising the youth activities of the District Lodge. It has established subventions for Youth Organisations in order to encourage their interest in social work among the Communities and Jewish quarters. It has introduced not only social but also educational trends in this activity. The Grand Lodge produced for Palestine use and the operations of the District an adapted Hebrew version of "This is B'nai B'rith." as well as extensive reviews of the activities of the Order throughout the world and in particular in U. S. A. and Palestine. The Grand Lodge proposes to encourage the initiative of brother immigrants from Central Europe in gathering material concerning the property of the European Lodges, in order to submit same to the Supreme Lodge for suitable action at the proper time. In 1943 most Lodges celebrated the centenary of the Order which was an appropriate opportunity for classification and further study of the fundamental ideals of the Order. The official function was postponed in accordance with the decision of the Supreme Lodge until the close of the war. During this period the position taken by the President of the Order, Brother Henry Monsky, at the all-Tewish American Conference, served as a source of pride and special encouragement among all brethren as well as all sections of the Jewish Community, who see in the increased interest of the World Order in Palestine not merely assistance to Palestine Jewry but the most effective and constructive manner of rescuing the Iews of the Diaspora. Palestine B'nai B'rith expressed its appreciation by inscribing President Monsky in the Golden Book of the Jewish Nationality.

3-000 During the same year the budget of the Grand Lodge again rose from LP.900 to LP.1,200. The devoted Treasurer of the Grand Lodge, Brother Moses Levin, passed away, and at present Brother Alexander Eliash, Banker, functions as Treasurer. The following is a brief summary of the special activities in which the Grand Lodge engaged during the three years of period under review: 1. Social Service Social Service activity continued normally and even expanded quite considerably in the years under review. Except for unusual cases the District provides constructive relief. An instrument of great value in this sphere is provided by the Loan Funds which are maintained by the majority of Lodges and which serve to help the members and also the public at large by granting loans without interest for trade purposes. The total capital increased during this period by about 25% and today has reached a grand total of about LP.7,000 \$50,000, which for the most part is in circulation. The Relief Fund for the permanent assistance of immigrant and refugee brethren continued its normal activity directed by the Grand Lodge. In order to concentrate and develop social services a Central Committee for these activities was established under the chairmanship of Brother Isaiah Press, the Honorary President of the Grand Lodge. 2. Cultural Activities and Inter-Lodge Relations Cultural activity in the various Lodges and the District as a whole occupies a most important position. In addition to the specific pro-

Cultural activity in the various Lodges and the District as a whole occupies a most important position. In addition to the specific programmes of the Lodges concerned with local affairs and those of our own members, interest was concentrated, on the initiative of the Central Committee for Cultural Affairs, under the chairmanship of Professor H. Bergman, upon four or five principal topics such as

1. The characteristics of B'nai B'rith in connection with the centenary.

2. Our function at the present time.

3. Discussion of the programmatic address of the Grand President, and

4. Youth problems in Palestine.

Upon each of these subjects a series of lectures was arranged which stimulated a thorough and sound clarification of our purposes and methods. We wish to mention the closer ties between the Lodges which are manifested in the reciprocal visits of brethren and exchange of proposals and lectures on various subjects.

Important tasks were carried out in the internal development of the Lodges by the women, who have accepted a very full share of our social service and cultural activities for the entire District.

War Efforts During the

During the last year attention has been given to the problem of demobilisation of our soldiers for although the war is still at its height, as elsewhere, we cannot postpone indefinitely the consideration of post-war issues. A special Committee is assembling material and preparing proposals for the most effective contributions of B'nai B'rith of Palestine to the solution of these problems, when hostilities cease, particularly in respect to the return to civil life of the hundreds of thousands of civilians in the various military and security services.


