#### Principles and Purposes of the Society:

<u>Preamble</u>: <sup>B</sup>nai Zion, the fraternal Zionist Organization of America, recognizes the need for an "open forum" where Zionists, cognizant of the importance of a reoriented American Zionist movement following the establishment of Israel, will have an opportunity of examining current issues in Jewish life and through an open interchange of views and ideas, crystallize opinions which will help to revitalize the Zionist movement in America. To provide such a forum and to implement these ideas, Bnai Zion has established the Dr. Abba Hillel Silver Zionist Society, and through its work to help not only the Zionist movement but the American Jewish Community as a whole.

The name of Dr. Abba Hillel Silver was selected for this new group in Bnai Zion as a means of paying tribute to the outstanding champion of the Zionist movement in this country and particularly for the important role he played as the Jewish people's spokesman before the United Nations.

The dynamic, vital and creative Zionism which Dr. Silver has always displayed will be the pattern which this society will seek to follow. The society will aim:

1) to stimulate creative efforts within the Zionist movement and to maintain a vigorous and widely-supported American Zionism.

2) to develop a Zionist pattern of living in this country which will serve as a guide to all members of the American Jewish Community.

3) to help forge a strong spiritual and cultural link between the people of Israel and the Jewish Community in the United States.

4) to provide a forum for the open and unfettered interchange of ideas and views regarding Jewish life in America.

My dear Dr. Silver:

Now that my rage and disappointment over the antics of our colleagues in Jerusalem is subsiding, I realize how useless it is for me to limit myself purely to the practice of my profession. The truth of the matter is, Dr. Silver, that I am an incurable Zionist and it rests with you to decide whether I can also be a happy one.

Since my return from Jerusalem, I have become convinced more than ever before that the future of the Z.O.A., of Zionism in general, and possibly of Israel itself, lies in a great measure in your hands. The weakness and ineffectiveness of the Z.O.A. and its leadership contributed greatly to the "Debacle of Jerusalem". I am convinced that you and you alone can provide the leadership necessary to bring about an effective change.

After you left Jerusalem, Sprinzak spoke to me on three different occasions asking me to help you "see the light", and that Israel and Zionism need you. Such apparently hopeless "antis" as Ezra Shapiro and Joseph Weiss spoke to me about the hopelessness of the Z.O.A. unless you come back. At an overflow meeting held at the Waldorf Astoria the other night, my demand that you return to leadership brought forth tremendous enthusiasm; and when I read the enclosed clipping from the Jerusalem Post, I felt like a rabble rouser because of the exclamations from the audience that indicated a determination to purge the Z.O.A. at once.

Jacques and I are ready to go to Cleveland alone or with a committee to convince you of the need for positive action at once. I know that your charming and wonderful wife will probably be reluctant about having you return to the strain and decision that

My dear Dr. Silver:

I sincerely hope that you will find it possible, although I have no desire to impose unnecessary burdens on you, to visit a few key communities on our behalf. In extending the invitation, it is understood that the matter has been cleared locally with all parties concerned and now that the position of the Jewish National Fund has been clarified in Jerusalem, I believe that some of the difficulty that we may have experienced in the past will be eliminated.

I would not think of asking you to go to all the cities that have requested you as their guest speaker. Of immediate importance are two communities and I have heard from the leaders in both cities urging, insisting and pleading that you should be the speaker this year.

1. Milwaukee is having a large-scale affair on November 11th which has been cleared with the Welfare Fund. The work in Milwaukee has been practically paralyzed excepting for the smaller collections and this year after a great deal of effort we have persuaded them to hold an annual function. Mr. Seidelman, who is the leader of the JNF and one of the important people in the Welfare Fund, is prepared and willing to go through with the affair but he has made the condition that you must be their speaker. If it is humanly possible, I would beg of you to accept this invitation.

2. Los Angeles has been trying for years now to have you as their guest speaker at the Annual Chanukah Festival which is the largest affair in the community. It brings out the largest attendance and also yields the largest sum of money. I am, therefore, renewing Mr. Strimling's request that you should be their guest speaker on December 23rd. San Francisco has fixed the date for their Chanukah dinner for December 15th but they are holding an option for December 20th and should you agree to go to Los Angeles and also San Francisco, they will have the San Francisco affair on December 20th. If you are unable to go to both cities then it would be quite all right for you to go to Los Angeles only.

It would be a real service to the JNF and I should be deeply grateful if you will give this invitation your most earnest consideration and advise me as soon as possible. If you are too busy to write a letter, I should appreciate a telegram. Dr. Abba Hillel Silver - 9/20/51

My dear Friend:

Thank you so much for your letter of September 17th and also the one of September 20th. I cannot at the present writing give you my reactions to your letter. I am at the moment very busily engaged in congregational activities after an absence of nearly three months from my post. The High Holy Day season has imposed additional responsibilities upon me.

I have really not had a quiet period for thought during which to think through the questions which you and other friends have in recent weeks, since my return from Israel, raised in their communications. I should like to wait a while before I make any final decisions. I am also waiting to see what will be the final outcome of the negotiations for a coalition government in Israel.

As regards my addressing the meetings for the Jewish National Fund, I am afraid that here, too, I must be allowed a little time to catch my breath. I wrote to Mr. Strimling in Los Angeles that I could not accept his invitation inasmuch as I must be in my own pulpit on that Sunday and I already have quite a number of other important congregational activities on that day. Before I left for my JNF tour of South Africa, I accepted quite a number of lecture engagements for the next few months, and I am afraid that I am unable to take on additional out-of-town commitments at this time.

On the eve of the New Year I should like to extend to you and Dorothy Virginia's and my warmest greetings and best wishes for the coming year. I hope to have the pleasure of seeing you in New York Before long.

I have taken up with the New York United Jewish Appeal the question of postponing the B'nai Zion dinner from February 8th to March 1st.

The problem in New York is that they have no agreement with B'nai Zion which would permit them to run a dinner in New York City for fund raising purposes at any time during the UJA campaign which covers the period from February 1st to September 1st.

The B'nai Zion dinner is a fund raising affair for the JNF. The position of New York City UJA is that since the Jewish Agency will make a substantial grant of some \$6,000,000 out of UJA funds to the JNF in 1953, there is no excuse for running a fund raising function for JNF in New York, particularly during the height of the New York UJA campaign.

Since New York objects strenuously to the February 8th date, it cannot possibly agree to the March 1st date when the New York campaign is gathering its greatest momentum.

The matter now seems to be up to B'nai Zion to resolve and I am afraid that it is completely out of our hands here. Because of your long familiarity of the situation here, I am sure that you understand.

At the meeting a few weeks ago attended by Dr. Goldmann, Mr. Locker, Mr. Zuckerman, Mr. Tisher, yourself and myself regarding Jewish National Fund fund-raising problems, I raised the question of the B'nai Zion Annual Order Day Dinner which was held this year on March 1. I pointed out that it was surprising that this dinner was held as late as March 1 which constitutes a reversal from all our attempts of previous years to move the B'nai Zion dinner forward earlier in the year. Indeed in 1952 the dinner was held in early February in recognizion of the need to give United Jewish Appeal full priority during the Spring months. You stated at our meeting that Rabbi Abba Hillel Silver spoke to Mr. Henry Bernstein on the telephone about this matter explaining that technical reasonsmade it impossible to have the dinner before March 1 and that Mr. Bernstein agreed to this one exception.

I find that I must advise you that Mr. Bernstein denies having discussed this matter with Rabbi Silver and having ever agreed to make an exception for the Annual Order Day Dinner.

If there is anything you can advise us which would tend to clarify this matter, I would greatly appreciate hearing about it.

My dear Dr. Silver:

I find myself in a quandary as you will see from the attached letter received from the office of the Jewish Agency. It is Honorary Vice Chairmen not a very enviable task to be the head of the JNF in these difficult times.

There are two matters that I wish to bring to your attention:

1. You will remember our telephone conversation in postponing the Bnai Zion dinner. You indicated at that time that you would communicate with Mr. Bernstein. That is what I conveyed at the Agency meeting when we were taken to task for holding our dinner in March whereas we had planned it earlier.

2. It is a great source of personal regret not only to me but to all my associates that after we had completed plans to officially receive Dr. Granott, we learned that the UJA was planning a meeting in New York on the same night. Since we had already several postponements and invitations had been sent out for the meeting of our National Advisory Board which is so urgently necessary, it is impossible to cancel the dinner at this late hour. I want you to know the facts so that there should be no misunderstanding as the JNF and I would not permit anything to interfere with the UJA, particularly with a function at which you are speaking. It is just one of those things and it so happens that the majority of those coming to this dinner are not exactly in the class of the large donors. We would have avoided the conflict but unfortunately when we sent out the announcements we did not know nor was any announcement made that you would participate in the program.
