Dear Rabbi Silver:

No doubt through the Jewish and non-Jewish press, you have read of the contemplated conference called under the auspices of the United Jewish Campaign and the Joint Distribution Committee to be held in the city of Chicago the evening of October 9th and the whole of October 10th.

The purpose of this joint conference is to present, first, a complete report of the United Jewish Campaign by David A. Brown, National Chairman, which will deal with the results in all of those sections of the United States and Canada, in which more than fifteen hundred individual campaigns have been conducted.

Second, to receive a report from Felix M. Warburg, Chairman of the Joint Distribution Committee, on its work in Europe. This report will review particularly the work of the Joint Distribution Committee during the past eighteen months.

Third, Louis Marshall will present to the conference the reasons which made necessary the raising of the quota from \$15,000,000 to \$25,000,000.

Fourth, to receive the reports from a number of outstanding men and women who volunteered their services to visit Poland, Roumania, Bessarabia, Latvia, Lithuania and Russia, and who have had the privilege of meeting in all those countries the representative Jews who carry on in a voluntary capacity the work of the Joint Distribution Committee, and who have seen with their own eyes the conditions of our people, the type and kind of work that we are doing, and the results of this work.

Among those who will present reports will be James N. Rosenberg, Vice-Chairman of the Joint Distribution Committee, who only recently returned from Europe and who spent considerable time in Russia; Herbert H. Lehman, Vice-Chairman of the Joint Distribution Committee and Chairman of its Reconstruction Committee, who has been in conference with the European leaders associated with us in this great relief enterprise; Dr. Cyrus Adler, Chairman of the Cultural Committee of the Joint Distribution Committee, who has just returned from Europe; Dr. Maurice B. Hexter of Boston who has just returned from a trip covering practically every country including Russia, in which the Joint Distribution Committee is functioning; Jacob Billikopf of New York and Philadelphia, who returns from a similar trip about the middle of September; Dr. Henry Moskowitz, Chairman of the Ort Reconstruction Fund, who has just returned from Europe; Mrs. Rebecca Kohut of New York; Dr. Ludwig B. Bernstein of Pittsburgh; Irma May;

Hortense Breckler; Stanley Folz of Fhiladelphia; Dr. J. W. Newman of New Orleans; Captain Frank Connes of New York -- all of whom have just returned or are returning from those countries in which the Joint Distribution Committee is at present working.

In addition to the above, there will be in attendance at the conference, Dr. Joseph A. Rosen, who has given of himself with a perfect abandon during the past five years as Director of the Russian activities of the Joint Distribution Committee; and Dr. Bernhard Kahn of Berlin, who for the past eleven years has been associated with the Joint Distribution Committee in all of its work and for the past four years has acted as its European Director.

It is contemplated that reports will be received from state chairmen and from state treasurers in those states where campaigns have been conducted. While fifteen hundred campaigns have already been conducted, there are still approximately five hundred campaigns yet to be completed in those communities where for local reasons, the campaigns have been postponed until this fall. A discussion of the coming campaigns and a general discussion will take place from the floor, in which it is expected that many of those present will participate.

The above program indicates that this is to be without question one of the most important gatherings of its kind in the history of America, and you, as one of those who have for so many years played an important role in this great piece of human engineering will want, we are sure, to be in attendance at this conference.

We believe, because of the importance of this conference that it is your duty as well as the duty of Jews throughout the country, to give the 9th and 10th of October to this cause, in which all of us are so deeply interested.

We are enclosing an acceptance card and a return envelope, and would appreciate your mailing them immediately upon receipt of this letter.


I trust that you will find it possible to accept the invitation of the community and of both National organizations.represented in the campaign.
