from Dr. Joseph Bloch of Vienna, his unpublished manuscripts in the Rphling case. At that time, the members of the Conference morally bound themselves to raise the sum of approximately \$1500.00 for this purpose. We regret to state that only about one-half of that amount has thus far been raised, and we call upon the members of the Conference to redeem their pledge by sending to the Treasurer as liberal an amount as they possibly can for the Bloch Fund.

## TO THE MEMBERS OF THE CENTRAL CONFERENCE OF AMERICAN RABBIS:

Dear Colleague:-

Your attention is called to the action of the Executive Board represented in the first statement which follows and to the action taken by the Washington Conference as represented in the second statement.

The Executive Board, at a meeting held at Washington April 12, 1921, voted that the Central Conference of American Rabbis co-operate with other religious bodies of our country in an effort to bring about a reduction of armament-building by the nations of the world.

It agreed to unite with them in a simultaneous presentation from the pulpit of the religious and moral sense of humanity anent this great question.

You are, therefore, herewith requested to speak to your Congregation on the topic of the reduction of armaments, at a service on, or as near as possible to, May 21 or 22, and to present to your people the consideration of this problem whose solution means so much for the promotion of peace and happiness among men. This solution can be incalculably helped by our own Government, to whose initiative it is believed the world will gladly respond; for "the work of righteousness shall be peace, and the effect of righteousness quiet and confidence forever."

"Whereas it is a well established fact that according to the Jewish ritual law, unfermented wine may be used on all occasions for 'Sacramental purposes', and

Whereas the Central Conference of American Rabbis has recommended the use of unfermented wine for all religious purposes,

Therefore, be it resolved, that we the members of the Central Conference of American Rabbis refuse to sign any and all requests for the use of unfermented wine for sacramental purposes."

# TO THE MEMBERS OF THE CENTRAL CONFERENCE OF AMERICAN RABBIS:

In these times of widespread suffering, many are the worthy appeals for help that come to you almost daily. But the fact that you are already over-burdened will not deter you, I am sure, from giving your loyal assistance to the American Committee of the China Famine Fund which has been appointed by President Wilson and in whose behalf I am addressing this communication to you.

Conditions in China are so horrible that they beggar description. Literally millions of human beings there face death by starvation. Unless we in this land of plenty come to their rescue, nothing can save them from destruction.

Will you help relieve this situation not only by your personal contribution to the cause but also by assisting in the organization in your community of an efficient local committee to take up the work?

The Protestant churches of America are planning to devote Sunday, Feb. 6th, to a special plea for the cause of starving China. It has been suggested that we set aside Sabbath - February 5th - or Sunday - February 6th - for a similar plea.

I shall depend upon you to respond to this call and to do what in you lies to relieve a situation that threatens the lives of millions of human beings.
