

Dear Sir: President Feiss has called my attention to the fact that you have recently been elected to membership in the Chamber of Commerce. I am writing to advise you of the Club facilities which your membership makes available to you.

The Chamber of Commerce Club occupies three entire floors of the Chamber building - the fifth, sixth and seventh. On the fifth floor we have our lounge and writing rooms, check room and lavatory, billiard room and barber shop. The regular charge for such work is made in the barber shop. A charge of sixty cents an hour is made for use of billiard or pool tables. The lounge and writing rooms are open from 8:co A. M. to 5:co P. M. every business day. The sixth floor contains the main dining room and alcove room with tables for two. Prices are reasonable; food and service above reproach. The dining room is open from 11:30 A. M. to 2:co P. M. every business day. The seventh floor is occupied by private dining and committee rooms.

Many members find it convenient to hold their business conferences here. I hope you will make use of the Club facilities which have been provided for you.

I hope I may soon have the pleasure of seeing you at the Club.
