

My dear Mr. Jamison,

Permit me to acknowledge your letter of August Twenty-first, inviting me to serve on the Cuyahoga County Committee for the Defense Test Day to be held on September twelfth. I regret that I cannot see my way clear to accept your kind appointment. I cannot see the widdom, or the value, of such an enterprise.

Army and Navy for that purpose. These organizations should of course, be kept up to maximum efficiency through practice, mobilization, maneuvers &c. But just where civilians can aid our national defense thru parades, picnics and oratory, I fail to see. I fear that the indirect results of such a military holiday would be to keep alive war sentiment and war psychology and fan the flames of national chauvinism - things which have proved destructive of the highest interests of humanity.

I am not, of course a pacifist. My services to our government during the last war will show that. Yet I believe that the President of the United States would at this time have served the interests of America and of mankind better if, instead of calling for a National Defense Day at a time when our Country is at peace with the world and in danger of no attack, he had called for a National Peace Day, summoning the conscience and thought of the world to serious and prayerful contemplation of the greatest task confronting mankind today - the outlawry of war.

of the Chamber Citation and Medal for Distinguished Public Service, the name of Dr. Abba Hillel Silver.

I am not suggesting his name primarily because of his match ass oratory, his scholarship, his influence as a preacher, his participation in manifold cultural, civic, and humanitarian movements in Cleveland, nor because of his position of leadership in World Jewry.

I suggest his name rather because of his deepseated love for liberty and democracy and his great contribution to these ocuses.
