Dear Friend:

A movement has been started to elect a charter commission to recommend changes in the charter of the city of Cleveland. This commission of fifteen members will be elected by the people and will hold public meetings during the next year to consider all proposed changes and new ideas for our city government. The commission will then recommend a new charter which will not become a law until approved by the voters at next year's election.

A citizens committee of 1000 is being formed to help secure the voters' approval of the idea of having a charter commission, and to elect fifteen members of the commission. This citizens committee approves of the administration of City Manager William R. Hopkins and believes that any changes in the charter should be made in the orderly and fair method of a charter commission.

The fifteen candidates who have been nominated for members of the commission are as follows:
