To the Members of The Federation of Jewish Charities and the Jewish Community of Cleveland:

The generous heart of Cleveland is again being appealed to for the relief of suffering incident to the Great War, and for the comfort and well-being of the thousands of our brave boys who are in Service.

This time the appeal is not an isolated one, coming from one war agency or another. It is the joint appeal of *all* the nationally accredited war agencies. Each agency, in and by itself, would make a compelling claim upon our generosity. Joined in one mighty appeal, they are irresistible.

First and foremost in this Sacred Union is the Red Cross—the Blessed Angel of the Battlefield—the symbol of hope, of comfort, and of consolation to all who dwell in the shadow of death amidst the ruin and desolation of war. It has gone with our beloved ones to France and is constantly watching over them.

The Y. M. C. A. has rendered invaluable service to the spirit and morale of the American forces by the broad and intelligent provision which it has made for the physical comforts, the social entertainment and the spiritual needs of the men in Service. The Y. M. C. A. has spelled enthusiasm, comradeship and—above all—clean manhood.

The Knights of Columbus has splendidly co-operated in this meritorious service. No denominational lines have been drawn—no dogma divides the devotion of all Americans to the one great cause—Victory!

The pitiful plight of the Armenians makes an additional demand upon our liberality. No people has suffered so cruelly as it has, no people has been subjected to such a deliberate and horrible policy of extermination through massacre as has the sorely tried people of Armenia.

Eleven other war agencies - each deserving your utmost consideration - have joined this Sacred Union.

But perhaps of prime importance to us as Jews is the fact that the Jewish War Relief Fund and the Jewish Welfare Fund for Soldiers and Sailors are part of this Union.

We have responded freely in the past to the terrible needs of our brothers in the occupied territories of the war. Our brothers did not appeal to us in vain. But their needs have not decreased during the last year. Their suffering has not been lessened. Hunger, with death in its trail, is stalking freely through the Jewish communities of Russia and Poland. Privation is almost universal. Infant mortality, due to lack of nourishment, has grown to appalling proportions. European Jewry is again appealing to us. We saved them in 1917. Shall we let them starve in 1918?

The Cleveland War Council, deeply aware of the plight of our unfortunate brothers, has apportioned for Jewish War Relief, Three Hundred Thousand Dollars out of the War Chest of Six Million Dollars which it aims to raise. This generous apportionment is an expression of its faith in the liberal response of the Jews of Cleveland.

The Cleveland War Council has also set aside Thirty-Five Thousand Dollars of the War Chest for Jewish Welfare Board work in the United States Army and Navy. The Jewish Welfare Board has placed Jewish Social Workers in every Camp and Cantonment in the United States. It has organized the religious life of the Jewish men in Service, and has sympathetically catered to their spiritual needs.

In all—\$335,000 has been devoted to Jewish War Agencies—a greater amount than the Cleveland Jewish Community has heretofore raised.

The War Chest Idea should meet with the hearty approval of every citizen. It is the pooling of efforts which heretofore have been expended in a series of campaigns and their concentration upon one big campaign makes for utmost efficiency it saves the time and energy of the splendid men who volunteered their services to these campaigns—it spares the citizens of the community the unavoidable annoyance of frequent solicitation. And above all, it brings the greatest result!

The War Chest Idea is moreover thoroughly American. It unites the appeals of all faiths and creeds into one broad humanitarian appeal. The concern of one becomes the concern of all. We are united by a common purpose, and every agency which finds its inspiration in this common purpose should meet with our common support and approval.

We feel confident that the Jews of Cleveland will respond freely and generously —even in greater measure than they have done heretofore. It is our sacred duty to our beloved country in this hour of need—to our boys in Service who are ready to make the supreme sacrifice for American ideals—to our afflicted brothers across the sea who are in dire need of food and raiment.





Dear Sir:

In answer to your letter of April 11th, asking if the Federation of Jewish Charities desires to be included in the May Campaign for the purpose of providing it's needs for Jewish War Relief and Welfare Work for 1918, I beg to express to the Council the appreciation of the Board of Trustees for the invitation thus extended, and to say further that the Board, at its meeting to-day, decided to consolidate its interests in the general Drive.

The amount required of Cleveland for the relief of Jewish Sufferers from the War is placed at \$300,000; and a further sum of \$35,000 will be needed for the purposes of the National Board for Welfare Work among Jewish Soldiers and Sailors.

Our Organization desires itknown also that it stands ready to co-operate in any manner necessary to a successful prosecution of the Campaign, and awaits your advice to this end.



My Dear Rabbi Silver:

This is to inform you that, beginning with this date, the Jewish Welfare Board closes its local office and that all Jewish soldiers and sailors in need of assistance should be referred to the Civilian Relief of the Red Cross, Standard Parts Building. The number of applicants for assistance to the Jewish Welfare Board became so small as to make unnecessary the continuance of this office. It would have been a needless expense. The national headquarters requested us to close the office in case that we were convinced that the local situation warranted it.

The office has been in existence since March and has done very creditable work. It has shouldered the responsibility of our local Jewish community to the returning soldier and sailor, and in so far as it has done that, it has earned the gratitude of the entire community. There have been about 2,000 callers at the Jewish Welfare Board seeking assistance or re-employment or information since March, 1919. There has been no expense to the local Jewish community, all such items being taken care of by the national headquarters. We are very thankful to all the members of the Board who rendered service to the cause.

It will be of interest to you to know that the report of statistics has been completed and that we are able to report that the Cleveland Jewish commuity furnished 2,912 men to the Army and Navy. This

is a remarkable contribution, considering the fact that the entire contribution of Cleveland to the Army and Navy was 40,000.

I believe that we are as much indebted to Mr. Gluck for the fine way in which he ministered to the returning soldier and I would therefore be thankful to you if you would send me a donation with which to purchase for him some slight token of our esteem. If you are so minded I wish you would please fill out the appended blank which you will return to me. The maximum donation should be \$1.00. I can hardly speak in too high terms of Mr. Gluck's service to our community. He has brought a fine spirit of sympathy to the returning soldier and sailor, and has, in almost every incident, been able to return the soldier and sailor to a normal life. He deserves well of us. I am glad to say in passing that he is now the assistant to Superintendent Chapman of Mt. Sinai Hospital.

Please accept my personal thanks for your sympathetic co-operation in the work.

Your letter of March 2nd to hand.

I have just received a letter from Max Senior of Cincinnati, who tells us that the Cincinnati War Chest has granted \$150,000.- to the Jewish War Relief which is to be paid between now and June first, and in addition to this the Cincinnati Community Council which is to conduct a drive from April 5th to the 14th has allotted \$200,000.- for the Jewish Foreign Relief all of which, if it succeeds will be paid during the year of 1920. This will make Cincinnati's quota which was originally, if my memory serves me correctly, about \$270,000.- or an over subscription of \$80,000.- Compare this with the showing of Cleveland whose original quota is \$718,000.- and who will show a deficit of \$268,000.-. Even if we would have received the \$500,000.- to the bad, due to the stupidity of some of our mutual friends.

> I still feel that if the matter is handled adroitly, that we can secure at least \$500,000.- from Cleveland. I also feel that you and Rabbi Goldman are the proper persons to start the ball rolling. It will be a thankless sort of a task, but the campaign is well worth going after.

I hope it will be your pleasure to get into conference with Goldman and vigorously prosecute the issue.

You did not tell me a word about the progress of the Palestinian Restoration Fund Campaign in Ohio. I am much interested and will be glad to have a few lines from you on this subject.



The delay in replying to your favor of the 29th ult. has been due to the intervening Jewish holidays and the fact that our Board of Directors had had not meeting in the meantime; but some time ago our Board of Directors requested Mr. Isidore Hershfield, a member of the Board, to take up this matter with your Federation at Cleveland, so as to dispose of it entirely and satisfactorily to both parties by a personal interview.

We clearly realize from your letter of the 29th ult. that you must now make your request to your community fund for your 1923 subvention, and the inclusion or exclusion of a subvention to us must figure of course, in your request to the community fund.

Mr. Hershfield is ready to go at any time to Cleveland and meet your Federation Board and thrash out the entire matter. Our actual aim in having Mr. Hershfield go to Cleveland is to come to some reasonable arrangement with your Federation so that solicitation in Cleveland by us will be permanently stopped. We realize fully your attitude and the great desirability of our receiving a subvention from your Federation without the intervention and expense of work by our solicitors. Will you not write or wire us when your Board can hold a regular or special meeting to confer with Mr. Hershfiel, and we promise he will come at once? Only three days or more notice will be necessary.

Mr. Hershfield, on various occasions and also at the recent conference of Jewish Social Workers in Providence, has expressed his opinion as to desirability and necessity of arranging with Federations for subventions, and thus dispensing with solicitation in Federation cities.





Amendment to Regulations of The Federation of Jewish Charities Proposed by the Board of Trustees

That Article VII shall read as follows :---

Committee

Section 1: As soon as practicable after the annual meeting of each year the President shall, with the approval of the Board of Trustees, appoint an Executive Committee: he may also appoint such other Committees, as in his judgment or the judgment of the Board, may from time to time be necessary or proper.

Executive Committee

- Section 2: The Executive Committee shall be composed of the President, Vice-President, Secretary and Treasurer and not more than six other members of the Board of Trustees, and the terms of the members other than the Executive Officers, shall be for three months from the time of their appointment, and until they shall have been discharged from such duty by the Chairman. The service of all Board members on the Executive Committee shall be scheduled by appointments made at the first Board Meeting following the Annual Meeting.
- The Executive Committee shall direct the work of other Committees and shall have such other powers as may be conferred upon it by the Board of Trustees. The Executive Committee shall meet at least once every month, and at such other times as it may be called together by the Chairman, and all records of its meetings shall be submitted to the Board of Trustees for approval.

This is not of course offered in any defence of those who are not doing their duty by the Community Fund, and many of whom were not doing their duty by the Federation either.

If you will indicate a convenient time when you would like to discuss this matter in Federation Board meeting, I shall be glad to arrange to have such a meeting called.





Progress of Survey of Jewish Charities of Cleveland.

The Bureau of Jewish Social Research has had members of its staff and all its Advisory Committee at work in Cleveland, on the Survey of Cleveland's Jewish Welfare Activities, since the middle of November.

The fields of activity which will be studied in the survey are, Recreation, Child Care, Family Welfare, & Service and Jewish Education. There will also be a study of the co-operation among administrative agencies such as the Federation.

The field of recreation is having the personal attention and direction of Mr. Samuel A Goldsmith, the head of the Bureau; Mr. Goldsmith is making his headquarters at 1537 Guardian Building and can be reached by telephone at Main 2559.

The study of recreation will bring Mr. Goldsmith in contact with such agencies as the Camp Wise Association, the B'nai Brith, the Council of Jewish Women, Educational Alliance, the Martha House, the Jewish Center and other congregational activities, as well as other agencies not included in the Jewish group, but making city-wide provision for recreation.

Miss Frances Taussig, Director of the United Hebrew Charities of New York and Miss Ealanor Blackman of the same organization, have begun the study of Family Welfare work at the Hebrew Relief Association and the range of their investigation will bring them into touch also with the Hebrew Free Loan Association, the Hebrew Shelter Home, the Instant Aid Society, the Jewish Day Mursery, the Jewish Relief Society, and the Social Service Department of Mt. Sinai Hospital, as well as the Mothers' Pension Bureau and other agencies ministering in this field of service. Miss Taussig and Miss Blackman, for the time being, may be reached at Randolph 5018.

Dr. Sol. Lowenstein, formerly head of the Hebrew Orphan Asylum of New York City and now Director of the Federated Jewish Charities of New York, is reviewing the studies of Child Care work already made in this community and extending his investigation with the aid of Miss Sherline. These studies will include the work of the Jewish Orphans Home, the Orthodox Orphan Asylum, the Welfore Association for Jewish Children, as well as the Juvenile Court, Filtere Association for Jewish Children, as well as the Juvenile Court, Filtere Society and other city activities which provide recreation and educational facilities for Jewish children.

A preliminary analysis of the work of the Out-Patient Department of Mt. Sinai is being made as well as further investigation of other agencies that are in effect helping to meet the health problems of the Jews of Cleveland. Dr. Michael M. Davis of the Committee on Dispensary Development of New York City, is acting as consultant in the Health Division of the Survey, and is being assisted in his preliminary work by Miss Henrietta Aidman, who may be reached at Main 2559. The problems of delinquency will be dealt with by Dr. Julius Drachsler, professor of sociology and economics of the College of the City of New York, who has already been here to plan his portion of the survey in connection with the work which will include the Big Brother and Big Sister Movements and facts available from the public schools, the Juvenile Court and the Recreational Agencies.

Mr. M. J. Karp, Director of the Family Welfare and Personal Service Bureau of Chicago, will study the problem of the Handicapped and the work that is being done for the Aged and Infirm and the Blind, by the Montefiore Home, the Orthodox Old Home and the Committee for the Blind.

The study of Jewish Education is also to begin very shortly, as soon as it is possible to make definite arrangements with those who are to participate, and will include the facilities provided by the Religious Schools, the Congregations and by the Hebrew School and Institute.

The agencies included in the community-wide study of Jewish Philanthropic Service are urged to lend their whole hearted co-operation to the efforts of the staff of the survey and to give freely every aid and information that may be sought and which will be necessary to the preparation of a program of future development of Cleveland's Jewish social service.

My dear Rabbi Silver:

It is my solemn duty to present for your consideration a problem of the utmost seriousness affecting the immediate and peremptory needs of Jews who are practically refugees from their native lands and who are now on the verge of despair. They are, first, the 10,000 men, women and children who are now stranded in various European ports. and second, the 5,000 who are languishing in Cuba.

Those of the first class mentioned left their homes and disposed of their belongings with the view of taking up their abode in the United States. They were provided with the requisite passports which bore the visas of various consuls of the United States. They had paid for their transportation to our country and were mentally, morally and physically qualified for admission in conformity with our laws, but solely on account of the exhaustion of the quotas assigned to the respective lands of their nativity they were not allowed to leave the ports from which they had arranged to sail. Since then they have been unable to secure repatriation, or to gain permission to seek employment in the countries in which they now find themselves and from which they are liable on short notice to be deported, and their plight is growing more hopeless from day to day.

Those of the second class mentioned were induced by the agents of steamship companies, regardless of what might become of them when they reached their destination, to migrate to Cuba. There but few of them have been enabled to secure employment, although ready, willing and able to work; a large proportion of them have been stricken with illness in consequence of climatic and other conditions with which they are unable to cope, are ignorant of the language and customs of the country, and are deprived of the helping hand of those who might advise and aid them in their efforts to gain a livelihood. The young girls are obliged to live under conditions which subject them to unspeakable dangers, and the children have no opportunity for education. Many have fallen a prey to these untoward and hopeless conditions.

The doors of our country are closed to these homeless ones, without fault of theirs. As stated, 10,000 of them relied on the visas of American consuls and found that they were not honored by our immigration authorities. The laws of our country must and will be obeyed. There will be no violation or evasion of them directly or indirectly. It is therefore necessary to provide a method whereby these refugees may be enabled to migrate into countries where it will be possible for them to live, and to give them financial assistance during the period that must necessarily elapse before they can earn a livelihood.

There is another phase of the subject of immigration which calls for immediate attention. As is well known, conditions in various parts of Europe are such that a considerable number of Jews find it absolutely essential for their well-being to migrate to other lands. To subject them to the tender mercies of steamship agents drumming for business, would only repeat in even more aggravated form, if possible, the experience of those now in Cuba. That would mean their destruction. We have no right to be indifferent to their fate. We owe it to them and to ourselves to be able to warn them against dangers and to advise them with regard to opportunities. To do so intelligently and effectively will necessitate a thorough investigation by competent experts of economic, climatic, political and other conditions in such countries as are willing to open their gates to newcomers. If this responsibility is not assumed promptly, there is almost a certainty that a serious calamity will ensue.

There are liberal governments whose territories are today open to immigration, and it is the purpose of the Committee to direct as many of the refugees now stranded as is practicable to such regions. As to those who are still in their homes a considerable proportion of them doubtless will seek to colonize in Palestine. To the extent that that will be possible in the light of the existing agricultural, industrial and commercial development of the Holy Land, it will be furthered in every legitimate way. But there are doubtless a considerable number who either do not desire to or who cannot take up their abode in Palestine, and for them, if possible, other outlets must be found. Among the lands in which there are comparatively few Jews which may afford a field for immigrants, are Mexico, such parts of South America as are not within the Tropics, Australia and South Africa.

Our immediate need is a sufficient fund to meet the acute phases of the problem and a reasonable sum to carry on the investigation to which "" reference has been made. It has been concluded that the minimum requirement for the year beginning on October 1, 1924, is \$500,000. This amount should be collected within the next few weeks. Delay merely means the multiplication of difficulties and an increase of the horrors which we are seeking to remedy.

I earnestly request you to bring to your Congregation and community the cause concerning which I have written. If it should not be possible to devote the Holy Day service to the actual collection for the cause, I have no doubt that you will so bring the cause to the heart of your people, that it will be easier to invite and secure their support when the appeal is directly made to them. I count upon your earnest and heartfelt cooperation in this thing.

My dear Rabbi:

The Federation of Jewish Charities is this week issuing an appeal to the Jews of Cleveland to respond in a more generous measure to the needs of the agencies represented in the Community Fund. The Federations have, during a period of five years made progress in the development of the philanthropic needs of the Community, while at the same time reducing to a marked extent the abnormal expansion which took place during the war period.

However, during this same period the population of greater Cleveland has increased from about 890,000 in 1920 to 1,043,000 in 1924, and there has been no commensurate development in the welfare activities to meet the demands of this growing population. The numbers of dependent children have increased, the number of families requiring ministration of one kind or another has grown, the demands upon each of the departments of welfare work have multiplied; all in greater measure than have the responses of the giving public to the Community Fund.

The Community Fund therefore realizes that the measure of restraint or restriction that has during these five years been imposed on welfare activity can no longer be continued, and that additional funds must be made available for the ensuing year. The Community Fund estimates that it will collect and use \$4,175,000 for 1924---the needs for 1925 are a minimum of \$4,375,000; more could be used to advantage.

An analysis of Jewish contributions to the Fund indicates that individual subscriptions have fallen off, while corporation and firm subscriptions have increased, but in the aggregate there has been no increase in the amount pledged to the Fund. The amounts which the Institutions of the Federation of Jewish Charities will need for 1924 and 1925 are greater than the amounts needed heretofore and the subscriptions of the Jewish Community must necessarily keep pace with these growing demands.

This represents the tenor of the appeals which are being sent out by the Federation and which are here attached for your information.

Will you in the course of this week, prior to the opening of the Community Fund Drive, present this message to the members of your Congregation---I am sure that it will be helpful to those who are giving their energies to aid the Fund in reaching its goal.

Referring to our conversation while you were in New York recently, I am pleased to send you a copy of the letter from Mr. S. Goldhamer which you requested, as well as a copy of the reply which was sent to him by the Chairman of our Executive Committee.

I hardly think it necessary for me to go into this matter more at length, as I know that you are well informed on matters concerning all phases of Jewish life and know all there is to be known in connection with the present conditions abroad, particularly as they affect the Jews.

May I not therefore urge you to make an effort to see Mr. Edward Baker as soon as possible and stress upon him the importance of taking immediate action in forming a special campaign committee in your city?

I shall appreciate hearing from you as to the result of your interview.

I am asked to write to you on behalf of several members of the Federation's Executive Committee who have received copies of your communication of November 14, requesting the organization of a local campaign committee for the raising of Cleveland's quota of the "Ort" Reconstruction Fund.

This request reaches our Community just at the time when we are engaged in our annual Community Chest drive, so that no action can of course be taken until this campaign is over,; however, aside from this consideration, it is their feeling that any effort to revive interest and support for foreign relief or construction work would, at this time, need the aid and inspiration of a successful campaign in New York City backed by these prominent in American Jewish life who have heretofore been the recognized leaders in the foreign relief work carried on by the Joint Distribution Committee.

This suggestion is made, not for the purpose of any attempt to discharge lightly Cleveland's responsibility in this cause, but for the reason that our Community, together with others throughout the country, discontinued their foreign relief activities several years age upon the advice of the Joint Distribution Committee that further relief and reconstruction work was well in the hands of the local committees abroad and that there was no further need for a continuance of America's participation.

It is gratifying to note that the Chairman of the New York City campaign pledges the raising of New York's quota, and we are sure that an d advice of the success of your efforts in New York will furnish the necessary impetus to our efforts locally.

While we can readily understand that no actual campaigning for the ORT Reconstruction Fund can be carried on while your Community Chest drive is in progress, we are, I confess, somewhat at a loss to understand why, in your opinion, it would be advisable to postpone action in Cleveland until the conclusion of our New York City campaign.

The New York drive is now well under way. Committees have been formed for the various New York districts: - Brooklynand its various sections, the Bronx, the West Side, Washington Heights, the East Side, etc., and effort is now being made to organize the various trade groups. Fifty thousand dollars have already been pledged to us; the larger and more important pledges are expected at the banquet which is being planned for next month with the participation of Herbert Hoover, Governor Smith and other prominent men. We have no doubt that New York will do its share fully; but it me must be understood that this city calls for a more extensive activity, and to postpone action in Cleveland until such time as the New York City drive is completed would, I fear, be greatly detrimental to our cause.

As regards the opinion of the Joint Distribution Committee in the matter of reconstruction work abroad, I feel that nothing could better indicate the attitude of the Joint Distribution Committee towards the work in general and ORT in particular than the following excerpt from a speech made at our national conference by Colonel Herbert H. Lehman, director of the reconstruction committee of the Joint Distribution Committee: -

"I feel very strongly that the work abroad cannot, under any circumstances, be considered as having been completed. I feel that a very little help on our part, relatively, will make a tremendous difference in the situation abroad. I believe that with a helping hand from this side, these men and women can be made selfsupporting, self-respecting, self-sustaining citizens of their communities, just exactly as they were before the war. I feel that we would be very remiss in this country in our duties, if we did not lend that helping hand. I want to say that I am convinced that we have got to work through foreign organizations; we can no longer do what we have done in the past, - send out our own organizations and maintain these organizations abroad; so mechavesgot to work with the organizations abroad. And of the various organizations of merit and responsibility none stands cut more strongly, in my opinion, than the ORT. There are no more self-sacrificing, no more devoted men and then those representatives of the ORT whom I have had the pleasure of meeting and with whom I have had the opportunity of cooperating. I believe that you are perfectly safe in working through and with the ORT." Such is the opinion voiced also by other important men of the J.D.C., such as Professor Cyrus Adler, whose s tatement was made public in the Jewish Tribune, Mr. James Becker, who is very active in Chicago, Mr. Cyrus Sulzberger, and others.

From the various facts and statistics which have been presented at our national conference and which later also appeared in the press, there cannot be the slightest doubt that the present economic situation abroad is anything but critical and that help must be forthcoming from America at one. I cannot help but feel, therefore, that the statements, as set forth in your letter, were based on some misunderstanding, which I sincerely hope the above facts will help clarify.

We are hopeful that Cleveland will not delay in carrying out its good intention of raising its accepted quota of \$60,000 and proceed immediately with the necessary preparations for the drive.



Social Service Report

1924

- The past year has been an eventful one for the Federation of Jewish Charities. With the completion of the Jewish Community Survey, there have been undertaken in earnest, many of those problems of adjustment and coordination in the scheme of welfare work, which have long been recognized as essential to its improvement, but which needed the stimulation and direction of the Survey, to their undertaking.
- The Survey likewise, brought about a closer working relationship between the groups active within and outside the Federation, which in turn is making possible at least the beginning of a proper coordination of our philan-thropic service.
- Lack of adequate funds is the big obstacle to further development of our work-- many of the recommendations made by the Survey, point to the unfilled needs which only more money can provide.
- In spite of these handicaps and the fact that the Survey was but recently completed, there is good cause for satisfaction in a review of what has been achieved thus far and in the prospects for further accomplishment indicated in the fine spirit of cooperation which is manifested on every hand.
- The Research Department, which has been organized on September 1, has greatly facilitated the community organization work. The Research Secretary has been engaged in compiling data for use by the five functional committees in their determinations of appropriate steps of procedure in the fields of child care, family welfare, delinquency, health, handicapped and recreation. The Research Secretary acts as secretary of each of the functional committees. The Department has also expanded and strengthened the publicity work of the Federation and its constituent bodies. Research studies are being initiated for the purpose of determining methods of improvement in service and organization. Efforts of this Department are being concentrated on the improvement of the statistical systems of each of our organizations, the latter to be utilized in the checking up of service, unearthing of causes of mal-adjustment, and in detecting ineffective methods. The Research Secretary is utilizing a large portion of his time in direct organization work, coordinating the work of agencies engaged in activities of common interest, reducing overlapping, and strengthening internal organization of the agencies.

Developments during the past year may be roughly divided in the following classes:

1. Contacts developed with unaffiliated agencies.

- 2. Coordination and extension of facilities already available in the Community.
- 3. Internal changes and improvements by the organizations themselves.
- 4. Increased facilities for professional training of social workers.
- 5. Establishment of department for the support of Jewish Education.
- 6. Cooperation with the Community Fund.
- 7. Endorsement of campaigns for approved national and foreign needs not included in the Community Fund

1. Contacts Developed with Unaffiliated Agencies

The so-called Orthodox organizations are gradually increasing their cooperation with the affiliated agencies. Members of the boards of the Orthodox Orphan Home, the Orthodox Old Home, Jewish Relief Society, and the Jewish Day Nursery are now associated on the boards of the Jewish Social Service Bureau and the Welfare Association for Jewish Children. These representations contribute greatly to a harmonious relationship between the affiliated and unaffiliated groups, giving opportunity for joint discussion of common problems.

In order to cement more closely these relations between the so-called Orthodox and Reformed groups, kosherization of custodial institutions has been recommended in the by the Federation: the Jewish Orphan Home has practically completed its kosherization; the Mt. Sinai Haspital has eliminated pork products from its diet except upon special order of the medical staff and is contemplating, in its new building plans, to re-install the kosher kitchen.

In this connection also, it has been recommended that wherever possible, Jewish agencies keep their offices closed on Saturday: the Federation took the initial step in this direction, making up for the lost time by increasing its week day working hours; the Jewish Social Service Bureau also closes its offices on Saturdays and major Jewish holidays and has its office opened on Sundays.

Attempts at a financial affiliation of the Orthodox agencies with the Federation, have been made, but has yet without success, due to obstacles inherent in the stuation.

2. Coordination and Extension of Facilities Already Available in the Community.

Functional Group Committees. - As an aid to the process of coordination of the functional work of our agencies, a Functional Relations Committee was created to head four Functional Group Committees, each addressing itself to a specific phase of service. The four Committees are:

- (a) Committee on Child Care
- (b) Committee on Family Welfare and Delinquency
- (c) Committee on Health and Handicapped
- (d) Committee on Recreation

On these committees are represented lay and professional members of our various agencies, the chairman of each of these four committees comprising the Functional Relations Committee with a chairman of its own.

Jewish Children's Conference.- The Jewish Children's Conference has been organized and is now in operation. This Conference brings together lay and staff representatives of all of the child care agencies on problems involving the placement of children, whether they are to remain in their own homes, to be placed in Foster or Boarding Homes or in Institutions.

<u>Hebrew Shelter Home.</u>- The Hebrew Shelter Home has been brought into a closer working relationship with the Jewish Social Service ^Bureau, whereby the service and equipment for work with Jewish transients has been greatly improved.

Big Sister Organization.-The **Explanation** Big Sister group has established its cooperative contacts at the Jewish Social Service Bureau and will, as a result, be enabled to do its work with delinquents and pre-delinquents more effectively. The professional facilities at the Bureau are utilized by the Big Sister Organization

Big Brother Organization .- The Big Brother group is also availing itself of the services of the Jewish Social Service Bureau, but the efficiency of this arrangement will no doubt depend upon the procurement of a male Big Brother worker; the Federation, unable to provide funds for this purpose, has approved the solicitation of a sufficient amount to enable the Big Brother Organization to engage such a worker.

Jewish Social Service Bureau, - The Hebrew Relief Association has changed its name to that of the Jewish Social Service Bureau, the new name expressing more adequately the scope of its work as a family welfare agency. With a change of policy put into effect in 1922, the Agency is finding a larger number of families requiring non-material help, availing themselves of the facilities of the Bureau, and it is rapidly assuming all of the functions of a well organizaed family agency.

The Jewish Social Service Bureau has removed from its former quarters on East 40th Street, where it was already finding itself outside of the boundaries of Jewish population; it is now located conveniently in the downtown section, where its cooperative contacts with other general service agencies, are greatly facilitated.

Educational Alliance and Council of Jewish Women. - The Federation during this past summer approved the action of the Educational Alliance in expending approximately \$2500 from its Building Fund for the establishment of a much needed summer camp for the older boys and girls on the new location of Camp Wise.

Mt. Sinai Hospital .- The capital account plans of Mt. Sinai Hospital, contemplating a need of \$998,000 to provide new Nurses' Home, Out-Patient Department and Laboratory Buildings with necessary mechanical and laundry changes and equipment, have been approved by the Federation, and the campaign is to be launched in the nonth of March.

Plans have been discussed with the Hospital for the establishment of a Health Clinic to serve the non-medical social agencies to provide physical and mental examinations for a larger clientele. The demand upon such a clinic was established through a statistical analysis but, owing to lack of funds, further progress could not be made.

3. Internal Changes and Improvements by the Organizations Themselves.

Sufficient time has not yet elapsed for the functional work of the Federation to extend into the agencies themselves, though some progress has been made in this direction.

Jewish Social Service Bureau Analysis .- A statistical analysis of per capita cost for material relief at the Jewish Social Service Bureau, was prepared in connection with the bringing up of this question by the Community Fund, and a more detailed study is being planned of both the expenditures of the Jewish Social Service Bureau and the Associated Charities for the purpose of determining the reasons for the disparities whic' exist here as well as in other cities.

Improvements in the statistical and recording systems of our various agencies are now being made for the purpose of enabling the agencies to check up on their service and to present adequate reports for analysis by the Federation and the Community Fund. The work has already been begun at the Jewish Social Service Bureas, where a new Kardex system has been developed. At the Welfare Association for Jewish Children a beginning has also been made in the direction of improving the statistical methods employed.

We expect to extend our statistical work into all of our agencies.

Martha House.- A study is now under way bearing on the social aspects of the Martha House in connection with the methods emplayed in the investigation of incoming girls, the standards for admission, and the social supervision within the home.

Jewish Day Nursery.-A study is also now in process on the Jewish Day Nursery with the object of determining to what extend the cases that are within the Institution and those what are now on the waiting list are legitimate nursery cases. This determination will enable us to ascertain to what extent the desired expansion of the Day Nursery is valid and in what way our social service agencies night aid the Day Nursery.

It is planned also to take up at an early date the various minor recommendations of the Survey relating to internal administration of the exencies.

4. Increased Facilities for Professional Training of Social Workers.

An appropriation of \$1000 was made from the funds of the Federation in connection with a course for settlement workers for the School of Applied Social Sciences.

5. Establishment of Department for the Support of Jewish Education.

The Bureau of Jewish Education has been organized for the purpose of stabilizing the financial support of existing institutions of Jewish learning in this City and for the purpose of increasing the facilities for Jewish education. The Federation also approved the campaign for the raising of \$75,000 by the newly created Bureau of Jewish Education to commence in January.

6. Cooperation with the Community Fund.

A thorough check of Community Fund subscriptions was again made this past year as the result of which the Federation office has on file a list of some 4,000 individual Jewish subscribers to the Community Fund and a further card index of some 7,500 names of Jewish non-contributors, many of whom have been on the Community Fund list at some time or other.

Several weeks prior to the Community Fund drive, about 12,000 appeals were mailed to both these lists, urging generaus support for the Community Fund.

<u>Eisenman Award</u>-The Eisenman award for 1924 is to be made on the basis of a contribution to the development of support for the Community Fund. The announcement of the Award reads:- "It is proposed to give the sum of \$500, together with an emblem symbolizing the award, to the Cleveland person who shall submit the most feasible plan by which the Cleveland Community Fund may enlist and sustain the interest of the giving public of Cleveland in the continuing needs of the welfare agencies of this City."

Trequent meetings have been held with the Investigating and Capital Account Committees during the year; current information on service and finance of each of our agencies was supplied the Community Fund monthly and when requested.

7. Endorsement of Campaigns for Approved National and Foreign Needs Not Included in the Community Fund.

Hebrew Immigrant Aid Society .- The solicitation of the Hebrew Immigrant Aid Society not to exceed \$2500 was endorsed.

<u>Sational Jewish Hospital for Consumptives.</u> The request for solicitation in Cleveland of \$30,000 for the National Jewish Hospital for Consumptives toward the cost of erection of an infirmary building for the Hespital was approved.

Ort Reconstruction Fund and Emergency Committee on Jewish Refugees. -The drive for the Ort Reconstruction Fund in the amount of \$60,000 and for the Emergency Committee on Jewish Refugees in the amount of \$25,000 have been approved by the Federation and a committee is being organized by the Federation to conduct the two drives jointly in the month of February.

Dear Rabbi:

On account of the fact that I am leaving this noon for Chicago, to be gone until Monday morning, I am asking Dr. Slawson to be present with you at the meeting of the Orthodox Orphan Asylum, Sunday night; I believe Dr. Slawson is sending you also, some material covering briefly the whole trend of child care work in this country, indicating the progressive limitation of the use of institutions for up-bringing of dependendent children.

In respect to our local situation, we of course have to bear in mind that we would have had no Orthodox Orphan Asylum, had those who were responsible for the administration of the Jewish Orphan Home yielded to community sentiment and kosherized the Institution years ago as they have finally done. However, that is past now and the thing that we are concerned about is that neither the Jewish Orphan Home nor the Orthodox Jewish Orphan Asylum shall expand their facilities with a constantly deminishing demand upon them----not because there are less children to care for, but because more modern and better methods prevail today.

In the case of the Orthodox Orphan Asylum the Federation has also to guard against an over-zealous demand for support. This was evidenced by the first intimations that were given us by members of the Board of that Institution; when the Federation extended its first invitation for them to come in, about a year ago, there was talk of the need of \$50,000 and \$75,000, all of which tended to chill any interest we might have developed with our folks for such an affiliation, and it is such methods as these that have constantly widened the gap of understanding between the so called Orthodox and those who are administering social service in a more orderly way.

I think if these things are brought home forcibly to the members of the Orthodox Orphan Home Board, the judgment of the better thinking members will prevail and we shall be able to deal with them more harmoniously. The Federation of the Jewish Charities, Alebeland

Dear Rabbi Silver:

I am enclosing herewith, a summary of important items pertaining to the child placement problem which I thought you might like to have for your meeting with the Orthodox Orphan Home Board on Sunday. An attempt has been made in this summary to present impartially, the facts bearing on the differential allocation of dependent children as between the private home and the orphan home.

May I also supplement the statement which Mr. Goldhamer made to you in his letter of February 18, to the effect that owing to the absence of kosherization at the Jewish Orphan Home, the Orthodox Orphan Asylum was originally formed. Reports from the Jewish Orphan Home are definitely indicative of the fact that kosherization of that institution has been consummated although it is probable that the specific type of facilities might not satisfy certain of the more extreme Orthodox groups. In addition, it is a known fact that Jewish education is stressed at the Jewish Orphan Home.
