My dear George:-

Following up our conversation of last Thursday I would suggest that your committee rent a room immediately somewhere in the Ulmer Bldg. and install a desk, telephone, etc. Rental should not exceed \$40-50 per month. Miss Saparatein should be asked to devote part of her time to this office. The District should undertake to pay some part of the salary which she is now receiving from the Bureau - the amount to be fixed by mutual agreement.

Dr. Garber's suggestion should be followed. A letter should be addressed to some fifty or a hundred Zionists telling them of the need of headquarters for the District and suggesting to them to contribute a dollar a month, in such installments as they deem most convenient, to defray the expenses.

I received my membership dues bill for the Z.O.A. There was no covering letter with the bill - not even a return envelope.

I suggest that two weeks hence a meeting of your membership committee be called together and that the names of those who failed to respond to the bills, be distributed among them for personal solicitation.


There should be some publicity in the Anglo-Jewish papers as well as in the Jewish World about the District and its membership campaign.

Dear Rabbi:-

I have been thinking a great deal about the contents of your letter of Jan. 18th with reference to your generous effort to raise a loan for six months operation of an office with a part time secretary.

I feel exactly as many others do that our efforts should be stimulated by your kind offer and we should attempt to extend that work so that any new plan can receive a fair trial.

I am thoroughly in accord with our employing Miss Saperstein as a part time secretary as she understands the work thoroughly, but the thing that sort of goes against the grain is the waste of expenditure that would be incurred by running an additional office.

I realize there is a very slight possibility of some criticism against the Bureau if it were generally known that 315 Ulmer Bldg. were also the Zionist office.

On the other hand I am inclined to believe in our endeavor to play absolutely fair with the Bureau and not let it become involved to its detriment as we sometimes bent backward. For example, I believe even if other office space were rented and equipped in the Ulmer Bldg. the bulk of the work would be done at the more confortable Bureau office.

Now, my suggestion is this, that we might arrange to pay the National Fund a maximum of \$10.00 a month to help them out to this extent. Use their office as our office address. I further believe in view of present conditions that the Bureau finance board would not object to Miss Saperstein giving part of her time to Zionist work, if that portion of her salary which she would derive of the Zionist organization

Dear Rabbi :-

would be deducted from the salary which the Bureau is now paying her.

I further believe that all telephone calls and any other expense incurred for Zionist work at the Bureau office should be paid for by Zionist funds.

The \$30.00 or \$40.00 per month which we would be obliged to pay for an office in the Ulmer Bldg. would mean \$360.00 to \$480.00 per year toward other Zionist activities and the \$10.00 a month which we would give the National Fund for their expenses would stay within the Zionist ranks, while it would decrease the National Fund expenditures in town it would increase the ultimate net amount sent to New York for Zionist purposes.

I hope that you will understand my view point on this subject. I am putting it in writing so that you will have an opportunity to think it over and we might possibly talk this over prior to the Finance Committee meeting of the Bureau.



Dear Rabbi Silver:

Replying to your note dated March 11th, please be advised that the original plan of reorganization of Cleveland Zionist affairs as outlined at our last conference has not yet been put into operation to any appreciable extent on account of various factors.

In the first place, I have personally been giving all the time I could spare to the arrangements for the Sokolow reception and to some little work done in conjunction with Dr. Garber for the Palestine Labor Federation.

In the second place, and what is even more important, I have been getting very little cooperation from the rest of the boys, all of them being occupied with personal matters as well as social duties of numerous types. I thought that Mr. Epstein would take the thing in hand, and in consultation with me at least raise the first thousand dollars with which some work could be done and the matter of employing an executive approached. However, he has not done this work at all. I have had a meeting with a group of our men about two weeks ago. The boys then undertook to see certain individuals and get them to pay a \$25.00 a year sustaining membership. This, also, has not yet been accomplished. I am going to make some efforts this week to put this problem on the agenda once more and see what can be accomplished. However, I am convinced that there is only one way really to approach a solution of this problem, and that is for a few men to underwrite a sum of money with which to employ a full time executive and then let him do the work of the organization. This volunteer work is very difficult to cope with on many grounds, the present depression being not the least of them.

If you happen to have luncheon downtown at any time this week, I should be glad to meet you at luncheon or at my office to discuss this matter further. Perhaps we could arrange to have some of the other active Zionists meet with us.
