I was delighted to hear that you were well again. It was only yesterday that I heard from Harry Branton about your illness and was frankly very worried. Let's hope that you will return to the best of health very shortly. I am pleased to hear that you consented to accept the chairmanship of World Zionist Affairs for the Cleveland Zionist Society. Your name has been placed on the mailing list of World Zionist Affairs Chairmen today. As far as the affiliation of Cleveland with the Ohio Valley Region is concerned, our statement of last year concerning membership dues for synagogue districts stands. This means that the synagogue districts in Cleveland, including the Cleveland Zionist Society, will pay their dues on the same basis as until now. Convey this information to the members of your executive Committee. I am sure they will now see no obstacle to joining the Ohio Valley Region. Besides, the example of the Cleveland Zionist Society will be followed by the two other Cleveland districts, which are looking to the Society for guidance in this respect. I am sure you know that the Regional Convention of the Chio Valley Region will be held in Dayton, Ohio, on June 12th and 13th. The participation of delegates from the three Cleveland districts in this convention will greatly contribute to the strength and prestige of the Region. His presence at the first convention with the participation of the Cleveland Zionist Society would definitely bolster our forces in the Region. The inclusion of the Cleveland districts into the Ohio Valley Region will permit better servicing and will afford the districts an opportunity to utilize the Regional Office and its very capable Director, Harry Branton. By the way, the office of the Ohio Valley Region, which is now located in Detroit, Michigan, will be transferred to Cincinnati on September 1st. From a central location like Cincinnati we will be in a much better position to reach all districts of the Ohio Valley Region.
