

Dear Silver:

Thanks for accepting the speaking engagement to open the Providence campaign on Wednesday, January 26th. Our friend Dr. Ilie Berger has managed to step up the income for the United Palestine Appeal every year that he has headed the campaign for the United Palestine Appeal. Incidentally, Providence is one of the few cities that raises funds exclusively for the United Palestine Appeal in a separate campaign.

My various letters to you seem to take on the character of communications from a speakers bureau. But surely I cannot be blamed if your great popularity is such that demands for you come from every section of the country and from every group.

The National Council of Federations and Welfare Funds will hold its annual Conference in Cincinnati on January 9th and 10th. The officers of the Council have asked the United Palestine Appeal to be formally and officially represented at this Conference. They name you as their first choice for a speaker.

Because of the nature of fund-raising today in which the Welfare Funds are playing an increasingly important part it is to the interest of the United Palestine Appeal to become integrated more thoroughly into the operations of the Welfare Funds both nationally and locally. Whatever sources of indifference to Palestine may exist in the communities it is in the Welfare Funds where such indifference may be overcome.

I do hope, therefore, that you will find it possible to accept the invitation of the Council of Federations and Welfare Funds for either January 9th or 10th, as your calendar may allow. As I understand it.

"Let Every American Jew Measure His Gift in the Light of the Future He Is Creating For Jews in Palestine" their program is made up long in advance and your early acceptance would be helpful in the publication of this program.

Dear Rabbi Silver:

As you have probably noted from our preliminary program, we are planning for the Sunday evening meeting on January 9 a presentation of the subject "The Community Looks Overseas". This meeting is being arranged by the Committee on National Jewish Problems of which Mr. Ira M. Younker of New York is the Chairman. We should like to have a presentation of the program of the United Palestine Appeal for the coming year with particular emphasis on what the UPA expects in the way of support from the welfare fund cities.

I have discussed this proposed program with Dr. Stephen S. Wise and Mr. Robert Silverman of the UPA and they have agreed with us that you are the best person to present this subject to our audience. Dr. Wise tells me that he has already written to you urging you to accept. I am hoping that your answer will be "yes" and that we can count on you for our program.

The program of the JDC will be presented by Mr. George Backer. Following the presentations which we assume will be about 30 minutes each in length, we expect to have a general discussion of the problems of organizations of local welfare funds in relation to budgets and campaigning for these and other causes. In the event that some prior understanding or agreement is not developed between the JDC and the UPA, questions may be raised by our member agencies as to the best methods of procedure on overseas budgeting in the coming campaign.

The GENERAL ASSEMBLY, scheduled for Cincinnati January 8-10, 1938, promises to be an eventful occasion. The presentations are concentrated on the current and serious issues in federation, welfare fund and community council, and there will be ample time for full discussion.
