Dear Sir: A cordial invitation is extended to you to be present at the annual wage hearing of the Cleveland Garment industry to be held Saturday, April 22nd at nine o'clock. The wage scale in the garment industry is set by an impartial board of referees composed of Judge Julian W. Mack, Chairman, Professor Jacob H. Hollander and John R. McLane. This Board is not called in as a board of arbitrators to settle a wage dispute but is by agreement given the responsibility of deciding a wage scale "after thorough investigation of all ascertainable facts, with due regard to the public interest, fair and equitable wages conforming to American standards and to the progress and prosperity of the industry". It is so unusual to have a large industry not only invite the public to be present when the matter of wages is considered and decided but to place the whole matter entirely in the hands of representatives of the public for settlement that we believe you will be interested in watching the new method in actual practice. Each side will present to the Board of Referees its views in regard to a proper wage and the Board of Referees will then decide what in their opinion the wage should be. We feel that the garment industry in Cleveland is setting an example to other industries everywhere and that the public which is so out of patience with the ordinary wage dispute should take an interest in and show its approval of the better method adopted by the garment industry.
