Dear Rabbi Silver:

I am very glad to report that Mr. E. F. Bozman, who is in charge of the Editorial Department of J. M. Dent & Sons, Ltd., London, has received favorable word from Cyril Goodman, executor of the Paul Goodman Estate.

I think it best to quote Mr. Bozman's letter of June 29 in full. Here it is:

"Your letter of June 15th. I have consulted Cyril Goodman, who is Paul Goodman's executor, and he has no objection to your proposal. I have also been in touch with Mr. Israel Cohen, who is very keen that any addition made should not be out of proportion to the book as a whole which is balanced very carefully.

"He suggests that the addition of one section, (No. 10), in chapter eleven, under the heading of the U.S.A., of about the same length as the other sections, should suffice, and would very much like to see a copy when it is ready.

"Will this meet your point? Mr. Cohen, who has the responsibility for the revised edition, is naturally most anxious that, after he has taken

July 9, 1951 m 2 m Rabbi Silver "so much care to be concise and to balance the whole book within the limits imposed, the new material should not spread out into a long essay." I would like your own personal opinion as to whether or not Chapter 11 can be adequately presented under the conditions suggested by Israel Cohen. My feeling is that our edition will be read by Americans, and it should fully present America's contribution to a Jewish State of Israel. I would very much appreciate your thoughts, and will be glad to return the proofs of A HISTORY OF THE JEWS if you would like to refresh your memory. I am pleased to know that my suggestion for including a proper account of the contribution of American Jewry and American Zionists to the establishment of the State of Israel has been received favorably. However, the suggestion of Mr. Israel Cohen that a section be added at the end of Chapter 11 does not carry out the intent of my suggestion. Coming at the end of the chapter, after the peroration, so to speak, contained in Section 9, it would look like an appendix - an afterthought, something put in for American consumption and to satisfy American readers. This section, if included, should come after Section 3. A good deal, of course, will depend upon what is said in the section, and I should like to see a copy of it.
