I have, as you of course know, the most sympathetic interest in the matters which you bring to my attention. No one, more than I, will vigorously condemn outrage, unfairness and mob violence wherever they may occur.

The treatment of the Jewish people in some parts of the world has been atrocious, and every true American will not hesitate to heap condemnation upon the spirit of persecution which has brought such conditions about. I wish to point out furthermore that persecution and mob violence, wherever and whenever they may occur, not only do brutal injury to the victims, but brutalizes those who inflict it.

It is impossible for me to believe that the present League of Nations can be regarded as a bulwark against such atrocities because, during the period when its American advocates have claimed that it was fully functioning, some of the worst atrocities have occurred without any apparent control on the part of the League. It is my feeling that this fact may be accounted for because the League idea, as insisted upon by the President in all its detail, really amounts to an armed alliance with emphasis upon force. I am for a league or association with the emphasis placed upon justice so that the world may become more interested in civilization and humanity than in mere guarantees of military protection given to territorial possession often acquired by conquest.

I know that it is the hope of many of the Jews in the world that there shall be established in Palestine a Jewish home-land and the progress of this aspiration has had my sympathetic interest, though I believe that the great ultimate good which the world may receive from Jewish contribution to civilization will come principally through such primary devotion, and service of citizenship, as they have given to America.

While I am not actively participating in this campaign, I feel compelled, however, to issue a statement relative to the attempt new being made in certain quarters to discredit Senator Harding, by attributing to him Anti-semitic motives in his refusal to endorse Mr. Brandeis for the Judgeship of the Supreme court.

Whatever the reasons may have been which prompted the Senator in his action, they were certainly not Anti-semitic. I have known Senator Harding for many years. I am fully acquainted with his intimate views concerning the Jew and Judaism. He is not only broad and telerant, but he has at all times publicly and privately expressed an enlightened appreciation and a keen admitation for the achievements of our people; for their great contributions to achievements and for their unswerving leyalty to America.

It is regrettable that such unjustified charges be made at a time when religious and racial differences should be subordinated to the great service of citizenship, and by men who are not at all concerned with championing the cause of our people.

Dr. Stephen S. Wise, Rabbi of the Free Synagogue, one of the long-time leaders of the Zionist Organization of America, who is supporting Cox and Roos welt, made the following statement today:

My attention has been called to a statement issued by the Indiana Democratic State Committee under the beading: "Senator Harding Voted No. on the Confirmation by the United States Senato of Justice Branders, a Distinguished Jew and a Leader of his Race in this Country.

The evident purpose of the Indiana Democratic State Committee is to move American Jews to believe that Senator Harding's opposition to the confirmation of Mr. Brandeis as a Justice of the United States

Supreme Court was due to the fact that the latter is a Jew.

Ir. Wise daid: "Though I am supporting Cox and Roosevelt, I wish to record the trongest poss ble objection to the act of the Indiana Democratic State Committee ax in making this kind of appeal to the Jewish citizens of America. There is no Jewish vote and there will not be a Jewish vote. Jews, like members of all other religious and racial groups, vote as Americans, passing upon the issues that come before the American people solely with regard to the question whether they serve the highest sims and ideals of Americanism.

It is only fair to Senator Harding to say that he voted against Justice Brandeis because he did not and does not approve of the things that Justice Brandeis has represented in American life. I believe that Senator Harding would have voted against Mr. Brandeis, if the latter had been a Protestant, Catholic or unbeliever. President Wilson did not appoint Mr. Brandeis to the Supreme Court because he is a Jew any more than Senator Harding opposed his confirmation

because he is a Jew. President Wilson named Brandeis to the United States Supreme Court because, like millions of his fellow-Americans, he considered Brandeis on e of the greatest of American jurists, a man who had proved himself not only a great lawyer but a wise, farseeing statesman.

senstor Harding voted sgainst Justice Brandeis' confirmation as did Senstor Lodge of Massachusetts and practically all the men who now surround Senstor Harding, because Justice Brandeis had become perhaps the greatest leader of sound, constructive liberalism in America. It is safe to say that, if elected President, harding will not appoint any man to the Supreme Court of the Justice Brandeis or the Justice Holmes type. Whether American citizens wish to leave liberalism unrepresented in the United States Supreme Court, as it will be as far as appointments by Barding as President would leave it, is a matter for them to decide at the election.

As a Jew and a Jewish teacher, I wish once more to register
my most earnest protest against attempting to drag any Jewish question into American politics. American Jews are Americans. As Americans, they think and vote and act. I am certain that the Democratic
National Committee will share my disapproval of the attitude of the
Indiana Democratic State Committee in issuing this appeal. It must
never be done again. It is a present the intelligence and the patriotism of a large group of American citizens.
