Responding to the oft-expressed desire of many of its own graduates, as well as those of other rabbinical seminaries, and after due deliberation, the authorities of the Hebrew Union College have decided to institute a Summer Course of Study at the College.

The completion of the new Dormitory and Gymnasium make this undertaking possible. They will provide the students of the Summer School board, lodging and physical exercise at minimum cost and with maximum convenience. The many opportunities for pleasant and stimulating recreation which Cincinnati affords, will likewise enable the students to combine study with vacation relaxation and pleasure. During the summer of 1924, the University of Cincinnati conducted a very successful summer school. This will be continued in 1925.

This Summer School of the Hebrew Union College is designed to meet the needs and desires of two particular groups, (a) Rabbis who wish to pursue graduate studies, particularly those leading to the degree of Doctor of Divinity, and (b) Jewish religious school teachers who wish to prepare themselves more fully and thoroughly for their class-room work.

Dear Fellow Alumnus:

The new Constitution and By-Laws of the Union give, as you are probably aware by now, the Alumni Association the right to elect two members of the Executive Committee of the Union, five members on the Board of Governors of the Hebrew Union College, and five on the Board of Managers of the Synagog and School Extension Department. These provisions go into immediate effect, but more particularly the one with reference to the Executive Committee of the Union. The new Committee being called into session on February 15th in the city of Pittsburgh, it is urged by Mr. Marcus Aaron, the Chairman of the Committee of twenty-six, that the Alumni nominations be made at once.

A similar request has been made to Dr. Abram Simon, the President of the Central Conference of American Rabbis. Under the Constitution of the Conference, the President, with the consent and approval of the Executive Board, has the right to make Conference appointments. Dr. Simon, therefore, proceeded to appoint, pending the approval of his Executive Committee, two Colleagues to the Executive Board of the Union.

The President of the Alumni has similar power, except that he should like to have the approval of all the active Alumni in the matter. He submits, therefore, for your approval the names of Rabbis David Philipson and Samuel Goldenson as our Alumni representatives on the Executive Board of the Union. Inasmuch as the first meeting of the new Executive Board is to be held, as above stated, on the 15th of February, and inasmuch as the President, Dr. Ettelson, is desirous of making these appointments immediately, so that these men could make their arrangements, it is urged that you send your opinion to the undersigned, at the above address, by return mail.

The election of the representatives to the Board of Governors and the Board of Managers has been postponed for a later day, and, therefore, we are making no request and no suggestions at present.

REPORT ON THE THESIS FOR THE D.D. DEGREE SUBMITTED BY RABBI ABBA H. SILVER. CLEVELAND. OHIO.

The Thesis bears the title: "Messianic Calculations in Israel --70-1700 C.E.", and in the form of an historical analysis it deals with the Messianic speculations in Israel from the Destruction of the Second Temple to the Shabbetai Levi movement, with the method and technique of these calculations, with the Messianic movements that arose as a result of or in conjunction with them, and finally with the opposition on the part of various authorities to these Messianic fancies.

The thesis consists of 276 pages and is divided into three parts. The first part, covering more than two-thirds of the essay, describes in detail the Messianic calculations, and side by side with them the historical Messianic movements. in the Talmudic period, the Mohammedan period, the period of the Crusades and then continues the narrative from 1200 -1350 (the time of the Black Death) from 1350 - 1492 (the date of the Spanish expulsion) devoting the last two chapters to the 16th and 17th centuries. Part 2 sketches the opposition to the Messianic calculations whereas part 3 gives a brief account of the methodology employed in these calculations.

Rabbi Silver's work is the result of a good deal of reading and study. He has endeavored to go to the original sources and has evidently made use of many works of the Mediaeval Jewish literature. He has also read up the general Jewish history of the periods dealt with so as to have an adequate background for his presentation of the subject. Yet on several occasions the referee would have wished he had not relied so much on secondary books of reference such as the volumes of the Jewish Encyclopaedia.

The referee has found the quotations given on the whole correct. There are only a few actual mistakes or miscomprehensions. On the other hand. Rabbi Silver has overlooked a number of very important data, especially in the chapters dealing with the Mohammedan period and with that of the Crusades. The referee has pointed out the essential corrections and additions in a number of notes which are appended herewith. He suggests that these notes be forwarded to Rabbi Silver with the request to have them typed and return one set to the College to be appended to the copy of the thesis that will remain in the Library.

The referee heartily recommends the thesis for acceptance by the Faculty as a creditable piece of work and offers no objection to the granting of the permission for publication, whenever requested by Rabbi Silver, provided cognizance be taken of the corrections and additions incorporated in the above-mentioned notes.
