If you could tell me the present location of your friend, and whether or not he is able to travel to a larger community if presently located in a smaller one, I might be able to suggest the name of a rabbi who might be contacted. It might help, of course, for me to know which rabbis he has already contacted so that I will not suggest one of these.

Aside from possibly helping you to locate a sympathetic rabbi, I do not know how I might help. I could suggest material to read, but it would be more desirable if these suggestions were to come from the rabbi who knows the potential convert best, so that reading could be suited to the person.

I can only wish you luck in your quest.







Temple Israel, New Rochelle, N. Y., has voted life tenure to JACOB K. SHANK-MAN (HUC '30) its rabbi for 20 years.



# BIBLE STUDY BY ELECTRONICS

To a generation of rabbis nurtured upon the grammatical intricacies of Messieurs Davidson and Weingreen, the new Hebrew program introduced at the Cincinnati school of the College-Institute last fall, may seem like an electronic fantasy. The old, leathered seminar room of our library is no more. It has been converted into a language laboratory. The laboratory is equipped with ten recording booths, tape recorders and a pilot room stocked with copying, recording and broadcasting equipment. A large screen has replaced the traditional blackboard; instead of chalk the laboratory assistants use slide projectors. During a class hour many Hebrew verses can be flashed on the screen and removed with the flick of a control switch. In addition to the traditional texts, in the bookcases there are now hundreds of record-tapes for Bible, Mishnah, Talmud and Modern Hebrew.

The new method is based upon the premise that acquisition of a language is essentially not an intellectual but a habit pattern exercise. Vocabularies are memorized in phrase-context rather than as separate entities. These pattern phrases are chosen to illustrate grammatical and syntactical features. Audio-visual techniques are used to break up the normal tediousness of repetition drill. Grammar and syntax are taught as aids to fluency and comprehension and only in context.

The entire Hebrew program of the freshman year has now been integrated. This was a logical development of an earlier program designed by Drs. Blank and Epstein, which had integrated the first semester freshman year and created the original Hebrew I program. In New York an adaptation of the coordinated program is under the direction of Dr. Hareli and in California under Dr. Bin-Nun. Instruction is divided into four phases. The first phase takes places at the summer school in Towanda where an intensive course in Hebrew is taught six days a week for eight weeks. Major stress is placed upon Modern Hebrew and basic language skills. In the fall quarter students concentrate on Biblical Hebrew study and Modern Hebrew. In place of the traditional formal grammar course, syntax grammar is taught as part of the texts studied. Emphasis is placed on drill and practical rather than theoretical language features. In the winter quarter, Bible is continued, and the students now begin Rabbinic Hebrew. In the spring quarter the emphasis shifts to Rabbinics and Commentaries.

A large number of instructors and laboratory assistants are used in the program. New manuals have been written for Bible by Dr. Hallo and for Rabbinics by myself.

The results of this program have already been gratifying. Progress in language has been very rapid. The next time you visit our Cincinnati campus, drop into the language laboratory and see for yourself how Hebrew has gone electronic.

Dear Rabbi Pilver:

I had a very pleasant interview with Morton Pomerantz and his father. We will be happy to have him as a student.

We have reinstituted the Undergraduate program which, in your day and mine, was known as the Preparatory Department. I have tried to discuss with Morton and his father the pros and cons of coming immediately or of his deferring his coming until he finishes at Oberlin. In a nutshell, if he comes to us right away, he will get his Hebrew from us spread out in the beginning stages instead of intensively as it would be if he came with his degrees. There are also some mechanical arrangements in his transfer from Oberlin to Cincinnati that they are looking into.

One of our faculty talked to him about his Hebrew knowledge and I am pleased that the report was favorable. We are going to have Morton take the written Hebrew Placement exam to see just at what stage he is.

I deeply appreciate your interest in sending us a student about whom you write that you are pleased with his intention to come. We will, of course, accept him on this recommendation from you.
