Dear Rabbi Silver:

This letter is written to you pursuant to our understanding arrived at at the meeting held in my office at which you, Edgar Hahn and I were present. The Beaumont Foundation has received numerous solicitations from Rabbis and other friends and officials of the Hebrew Union College-Jewish Institute of Religion for contributions to the Development Fund which is now in its campaign stage. These requests stem from the various cities in which the Beaumont Foundation is active. Inasmuch, however, as the purpose of the Fund is national in scope, the trustees of this Foundation determined, as a matter of policy, not to make separate grants through the local communities in the various cities, but to make a general grant on a national basis.

I am therefore happy to advise you, in your capacity as Honorary Chairman of the national campaign, notwithstanding the heavy commitments which this Foundation has assumed in areas of philanthropy which are historically within the pattern pursued by Louis D. Beaumont in establishing this Foundation (which commitments are currently very substantially in excess of the Foundation's available income), that the trustees of the Foundation have approved a special grant to your Fund in the sum of \$50,000.00, payable in three equal annual installments, the first of which is payable in December, 1961, the second in December, 1962, and the final installment in December, 1963.

Without commitment on the part of the Foundation, the trustees will, on their own motion at a later date, review the matter with a view of making a further grant if, in their judgment, the then circumstances of the Foundation should so warrant.

Dear Board Member: On November 21st, Judge Baar, the Chairman of the Board of the Union of American Hebrew Congregations, addressed a letter to Robert P. Goldman. I enclose that letter; Judge Baar was informed in advance of our intention to circulate his letter and he raised no objection. The underlinings, however, are mine. Two basic matters are at stake: 1) The College-Institute insists on returning to the arrangement prevalent before 1959 whereby prospective donors may determine completely where their funds are to go. 2) The "Development Fund" was entered into by contract between the College-Institute and the Union, and the contract bears the terminal date of December 31, 1962. The Union position is that that contract must be renewed and on Union terms respecting designation, and that if the College-Institute Board does not agree, then the Union will proceed -- so Judge Baar's letter threatens -- to abrogate the historic autonomy of the College-Institute Board. Judge Baar's letter prompted two replies from Mr. Goldman, and a telegram to Judge Baar from me. You will note that both Mr.Goldman and I have advised against action which would be detrimental to the Reform movement. In this conviction, I have deemed it desirable to inform you of our assessment of Judge Baar's letter. I felt the subject matter of this letter is of such importance that you and the other members of the College Liaison Committee should be advised in ample time before our meeting in Washington next week. First of all, my attention has been called to the fact that the College Board meeting is scheduled for January 31st, and today I received the formal notice. This is practically the same time that the U.A.H.C. Executive Committee is meeting in Los Angeles, and will make it impossible for Maurice, others and myself to attend. May I suggest that earnest consideration be given to changing the date to eliminate the conflict. Perhaps we can resolve this when we meet in Washington. All of us, I am sure, have had the opportunity for calm and sober reflection and soul-searching since our conferences in Cincinnati. The intervening time also provided the opportunity for us here to sound out the sentiments of some of our leadership around the country and to meet with the available members of our Liaison Committee for review of the discussions in Cincinnati. We have reached the following conclusions. Despite the pressure on the College because of the debt which it has incurred, we feel the course of action suggested by the College will create such rivalry and so deepen the divisiveness with which we are now confronted that untold harm will come to our movement, the repair of which will take years to accomplish. I know that some of your people gloss over this as nonexistent or unimportant. Forgive me if I say that in doing so they are either naive or unwilling to face the facts. Our Liaison Committee will report to the Board at its next meeting that the Development Fund Campaign should be continued as a genuine joint effort as suggested by Max Koeppel in his report. This eliminates the possibility of ear-marking without accountability and the exceptions suggested by the College as an alternative.

We urge the serious consideration of either of the following programs which we are convinced would be constructive and remove all the informities to which we have called attention: We will go along with your suggestion of a 70-30 split of Development Corporation funds until the bank debt is paid, at which time the percentages of distribution are to be reversed until the parity of proceeds between the College and the Union has been achieved, after which the funds are to be divided on a 50-50 basis; OR The Union is prepared to take over the obligation of the College bank debt and assume the payment thereof. With the use of the same securities which support the College debt to the Cincinnati bank, we are confident we can arrange financing here in New York at a much lower interest rate, thus reducing the debt service charge substantially. I should like to be advised of the exact amount of the College debt and the securities used to support it. We believe both plans are constructive and doable and either would provide the College and the Union with a stable financial base; provided, however, the following conditions are met: That the College make no further capital commitments including the Los Angeles project, until the bank debt is paid; That there be joint budgeting, both capital and maintenance, so that we may operate on the basis of needs rather than on an arbitrary numerical method; That the independent survey which the Biennial approved a year ago be implemented on a comprehensive basis which would include all the activities of our movement, embracing the functions and operations of the CCAR, the College and the U.A.H.C. and take into consideration needs, financing, program and future undertakings. We are greatly concerned about the impact on our movement of the financial policies pursued by the College. One has to have a decent respect for the opinions of others and in these matters we feel that the College Board ought to give due satisfaction to the almost unanimous judgment of the Board of the parent body.

If, however, the Board of the College remains determined to pursue independent policies which seem to the Board of the Union to be detrimental to the movement as a whole, we will have no recourse, consistent with our legal obligation, other than to create conditions within the Board of the College which will make it impossible for that Board to authorize actions which the Board of the U.A.H.C. deems inconsistent with the best interests of Reform Judaism. We would come to the adoption of such a course most reluctantly. The administration of the Union has, for a long time, been resisting insistent demands from our national leadership along these lines. We trust this will not be necessary. We view the situation as so serious and urgent that perhaps you and any others whom you suggest may want to meet with us in Washington on Thursday or Friday of next week. Further in reply to your letter of November 21st, I have to state that a very simple matter has come to be unduly complicated. It states that the Union Liaison Committee will recommend to the Union Board the continuation of the Development Fund, but without designation, as we have proposed. In other words, you reject our proposal. In its place, you make two counter-proposals, which in your letter are tied to three conditions.

Three years ago we made a contract for joint capital fund raising to run for three years. We have lived up to the contract. On the eve of the expiration of that contract, you inform us that we must renew that expiring contract on terms which you dictate, and if we do not, the Union Board will take over control of the College Board and thereby destroy its autonomy.

This comes at a time when we were discussing various forms of continuing the Development Fund jointly, and you had suggested that we should have a further joint meeting to discuss these matters shortly after the middle of the present month.

Your threat has grave implications for the future of Reform Judaism in America which you should consider very carefully.

NEW GROUP BEGINS WITH 30 LEADERS WHOSE GIFTS TOTAL \$2,000,000 PLUS

Development Fund Shows An Additional \$2,800,000 From Individuals, Rabbis, Sisterhood and Brotherhood

Builders of American Judaism!

Here is the newest and brightest star to emerge in the constellation of American Jewish philanthropy. Let's repeat the name.

Builders of American Judaism!

The more you study it, the better it looks. The more you say it, the better it sounds. The more you apply it to yourself, the better it makes you feel.

Acting in mid-December, 1960, the leaders of the Development Fund for American Judaism brought the Builders into existence as a major part of the effort to bring together \$15,000,000 for the capital expansion of the Union of American Hebrew Congregations and the Hebrew Union College-Jewish Institute of Religion — and specifically to serve these paramount purposes:

1. Builders of American Judaism shall be the Big Gifts wing of the Development Fund,

2. Builders of American Judaism shall seek gifts in the range of \$25,-000 and over, with emphasis on "over", gifts payable in 3 to 5 years,

As a mark of high distinction and honor, the title 'Builder of American Judaism' will be conferred upon all contributors making gifts to the Development Fund of \$25,000 or over. Each Builder of American Judaism will also receive a specially inscribed plaque, carved in bronze, proclaiming that he or she "shall be remembered in perpetuity for a supreme act of generosity and sacrifice."

30 Builders Give \$2,000,000 Plus

Announcement of the new group's formation was made jointly by former U. S. Senator Herbert H. Lehman, Honorary Chairman of the Development Fund, and Max L. Koeppel, the Development Fund's General Chairman. They emphasized in their announcement that the Builders of American Judaism was starting with a nucleus of 30 men and women — contributors whose gifts to the Development Fund range from \$25,000 to \$250,000 each for an aggregate of more than \$2,000,-

000. These gifts, they explained, are exclusive of another \$2,800,000 that have come in from other sources since the Development Fund's inception in November, 1959 — sources that include the Reform rabbinate, the 'Sisterhood Shares' drive of the National Federation of Temple Sisterhoods, and the Development Fund effort of the National Federation of Temple Brotherhoods.

Three Give \$250,000 Each

Sen. Lehman underscored one of the purposes of the new group with the presentation of Builders' Plaques to three men whose gifts are in the loftiest tradition of American Jewish philanthropy — gifts to the Development Fund of \$250,000 each. The three charter Builders are:

Mr. Koeppel, the Development Fund's General Chairman who serves also as the Treasurer of the Union of American Hebrew Congregations and who is prominent in the field of realty investments.

David W. Klau, a National Chairman of the Development Fund and a Vice-Chairman of the Hebrew Union College-Jewish Institute of Religion. Mr. Klau is an industrialist.

Jack A. Goldfarb, a National Chairman of the Development Fund and a member of the Board of Trustees of the Union of American Hebrew Congregations. Mr. Goldfarb is a manufacturer.

Mr. Koeppel turned the tables on Sen. Lehman immediately afterward by presenting this outstanding humanitarian and public figure with a Builder's plaque in recognition of the Senator's own gift.


In accepting the designation of Builder, Sen. Lehman remarked that he "couldn't think of a better cause than this one, which is doing so much to strengthen Judaism and which truly deserves the spirited and generous help of every man and woman who values the faith that has kept us going for so long."

Four Compelling Reasons

Mr. Koeppel, in his announcement, gave what he described as four "compelling reasons" for the Builders establishment at this time.

- 1). The explosive growth of the American synagogue movement, which embraces more than 1,000,-000 men, women and children in Reform Judaism alone an increase of 500,000 over the past 15 years has made it mandatory for the national institutions serving this constituency to act decisively in modernizing their outmoded facilities, and in acquiring new facilities.
- 2). Although the American synagogue encompasses the majority of American Jews, financial support of the central religious institutions serving them has lagged significantly behind the amounts annually given for medical, educational, welfare, health and refugee causes. While there ought to be no diminution in the support of causes and enterprises vital to the good health of Jewish communal life in this and other countries, there must be a radical improvement in the support accorded the institutions that serve the synagogue - in this case, the UAHC and the HUC-JIR.
- 3). The formation of the Builders of American Judaism should be viewed as a bold and dramatic step to elevate the standards of giving in precisely the area of Judaism per se, which provides the philosophical basis for Jewish philanthropy but which has benefitted the least from it in philanthropic terms.
- 4). The setting of \$25,000 as a minimum requirement for membership in the Builders of American Judaism was not done arbitrarily. It

was based on the long-term record of giving to Jewish communal causes. This record shows that funds are available and have been given in growing measure over the past 15 years for a variety of communal enterprises. This generous impulse on the part of American Jews must now be stimulated in the direction of central religious bodies. So far, 30 men and women have come forward with gifts to the UAHC and the HUC-JIR of \$25,000 and over. There are many more who have the means to respond in a like manner. We feel confident that the Builders of American Judaism is the vehicle that, finally, will move men and women to think and to act in far

larger philanthropic terms than they have been accustomed to with respect to the institutions that stand at the center of synagogue life.

Each Is A Builder

Here are the men and women to date who have earned the title 'Builder of American Judaism'. Included here are 12 gifts of \$25,000 each; one gift of \$35,000; six gifts of \$50,000 each; one gift of \$100,000; one gift of \$110,000, and three gifts of \$250,000 each.




The New Face of the Campus

by growing, seeking congregations throughout the land, our Reform Judaism came into its ascendancy.





The modern forms we have chosen for our new home reflect the dynamism of our faith and teaching.






Dalsheimer Rare Book Wing






The New Dormitory
