Cleveland, Ohio Dear Rabbi Silver: I am writing this letter to you because of the very important development of matters in connection with the Hebrew University that have taken place as a result of the recent news concerning Mount Scopus. I know you will understand the reasons that I have marked this letter "Confidential" and why I do not enter into all the details in writing. You will be aware of the fact that we have had our plans prepared for the most important building on the new campus of the University, that for the National and University Library. With the development of our campus, and the centralization of more and more of our teaching and research there, the need to have the Library established as soon as possible had, in any case, become very urgent. Work had already been started and the digging of the foundation completed. In the first stage, we are planning to erect a building which will house a million and a quarter books, and all the very important archives and manuscripts which belong to the University. Our Library, of course, is not only the Library of the University, but as the National Library, serves the whole of the State of Israel. We are now suddenly faced with a unique opportunity, as well as an urgent challenge. For some ten years we have been at tremendous disadvantage because over one-half million books and periodicals were isolated on Mount Scopus. As a result of the recent United Nations arrangements, we will now be able to bring these books into town. This apart, apparently, from equipment and other things. The challenge now is for us to erect in the shortest possible time the Library building which can house these books. as well as the approximate one-half million volumes that we have accumulated in recent years in the city of Jerusalem. I need not stress the implications of our being unable to house the books and archives from Scopus for which we have been pressing so hard. 373

Rabbi Dr. A. H. Silver -2-January 21, 1958 I am happy, as I am sure you will be, to know that all the plans and necessary preparations are ready for the commencement of the building. The challenge is for us to find the means whereby we can complete the first stage of the building within one year, and the whole building in a period of two years. This can be done if our friends will make a supreme effort. The factor on which everything now revolves is the financial one. We must, firstly, make an immediate drive for the collection of outstanding pledges for the Library and, secondly, make an all-out effort to raise the additional sums which will enable us to build the Library. I am certain that you as a member of the Board will understand without my going into further detail the vital importance to the University, to Israel as a whole, as well as, even in a wider sphere, to our being able to start construction immediately and complete it as soon as possible. This can be done if the members of the Board are prepared to make a special effort in this connection. I am sure that we will have your full cooperation.
