
Dear Rabbi Daniel:

their Specially Assigned Lists.

A project of the kind and quality described in the Prospectus, together with several other related commemorative activities which the Committee has in mind, will require a separate fund of approximately \$25,000.00. It is not intended that there shall be a public solicitation of the general membership, although contributions from any source will of course be gratefully accepted. From the assurances received from a comparatively small number of the Temple members with whom the project has been discussed, the Committee believes that the requisite amount can be quietly raised without embarrassment, to the Temple or the Rabbi, that might result from a public appeal, from those members who have in the past demonstrated their loyal support of the Temple and their love and admiration for Rabbi Silver and who would feel honored in making contributions of \$100 or \$200 or more, as they may see fit, towards the fund. Checks should be made payable to The Temple, Cleveland, Ohio. The publication of such a volume is an honorable and honored tradition in Jewish life. You may wish to acquaint yourself with such recent publications as the Jubilee Volume in honor of Dr. Mordecai Kaplan, founder of the Reconstructionist movement, and the volume in honor of Professor Salo Baron of Columbia University. Dear Rabbi Silver:-

This is acknowledgement of your letter of Oct. 13, 1961.

We are delighted that you are thinking of us in connection with the Jubilee Volume in honor of your fathers seventieth birthday.

It is very difficult to offer an estimate on the book without seeing the book. The most expensive part of the book is the composition, and we would have to know exactly what is involved in the composition before offering any estimate.

Perhaps as a guide it might interest you to know that the Hebrew Union College, 1600 copies of 400 pages, cost the College about \$15,000.00. Additional copies would cost them approximately \$1.00 a piece.

We could provide you with the finest type of a book, as we have for the major Jewish institutions of the country.

I think you ought to plan on giving us one year to set all of the type, have you read galley proofs and page proofs, and then have us produce the book.

When you decide on the kind of a book you would like, we could make up sample pages and submit them to you.

My suggestion is that out of your library you pick what you consider the handsomest book there, and let us use that as a model book as to the type, the type page, the binding, etc.




Dear Rabbi Silver:




Dear Rabbi Silver:

The volume, "In the Time of Harvest," was subsidized in its entirety. The total project ran approximately fifteen thousand dollars, which was raised quietly some two years ago by contributions. There is a possibility that we will receive monies from the commercial sale of the book, and these will be placed in the Abba Hillel Silver Charitable and Education Foundation, which is the owner of record.

Briefly put -- and the contract is a lengthy one -- the sponsors undertook to pay the entire cost of manufacture and retained control over the type of paper, type face, etc. In essence, Macmillan jobbed out its publication skills and guaranteed us its editorial know-how, publicity channels, etc. Thirty-five hundred copies of the book were published with both The Temple and Macmillan participating in the profits from their sale. They are being sold through normal commercial agencies, as well as The Temple.

May I give you a bit of hard-earned advice? We made our deadline, but only through a rigid policy of editorial control. Once the manuscript had been received, it was typed from the author's text on to a master. This was done at The Temple. The master was returned to the author for any corrections or changes he might wish to make.

We guaranteed the returned typescript would be published as we received it. Despite endless pleas, no galleys were distributed for correction. Authors are notorious for changing their minds and every change is time consuming and costly.

PROSPECTUS OF A COMMEMORATIVE VOLUME TO BE  
PUBLISHED IN HONOR OF RABBI ABBA HILLEL SILVER

The congregational year 1961-62 presents an unprecedented milestone in the history of the Temple. It marks the 45th year of the uninterrupted leadership of Rabbi Abba Hillel Silver as its spiritual head. The congregational year 1962-63 immediately following, will contain the 70th birthday anniversary of Rabbi Silver. These long fruitful and eventful years have been replete with unfailing and dedicated service on his part, not only to the Temple but to world Jewry and all humanity as well. During these years, wide recognition has been accorded to the great Rabbi as an outstanding personality of world stature. All this assuredly calls for appropriate commemorative observance on the part of those fortunate persons who comprise the Temple's membership.

In appreciation of the foregoing, President Bertram J. Krohngold has appointed a special organizing committee, with Abe M. Luntz as Chairman, to formulate a plan for the suitable commemoration of this important biennium occasion.

In view of the fact that Rabbi Silver has always declined any commemorative gift of a personal nature and in all probability feels no differently in that respect now, the Committee has planned a jubilee project which, it is believed, will not only be acceptable to him but will please him deeply. The principal feature of the project will be the publication, without profit, of an important commemorative volume to be issued in his honor. The publication of such a volume is in accordance with an honorable and well established tradition in Jewish life. It will contain an extensive biographical essay on Rabbi Silver, including an appreciative appraisal of him as Rabbi, inspirational leader and as a great human being; it will also contain a complete bibliography of his works and numerous scholarly articles of leading writers, including of course Rabbi Silver, basically



drawn from the important religious, cultural and literary areas which have been of great interest to the Rabbi and in which he has made so many outstanding and enduring contributions. A distinguished group of eminent scholars will select the contents and edit the book. It will undoubtedly be an impressive volume, not only a highly fitting and lasting tribute to Dr. Silver but will be, as well, an important work of permanent literary value entitled to an honored place in public and private libraries, religious and lay, wherever they may be.
