



Dear Dr. Silver:

When I opened the Times this morning and read the news about your new appointment, I did not know whom to congratulate: you or the Jewish people?

Harry (Shapiro) told me a few days ago that this was coming, and, therefore, it was no surprise to me. The question which is constantly in my mind since I read the news is whether one may indulge in an optimistic interpretation of the fact that you have agreed to head Israel Bonds. What I mean is: can this be taken as a sign that you would return to active political leadership?

It is a long time since I talked to you "Ponim-el-Ponim", and I have no way of knowing your thinking on the recent political developments in the Middle East. Speaking for myself, I feel acute physical pain when I read the news from that area - most particularly when I observe the temperamental adventures of Israel's policy vis-a-vis the Arabs.

In a way, Israel's foreign policy reminds<sup>me</sup> of the life story of my friend, Dr. Akzin. I always felt that no one could do as much damage to Akzin as Akzin did to himself. The same is true, I am afraid, about Israel. Whenever they land in a position when world public opinion is on their side, they hasten to do something so outrageous that the outside world has no choice but to turn against them. First Kybia, now Syria. They sure have a talent for the poorest timing imaginable.

If Harold is still in Cleveland, please remember me to him. My best wishes to you and yours for a Happy New Year.
