"Rabbi Abba Hillel Silver, great spiritual leader and great Zionist, will be guest of honor in Los Angeles at a city-wide dinner Saturday, October 20th, sponsored by the Zionist Organization of America in behalf of Israel Bonds," it was announced today by Rabbi Jacob M. Ott, President of Western Region of Z.O.A.

"The banquet with Rabbi Silver," Rabbi Ott stated, "will be the opening session of the Fifth Annual Convention of the Western States Region."

Krown announced that the October 20th banquet will honor Rabbi Silver "for 50 years of Zionist activity. He brings us his eloquence and guidance at the time most difficult/in Israel's history. He is one of the most informed men in the world today, and his message will be of utmost importance in view of the current Middle-Eastern situation."

Spurred by the news that Rabbi Silver will be honored on October 20th, all Z.O.A. Districts are planning an immediate and intensive campaign to contact all members and to ensure maximum B.I.G. sales for the affair.

There is no doubt in my mind that the present Munich appeasement line, vis-a-vis the dictator in Egypt and the Arab states generally, will have to be abandoned before long. The objectives which were sought through this appeasement policy have completely eluded the Western world. It was a false, and it has now been proven to be a bankrupt policy. It opened the doors wide for Communist penetration, and it has encouraged Arab flaunting of the interests of the free world.

But until such time as this blundering policy will be finally abandoned, and the Western governments unite firmly in the defense of the interests of the free world in the Middle East, Israel, which has been imperiled, must look to its own defenses and to the support which its friends in all parts of the world can bring to it.

Economic strength is the surest way to build up Israel's security.

And the purchase of Israel Bonds is the surest way to make Israel economically strong. Every completed irrigation project, every new settlement and settler, every new road built, every harbor improved, every new ship and sailor, every new industry and factory, every mine and oil well, is so much red blood poured into the arteries of the nation, contributing to its strength and power and defense potential.

We cannot control what the nations will ultimately do with reference to Israel, but we can control what we ourselves can do. We will not slacken our efforts in any way. And we will see to it that the young State of Israel will grow stronger through the years.

Rabbi Abba Hillel Silver, who will be honored for his fifty years of creative Zionist leadership at a dinner, Saturday, October 20th, in behalf of Israel Bonds at the opening session of the Western States Region of Z.O.A. this week sent Charles Krown, Dinner Chairman, a special letter outlining the famed Rabbi's stand on the Middle-Eastern situation.

Silver, expressing his anticipation at being in Los Angeles, stated,
"There is no doubt in my mind that the present Munich appearement line,

Hilton has motivated the largest mobilization of Z.O.A. forces in recent years,
Charles Krown announced.

With special committee meetings scheduled almost daily, an extraordinary session will be held for members of the Z.O.A. Regional Board and members of the Rabbi Silver Banquet Committee, in the Board Room of the Jewish Community Building, 590 N. Vermont, Monday, October 15. Rabbi Max Nussbaum will address that meeting, giving the background on the Z.O.A.'s National Convention, and the significance of the Silver meeting as the opening session of the Western Region.

Co-Chairing the October 20th dinner are Abe Spiegel and Jack Smith, with Theodore Strimling as Honorary President.

Rabbi Abba Hillel Silver, one of the great figures of American Jewry, delivers an important address tomorrow night, Saturday, October 20th, in the Beverly-Hilton, when he will be honored for his fifty years of creative Zionist leadership.

Rabbi Silver will be guest of honor at the dinner which opens the Fifth Annual Conference of the Western States Region, Z.O.A., in behalf of State of Israel Bonds.

A packed hall is expected to hear Rabbi Silver, who is Chairman of the Board of Governors of the Israel Bond Organization, strongly define Israel's position in the world today — and to insist on the role of American Jews in the struggle for peace in the Middle-East.

Dinner Chairman Charles Krown announced that "celebrating 50 years of creative Zionist leadership on the part of Rabbi Abba Hillel Silver takes on even greater meaning when we realize that he comes to us at a time when our activities in behalf of Israel's economic security may be determining the survival of Israel. Dr. Silver views the Los Angeles gathering as a key to what will be done throughout the nation. We have been chosen to set the example. What we achieve will measure what Israel can achieve in its determined struggle to win the peace."

Krown paid tribute to the Z.O.A. committee which has been working day and night on the affair. Rabbi Jacob M. Ott, President of the Western States Region, Z.O.A., and dinner co-chairmen Abe Spiegel and Jack Smith, with Honorary Z.O.A. President Theodore Strimling have led the way in regular committee sessions for six consecutive weeks.

Rabbi Ott will open the October 20th ceremonies. Rabbi Max Nussbaum of Temple Israel will introduce the guest of honor.

Rabbi Silver's offices, held during his long service, include National Chairman, United Jewish Appeal; National Chairman, United Palestine Appeal; Dudleian Lecturer, Harvard University; member Near East Relief Committee; President, Central Conference American Rabbis.

Remaining Conference sessions will continue through Sunday, although Rabbi Silver's only appearance will be at the Saturday banquet.




