Dear Senator Lausche:

I am writing to you on a matter which concerns me deeply - the American aid program to Israel. I have been interested in this matter from the beginning - since 1951 when I urged the Administration to include Israel in our mutual security program.

As you may know, Israel took in some 600,000 immigrants between 1948 and 1951 and its economy was gravely imperiled by its own humanitarian action. Accordingly, in that year I appealed to Senator Robert Taft and to some of his colleagues to sponsor a bill for a grant to Israel, and I am very glad to say that Congress heartily concurred.

I have recently learned that in the current mutual security program, which will soon be taken up by your COmmittee, the Administration contemplates no further special assistance to Israel. Instead, the Administration intends to aid Israel by development loans and through the sale of surplus foods.

The fact of the matter is that in recent years the grant program to Israel has been declining and there has been a shift to loans and surplus foods, as you will note from the following table. But I am troubled by the Administration's apparent intention to terminate the grant program completely at this time.

I would be grateful to you if you would take/this matter in any way which you think appropriate, whether by direct approach to the Department of State or by your intervention during the hearings on the mutual security program. Here is the situation, as I understand it:

1. The Administration is attempting to justify the termination of grant aid on the ground that Israel has made substantial progress and therefore no longer needs direct grants. Like all of Israel\*s friends I have been very pleased by the remarkable progress that that young country has made, but I have the impression that her progress, however commendable, does not justify the end of American grant assistance.

Israel is still taking in a substantial number of immigrants. While this has been the responsibility of the Jewish community in the United States and elsewhere in the world, the Israelis have been heavily taxed by the opportunity to receive and welcome these newcomers. This humanitarian undertaking merits the

continued interest of our government. I am not urging a special grant or appropriation for refugee resettlement. I understand that the government of Israel has made no such request. But I do suggest that it would be wrong to reduce aid to Israel under these circumstances.

- 2. It is true that Israel has made progress. Her exports have grown and her reserves have increased. But Israel still has a large trade deficit of some \$340 million a year, the gap between her exports and imports. This gap has been covered by the sale of Israel bonds, by contributions from the United Jewish Appeal, by grants and loans from the United States, and by the reparations and retribution payments from West Germany. But all reparations payments from Germany will come to an end in a few years. I understand that the final payment will be made in 1965. On the other hand, Israel will face new demands upon her economy by 1962, since the first Israel bond issue will be maturing at that time and she will have to start paying off her debts. Obviously she will try to refund, but her debt service will increase and her income will decline. The obvious solution is to expand Israel's economy as quickly as possible, so that she will be less dependent on imports and outside aid and will be able to develop her export trade. To avert a disastrous crisis in 1963 we ought to be spurring Israel's development now. Thus, I believe that any reduction in aid to Israel at this time would be a perverse action in the light of the progress that she has been making and the needs that confront her in the next few years.
- 3. I know it is argued by some economists that Israel's gross national product per capita is high and that her people are producing more than some of the peoples of Europe. Certainly she leads the new countries which have come into existence since 1945. But there is an important consideration to keep in

mind. Israel does not receive any arms from the United States or from any other country. Israel has to pay for her arms. Moreover, Israel does not receive any defense support from the United States. Israel must take a large part of her earnings and allocate them for the maintenance of her army. Meanwhile, her neighbors have been receiving lavish arms shipments from both the Soviet bloc and from the West. Egypt, Yemen, Syria and now Iraq have all been getting huge arms shipments from the Soviet bloc. Our own country has provided military assistance to Lebanon, to Iraq, to Saudi Arabia and to Jordan. No one gives arms to Israel. Israel must shop for her arms and pay high prices. I am not suggesting that the United States now grant arms to Israel. The Israel government has no such pending application. I do argue that our aid program to Israel should take into account the absence of any assistance to Israel's military establishment. I have the conviction that Israel's army is a force for stability and peace in the Near East and that it is much in the interest of the free world to help preserve Israel's economy.

- 4. I have been impressed in recent months by Israel's growing relationships with the new countries in Asia and Africa. She has established the friendliest relations economic, cultural and scientific with new governments which are looking to her as an inspiration and an example of what can be done to raise living standards in a democratic community. It is in the best interests of the free world to strengthen that young democracy so that she may continue to serve as a vivid demonstration plant for freedom.
- 5. Finally, I think that the sudden termination of our aid program to Israel will be misunderstood and will have unfortunate repercussions in the Arab world. Many Arabs who still reject peace with Israel will interpret our action as an encouragement to press their boycott and war against Israel.

Continued United States aid to Israel is one forceful way of letting the Arabs know that we continue to stand by Israel and that we want the Israelis and the Arabs to make peace.
