IN THE HOUSE OF REPRESENTATIVES

JANUARY 29, 1947

Mr. HOLIFIELD introduced the following bill; which was referred to the Committee on Foreign Affairs

RESOLUTION

Whereas a singular omission exists in the councils of the United Nations concerned with the structure of an international organization and the establishment of permanent peace, as well as in the commissions, agencies, and other administrative bodies engaged in the consideration of war crimes, relief, rehabilitation, and reparations, by virtue of the exclusion from participation in these intergovernmental bodies of the Hebrew people of Europe and Palestine whose vital contributions in the war against the Fascist Powers were made by Hebrew battalions in Allied armies and by underground resistance groups in occupied countries, and whose casualties in this war exceed four million dead; and

Whereas the atrocities disclosed in the recent occupation of German concentration camps have proved to a horrified world that Fascist Powers, allowed to perpetrate their savage outrages against this homeless, dispersed, and unprotected

people, will extend these acts to all peoples in their power; and

Whereas the plight of the Hebrews in Europe is desperate, the problem of their relief and rehabilitation being hedged by special difficulties affecting no other people so that even in those liberated countries where the Hebrews have regained their legal rights, they are dying by the thousands from starvation and disease because there has been no restitution of jobs, homes, or property; and

Whereas the retention of the status quo in regard to the Hebrew people is in itself a threat to the world peace, for Fascist forces in all European countries will again utilize anti-Semitism as an instrument for their return to power and in the destruction of democratic governments, resulting in a threat to a peaceful world order; and

Whereas the vast majority of the survivors of the Hebrew people in Europe reject the possibility of returning to the lands of their recent martyrdom and of owing allegiance to the nations that have participated in their persecution, but, on the contrary, regard themselves as constituting with the Hebrews of Palestine a single national entity, intimately and inseparably welded by the sufferings they have endured in common: Therefore be it

- 1 *Resolved*, That it is the sense of the House of Rep-
- 2 sentatives of the United States that the Hebrew people of
- 3 Europe and Palestine be recognized as a renascent Hebrew
- 4 Nation, it being understood that this action applies to all
- 5 the Hebrews in Europe who voluntarily renounce allegiance
- 6 to all other nations and that it does not affect the legal

1 status, political allegiance, or civic rights of Americans of
2 Hebrew origin or Jewish faith nor the legal status, political
3 allegiance, or civic rights of the nationals of Hebrew origin
4 or Jewish faith in any other country; and be it further

5 *Resolved*, That the Hebrew Nation shall be accorded
6 the same rights of self-determination within the general pro-
7 gram of international adjustment as may be freely granted
8 to other nations and shall be entitled to take its rightful
9 place among the free peoples of the earth as a member of
10 the United Nations and to be represented as such, in the
11 councils, commissions, agencies, and other intergovernmental
12 bodies of the United Nations; and be it further

13 *Resolved*, That it is the sense of the House of Repre-
14 sentatives that the rights previously granted to the Jewish
15 people and recognized in international law by virtue of
16 various treaties and covenants, including the Balfour Declara-
17 tion, the mandate of the League of Nations, the treaties and
18 covenants of the subscribing members of the League of
19 Nations, as well as those treaties and conventions sub-
20 scribed to by the Government of the United States shall
21 now be conveyed to the Hebrew Nation without prejudicing
22 the normal rights and prerogatives of the Hebrew Nation
23 by the limitations contained in these treaties and covenants;
24 and be it further

25 *Resolved*, That it is the sense of the House of Repre-

1 sentatives of the United States that the United Nations
2 assume responsibility for the repatriation of the Hebrews
3 in Europe, who desire to end their long exile and their status
4 of pariah in many nations and to return to their national
5 territory of Palestine, by establishing a special intergov-
6 ernmental agency to facilitate and effectuate the process of
7 repatriation; and be it further

8 *Resolved*, That in keeping with the resolutions adopted
9 by previous sessions of the United States Congress and the
10 declarations of sympathy and support issued on several oc-
11 casions by the Presidents of the United States, by both the
12 Democratic and Republican Parties, and by numerous
13 national American organizations, the Government of the
14 United States lend its good offices to the end that the land
15 of Palestine shall be placed under an administration which,
16 in accordance with the expressed intentions of the League of
17 Nations mandate, will offer the Hebrew Nation the fullest
18 opportunity to reconstitute this territory within its historic
19 boundaries as a free state, with the Arabs as equal members
20 in a democracy, guaranteeing to all its citizens full civic,
21 religious, and political rights and liberties, and dedicated to
22 the principles of freedom and justice and world peace.

Mr. BUCKLEY submitted the following concurrent resolution; which was referred to the Committee on Foreign Affairs.

---

## WRHS CONCURRENT RESOLUTION

Whereas the Palestine issue is now being considered by the United Nations General Assembly at its special session; and

Whereas the people of the United States look to the United Nations as the trustees of the world's conscience and expect it to live up to the promise of a Jewish homeland contained in the League of Nations Mandate of 1922; and

Whereas there have been at least seventeen committees of inquiry on the subject of Palestine, including the Anglo-American Committee of last year, whose unanimous report was not accepted and acted upon by Great Britain; and

Whereas the Jewish people vitally concerned in this matter are not represented on any committee of the United Nations investigating Palestine; and

Whereas the British Government is enforcing the white paper of 1939, declared illegal by the Permanent Mandates Com-

mission of the League of Nations and condemned by men of good will in every land; and

Whereas acting under that illegal policy the British Government has imposed totalitarian measures of repression on the entire Jewish community of Palestine culminating in the ignoble hanging of four young martyrs and the deaths of others; and

Whereas Great Britain continued to keep over one hundred thousand troops in Palestine, and recognizes no law, but the law of brute force and terror, which contribute greatly to the chaotic conditions that now exist there, and which is contributing greatly to world instability; and

Whereas the Jewish people in Europe have already suffered greatly, especially in the loss of over six million people exterminated by Hitler and other tyrants and suffered and endured unspeakable horrors in the concentration camps of Europe; and

Whereas the plight of the Jewish survivors in Europe is desperate, and steadily growing worse because they are dying by the thousands from starvation and disease because there has been no restitution of jobs, homes or property, making it imperative that they be permitted to leave Europe and go to Palestine the land of their choice at the earliest possible moment; and

Whereas the seizure and mass deportation to Cyprus of Jewish immigrants by the British is in direct violation of the mandate, of the principles of the Atlantic Charter, and of every moral and democratic concept; and

Whereas the Government and the people of the United States of America, through the passage of resolutions by previous

sessions of the Congress of the United States and the declarations of sympathy and support issued on several occasions by the Presidents of the United States, through planks in the platforms of both the Democratic and Republican Parties, are committed to the policy laid down by the framers of the Palestine Mandate; free Jewish immigration into Palestine so that the Jewish people may reconstitute that country as a free and democratic commonwealth; and

Whereas the President of the United States of America has asked on four separate occasions that Britain carry out the terms of the existing mandate for Palestine and admit, at once, to Palestine one hundred thousand displaced Jews;  
Therefore be it

1       *Resolved by the House of Representatives (the Senate*  
2    *concurring), That it is the sense of the Congress of the United*  
3    *States that the President of the United States take all the*  
4    *steps necessary to insure that during the special session of*  
5    *the General Assembly of the United Nations, the Delegate*  
6    *of the United States shall advocate the program for Palestine*  
7    *which our country has reaffirmed time and again; and be it*  
8    *further*

9       *Resolved, That we respectfully call upon the President*  
10   *of the United States to bring the great weight of the United*  
11   *States Government to bear on Great Britain, the Mandatory*  
12   *Government, to the end that pending a final settlement of*  
13   *the Palestine issue by the United Nations, an interim policy*  
14   *based upon the terms of the existing mandate for Palestine*

## CONCURRENT RESOLUTION

Whereas Great Britain as the mandatory of Palestine has requested the United Nations General Assembly to make recommendations concerning the future government of Palestine and has agreed to submit to the General Assembly an account of its administration of the League of Nations' Palestine Mandate; and

Whereas the United Nations General Assembly has accepted this request and will make recommendations for the solution of the problem of Palestine; and

Whereas by virtue of the American-British Palestine Mandate Convention of 1924 the assent of the United States is required to changes in the Palestine mandate; and

Whereas the policy of the United States regarding Palestine has been established by the President as follows: " \* \* \* that a national home for the Jewish people should be estab-

lished in Palestine"; and by the Congress as follows:

"\* \* \* that Palestine shall be opened for free entry of Jews into that country to the maximum of its agricultural and economic potentialities, and that there shall be full opportunity for colonization and development, so that they may freely proceed with the upbuilding of Palestine as the Jewish National Home, and, in association with all elements of the population, establish Palestine as a democratic commonwealth in which all men, regardless of race or creed, shall have equal rights": Now, therefore, be it

- 3       *United States announce its continued adherence to its Pales-*
- 4       *tine policy as established by the President and the Congress*
- 5       *and its willingness to join in the carrying out of a solution*

Whereas the Congress of the United States (in Public Resolution 73, Sixty-seventh Congress, second session, and S. Con. Res. 44, Seventy-ninth Congress) has favored assistance for the rebuilding of Palestine under the terms of the League of Nations Mandate; and

Whereas the United Nations have formally adopted a resolution which recognizes the rights of the Hebrew people to sovereignty in Palestine and have called upon the British Government to evacuate a seaport in an appropriate area of Palestine not later than February 1, 1948, in order to facilitate the free entry of Hebrews into Palestine; and

Whereas some two hundred and fifty thousand Hebrews now find themselves in the allied zones of occupation in Germany, Austria, and Italy living under deplorable conditions, and considerations of humanity and justice dictate that these

survivors of Nazi brutality, who lost six million of their kin, should be assisted to resume a new and dignified life; and

Whereas immediately after VE-day the United States Army repatriated seven million European displaced persons to their countries of origin; and

Whereas the United Nations decision on Palestine now makes it possible to repatriate all the Hebrew displaced persons to that country; and


Whereas the President of the United States, on October 4, 1946, publicly announced that preparations for this movement have already been made by the United States Government and that the Government is ready to lend its immediate assistance for the purpose of transporting displaced persons to Palestine; and

Whereas the speedy evacuation from Europe of the Hebrew displaced persons would have a beneficial effect on the stabilization of Europe which the United States now seeks to achieve; and

Whereas the maintaining of these displaced persons in the camps constitutes continuing expenses to the occupation authorities, which expenses are greater than the single cost of their repatriation to Palestine: Now therefore be it

- 1        *Resolved*, That it is the sense of the House of Representatives that the President (1) should direct the appropriate agencies of the Government to take action to remove (4) from the American zones of occupation in Europe all Hebrew (5) displaced persons and to assist in their repatriation by trans-

1 porting them to Palestine prior to October 1, 1948, in order  
2 that camps and settlements for Hebrew displaced persons  
3 in the American zones of occupation may be closed by such  
4 dates; (2) should direct the proper authorities in the Amer-





Whereas it has been the intent and purpose of the democratic nations of the world since the enunciation of the Balfour Declaration in 1917 to guarantee the establishment of a Jewish national home in Palestine; and

Whereas it has been the high resolve of the United States as set forth in a congressional resolution of 1922 and often reaffirmed since that a free and democratic Jewish Commonwealth be set up in Palestine; and

Whereas a mandate was given to Great Britain, following the freeing of Palestine from Turkish domination, for the purpose of establishing a Jewish national homeland in Palestine; and

Whereas every President of the United States since Woodrow Wilson has affirmed the belief of the United States in the age-old hope of the Jews for a homeland in Palestine; and

Whereas the British mandate over Palestine is now coming to

an end after twenty-five years, during which the establishment of a Jewish homeland in Palestine has not been accomplished; and

Whereas the United Nations, at the urging and with the support of the United States, has agreed upon the establishment of an independent Jewish state in Palestine by partition; and

Whereas the United States, having advanced and supported this plan for partition, has now reversed its stand and seeks to influence the United Nations to alter its partition decision; and

Whereas this about face of the United States seriously jeopardizes the fulfillment of the historic commitment of the whole democratic world for a Jewish homeland in Palestine and furthermore imperils the Jewish people of Palestine by denying them arms to defend themselves against aggression; and

Whereas the Hebrew people have consistently demonstrated their unwavering devotion to the principles of democracy and humanity, as well as their ability and willingness to serve as a bastion and an arsenal of democracy against the forces which threaten those principles: Now, therefore, be it

1       *Resolved by the House of Representatives (the Senate*  
2       *concurring), That it is the sense of the Congress of the*
