PERSONAL AND CONFIDENTIAL

My Dear Dr. Silver:

I have been anxious to write to you for some time to bring to your attention several developments in Washington which I believe will be of interest to you.

During the past week, I have had an opportunity to discuss the problems of Israel both with Secretary of State Marshall and with President Truman. As you will understand, I took the occasion at these discussions to stress our need for full recognition from the United States Government, for financial assistance in immigration and development, and for early admission to the United Nations. While both Secretary Marshall and President Truman received me in a friendly manner, they did not give me specific assurances on these points.

Meanwhile I have heard, through a responsible source, of certain developments affecting a "deal" between the Administration and the Republican Party leadership affecting Israel which troubles me profoundly. According to my report, Messrs. Lovett, Dulles, and Vandenberg met recently and agreed on a common line with respect to foreign policy in general and Israel in particular. This agreement involved a determination to keep discussion of foreign policy out of the Presidential campaign. At the same time, the parties to the agreement have reportedly concurred that they should not express differing views on the problems of Palestine and that U.S. Government policy on Palestine should be developed in close consultation with the British Government. I wonder how far the leadership of the two parties is aware of this "deal" and what can be done to prevent a direct betrayal of both Party platforms.


I am enclosing also a letter which I have addressed today to Under Secretary Lovett about a related matter which troubles me equally. Quite frankly, the Administration has done nothing to implement its promises of financial assistance for our resettlement and development requirements. Instead, we have been put off by empty words from week to week, and from

month to month. I can hardly imagine that the President has known what a run-around we are being given on this question. Here again information at the highest political level may be helpful.

I know that you will be leaving for Israel shortly in connection with the meeting of the Actions Committee and that you have most important functions to perform there. Perhaps, however, you and your friends can give some attention to these matters before your departure.

Best wishes for a pleasant and successful trip to Israel and best regards to all our friends there.


Dear Dr. Silver:

Statement made by Special Representative of the U.S.A.

Mr. James G. McDonald at Conference with the

Minister for Foreign Affairs, 6.9.48

The United States Government expresses the hope that Israel will become a great force for constructive rebuilding within Israel's own territory and will be able to exercise a beneficial influence upon this whole area.

The U. S. Government desires to aid in every proper way in this constructive development.

I am requested to emphasize in the closest possible terms the statements which I made to you and Mr. Ben-Gurion during our first talks: the U.S. is determined to use all its influence to prevent the violation of the truce and should, unhappily, such violations occur, will support in the Security Council an immediate action, if necessary under Article 7, against the aggressor. My Government feels strongly that such violations must not be tolerated because the maintenance of truce is an essential prerequisite of peace negotiations.

My Government would be grateful if the Provisional Government of Israel would let it be known, through me, if the Israel authorities have any reason for confidence that any one of the Arab States or any group of Arab States is prepared to initiate peace negotiations.

In order to determine whether there is a basis for facilitating peace negotiations, my Government, in strictest confidence, desires to learn the reaction of your Government to the following suggestions which, although tentative and in the nature of "trying on for size", are put forward by my Government in its earnest desire to aid Israel in becoming a permanent force for the maintenance of peace and economic development in the Middle Eastern area.

The suggestions are advanced that:

- (1) Perhaps a solution can be worked out as a feature of any final understanding with Transjordan which would exchange a large portion of desert land of the Negev for that portion of fertile Western Galilee which Israel now occupies militarily.
- (2) While my Government believes that Jerusalem should be an international enclave along the lines recommended by the General Assembly Resolution of November 29, 1947, and the Trusteeship Council Resolutions of April and May, the U. S. would consider acceptable any other arrangement satisfactory to Israel and the Arab States, provided the safety of and access to the Holy Places is guaranteed.
- (3) The U.S. Government would like the Israel Government to consider some constructive measures for the alleviation of Arab refugee distress which is a factor influencing world opinion.

It should be clear that my Government feels that demands which exceed suggestions (1) and (2) above would be prejudicial to the possibility of effecting permanent peace in Palestine.

If the Israel Government is prepared at this time to make known to my Government constructive views in response to the above suggestions, the U. S. is willing to commend the above programme to the Mediator and the British Government which it is contemplated can exert considerable influence on the neighboring Governments.



My dear Mr. Epstein:

You may recall that the Americans for Haganah was requested some months ago by the Jewish Agency to wind up its activities and to dissolve, its work having been accomplished. The organization was to wind up its activities by October 1, 1948. On that date the organization formally announced its dissolution but simultaneously announced a continuation of its magazine, Haganah Speaks. The Executive of the Jewish Agency regards this as a clear contravention of its decision and the earlier agreement of Americans for Haganah. Furthermore, the magazine, Haganah Speaks, has been used in recent months for purposes of partisan political propaganda and the Haganah of old and the Z'va Haganah of today is in no way connected, as you well know.

This matter was again considered by the Executive of the Jewish Agency yesterday. It intends to issue a statement to the public stating that Haganah Speaks is in no way connected with the Z'va Haganah, the national Jewish army of Israel, and that the title of Haganah in this publication is entirely unauthorized as well as misleading. Before issuing the statement, the Executive would like to make sure that such a statement would be entirely in keeping with the facts, as they are known to you and to the government of Israel. Please let me have the information at your earliest convenience because the Executive would like to act on this matter promptly.


