Dear Doctor Silver:

In view of the decision of the United Nations relative to the partition of Palestine, it appears likely that the entire structure and function of political Zionist organizations in the Galuth will undergo revision. It seems doubtful that the World Zionist Congress and the Jewish Agency as now constituted will have either the purpose or the authority they now enjoy.

Under these conditions, certain fundamental changes in the outlook of the individual Jew in the Galuth must be considered, and it is in regard to this new orientation that I write you at this time. I wonder if you would be kind enough to let me have your own opinion on the following specific questions.

- 1. Is there a valid reason for the continuance of the several independent (and at times conflicting) political Zionist organizations in America? I refer to the so-called "legitimate" groups: The ZOA, Mizrachi, LZOA, etc. To what extent are we in the Galuth morally justified in attempting to direct the life of the Yishuv?
- 2. What positive, constructive role do you envisage for the American Zionist in the new era of the fourth Jewish State? Obviously, we will be called upon to make financial and technical contributions to the Yishuv. But, are there other areas of mutual benefaction which should be emphasized and exploited? In other words, what is the character of the movement to be which will take the place of the political struggle for the mass of American Zionists?
- 3. Why are the current shekel campaign and the next World Congress so extremely important? I believe I can answer part of this question myself: we must make a final show of solidarity with the Yishuv. But why the bitter fight in the elections? Why was no attempt made to lay aside the political differences for this last meeting?

I am taking the liberty of sending this same list of questions to a representative group of leaders in American Judaism, and would appreciate your reply. Would you be kind enough to indicate if I may quote from your answer in the event that I decide to summarize the several opinions in a short publication?

MEMORANDUM RE: Establishment of American House in Israel. It is suggested that an "American House" be stablished in Tel Aviv to concern itslef with visitors to Israel from the North and South American continents. Such an American House would: 1. VISITORS -(a) Contact all visitors on their arrival in the country. (b) Assist them in their personal arrangements, viz. hotels, banking arrangements, etc. (c) Provide them with information on tours through the country, arrange hospitality in private homes, obtain invitations to official functions, etc. (d) Provide them with economic information, arrange contacts with business and industrial leaders, visits to factories, etc. (e) Provide a lounge and writing desks, which will be a meeting place for such visitors where they can contact their friends. 2. VOLUNTEERS FROM OVERSEAS -Right now there is an immediate problem of taking care of the volunteers from the North and South American countries. At present the Palestine Mortgage & Savings Bank Ltd., which is a subsidiary of the Palestine Economic Corporation, New York, has provided office space in its premises for the American and Canadian boys. If a meeting place such as the proposed American House can be established, it would be of great benefit to them. They could receive their mail here, contact their friends, and use it as a centre for recreation. 3. REQUIREMENTS -(a) One large lounge from and two small rooms continguous to it, preferably in Hayarkon Street in the vicinity of the Gat Rimon Hotel. (b) One Executive Secretary (male) and one Receptionist, possibly volunteers from the ranks of Americans resident in Tel Aviv.* (c) One automobile and office equipment and furniture. * Note: With the large number of vlunteers from overseas at present in Israel additional personnel might be required. Copies to: Rabbi Silver Mr. Frisch Dear Emanuel, I understand that the Government has definitely stated that they will discontinue the LP. 5 .- a month pocket money which has been paid for the last couple of months to the volunteers from overseas. The South-Africans are continuing to pay the money to their boys out of their own pocket, which sum they feel will be replaced by funds they will raise in South-Africa. Mrs. Sacks intends to raise the money for the Canadians, so that they may continue to be paid. I think we should do likewise for the Americans. These boys are strangers here without families and for them to get by on just IP. 2 .- a month is asking too much. Our budget for the month of October would be:-400 bogs @ LP. 5 .-LP. 2,000 -Welfare and recreation fund, administration, allowance for additional volunteers LP. 2,500.-As you know, the Bank has already organised the American-Canadian Office in its premises and will be glad to continue the work. Please let me know at your earliest convenience, and in any case not later than the 20th of the month, that the funds will be available. Best personal regards. P.S. I will be glad to supply you with a complete list of all the boys and girls who are registered with us and their home addresses. Encl. LH_RS.
