Dear Dr. Silver:

This is with respect to our telephone conversation today regarding the Army Mission, the JDC loan and other related matters.

Attached hereto is a copy of the cable received today from David Bahral, presumably on behalf of Dr. Goldstein; a copy of my response is also appended.

I am grateful to you for your ruling that this notification from Tel Aviv is a general instruction which is not binding on commitments already made and which have to be honored. I am having a complete audit made up to August 31st which will include a statement of our commitments and "accounts payable", so that upon Dr. Goldstein's arrival in New York we will be in a position to discuss these questions and future procedure with him.

After our telephone conversation, I spoke with Mr. Leavitt of the JDC and informed him that we accepted that part of his decision relating to the February 15th repayment of \$1,000,000; in so far as the other million which they want repaid on December 15th is concerned, due to the short term, we would require the consent of Tel Aviv. Leavitt, after checking with his people, agreed to this procedure. He will let us have his check for \$1,000,000 on Monday and await our word with respect to the other million. In the meantime, I hope we will get some response from Tel Aviv; failing that, I will attempt to get the JDC to agree to a longer period; failing that, we will consider whether we ought to take the million at the JDC terms.

Pursuant to your earlier suggestion, I will try to convene an informal meeting of the Members of the Executive as early as possible next week and lay the whole question before them for the purpose of appraising the situation. Another reason for my cautious attitude, which I did not mention to you on the telephone, is that we have old loans maturing in December and early January amounting to about \$1,000,000 and I do not wish to over-extend the Agency's capacity to repay without fully informing the Executive and obtaining their concurrence to these acts.

I am attaching hereto copy of a cable I have sent to Kaplan indicating the position and asking for his views in the matter.

MEMORANDUM

To: Members of the American Section of the Jewish Agency Executive.

FROM: Gottlieb Hammer

We are sending you under separate cover a copy of Dr. Bernard Joseph's book entitled "British Rule in Palestine".

This book was published under an arrangement made last winter when Dr. Joseph was here. The Agency has invested something like \$3,600.00.

We now have on hand 750 paper-bound and 250 cloth-bound books. Our problem is what to do with these books. Various suggestions have been made with respect to their disposition. The general consensus of opinion is that this book is not particularly timely but is useful when handled as a reference work. Distribution might be made to reference libraries throughout the country. Should this distribution be made by the Agency, the Emergency Council or by the publisher directly?

This note is being circulated to members of the American Section of the Executive to permit quick disposal of this question when the Executive meets next.
