Today we received a letter from our headquarters in Palestine and also from the secretary of our Second American Kibbutz in which they tell us that the resolution passed at the last Washington Conference of the United Palestine Appeal, greeting the establishment of a sister colony next to Ein Hashofet, the colony named in honor of Justice Brandeis, is not know to the Head Office of Keren Kayemeth in Palestine.

Because there is now question of the establishment of the Second American Kibbutz in this region as a result of questions which have arisen as to the allocation of the land, may we ask you to send a copy of the resolution of the U.P.A. Conference to the Jewish National Fund head-quarters in Jerusalem? We should also appreciate a copy of the letter you send.
