Dear Dr. Silver:

The Administration of the Jewish National Fund has been urged from many quarters to take such steps as would bring about a better understanding of the need, feasibility and effectiveness of Geulath Ha'aretz work during the war. It was also felt that our traditional fund-raising activities should be stimulated at this time of uncertainty.

The Board of Directors has therefore deemed it necessary to convene the bi-annual National Keren Kayemeth Conference for the early part of November. The sessions will take place in the Hotel Statler, St. Louis, Missouri, during the Armistice Day week-end (November 9th, 10th, 11th), and will be attended by delegates of the Jewish National Fund Councils and representatives of the Zionist organizations and groups which are cooperating with the Jewish National Fund.





Dear Dr. Silver:

We have had requests from Detroit for the last few years asking us to prevail upon you to be the speaker at their annual affair which usually yields as much as \$14,000.00. This function is sponsored by the Ladies Auxiliary of the Jewish National Fund. It is a traditional affair in the community, and one of the largest things that Detroit has. Because of the war and the desire on the part of the Ladies Auxiliary, which is the best J. N. F. organization in the country, to save money that they would ordinarily spend in providing luncheon to the women, they have abandoned the idea of serving lunch and this year every dollar that will be raised will accrue to the J. N. F.

I realize the burdens that you are carrying, and you know that we never want to impose upon you unnecessarily, but as long as we have a raincheck because you couldn't come to New York last Sunday night, it would be a wonderful thing if you could accept our invitation to speak in Detroit on the afternoon of March 11th.

There isn't the slightest difficulty insofar as the Detroit Welfare Fund is concerned. The very fact that you would be the speaker would make it possible for the committee to substantially increase the income over the amount they raised last year. What they do usually is that every woman undertakes to raise a substantial sum, and they then get together for the large function which is held once a year representing the culmination of all their efforts. No appeal for funds is made at the affair itself.

It would be a great service to the Jewish National Fund if you would be good enough to accept this invitation. We are celebrating the 40th anniversary of the Keren Kayemeth and your acceptance would give the women a great deal of encouragement in the wonderful work they are doing. I beg of you, please accept this invitation. I am not going to burden you with many requests during the coming year, but this is one request which deserves your consideration, and we hope
