Dr. Silver, who you know is the President of the Zionist Organization of America and the Chairman of the American Zionist Emergency Council and who is giving most of his time to the service of his people in meeting the present crisis. has asked me to prevail upon you to participate in a Temple program which Mrs. Silver is arranging on May 21st at Cleveland, Ohio. My dear Dr. Silver:

I purposely refrained from asking you, as I did last year, to visit at least three or four communities for the JNF. I am fully aware of the fact that you have been carrying heavy burdens. I wish to add a word of my own in deep appreciation of that truly historic utterance that you made before the United Nations. As I told you over the telephone, what you said and how you said it and the whole manner of the presentation has evoked tremendous interest not only among those who heard you at the United Nations but also throughout the country. We hope this is the beginning of a new day. Without being over-optimistic, we have won a victory at the United Nations.

Since you owe me three or four engagements and I do not intend to collect them, I have one immediate request that I wish to make of you because I consider it a very, very important one.

Brith Sholom is to have its Convention on June 21st. They are really a wonderful organization, deeply imbued with our cause. They have recently undertaken a new Nachlah project. They were the first fraternal body in America, long before the Bnai Brith and other organizations made commitments for Palestine, that not only went on record for all-out support for Zionism but that have given tangible expression in terms of fund-raising by creating the first Nachlah in Palestine.

Under the leadership of Frank A. Simons, the newly-elected Grandmaster and Louis I. Gilgor, very capable and faithful Grand Secretary, the Brith Sholom is making excellent progress. They are most anxious to have you participate in their program in connection with the National Convention. They are 100% with us in support of our program. I am, therefore, sending you this note to urge upon you to accept the invitation that they have already extended to you. It will be a great service to them and also to us to have you address them. You could still be back in Cleveland on the morning of the 22nd as they will be very glad to make arrangements for you to speak in the early part of the evening.

I am terribly sorry that you could not reach me earlier with reference to securing Justice Jackson. I will do the best I can to be of help but the matter is not in my hands now.

Please give my cordial greetings to Mrs. Silver. greetings.
