
My dear Rabbi Silver:

I read with a great deal of interest that you have published a new book - "The Democratic Impulse in Jewish History". I would appreciate it very much if you would forward a copy to me.

May 1 not take this opportunity of speaking to you on another matter. My recent trip to Europe convinced me that if the Jewish Telegraphic Agency were in a position to work on a more extensive scale, the good which would result to the Jewish community would be inestimable. The Jews in a city like Salonika or in countries like Turkey and Roumania are exposed to all manner of discrimination, abuse and agitation. The position of these Jews could be improved if we were in a position to employ well-known American newspaper men of high calibre. At present, we maintain local correspondents in these countries but because they are citizens of the country their freedom of action is severely hampered. There have been cases where correspondents of the Jewish Telegraphic Agency were subjected to harsh measures. Some years ago our correspondent in Budapest was deported and had to live in Vienna for more than two years. Our Bucharest corr spondent serves us only inefficiently, anxiously hiding the fact that he is our representative. There have been instances where correspondents were imprisoned for supplying for supplying foreign newspapers with unfavorable news. Only three months ago the correspondent of the Vossische Zeitung in Bucharest was arrested and kept in prison for a few months.

It has happened in the past that because a report appeared in the American press or in even one influential newspaper like the London Times, the situation involved was essentially influenced. American newspaper men would not be hampered in their activities. They could, without hesitancy, interview members of the government wherever the Jewish community would be subjected to discrimination or persecution. The help which the Jewish population would derive from their presence would be of great value.

I was delighted to learn from Mr. Simons that you promised to write to a number of members of your community, asking that they subscribe to our three-year fund.



We are faced at the present time with great financial difficulties. We have been adversely affected by the decline in the Yiddish newspaper field. One big Jewish daily, the "Jewish Daily News", has ceased to exist. The Philadelphia "Jewish World" as well as Yiddish dailies in other parts of the country are fighting against increasing odds, and are for this reason either discontinuing our service or decreasing their fee to us. We have in this way lost a revenue of more than \$10,000 annually. In addition to this, the various measures I have taken to improve and extend our news service have greatly increased our expenditure.

Your action at this time would be particularly helpful. Trusting to hear from you and looking forward to your response with a great deal of expectancy, I am,

My dear Dr. Silver:

A survey recently made by Messrs. David M. Bressler and Morris D. Waldman as to the financial needs of the Jewish Telegraphic Agency-Jewish Daily Bulletin and our own studies show that it is necessary that a fund of at least \$50,000 a year for a three-year period be underwritten and that every effort should be made to bring this annual underwriting to \$75,000, in order to enable these agencies to reach their fullest measure of usefulness.

There is no longer any need of argument in support of the importance, indeed the necessity of keeping alive the Bulletin. It has demonstrated over and over again that the power of public opinion and truth is the greatest safeguard and help for Jewish causes and the Jewish people.

Toward this fund. Mr. Julius Rosenwald and Mr. Felix M. Warburg have each subscribed \$10,000 a year for a three-year period. Mr. Mortimer L. Schiff has contributed \$5.000. Colonel Herbert H. Lehman \$2.000. Mr. Paul M. Warburg \$1,000. This Committee has now been organized to secure pledges for the balance needed.

We urge upon you most earnestly that you join in our efforts to strengthen and further develop this significant and indispensable service which the Agency and the Bulletin are rendering. We know of your interest in the Jewish Daily Bulletin, of whose Advisory Board you are a member, and I sincerely trust that the importance of this matter justifies our appeal to you.

Dear Rabbi Silver:

A most unusual opportunity has just been taken advantage of by the Jewish Telegraphic Agency which promises to accomplish more substantial results for the benefit of the Jews of Palestine and the Zionist movement than any other single development within recent years. Much of the news that has hitherto reached Palestine and its neighboring countries has come from sources which were unfriendly to Jewish interests. As a result, misunderstandings have arisen in the minds of the Arabs; frequently the Jewish position has been mis-stated; the prodigious investments of the Palestine movement, even, have been jeopardized.

Now this situation is to be remedied - by special arrangements with Reuters of London, the Jewish Telegraphic Agency has been granted a <u>monopoly</u> on its vast news-service. Hereafter the Arabic and Hebrew press of Palestine <u>must</u> get its foreign news through us, and Palestine's domestic news will be cleared by us through Reuters for the foreign press. What this arrangement means to the future welfare of the Jews of Palestine, and to the development of a better world-understanding of Zionist plans and activities, it is impossible to over-estimate, - accurate and unbiased information will take the place of mischievous and unfriendly propaganda.

The consummation of this arrangement, so fraught with significance to every one interested in Jewish affairs, will of course be expensive - frankly, in entering into it, we have been actuated by a sincere belief that we could depend upon the cooperation, in a modest way, of men like yourself who realize the tremendous possibilities of this far-visioned development. It is not a large sum which we require to bring our budget back into balance. If <u>one</u> <u>hundred</u> individuals will contribute to our fund \$100 each per year for three years, we will be able to cover the added cost.

Can we count upon you for this small amount? Surely no equally modest sum can accomplish for such a worthy purpose greater good in behalf of Palestine! In granting this request you have the satisfaction of knowing that you are working shoulder-to-shoulder with such forward-looking Jews as Julius Rosenwald, Louis Marshall, Felix M. Warburg and many others, some of whom are contributing to the expenses of the ordinary deficit of the Jewish Telegraphic Agency and Jewish Daily Bulletin a sum <u>one hundred times</u> greater than the amount requested of you.

The enclosed pledge is for your convenience. It is perhaps needless to add that <u>promptness</u> will <u>multiply</u> the value of your cooperation.





I wish to acknowledge your letter of September 16th, in which you advise me that you have urged upon the officers of the Jewish Welfare Federation their favorable consideration of setting aside an item in their annual budget toward the fund we are raising for the Jewish Telegraphic Agency and Jewish Daily Bulletin.

I received word from Mr. Goldhammer that the application I had filed with the Qeveland Federation for a grant of \$5000. for each of three years, had been referred to the Finance Committee. On a number of occasions Mrs. Herzog expressed her appreciation of the work the Jewish Telegraphic Agency is doing. During the latter part of 1928 Mrs. Herzog made it possible for me to appear before the Board of the Federation where they had an exposition of the essential work these enterprises were performing in the interests of the Jewish community. At that time I had the assurance from Mrs. Herzog that pending some negotiations with the Community Chest, we would obtain a grant.

The Palestine emergency, which in its wake overwhelmed the Jewish Telegraphic Agency, makes the obtaining of additional funds for the JTA a matter of great urgency. I have as yet not heard from them, and would appreciate exceedingly if you would communicate with Mrs. Herzog and the officers to learn of their decision in regard to our application.

You are undoubtedly acquainted with the work of the Jewish Telegraphic Agency. It is a great news gathering agency which has its representatives in all parts of the world and which supplies the newspapers of all countries with fair and authentic reports of those important events which have a Jewish significance. Up to the time of the organization of the Jewish Telegraphic Agency we were at the mercy of non-Jewish agencies which were frequently hostile to us and which gave to the world distorted and prejudicial accounts of events which had great bearing upon the political or economic status of our people.

The Jewish Telegraphic Agency has been on the alert to report any infraction of Jewish rights anywhere in the world, and governments have been deterred in well-known instances from anti-Jewish acts and legislation by the fact that there was such a Jewish publicity agency which could broadcast such acts to the entire world.

Thus recently the Jewish Telegraphic Agency was in position to supply the newspapers of the world with accurate and authoritative accounts of what transpired in Palestine and thereby served to arouse public opinion. During the crisis in Palestine the Jewish Daily Bulletin, the organ of the Jewish Telegraphic Agency, received daily over five thousand words of cabled dispatches, many of them sent at urgent rate costing  $85\phi$  per word. It has incurred a deficit of over \$30,000. This well-nigh indispensable service is in danger of being discontinued if friends do not rally to its support in its present emergency.

I am convinced that it is of vital interest to our people that this news service shall continue. I am accordingly writing to a few of my friends requesting them to contribute to a fund of \$2000. which I hope to raise in our community. This sort of an appeal must of course, by its very nature, be limited to a very small group of people.



I have your letter of November 7th.

I was very much surprised to learn that some of the people whom you approached feel that the Jewish Telegraphic Agency is a private undertaking and its support therefore, is no concern of theirs. It seems to me that those who express this sentiment have not given sufficient thought to the subject.

If the Jewish Telegraphic Agency were an official or communal institution, its usefulness to the Jewish community would be severely impaired. It would then be regarded by the press not as a journalistic enterprise but one whose purpose is propaganda. Much of its news would then be discounted. You will be interested to learn, for example, that only quite recently the Palestine authorities inquired of the Zionist Executive whether the Jewish Telegraphic Agency is an institution maintained by the Zionist Organization. If, during the recent emergency, we were in a position to be of real help, it is due to the freedom of action we possessed because of the fact that we were not burdened with that official responsibility which rests upon every communal institution. If Reuter in England were an official government agency, the British Prime Minister would be interpellated in the House of Commons with regard to its every report. The Government would be responsible for Reuter's every utterance. The Government would not be in a position to issue balons d'essai in order to sound public opinion; it could not deny reports it had inspired the previous day. The same is true of the Havas agency in France. Every one of these governments can afford to maintain an official news service, yet none of them does so because they find

# **RIOTOUS STUDENTS** TO BE DRAFTED INTO ROUMANIAN ARMY

Education Minister Orders Measure to Prevent Anti-Jewish Attacks

(Jewish Telegraphic Agency)

Bucharest, Dec. 4-Loss of exemp-tion from military service as a punishment for participation in anti-Jewish riots and for causing disturbance of the peace, was threatened in an ordinance issued by the new Minister of Education, Kostacescu.

The University authorities were in-formed that in case of anti-Semitic student riots, those guilty of disturb-ance of the peace will immediately be drafted into the army. This measure was taken, it was declared, in the be-lief on the part of the government lief on the part of the government that it will prove to be effective against the continuous agitation said to be carried on by the opposition parties among the student body in connection with the election campaign.

# JEWS ATTACKED IN HAMBURG THEATRE (Jewish Telegraphic Agency)

Berlin, Dec. 4-Jews were the principal victims of a riot which occurred in a Hamburg theatre on Saturday night at the first performance of a drama named, "Youth Sickness."

The play, by an anonymous author, called forth the displeasure of the anti-Semitic party which apparently had organized an obstruction. A gas bomb was thrown into the audience and many of the playgoers were attacked and insulted. The police had to be called in to restore order. Three hundred Hit-lerites who were in the theatre and were responsible for the outbreak were ejected by the police. Among the 19 persons arrested there were two mem-bers of the Hamburg Diet, Buettmann and Brinkmann.

# LAWYERS ASS'N PLEDGED TO FIGHT NUMERUS CLAUSUS (Jewish Telegraphic Agency)

Prague, Dec. 4-Efforts inaugurated by some student groups to launch a campaign for the introduction in Czechoslovakian colleges and universi-ties of a numerus clausus, a law for the limitation of the number of Jewish students to be admitted, were rebuked in a resolution adopted by the national convention of the Federation of Cze-choslovakian Lawyers.

The seven hundred delegates attend-ing the convention pledged themselves to combat in any form, open or secret, such limitations.

At the police station a stirring drama was revealed in the explanations of the prisoners. The girl, who was a servant, disappeared two years ago. All search failed to locate her. During this per-iod, it was revealed, Fanny had been kept in a Catholic convent, where she was converted. Now, confronted by her father, she declared that she prefers to

Frantically the father appealed to Deputy Reich, representative from Ga-licia in the Polish Sejm, who in return appealed to the State Attorney. In a statement published in the "Nasz Przegland," Polish Jewish daily, Depu-ty Gruenbaum declares that if his presence really is an obstacle in the way of the government for meeting the economic and cultural demands of the Jew-ish population, as the Minister of the Interior Skladkowski declared at the last session of the budget commission, he will resign. He concludes, however, by declaring: "We want action, not words." words.'

it more advisable to utilize private news agencies, which they heavily subsidize.

But let me assume for one moment that we were indeed to be "communalized". In that case each communal body could assume responsibility for us. But there isn't a single Jewish organization which would be willing to do so, and even if there were, we would become identified with one particular movement and arouse the distrust of all others. Were we to create a Board on which a number of communal leaders would be invited to serve, this Board, in order to satisfy all groups, would have to be a sort of all-embracing American Jewish Congress, and then the Jewish Telegraphic Agency would become the battlefield for fighting out all of their differences. The statement which you gave me in Zurich for example, and which was published in full by us would, under such circumstances, be an occasion for the representative of the Zionist Organization to severely criticize the Jewish Telegraphic Agency. A news service whose very foundation is efficiency, certainly could not function if weighed down by a Board of this kind. Besides, our income from newspapers would decrease if we were turned into a communal enterprise. and our deficit would thus be considerable enlarged.

The Jewish Telegraphic Agency must be understood to be an enterprise of a rather unique character. It is true that it appears to be a private undertaking: at the same time it is definitely of indispensable value to the Jewish community, and it is for this reason that men like Mr. Marshall, Mr. Warburg, Dr. Cyrus Adler, Judge Mack, Mr. Rosenwald, Dr. Lee K. Frankel and others have joined a Committee, headed by Mr. Rosenberg, in order to raise funds for us. You will be interested in learning that at the time this Committee was formed, at a meeting at the Republican Club in New York, it was laid down in a resolution proposed by Mr. Marshall that this Committee is in no way to interfere with the work of the Jewish Telegraphic Agency, Mr. Marshall having perceived the fact that the independence of the Jewish Telegraphic Agency is a vital necessity if it is to exercise a useful function. In his letter in which he emphatically endorsed the Jewish Telegraphic Agency, Mr. Marshall stated that if this institution "did not exist, it would become necessary for the community to create a substitute possessing the same high qualities".

Let me nevertheless add, that the question of perpetuating the Jewish Telegraphic Agency is one which gives me real concern, and if the means were found whereby the existence of the Jewish Telegraphic Agency could be assured on an impersonal basis, no one would welcome it more than I. The necessity of constantly engaging in fund raising is both humiliating and harmful to an enterprise to which real independence would mean multiplied usefulness.

I fully appreciate the difficulty of raising funds at the present moment. On the other hand, we have for a number of years obtained practically no help whatever from Cleveland while other communities, particularly Chicago, extend us considerable support. Our expenditures have, due to the Palestine events, greatly increased, and unless we obtain substantial relief the existence of the Jewish Telegraphic Agency will be seriously endangered. I therefore most earnestly appeal to you to make as strong an effort as possible in our behalf.

On behalf of the Committee of Sponsors, may I extend the invitation that you join this Committee? I would very much appreciate receiving your consent.



## MEMORANDUM

# On the Present Situation of Religious Jewry in Russian and what Could and Should be done to Better it

It isawell known fact that Jews in Russia suffer because of their religious observance. That fact received great publicity and is undeniable.

In brief the present religious condition in Russia could be summarized by stating that there is a triple government rule in that country.

- a) The Central Government Constitution.
- b) The Local Government Rule.
- c) The Yevesekzia or Hebrew Sect in the Communist Party.

That attitude of the Central Government toward religion is selfunderstood not too kind and pleasant. Under certain limitations or restrictions there is a legal opportunity and right to conduct certain religious work. These rights were created through a demand voiced by Russian Jewry and through protection from the land itself that have brought about the legality of certain measures. They are:-

a) Education: - Permission has been granted to teach in groups not exceeding three children who are minors, I.e. under the age of 18. There is, in compliance with this, a possibility of having several classes in one building if the classes are not giving instruction to more than three children at a time by one teacher.

b) <u>Adult Education</u>: - Permission has been granted to teach adults (those passing the 18th year) in unlimited groups. This provides for an opportunity to organize many courses in religious subjects. It also makes possible the establishment of classes for the University Students. c) <u>Synagogues:</u> The operation of same is not prohibited. Much could be accomplished along these lines if sufficient funds are available.

d) <u>Mikvoath or Ritual Bath Houses:</u> As in par above(C) If the Central Government is not too rigid on certain measures, the local government, however, proves to be exercising more rigid restrictions and limitations. It is a result of certain Communist members in the government who are structer.

Then there is the Yeveekzia or as we known them as the Hebrew Sect within the Communist party, meaning the Jewish members of the order. These Jews in order to find grace in the eyes of their fellow members and superiors are exercising still rigider measures on their brethern, the religious Jews and are harder with their restrictions. They do all in their power to undermine the religious existence among the Jews by vafious means. Fropaganda, false accusations, and various other means. It should be stated, that had there been an opportunity to work in harmony with the restrictions and few rights granted by the Central government much could be accomplished, but the hard hand of the local Government rule and especially the Yevsekzia prevents and hinders the way.

And another point: - The Constitution if studied carefully will reveal another interesting point and that is that the Moselems are granted more rights than is the Jew. The excuse given is that the Moslems are fanatics, and therefore the government does not recommend anti-religion there. This proves that the government is paying attention to a movement and pressure that comes from the public. For the Iskam has conducted such a movement.

Jews are unable to exert that power befause of lack of funds to conduct such a movement. And it is a regretable fact.

What interests us is the solving of the Jewish religious problem as it atadaxnows standsnow:

a)Education; -

1. If it would be possible for us to enlist at least 25,000 children as students in Hebrew schools to provide them with a religious Jewish education, a great problem would have solved. But, the question of funds is our great and only obstacle. To execute this program we are in need of at least \$5.00 per month per child.

2. The girls ought by no means be neglected. They are the mothers of the future Jewish people and they must be given a Jewish education. We need funds to continue our work in the 'Beth Jacob' schools for girls and also establish new ones.

3. There is an adult Jewish youth (& i.e. over the age of 18) affiliated in groups of the 'Tifereth Bahurim' organization . Religious young men who are after hard day of work assemble in their clubs and discuss Jewish topics. Among them university students, clerks and laborers. They are Sabbath observers. We need funds to support their ideal work and provide and find work for them.

4. The public is poor and cannot provide the full needs of the already existing Talmud Torahs and Yeshivoth. Greater aid is necessary. Funds are meager.

Let it be emphasized here that the question of educating the youth is of utmost momentous importance. One that if not attended to now is liable to lose for us a whole generation. That generation in turn, because being ignorant of Judaism is liable to lose for us its posterity too. This must not be permitted.

## b) Rabbinical Aid: -

Under three classes are Russian inhabitants divided. a) Workers; b) professionals and c) Burjues or Rich men. Rabbis have been classified under the third and are therefore charged prices of the rich men.

It is painful to know the critical situation of the 650 rabbis who cannot be auded by their communities because the communities are poor and are unable to extend any ship help. We must provide for them monthly relief.

c) Yeshivoth: -

The maintenance of the already existing Yeshivoth and the erection of new ones wherever necessary. It is a matter of great importance and funds must be provided for it.

d) Courses for Students: -

Many are the university and college students who are eager to receive Jewish education and religious instruction. But we lack funds to provide same as it should be.

e) Kosher Food: -

This, too, is a very painful problem. Kosher food is high priced for various reasons. There should be instituted Folks' or Public Kitchens where same shall be sold at low prices. Funds are urgently necessary to provide for this need as it is one of the greatest fundamentals of Judaism, and many many of our brethern are because of poverty and the lack of such kitchens compelled to deviate from the observance of same.

Our goal in visiting America is:-

a)To bring relief by raising funds to the many Jews there. It is a question of saving three million Jews from starvation and suffering.

b)Through it we shall be able to bring about also

certain lighter measures and the removal of certain restrictions placed upon Religious Jewry there. As said the government pays attention to movements in religious questions. By bettering the conditions of the religious institutions a movement would be created among our Jews there and hopefully we are that the same would find an echo in government halls.

#### MEMORANDUM

## On Jewish Religious Education in the Russian Socialist Federative Soviet Republic.

1. According to the Constitution of the E.S.F.S.R., the Church is strictly separated from the State (Art. 4 of the Constitution), so that no religion obtains any support from the Government, but is considered to be a private affair of every citizen. At the same time, the School is separated from the Church, and no religious teaching of any kind is allowed in any schools (except special ecclesiastic schools), either Governmental, public or private. (Art. 9 of the Constitution.)

2. However, the same Art. 9 of the Constitution contains a provision to the effect that Citizens may teach and be taught religion <u>prevately</u>. This provision was explained by the People's Commissariat of Justice of the R.S.F.S.R. in the Circular No.18711 dated 16th March 1924 in the sense that parents are not forbidden to teach their infant children the so-called "Law of God" in their own homes. Such teaching may be carried out either by parents personally, or by persons invited by them at home, subject to the condition that the number of **patkits** pupils should not exceed three. (See the standard book on "Separation of Church from State" by P. V, Gidulianoff--"Systematised Collection of Legislation of the Union of Justice of R.S.F.S.R., Moscow, 1926, Page 373.)

3. This interpertation of the law given by the People's Commissariat of Justice was put at the basis of the so-cal led "Administrative Statue **EXAMINISTRATION STATEMENT** of R.S.F.S.R., "which proved for the teaching of r religion at home on condition that the number of outsiders, i.e. of the children coming from outside to a private house for religious education should not exceed three. (Gidulianoff, page 374.)

4. Such are the rules regarding the religious education of infants. As regards the adults, i.e. those who attained the age of 18 which is the age of majority in Soviet Russia, - the Circular of the People's Commissariat of Justice No. 537 dated the 26th April 1919 laid it down that "the teaching of religion to the persons who attained the age of 18 is not forbidden, but on the contrary is permitted outside schools and educational establishments. Consequently it always depends on the discretion of a local Council of Workmen's and Peasents' Deputies (the "Soviet" which is the organ of local administration) to acede to an application for granting the believers the use of a temple or another building for the religious teaching, if there exists a demand for teaching." and the Circular adds that "direct prohibition, if the population in a given locality is still possessed by religious prejudices, may only lead to unnecessary irritation." (Gidulianoff, pages 371-372.)

5. It is worthy of note that the Circular of the People's Commissariat of Justice No. 18711 referred to above under par. 2 which explained the Constitution in the sense that private teaching of religion at home is allowed, provided the number of children attending at a private house for tuition does not exceed three, was the outcome of a strong pressure exercised on the Government of the R.S.F.S.R. on the part of many scores of thousands of Jewish parents who sent in their application en masse through their influential representatives and thereby obtained the above quoted ruling which enabled the setting up of small private enterprises for religious tuition to small groups of three at a time Section 121 of the Penal Code of R.S.F.S.R. punishes with hard labor for the term not exceeding one year all persons guilty of religious tuition given to infants and minors, if it is given in groups, i.e. in numbers exceeding three.

6. It is also remarkable that the Mohameden population of Russia enjoys a sort of privilege as regards religious tuition, which the Government explains by the fact of "earlier development and fanaticism of the people professing Muslamic religioun" The Presdium of All-Russian Central Executive Committee gave directions that the organization of group tuition in mosques or outside mosques should be allowed for the benefit of children over the age of 14. Moreover, on the terromitory of Turkestan (Central Asia), by permission of the local Central Executive Committee, the MMosluman population are in possession of confessional schools, primary schools -- mektebe -- and secondary --medresse. (Gidulainoff page 375.)

7. The facts mentioned above in par. 5 and 6 of this Memorandum show that the prohibition of the Soviet law against the Jewish religion education is not unsurmountable, and that in certain circumstances one is entitled to me hope that the Jewish population may obtain permission to institute religious teaching by small groups of ten to twenty pupils. The legislation in the U.S.S.R has taken other forms than that in the Central Soviet Republic. Though the principle "that citizens are allowed to teach and to be taught religion privately" is also here in force. (Decret regarding the separation of the Church from the State in the U.S.S.R. of the 21/1,1222 1919 Art. 10/11. Nevertheless the Justice of the U.S.S.R. interpretathis sentence quite arbitrarily in the sense that it refers only to adults i.e. citizens who attained the age of 18 years. Accordingly there exists a general prohibition in U.S.S.R. to the effect that the teaching of religion to persons who are under the age of 18 years is forbidden. "The teaching of religion in private houses to persons who have not attained the age of 18 years is forbidden." (Article 29 of the Code of education laws). The same is reiterated in the Circular of the interior Commissariat in the U.S.S.R. No. 336, in the year 1923. It is to be understood from this Circular that the teaching of children by parents is considered to be allowed, for it reads as follows: "Citizens are not allowed neither in churches, private houses or private institutions for tuition, nor at home to give religious tuition in groups to persons who have hot attained the age of 18 years. These words "at home in groups" are to be understood that only the tuition in groups is forbidden at home, however by no means the personal teaching to younger members of the family. Though the legal conditions in Russia as regards the Jewish religious tuition are very sad, nevertheless under the mentioned facts there exist some reasons for hope that the Jewish population in the Ukraina will receive the same rights as in the R.S.F.S.R, and on the other hand, that the legislation in the R.S.F.S.R. will take more enduring forms by way of extending of the already given provisions.

8. The provisions of law in the territory of the White-Russain Soviet Republic are nearly the same as in the Central Soviet Republic.





My dear Rabbi Silver:

The Executive of the American Jewish Committee recently appointed a committee, which reported that the existence of the Jewish Telegraphic Agency is in serious jeopardy. Whereas in 1929 the Agency secured in contributions the sum of 110,000, this year, due to the economic depression, it has obtained only 76,000, while important news developments with regard to Russia, Roumania, Palestine, Germany, etc., have imposed upon it heavy obligations.

The Agency is indebted to cable companies and banks to the extent of 25,000. It requires an additional 7,000 to cover its current deficit until the end of the year. Its needs for 1931 are estimated at 100,000, of which amount only 30,000 has been pledged.

The Committee was unanimous in the belief that the Jewish Telegraphic Agency is rendering an indispensable service to the Jewish community at large and that its work is of particular importance to the American Jewish Committee; that in view of this, every effort should be made to obtain the necessary funds, in order to make possible the uninterrupted functioning of the Jewish Telegraphic Agency. Necessarily the contributions must be obtained from a comparatively few persons.

The Executive Committee agreed with the views expressed by the Sub-Committee and entrusted the undersigned to make an effort to obtain financial relief for the Agency.

#### Rabbi Abba H. Silver,

We know that you have long since been a friend of the Jewish Telegraphic Agency. It renders important services by spreading objective Jewish information through hundreds of newspapers, reaching in the United States alone, through the Associated Press, 1250 dailies; it is truly of protective value to our community by dispelling prejudice, counteracting willful agitation and creating a better understanding of Jewish conditions.

It would be deplorable indeed, were the Agency to disappear because of its financial difficulties.

We are, therefore, addressing ourselves to you, to urge you to make a special grant to the Jewish Telegraphic Agency or to increase your annual contribution. The Agency is severely pressed and unless immediate help is forthcoming the Jewish community may lose a valuable instrumentality.

#### NICKERSON DISCLAIMS ANTI-SEMITIC ANIMUS

Resenting Attack on His Book "The American Rich" He Claims That A Separate Legal Status for Jews Does Not Mean Segregation--Insists However There Is Menace in "Historical Record of Jewish Question"

Bernard Richards in Trenchant Reply, Analyzing Different Classes of Writers on Jewish Problem, Proves Identity of Nickerson With Position of Foremost European Anti-Semites Like G. K. Chesterton, Leon Daudet, etc.

The office of the American Jewish Congress, 33 West 42nd Street, has just made public a letter from Mr. Hoffman Nickerson, author of "The American Rich", protesting against the attack upon his book contained in a communication addressed to him by Bernard G. Richards, Executive Director of the Congress. Together with this letter was also issued Mr. Richards' reply to Mr. Nickerson, again characterizing the book as a distinctly anti-Semitic production.

The letters are as follows:

January 19, 1931.

Mr. Bernard Richards, 33 West 42 St., New York City.

Dear Sir:

I am afraid it is impossible to write frankly on bitterly controversial subjects without arousing a certain amount of anger. This is regrettable but cannot be helped if one believes that only by complete frankness can difficult problems be solved. In this connection I take pleasure in quoting part of a letter recently written to me by Maurice Samuel; "I enjoyed thoroughly the quality of forthrightness in your writing; after the usual snuffling that one hears on the Jewish problem, this is a relief. The way out of a dispute is through a statement of its terms, and not through dis-

tortion of them: i.e., in the jargon of our day, we must not sublimate a quarrel, but reduce it to its simplest elements, and then seek accomodation. I do not remember seeing anywhere an equally honest attempt at simplification".

I take it that the general thesis of my book is not closely related to the discussion between us. As to it therefore I will say only that I propose no "new autocracy in this country" as you say. In using the phrase elective monarchy I wish chiefly to call attention to the already existing and great powers of the presidency and of the governors of states. I believe that those powers will probably be increased at the expense of the congresses and legislatures; further than that I do not go. If I am right in believing that economically independent men will increasingly interest themselves in public affairs, the resulting condition would certainly be compatible with far more personal liberty than we now have and with as much actual equality as now exists.

As to my treatment of the jewish problem (which I was careful not to call a quarrel) your letter contains not a little ferocious denunciation which interests me only as a melancholy illus-

tration of how hard it is to get people to discuss this difficult and important question without passion.

Where you address yourself not to denunciation but to argument I willtry to deal with what you say. What I say is that "The jewish problem is that of the friction caused by the present status of the jew, deriving from the contrast between the legal fiction that no separate jewish nation or people exists, and the fact of their separate existence." (p.215) This opening sentence Maurice Samuel thought so apt that he told me he proposed to use it as the heading of some work of his own on the question. I fully agree that the historical record of the jewish question is a menacing one but I call to your attention that the menace is in the historic facts and not in my will or imagination. That I propose segregation of the jews is simply not true. A separate legal status need not imply segregation at all. Americans living in Europe or Europeans in America are not segregated because they retain their own nationalities.

May I ask whether you yourself are a Zionist? And if so what do you understand by "a jewish national home" if there be no jewish nation?

As to my treatment of Bolshevism you do not argue against my chief statement that in its <u>original</u> directing group Lenin was the only non-jew. As to the alleged influence of a jewish woman upon Lenin is that an improbable, still less an impossible story? Do you not know that many non-jewish men have been attracted to jewesses? Surely you must know that many non-jewish men found them beautiful or charming.

You blame me for not distinguishing between believing and atheist jews. Surely your intelligence must grasp the fact that the jewish religion is not altogether the same thing as the jewish body throughout the world. That Bolshevism has injured traditional Russian jewry I both believe and deplore with you.

The lack of complete identity between the jewish body and the jewish religion will cover your point as to Pulitzer. That Horace Greely advocated a socialist revolution, including the nationalism of the means of production, I shall be glad to see proved. Brook Farm merely proves what everyone knows, i.e. that not all socialists are jews. If you can give me evidence to show that any American newspaper previous to Pulitzer's World "systematically stirred up class hatred" I shall be grateful for the information.

Kindly disabuse your mind of the error of attributing evil motives to those with whom you happen to disagree. If you really think anyone a monster of bigotry, fanaticism, and God knows what, then why bother to write to them? You will not find an intentionally discourteous or slurring word in my chapter on the jewish problem and I respectfully submit that you cannot say the same for your letter to me.

My dear Mr. Nickerson:

Your letter of the 19th instant has come here in my absence from the city and therefore was not acknowledged earlier. I note that Mr. Maurice Samuel, whom you quote in your book, has expressed appreciation of some of your paragraphs and I observe that you have written on the subject of my communication to the Hon. Nathan D. Perlman to whom you refer as an old friend. All of which should tend to draw us together in the unison of forebearance and tolerance for which I pleaded.

But, unfortunately, the stubborn fact of your book remains and much as one would want to write politely and dispassionately, it is very difficult to maintain one's calmness and to blink the offensive assertions and menacing implications of "The American Rich" with its numerous references to "jew Bolsheviki" and its chapter on "The Jewish Problem", which, despite your assurance to the contrary, is very clearly intended to present the Jew as a source of uneasiness and trouble to the general community. Concluding your final plea for monarchy and even royalism, you ask, on Page 302, "for an honorable and separate status for the Negro and the Jew, permitting us to utilize their distinctive gifts while preserving us from too much racial contact with the first and from the alien soul of the second".

The Jewish question is generally approached in two different ways:

1. It is treated by the Jews themselves as their sole problem to be solved in their own way; then the question is also dealt with by leaders of thought and humanitarians of Christian and other faiths who would like to assist the Jews in solving the problem as their problem and in their own way. To this class belong many illustrious persons from George Eliot to Anatole Leroy-Beaulieu, from Lawrence Oliphant to John Hay, Lord Balfour, Thomas Masaryk, the Counts Cudenhove-Kalergi, father and son, and a host of other imperishable names whose championship of justice for the oppressed has relieved at least part of the darkness of a long history.

2. The Jewish question is approached by non-Jews who present it as a problem confronting the world, a problem which primarily concerns the peoples outside of the Jews, conjuring all manner of evil and peril to the nations, and varying in form and extent from the days of Haman to those of Serge Nilus of the pitiful Protocols of the Elders of Zion. To this class belong G. K. Chesterton, Leon Daudet, Hillaire Belloc, Charles Maurras and Pobedonostzev, all of whom you quote in encomium (though not necessarily on the subject of the Jews). Thus the first group of writers is seeking to help just as surely as the second group is endeavoring to do mischief. Mention might be made of a third class of neutral or scientific students, displaying no bias whatever, but responsible Jews have never been heard to complain of the efforts of impartial seekers after truth.

The sources of your monarchical and anti-Jewish inspiration here referred to, repeating ad nauseam the tedious untruths of Schonerer, Ahlwardt, Stoeker and Storzy, et al, best characterize your book, which, whether you wish it or not, undoubtedly deserves a place in the new literature of anti-Semitism.

The favorite method of the writers whom you quote, and which you have made your own, is that of endeavoring to identify the Jewish people, and, realizing the full intention of this effort, whether it is always entirely conscious or not, to in this case identify simply means to undo. Mr. Chesterton undoubtedly lies awake night after night wondering whether the Jews are a nation or not and the same worry on your part presumably prompted you to call

Mr. Samuel, enamored of nicely-turned phrases, erroneously supposes that you have revealed a great truth in the statement that "The jewish problem is that of the friction caused by the present status of the jew, deriving from the contrast between the legal fiction that no separate jewish nation or people exists, and the fact of their separate existence." Would it not be just as true to say that the friction is caused by the prevailing fiction that Christianity is being practised in this world of ours? Does not the same manner of racial and religious friction occur without any reference to nationality or legal status? Assuming that there is a legal fiction which you could remove, could you also dispose of human prejudice and bigotry and an unreasoning distrust, if not hatred, of all minorities, whether they be Jewish or not?

I am sure no one has ever tried to withhold from you or to keep you in suspense with regard to what most Jews believe about our historic identity as a people. Lacking the physical appurtenances of a nation, we possess many of the spiritual and cultural attributes of a nationality; we may, in the light of recent aspirations and endeavors, be called a nation in the making. But, how does this, or for that matter any other definition affect our standing in the countries of which we have become part? How does a potential nationality any more than an actual State with which any race may be associated, deleteriously affect the position of large numbers of immigrants who, whether they have come early or late, have cast their lot with the people among whom they dwell, obeying the laws made for all and fulfilling their duty as citizens.

The desperate struggle of forty years to give some semblance of reality to the Jewish national strivings in Palestine. the tragic frustrations, caused by the faithlessness of Christian leadership, make a hollow mockery out of your apprehensions with regard to Jewish nationalism or Jewish political influence of any kind. The spectre of fear which you and other writers of your school have envisaged does credit neither to the thinking faculties nor to the humanity of those who are endeavoring to build a philosophy on discarded medieval Jew-phobia.

It is useless to note again the absence of the element of human compassion from your work and your attempt to justify your position becomes equally futile when, in the course of your letter, one reads the astonishing statement that "I fully agree that the historical record of the jewish question is a menacing one but I call to your attention that the menace is in the historic facts and not in my will or imagination". It is not clear exactly with whom you agree, presumably with Pobedoncstzev, of unholy memory. for whose time and ideas you so pathetically yearn. Anyway, your strange and contradictory confession proves that nothing can be gained by a continuance of this correspondence.



At a meeting of Federation executives held in Cleveland in 1931, following a discussion of the effect of the economic depression upon Jewish social work, among other recommendations adopted was the following:-

In addition to the agencies dealing directly with the maladjustment of families with dependency of children and the aged, and with problems of impaired health, communities have developed additional agencies which are concerned with other aspects of the economic, social or cultural problems. Organized effort to establish community programs concerned with Jewish education, recreation and culture, are considered as essential phases of Jewish social work. Other services are organized nationally and are concerned with clients widely distributed, or with problems of national or international significance to the Jewish group and have only occasional contacts with local communities. Because of this fact the federation as the intermediate agency has a definite responsibility towards national social work. It is important that during the time of distress these elements of the Jewish social work program in the United States be safeguarded.

Since then Judge Horace Stern has suggested that the synagogue be developed as the center of our various communal and social activities, while Dr. H. L. Lurie emphasizes the desirability of a centralized agency such as the Welfare Fund.

We believe the clarification of the problem of how American Jewry can be best organized is of vital importance for the future of Jewish life. We are for this reason addressing ourselves to Jewish leaders throughout the country, with the enclosed questionnaire.







To the Editor of the Jewish Daily Bulletin:

Rabbi Solomon Goldman seems to be angry because I quoted from his essay "God And Israel" to indicate the nationalistic extravaganza to which some of our writers and rabbis had been addicted in the pre-Hitler days. He calls heaven and earth to witness that he has been made the victim of "lashon ha-ra" and that he is being pursued by an implacable enemy. To refute my statement, he quotes other passages from his essay which in no way affect the clear meaning of the passages which I quoted, to wit:

"Even when God is universalized and monotheism energetically preached, the <u>Jew but reluctantly shares his God</u>, his Father, with the rest of humanity. He still remains a kin of Israel....God, then <u>is absorbed in the nationalism</u>, or more correctly, in the nationality of Israel. <u>He becomes the national ethos</u>.... He is the national God; He is the soul of the nation."

I suggest to those who are interested in ascertaining whether the above quotations are or are not the very essence and purpose of the Rabbi's essay, to read the latter in extenso.

To a rabbi uttering the above sentiments, it all seems so harmless and intimate and sweetly patriotic, but when he hears the same sentiments from the mouth, say of the "Gauleiter" of the Berlin Section of the German Christians, Dr. Krauss, he becomes either indignant or contemptuous: "National-Socialism must not be judged from a Biblical or Ecclesiastical standpoint; it is the Bible and the church which must be judged from a Nazi standpoint. <u>The Nazi</u> state embodies the totality of God."

Rabbi Goldman informs us that fourteen months ago, (i.e., <u>after</u> the racial-nationalism of the Nazis had beaten into the dust the Jewish community

of Germany and had frightened some of our own super-heated nationalists), he made a speech somewhere and declared that "whatever may have been its (Jewish nationality) tribal limitation in nomadic times, the prophets cleansed and purified it." That is all very nice and shows that the Rabbi knows how to adjust his preaching to the mood of the hour. But it is hardly relevant to the subject of my editorial.







I have before me your telegram regarding the elimination of a paragraph from your editorial last week. I am greatly at fault for not communicating with you earlier regarding it.

Last Friday I received letters from Dr. Honor and from Dr. Louis L. Kaplan of Baltimore, protesting at the misinterpretation of Dr. Honor's speech by the Bulletin. Dr. Kaplan's letter follows:

"The report of the address delivered by Dr. Leo L. Honor of Chicago at the Jewish Religious Teachers' Conference held in Washington November 30 - December 2, which appeared in last Wednesday's issue of the Bulletin was both inaccurate and misleading.

"I cannot understand how anyone who heard his address and heard his stirring interpretation of the Exodus story in which he indicated the great ethical content which our people in the past extracted from this experience and which our teachers must convey to their students, I repeat, I cannot understand how anyone could have made the comments that were contained in the press report. What he did say is that the Bible stories, because they contain such profound religious teachings, ought not to be used merely as story material in the lower grades where their spiritual values cannot possibly be appreciated, but rather that they should be reserved for the higher grades where they can be discussed and understood adequately, and where their inspirational character can be a very important character-building influence.

"I would appreciate your publishing this letter."

In view of these letters and the obvious injustice the Bulletin did to Dr. Honor, I took the liberty of eliminating your criticism of him based on our erroneous report. It was with no intention of censoring your editorial in any way, but solely with the purpose of preventing further injustice.

Regarding publication of statements in reply to your editorial on the Hebrew schools, we took this step only after we had confidentially received a copy of a telegram sent from your city to the heads of all education bureaus throughout the country. This telegram was Dr. Abba Hiller Silver ..... 2..... December 20, 1934.

signed by A. H. Friedland, Nathan Brilliant and Alfred H. Sachs. It follows:

"PLEASE REFER RABBI SILVERS ARTICLE JEWISH DAILY BULLETIN SUNDAY NOVEMBER EIGHTEENTH ATTACKING ENTIRE SYSTEM AMERIC AN HEBREW S CHOOLS BUREAUS JEWISH EDUCATION STOP BULLETIN UNDOUBTEDLY PREJUDICED SILVERS FAVOR BUT BELIEVE WOULD NOT DARE SUPPRESS PUBLICATION NUMEROUS LETTERS FROM JEWISH LEADERS AND BUREAU HEADS STOP SUGGEST YOU SEND PROMPTLY VIGOROUS ARTICLE TO BULLETIN AND JEWISH DAY AND TAKE OTHER STEPS TO MAKE THIS MATTER PUBLIC ISSUE PLEASE REPLY BY WESTERN UNION."
