



## MEMORANDUM

### Statement of Issue

The great principle of freedom of the press is the issue between the Jewish Telegraphic Agency and the lea ders of the Histadruth. The leaders of the Histadruth (the Labor party within the Zionist movement), clothing themselves with the authority of the Executive of the Jewish Agency for Palestine which they control, have embarked upon the business of selling news in competition with the Jewish Telegraphic Agency.

This new service; styled "Palcor", operates from the offices of the Executive in Palestine. Funds of the Jewish Agency are being used for this purpose. The gentleman who is in charge of this service is an employe of the Executive. In London it also operates from the offices of the Zionist head-quarters, and the salary of the man in charge of the Palcor service there is paid by the Executive in London.

Palcor has been established by the leaders of the Hista-druth in order to control the news emanating from Palestine and to solidify their own position by a propaganda service which would serve their own partisan interests. The Palcor service makes no pretense even of impartiality. The Hista-druth leaders, in order to give their news service added prestige and authority, have utilised the dominant position they hold in the Executive to launch this enterprise in the name of and on behalf of the Executive of the Jewish Agency for Palestine.

## Negotiations between the J.T.A. and the Executive

On December 2, 1934, I attended a meeting of the Executive of the Jewish Agency for Palestine in Jerusalem and submitted to them the following proposals in writing:

- "1.- That all reports contained in the Palcor should be made available to the press through the J.T.A. The J.T.A. would undertake to incorporate them without any change whatever in all bulleting issued by the seven offices of the J.T.A.
- 2.- The J.T.A. to continue its own news service from Palestine. That the closest possible contact will be maintained with the Executive by the J.T.A. and every effort will be made to establish harmonious complaboration.
- 3.- The Executive to compensate the J.T.A. in view of the above undertaking of distributing Palcor news.

This arrangement would give assurance to the Executive that its aim of supplying the Jewish world with a comprehensive new s service would be fully met. It would have the additional advantage of securing for it the wide publicity which only a general Jewish news service can obtain and make available to the Executive the numerous connections with newspapers and news agencies the J.T.A. possesses. It will obviate the competitive struggle between two news services creating a chaotic condition in the field of distribution of news.

I sincerely hope that these proposals will meet with your favorable consideration."

-2-I pointed out to the Executive the advantages of a general Jewish news service in preference to an out-and-out Zionist news agency; that all other important aspects of Jewish life, like anti-Semitism, the fight for the maintenance of Jewish position and Jewish rights in the various countries of the Diaspora, questions of emigration, relief, etc., could not be ignored; that one truly influential news service was preferable to a number of agencies catering to the various parties and dealing with the various problems with which the Jewish community is confronted. I showed them that an independent news service was more flexible and desirable; that new situations may arise which might necessitate arousing public opinion a gainst policies or actions of the British authorities, and that if the news service were controlled by the Executive, as Palcor is, the Executive would be seriously embarrassed if approached by the Administration to refrain from what they would term hostile propaganda abroad. (As a matter of fact, our experience proves that the official Jewish leaders in every country, when the government appeals to their patriotic sentiment, indicating that the interests of their country are damaged by the reports of the J.T.A., - have readily acted upon the suggestion of the govornment. This was, for example, the case when our Viennese correspondent was deported. At the time of the Heimwohr putsch in Austria, he telegraphed that Austrian Jewry was anxious about their fate in a Christian-Fascist corporate state. The Jewish leaders appealed at the request of the government to the American Legation not to intervene against the deportation of our correspondent. It can readily be imagined what pressure would be exercised on a group-controlled Jewish news service. It could not report developments as independently as it should.) I also pointed out that the Jewish newspaper field was extremely small, that even the J.T.A. was faced with a considerable deficit from the very outset, and that the establishment of a new service was bound to create serious difficulties for the J.T.A. I particularly emphasized that to offer news by cable to newspapers and to charge subscription fees constituted actual competition with the J.T.A. Whether the Executive was controlling the J.T.A. or trying to replace it by an agency controlled by the Executive is in essence the same. I a rgued that there was no need for the Executive to establish a news service. It should have a Department of Informa tion giving information to every correspondent, and that department should not be headed, as is now the case, by a man who is a correspondent of a newspaper or running a competitive news service. A few days after having submitted my proposals to the Executive, I was informed by Mr . Ben-Gurion and Mr. Shertok that they had not been accepted. No reasons were given for this refusal, and Mr. Ben-Gurion refused to enter into any further discussion. Histadruth Control of the Agency Executive The Executive is presided over by Dr. Ruppin who, as he himself admits, takes no interest in political questions, but devotes himself to his department (colonization). Dr. Berkson has resigned. Dr. Senator, who represents the non-Zionists, is affiliated with the Histadruth. Mr. Ben-Gurion, Mr. Shertok, Mr. Kaplan and Dr. Senator, therefore, form one

-4of such a discreet and tactful nature that Reuter would never have to acknowledge publicly that it is at all subsidized. Only in our community are such questions, which are really of a delicate nature, made the subject of public discussion and controversy. The Router service frequently publishes news which is unfayorable to the government. Whenever delicate problems come up, Reuter's representative calls on one or aanother governmental department, listens to the observations of the government official, and modifies his report if the suggestion of the official seems to him reasonable. There is mutual good-will and confidence, and no attempt is made on the part of the government official to actually dictate or control the Reuter service. Reuter jealously watches its independence. The government is not interested whether Router makes a profit of has a deficit, but the support it gives Router is merely based on recognition of the services Reuter renders by giving British news wide publicity and carrying news to those parts of the Empire where the number of newspapers is small but where the government's interests domand that an atmosphere friendly to Britain should prevail. The question of subsidy was not one of the main points in my discussion with the Executive. The request was only made that if the J.T.A. was to distribute the Palcor service, additional expenditure attached to this work should be taken care of by the Executive .. The course on which the Zionist Executive is about to embark is extremely dangerous. It would eventually lead to the establishment of a Revisionist, Mizrachi, etc., small press services, none of them commanding the whole sphere of influence, the numerous contacts with leading agencies, newspapers, governments, statesmon, institutions, organizations, etc., which the J.T.A. has succeeded in establishing. It is the curse of Jewish partisan strife that in the heat of battle none of our parties has any use for a cool, objective, non-partisan recorder, but clamour for a news service each can control. Hostide Actions of Histadruth Leaders A number of steps were taken by Histadruth leaders in order to weaken or discredit the U.T.A .: 1. The Executive of the Histadruth cabled to the Histadruth in South Africa to boycott the J.T.A. because it was a "Revisionist" enterprise. A circular of defamatory nature wasswidely circulated by the Histadruth in South Africa. At a sub-committee meeting of the South African Zionist Executive, the alleged Revisionist tendencies of the J.T.A. were disproved. It was decided, by a considerable majority, to publish an editorial favorable to the J.T.A. in the "Zionist Record". official Zionist organ. Thereupon, a member of the Zionist Executive in London caused a telegram to be sent to South Africa advising against publication of this editorial. 2. The Executive under the influence of the Histadruth leaders has withheld important news from the J.T.A. or handed it to the J.T.A. after it had already been made public by the Palcor. Although it was promised that this practice would cease. I am in receipt of a letter dated as late as December 27th from the Palestine correspondent that such is not the case.

-5-3. Histadruth members of the Executive, while promoting a rival system, have endeavored through the use of threats to intimidate the J.T.A. 4. The Executive handed us an ultimatum in connection with the proceedings of the Action Committee, threatening us with the establishment of its own cable service in case we circulated reports about the Action Committee session emanating from other than official sources. (The ultimatum was superfluous. We prefer to receive official communiques - but the Executive Committee in the past did not issue such communiques in time. In addition, their communiques were inane. We would, nevertheless, have confined ourselves to these communiques if there were not a number of journalists who were members of the Action Committee and who would wire and write on the proceedings to their respective newspapers. The Action Committee was never able to enforce a sufficient measure of discipline on their members not to divulge the proceedings of the Action Committee.) Laying the Revisionist Bogey The origin of rumours that the J.T.A. is Revisionist are multifarious: 1. Oppositions always attract a great deal of public attention because of their intense activities. The fact that, for example, the British press frequently reports Moseley's speeches while only once in 6 ot 7 months one by McDonald appears, certainly does not indicate that the British press is pro-Fascist. 2. Party passions have been inflamed to an unprecedented degree within the Zionist movement. The Histadruth members of the Executive take the view that the Revisionists are Fascists or Hitlerites, or as one of them said to me "certainly insane". They do not want us to report the activities or speeches of Revisionist leaders . They frankly state, "One cannot remain impartial with regard to the Revisionists, because they are a danger to the movement." The Histadruth leaders as a matter of fact resent the impartial attitude of the J.T.A., and expect us to fully identify ourselves with their own viewpoint, which is naturally impossible. As a matter of fact, one of the points on which the most severe criticism of the J.T.A. was based is the fact that the J.T.A. reported extensively on the Jewish colonization work in Russia. The Post "Affaire" -Agronsky Two years ago when the depression assumed very serious proportions, I was compelled to cut our budget most drastically in every part of our system. I wrote to Mr. Agrensky informing him that I had to cut his salary from 155 to 140 a month. I understand that Z40 is not considered a meagre salary in Palestine. Mr. Agronsky replied that he would resign if I insisted on the cut. Two weeks later, when I noticed that Mr. Agronsky had started an editorial column in the "Palestine Bulletin", I expressed my resentment in a cable that he had done this without consulting me first. We had been subjected to very

severe criticism because of editorials which Mr. Agronsky's pred; essor had published, and I felt that such an important. parture should not be assumed by a correspondent on his in initiative. Mr. Agronsky, who had already offered his resignation because of the salary cut, seized upon this later development to make it seem that he was resigning chiefly because of my interference with his editorial conduct of the paper, as he well appreciated that it would be easier for him to arouse sympathy on these grounds than on the salary cut. He then launched an effort to establish a competitive paper. I was most painfully surprised that Dr. Weitzmann and other influential Zionist leaders in no wise hesitated to back Mr. Agronsky by trying to obtain funds for him. Mr. Agronsky had always catered to Dr. Weitzmann and leaders of the Labor Party. Our Agency, just because it is impartial, cannot identify itself with any group or party within the Zionist movement. Instead of being backed by everybody, we find that nobody is definitely behind us because of our policy of not taking sides. However, I felt that it would be detrimental to the best Zionist interests if there were two papers in the English language in Palestine, conducting an acrimonious fight against each other, and I did something so generous that it indeed bordered on folly. I gave up the control of the paper, turning 49% of the shares over to Agronsky's group, and 2% to Lord Melchett. Not a single cent was asked or received by myself or the Jewish Telegraphic Agency. We turned the paper over without one penny's worth of debt attached to the paper. The Z2000 which Mr. Agronsky raised were to be put into the paper itself. If I had assumed that this step on my part would satisfy Agronsky and his group, I was soon to be disillusioned. Mr. Agronsky had agreed that the name of the paper should not be changed. He began to exercise pressure on me to consent to a change of name. I agreed. He incorporated his group although he had not breathed a single word about this intention when we concluded our agreement. He went still further. He gave his corporation the same name as the paper. Thus he materially changed the situation to his advantage. Today Mr . Agronsky speaks of the "Post" as an entirely new paper. Mr. Agronsky had agreed in the presence of Lord Melchett that in case he should not be successful the management would return to me. When I reminded him of his promise, I received a letter from Mr. Goldwater, the chairman of the corporation, that the company, if unsuccessful, would be liquidated in accordance with the laws of Palestine. Lord Melchett, who was to act as arbitrator, on two occasions rendered a decision, or opinion, upon hearing from Mr. Agronsky and without awaiting my statement. The old saying, "Don't put your trust in princes", I am afraid is equally valid with regard to Twentieth Century lords ! Then the feeling was forced upon me that the intention was to ignore and nullify whatever influence I was entitled to, and I began to look around for a purchaser of my shares. I tried to persuade Mr. Haskel to buy my shares for 22000. He was not at all anxious. Meeting Mr. Agronsky at the Prague Zionist Congress, I informed him of my intention to sell the shares. He asked whether I would not sell them to him. My reply was, "Certainly, with pleasure!" But he did not take me up. Weeks later I met him again in London.

I informed him that I was continuing my effort to sell the shares. He again made no offer! It took a few more months to complete the transaction with Mr. Haskel, which was finally concluded in November, 1933. During all these months not a single word was received from Mr. Agronsky indicating that he was willing to buy. Only after the shares had already been sold to Mr. Haskel, I received offers emanating from Mr. Agronsky. I was very glad to receive the 12000 from Mr. Haskel, which helped take care of some very pressing committments.

The sales of the shares in the "Palestine Post" to Mr. Haskel was utilized by Mr. Agronsky to launch the rumours that the J.T.A. had submitted to Revisionist control. As a matter of fact Mr. Haskel has not purchased a single share in the J.T.A. The shares which Mr. Haskel bought from me have subsequently been sold to Judge Rosenblatt. Nevertheless the campaign against our Agency continues.

## J.T.A. Threatened by Revisionists

Dtringabsolutely preposterous and entirely unfounded that the J.T.A. is imbued with a Revisionist bias. During its entire existence of seventeen years, the J.T.A. has consistently maintained an attitude of loyalty toward the Zionist Executive. We have at all times given wide publicity to every announcement emanating from the Executive. Even during the last ten months at a time when the Histadruth was making life for us as miserable as possible, we have not discriminated against the Histadruth. We have paid a great deal of attention to the visits of Histadruth leaders like Mr. Locker and Miss Kaplan, etc., as even a casual perusal of the Jewish Daily Bulletin will prove.

No reader of the Bulletin could obtain the impression, I am sure, that we are campaigning for or against any particular group within the Zionist movement. If nothing else, at least the truly superhuman effort we made during the riots in 1929 to arouse public opinion throughout the world should have prevented any Zionist Executive from turning against our Agency and from establishing a press agency without first at least getting in touch with us and ascertaining whether some satisfactory arrangement could not be concluded.

As a matter of fact, the Revisionist Party is very resentful about what they consider the obvious reluctance on the part of our Agency to give them publicity, and I have on a number of occasions received threatening letters from them. Mr. Ja botinsky has frequently intimated that he would establish a news service which would give justice to Revisionist news. A few quotations from letters will prove my point:

One from Revisionist Headquarters informs us that "the headlines regarding the Stavsky case are unfortunately worded".

Mr. Jabotinsky in August, 1934, writes that his "friends are more than angry with the J.T.A. which reached the limit of unfairness when they circulated a totally fantastic story about a Betarist mortally, or semi-mortally wounding a member of another party... It is undeniable that our statements, even the most sensational ones, never get the honor of being transmitted in full by cable. They reach the public in a mutilated form and then it is too late to make the papers print them in full. Compare this with the display the J.T.A. gives every step of the Z.E."

many correspondents of our Agency. He holds no conspicuous position in the Revisionist Party, is not actively engaged in Revisionist work, and for the past six years or more has refrained from writing on political Zionist subjects. He has been our staff correspondent for the last sixteen years, almost from the very beginning of our existence. He wass deported by the Austrian Government a year ago. He is a n excellent journalist, knows his work, and we place every reliance on his integrity and sense of responsibility. He has not mastered English sufficiently to be useful in our London office; we cannot use him in Paris because of his lack of knowledge of the French language; he possesses, however, Hebrew and knows enough English to represent us effectively in Palestine. Needless to say we cannot dispense with one who has for sixteen years faithh fully served our system, and barring him from Palestine would make him a burden to our Agency.

We havenever enquired into the political views of our correspondents. Our instructions are that they must adhere to a policy of strict impartiality. If they prove to be partial, we reprimand them. If they continue a partial attitude, we dispense with them. But it is unjustifiable to bar a man from representing us on the grounds that his party convictions are not in consonance with those of the Executive.

3. I understand that Histadruth leaders point to inaccuracies of J.T.A. reports. I wish to say that the J.T.A. performs its work in the most conscientious spirit. Certainly mistakes occur, but they are inadvertent or honest mistakes. No work is so much subject to error as the reporting of news. An accident occurs on the street and of three eye-witnesses, each gives a different version in court. As the correspondent is rarely present at the spot where news development has taken place, he usually learns it from second-hand sources or from newspapers. It can readily be imagined that this news -when cabled briefly to seven different offices, in each of which there is a different editor with a different knowledge of the background, and as cables are sometimes mutilated -occasionally a word or phrase is misinterpreted. It is easy to pick out of the thousands of reports, which we handle in the course of a year, half a dozen or a dozen reports and build up a case against the J.T.A. All this is merely incidental. In the big lines of our work nobody can question our earnestness and our desire to perform our duty in a constructive sense.

Under the headline "Why a New Telegraphic Agency?", Doar Hayom, a Jerusalem daily, writes that "It is very much to be regretted that the existence of an institution like the J.T.A. is being undermined so nonchalantly."

The Yiton Meyochod, daily evening paper in Tel Aviv, says in part, "To know from experience how impartial! the publicity and the information of the new news service is."

Hayarden, Hebrew daily in Jerusalem, severely criticizes the Executive for its efforts to subject the J.T.A. to a censor-ship, and heads its editorial emphasizing the J.T.A. value, "The Jewish Agency wishes to Free Itself of an Impartial News Service".

The Tel Aviv daily Haaretz says that those who are responsible for the "new service ought to understand that if their news is colored in a partisan spirit, the game will not be worth while".

Boust'nai, the official organ of the Jewish Farmers Association in Palestine, edited by the Lionist leader M.Smiliansky, is no less severe in its condemnation of the new service: "Especially opposed to the J.T.A. is the Labor Wing, for this reason only--the J.T.A. refuses to color its news to suit the Laborites. The three editors of the new Palcor service are all Laborites. They are (good boys!. They are kosher."

Chwila, the leading Polish Zionist newspaper in the Polish language, Teels that "The new Palcor service has often been damaging to the Zionist tactics..."

J.T.A. Will Remain Strictly Impartial

It is needless to emphasize that the J.T.A. has not changed and has no intention of changing its policy of strict impartiality. The complaints which have been made against the J.T.A. are without any foundation whatever.

To be fair in the presentation of news, to be scrupulous and to guard against misrepresentation, is its policy which it follows with almost religious fervor. The J.T.A. is only too well aware of its responsibility and realizes the untold havec one careless word may inflict. Never has a personal animus been injected into our work. It is truly impersonal. It has never tried to "get even" with its worst enemies by ignoring their public activities or mressing up reports which might hurt them.

In its seventeen years of work, the J.TAA. has built up a powerful Agency. Its connection with newspapers, news agencies and institutions of every type, Jewish and non-Jewish, is a real asset to the Jewish people and should not be trifled with. The J.T.A. deserves to be treated with such regard as the position it has obtained in the course of years metits. The J.T.A. has a great and earnest ambition to make the Agency as powerful and useful an institution as possible in the interests of our people.





### MINUTES

Of the Organizational Meeting of the Jewish Telegraphic Agency Board of Control, held Nov. 15,1935, 4:30 P.M. at the office of Mr. Herbert Bayard Swope, 1270 Sixth Avenue, New York City

The following were present: Messrs. George Backer, Dr. Maurice Karpf, Walter E. Meyer, Miss A.R. Emmanuel for Mr. Felix M. Warburg, J. M. Kaplan, David Podell and J. Landau. Tr. Maurice Hexter, member of the Executive of the Jewish Agency for Palestine, attended the meeting as a guest. Mr. Herbert Bayard Swope presided.

The meeting was called to order by Mr. Swope. Mr. Swope was elected temporary chairman and Mr. Jacob Landau temporary secretary of the meeting. Mr. Swope announced that a letter he had addressed, subsequent to the luncheon conference at the Lotos Club, to those who had attended the conference and a number of others had resulted in contributions and pledges amounting to approximately \$25,000. Among the pledges received he mentioned a promise made by Mr. John M. Schiff to contribute \$2500 annually for a period of two years if five others would promise likewise before December 31st; and a promise of \$2000 from Mr. Henry Ittleson if the entire sum of \$70,000 which was sought were secured.

Mr. Swope announced that a meeting of the stockholders of the Jewish Telegraphic Agency, Inc., had been called for Nov. 19th in order to permit the creation of a new board of directors. Steps are also being taken to effectuate a change in the charter of the J.T.A., making it a non-profit corporation, which will permit contributions to be deducted from income tax returns. The chairman also remarked that the Board is being established in order to give weight and body to the J.T.A. Mr. Podell offered to do the legal work necessary to transform the J.T.A. into a non-profit corporation.

Mr. Swope announced the transference of Mr. Landau's stock to a committee of trustees, consisting of Messrs. Backer, Horowitz and Landau. Mr. Landau thus surrenders all personal control of the property and necessarily over the policy of the J.T.A. The J.T.A. represents more than 18 years of unflagging effort and of exclusive commitment on the part of Mr. Landau.

The following were unanimously elected on the board of the J.T.A. on motion made by Mr. J. M. Kaplan: Dr. Cyrus Adler, Solomon Agoos, George Backer, Jacob Blaustein, Dr. Alfred Cohn, Louis J. Horowitz, J. M. Kaplan, Louis Kirstein, Jacob Landau, Albert D.Lasker, Walter E. Meyer, David Podell, M.Rothenberg, Arthur Lamport, David Sarnoff, Rabbi Silver and Felix M.Warburg. Each of them has indicated his interest; but in one or two cases final acceptance has not yet been made. Mr. Swope was authorized to extend an invitation to Mr. David Sarnoff to join the board.

The following resolutions were unanimously adopted on motion of the Chair:

- 1. The board shall have the right to enlarge or decrease its membership.
- 2. No liability whatsoever attached to membership on Board.

Mr. Swope nominated Mr. Louis J. Horowitz as chairman of the Board. Mr. J. M. Kaplan said he felt the work of the J.T.A. to be of great public importance and opinion-making, and that Mr. Horowitz could aid greatly in this work. He described Mr. Horowitz as a man of unusual ability, great organizing capacity, and successful at anything he would undertake. Mr. Horowitz was unanimously elected chairman of the Board. Mr. Felix M. Warbung was elected vice-chairman, Messrs. J. M. Kaplan and David L. Podell vice-presidents, and Mr. Jacob Landau secretary and managing director.

Mr. Swope suggested Mr. George Backer as president and treasurer. He pointed out that Mr. Backer had given generously of his time and money to the Agency and had familiarized himself with all its problems, and because of his literary inclinations had taken a deep interest in the work of the Agency. Mr. Backer was unanimously elected president and treasurer.

The following were unanimously elected members of the Executive Committee on motion of Mr. Kaplan: George Backer, L.J. Horowitz, Dr. M.J.Karpf, M. Rothenberg and Jacob Landau.

The following resolution was unanimously adopted on motion made by Mr. Kaplan: The Executive Committee shall have the power to expand or restrict its membership, and, further, that they shall be ex-officio members of all committees.

Dr. Karpf suggested that similar committees be established in London, Paris and Jerusalem. Mr. Swope mentioned that Mr. George Backer may go over to London in January for this purpose.

The following were elected unanimously at motion made by Mr. Kaplan to bring about cooperation between the J.T.A. and Palcor: Messrs. Warburg, Podell, Kaplan, Dr. Silver and the members of the Executive Committee.

Mr. Swope said that representatives of newspapers and such bodies as the board may deem desirable may be added to the Board in the future.

Mr. Swope road letters from Dr. Adler, Judge Mack and Judge Irving Lehman.

Dr. Adler wrote: "I too agree with the general tenor of the discussion as to the necessity of the maintenance of the Jewish

Telegraphic Agency. I have been interested in it from the time that Mr. Landau first came to this country. I know too that it has always proceeded with insufficient funds, and I believe that with proper support its news service could be greatly improved."

Judge Mack expressed regret at not being able to accept membership on the J.T.A.-Palcor committee because he had already served on such a committee, and felt under the circumstances he could not sponsor one or the other. "I have always said and shall continue to say, that a world Jewish telegraphic service is essential, and that for this reason J.T.A. must be supported, inasmuch as it has had so many years experience."

Dr. Hoxter reported that he and Dr. Karpf had a long discussion with Mr. Bon-Gurion in London about the question of a rapprochement between the Palcor and the J.T.A. A proposal was submitted by Mr. Ben-Gurion at this meeting, which Dr. Hexter submitted to the Board, making it clear that Mr. Ben-Gurion indicated that this was merely his personal view. Dr. Karpf pointed out that at the meeting of the Administration Committee of the Jewish Agency for Palestine which took place in Lucorne, the J.T.A.-Palcor controversy was referred to the Executive. The Exocutive appointed a committee to deal with this matter, of which he is a member. This committee will study the report worked out by a previous committee appointed last January by the Administrative Committee of the Jewish Agency. He stated that he personally was opposed to the very principle of a politically controlled news service and was submitting a minority report to the committee to this offect. Dr. Hexter and Dr. Karpf indicated that Mr. Ben-Gurion's proposal might be considered as a basis of negotiation. They were in no way prepared either to accept this proposal or to urgo it on the group.

Mr. Kaplan expressed the view that by allotting some seats on the board of the J.T.A. to the Zionist Executive, harmony could perhaps be established. Mr. Meyer stated that a Palestine orientated Jewish news service may not always prove to be in the best interests of the community. He could visualize that certain activities or developments in Palestine may be centrary to Jewish interests in other countries.

Mr. Swope said that he had followed the work of the J.T.A. for quite semetime and had convinced himself of its value. He was opposed to an official news service. Even to define what is news is extremely difficult, he pointed out. The same report which one day would be of great news interest, would cease to be so after a number of days in which the same kind of development repeated itself. If, for instance, a thousand Jews were killed in Germany or any other place today, it would be featured on the first page of every American newspaper. But if this were to happen day after day for a number of days, it would eventually be given only a few

lines somewhere on the inside pages. The news value of news is determined by its "shock impact". Mr. Swope differentiated between the intrinsic and extrinsic implication of Jowish news gathering. With regard to internal party strife, an Agency like the J.T.A. should be wholly inert. It was different with regard to extrinsic developments, those affecting the entire body of Jowry.

Dealing with other aspects of the Agency, Mr. Swope said that it would be of enormous importance if famous journalists or writers, men like Sinclair Lewis or H. G. Wells, could be sent by the Agency to Germany or other countries, and if their articles could be syndicated to newspapers throughout the world. He also referred to the importance of the J.T.A. being utilized by the general press as a tipping agency -- the papers themselves obtaining from their own correspondents reports on developments to which the J.T.A. had drawn their attention.

It was in his opinion of vital importance that an offort be made to obtain support for the Agency from as wide a circle as possible in order to avoid the possibility of pleading for special interests.

The moeting adjourned at 6:45 P.M.

Dear George:-

I am prompted to write this note to you and Mr. Landau by the deep interest I have felt in the operations of the JTA since I took enough trouble to discover the nature of the work it is doing.

I am astounded that the JTA has not a greater circulation. I made an inquiry into the undertaking several years ago, when I was Editor of The World, and I then found it was doing a good job. Now, with conditions radically different; with the German volcano solidifying and intensifying the concern of every man and woman of tolerant mind or of Jewish blood, the JTA is serving an absolutely essential purpose. How can intelligent action be taken unless intelligent information is first provided? Therein lies the justification for the JTA.

I read regularly the report in its new form. I find it a model of condensation; of width of subjects; of information and of importance. It prints the news that every man and woman who has a specific interest in a specific subject should know; it prints news that is not to be found in the daily papers because the news has become repetitious or parochial or, for some other reason, it lacks availability for the daily press.

You are bringing to the members of the Jewish communities in this country the news they ought to know, though, God knows, they may not want to know. I imagine there are at least 5,000 leading Jews who may become subscribers to the service. That would be only one tenth of one per cent of the total numbers of Jews in America. It is true that the cost of the JTA service is, seemingly, high, but \$50 a year is actually cheap for a daily report covering the entire world, through cables from staff correspondents, and prepared in a manner at once simple and effective.

The point of this letter is to suggest that you make a drive for subscriptions. The JTA is a non-profit making institution, and I think that should be known. I am confident that the excellence of the product will win its own way once it has been examined. In helping the JTA, the subscribers are doing a bigger thing than charity, because, by anticipating emergencies, the need for charity frequently may be removed.

The drive for funds to secure the J.T.A. for the next two years has made considerable progress. A great deal of our indebtedness has been wiped out and it is the opinion of our Executive Committee that by the close of 1936, the J.T.A. will be in a healthy sound position.

Mr. Landau's brief trip to the south and far west was extremely successful. He secured the cooperation of a number of community funds which had never participated before, and was able to increase the allocations from other communities. Mr. George Backer, our president, sailed for Europe to join Mr. Landau in an effort to reorganize the European offices along the lines pursued here.

The Galland Fund of Portland have assured us of an allocation. We would appreciate immensely your interceding with the trustees of the Beaumont Fund for a favorable response to our application.

Karpf, Louis Kirstein, Walter E. Meyer, David L. Podell, Morris Rothenberg, Arthur M. Lamport, Louis J. Horowitz, Rabbi Abba Hillel Silver, Sol Kline, Samuel A. Goldsmith, Mrs. Edward Jacobs and Felix M. Warburg. Mr. Landau assigned his shares to this board. The officers of the corporation are George Backer, President, Felix M. Warburg, Vice-Chairman, David Podell, Vice-Bresident, Arthur Lamport, Treasurer and Jacob Landau, Secretary and Managing Director. The Executive Committee consists of George Backer, Dr. Karpf, Arthur Lamport and Jacob Landau.

### MEMORANDUM

The Jewish Telegraphic Agency maintains seven (7) offices: New rk, London, Paris, Berlin, Warsaw, Prague and Jerusalem, and correspondents in every larger Jewish center. The service of the JTA is utilized not only by Jewish papers the world over, but by the Associated Press, which turns the JTA reports over to 1,250 American dailies; Reuter, which is the most powerful news service of the British Empire; and Havas, the French agency.

The budget of the JTA, prior to the depression in 1928 and 1929, approximated \$250,000. It obtained about \$140,000 from the sale of its news and raised \$110,000 from the community. During the years of depression the agency was forced to drastically cut its budget. Its budget amounts today to \$125,000. Its income from the newspapers shrank to \$70,000.

The present budget of the JTA does not enable the JTA to function to the maximum degree of its usefulness. The following measures would be required to give the agency that scope which in the present volcanic state of Jewish affairs would be desirable in the best insterests of the Jewish community:

- (1) It would be of the utmost importance to enable the JTA to employ internationally known American and British correspondents in such countries where the Jewish position is particularly in danger; i.e., Poland, where anti-Semitic agitation has recently assumed very dangerous proportions; Roumania, Hungary, Austria, Lithuania, -atvia, Greece and Turkey. The gathering of Jewish news has lately become, in a number of countries, a most difficult and hazardous undertaking. While following a ruthless anti-Semitic course, the governments of these countries are anxious to prevent the news from leaking out. The very presence of a prominent news-paper man like Wickham Steed, the former editor of the London Times, and other men of this caliber, would have a deterrent affect. These countries are not as powerful as Germany and depend on moral, financial and political factors in England, France and the United States. To draw a safety cordon around Germany and to prevent the example of Germany being followed by these countries is a command of political wisdom. If the Jewish position should break down in a number of European countries, the repercussion of such a development is bound to affect Jewish prostige even in the United States. In order to employ a number of outstanding newspaper men and to enlarge the budget of the agency for cable tolls, the budget would have to be increased with at least \$60,000.
- (2) Sometime ago the JTA entered into negotiations with the British authorities with regard to the sending out of a daily dispatch from the Rugby Station, the most powerful radio station of the British Empire. Such an

-2-

arrangement would be most effective in order to counter the propaganda which emanates from the German radio station in Nauen, which disseminates news throughout Europe and also to South Africa, South America and other countries. The British authorities were willing to make very far reaching concessions by cutting the rate into half, charging the JTA instead of eight (8) pennies, only four (4) pennies per word. Some additional arrangements would be required in the countries where this news is to be disseminated. With the sum of \$35,000 a daily dispatch of 1000 words could be arranged for. The propaganda value of such an arrangement cannot be sufficiently emphasized.

- (3) It would be desirable if the JTA were in a position to supply the smaller newspapers throughout the country with a mat or plate service. A similar service should be rendered in the German language to the German language newspapers in the United States. This service should include not only articles and features, but also cartoons. The most effective weapon in our fight against Germany is to make the Hitler regime ridiculous. It would have to carry material of general interest as well as articles the purpose of which would be to counter Nazi propaganda. Full light should be particularly thrown on the economic difficulties of Germany, proving the anti-Semitic course has not benefited Germany. The sum of \$25,000 would be required to make this service possible.
- (4) The JTA should be in a position to contract some of the most outstanding personalities, men like H.G.Wells, Sinclair Lewis, General Smuts, Winston Churchill and Lord Robert Cecil, for visiting Germany and arranging for the syndicating of their articles, their delivering lectures, speaking on the radio, etc. The agency would work out arrangements with general feature syndicates and lecture bureaus, and keep itself in the background. In view of the considerable amounts which these agrangements would necessitate, the sum which the agency would require for the carrying out and covering it with regard to possible losses, would be \$20,000. The effectiveness, however, of such propaganda, cannot be overestimated.

Altogether, including its present deficit of \$55,000, the JTA could, if it were in a position to raise \$195,000, render a most vital service to the Jewish community. The basis of the JTA has been recently broadened. Mr. Herbert Bayard Swope, former executive editor of the New York World (one of the most influential and vital forces in the United States), recontly called a conference in which participated Mr. Bernard Baruch, David Sarnoff, George Blumenthal, John Hertz, Samuel Zemurray, George Backer, Lessing J. Rosenwald and other outstanding persons. The following measures were adopted:

(1) The agency was transformed into a community enterprise.
Mr. George Backer is the president of the JTA. Mr. Felix
M. Warburg is vice-chairman. Other members of the Board
are Albert D. Lasker, Louis Kirstein, Dr. Cyrus Adler,

Jacob Blaustein, Arthur Lamport, who is also treasure of the J.T.A., Dr. Maurice J. Karpf, a member also of the Executive Committee, Solomon Agoos, S. A. Goldsmith, Louis J. Horowitz, Walter E. Meyer, David L. Podell, Sol Kline; and so; e prominent Zionists like Morris Rothenberg, the president of the Z.O.A., Mrs. Edward Jacobs, President of Hadassah, and Rabbi Abba Hillel Silver.

- (2) Mr. Landau transferred his shares to the Board.
- (3) The Agency has been registered as a non-profit corporation.

With this new set-up, the JTA would be in a position to effectively carry out the various measures outlined above.

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING HELD APRIL 22,1936, IN THE OFFICE OF DR. KARPF, 71 W. 47th ST.

Present: Mr. George Backer, Dr. M. J. Karpf and Mr. Jacob Landau Mr. Lamport apologized for not attending due to his absence from town. Mr. Rothenberg was unable to attend, due to a trip to Chicago.

Mr. Backer reported on his trip to Europe. He visited the various offices of the J.T.A. and familiarized himself with the workings of the system.

Mr. Lionel Cohen, K.C., son of Sir Leonard Cohen, former president of the ICA, arranged a dinner meeting in order to enable Mr. Backer to meet some of the outstanding Jewish leaders in England. Among those present were become monteriore, president of the Joint Foreign Committee; meville Laski, president of the Jewish Board of Deputies; Mr. A. Levinson, chairman of the Parliamentary Committee of the Jewish Board of Deputies; Mr. Leonard Stein, nonorary counsel of the Jewish Agency for Palestine, Capt. Johnson of the mothschilds and Mr. Jacob Landau.

ments in the united States with regard to the J.T.A.

Mr. Backer also met a number of other Jewish leaders, among them, Mr. Samuel Marks, Mr. Otto Schiff, Sir nerbert Samuel, etc., etc.

The sum of £1200 was raised during Mr. packer's presence in Europe.

Sir Robert Waley Cohen displayed a particular interest in the work of the J.T.A. He promised to raise, together with Mr. Otto Schiff, the sum of £2000. Sir Robert indicated his willingness to come to the States during the fall or winter in the interests of extending the work of the J.T.A. and taking up other problems of propaganda.

The Executive Committee unanimously decided to propose to the next meeting of the Board of Directors to adopt Sir Robert Waley Cohen as a member as well as to coopt two or three other Jewish leaders in England and as members of the New York board.

Particular interest in the work of the J.T.A. was also manifested by Neville Laski and I.M. Sieff, as well as by Baron Robert de Rothschild in Paris.

Mr. Backer met in Paris Dr. Bernhard Kahn, Mr. Louis Oungre, Mr. David Weill, Mr. Leo Simon, Mr. Lecache, Prof. Oualid, member of the Execuative Committee of the Alliance Israelite, Mr. Schwartschild, editor of Das Neue Tagebuch, and others.

Mr. Backer visited Poland where he studied the Jewish situation touring some of the smaller communities. He conferred with Jewish leaders as well as the American ambassador in Warsaw. A meeting was held in the house of Mr. Raphael Schereszovsky, which was attended by leading members of the Poland Jewish community. A committee was elected whose task it is to organize a J.T.A. committee. The members of this committee are: M. Eiger, Raphael Schereszovsky, and the following Jewish members of the Sejm, Dr. Emile Sommerstein and Dr. Henrik Rosmarin.

Mr. Backer also visited Germany, while Mr. Landau proceeded to Budapest. The Jewish community in Hungary entertains serious misgivings
with regard to certain tendencies which have recently manifested themselves to oust Jews from their economic positions. The Jewish leaders
felt that if the J.T.A. at this time could send a prominent, internationally known newspaper man to Hungary, a great service would be rendered to Hungarian Jewry.

Mr. Backer expressed the view that if the J.T.A. could be further strengthened it would exercise a very important function and that extension of the J.T.A. work at this time was an imperative need.

Mr. Backer while in Europe conferred with Dr. Nahum Goldmann who had been authorized by the Zionist Executive to negotiate with Mr. Backer in order to bring about an understanding with the Executive regarding the Palcor Agency. Following a meeting of Mr. Landau with Dr. Goldmann in Geneva, Dr. Goldmann wrote a letter to Mr. Backer informing him of the terms which might be the basis of an agreement. The proposals of Dr. Goldmann are attached hereto. Dr. Karpf stated that he was in receipt of a letter from Dr. nexter informing him that the executive had discussed the J.T.A.-Palcor issue and Dr. Hexter promised in his letter that he would forward a translation of the minutes as well as his own observations and recommendations. It was decided to give consideration to Dr. Goldmann's proposals after receipt of the information promised by Dr. Hexter in his letter.

Mr. Backer reported on the financial situation. He pointed out that for the first time in many years the income and expenditures of the J.T.A. were even. The expenditures of the J.T.A. for the year 1936 will amount to approximately \$150,000, the income from sale of news to \$80,000, leaving a deficit of \$70,000 which has been covered by contributions. About \$17,000 of the contributions came from Jowish welfare funds. The Agency, however, Mr. Backer stated was not in a position to function as effectively as it should in these times. He was particularly concerned about employing at least two American newspapermen who should constantly travel in order to cover more adequately important developments, particularly in those countries where the Jewish position is jeopardized.

A resolution was unanimously adopted to call in the second installment of the pledges made on the two year plan which was adopted at the meeting called by Herbert Bayard Swope and held on October 30, 1935.

It was decided to explore ways and means to send to Palestine an American trained newspaperman.

Mr. Landau reported on the arrangement which was effected with the Havas News Agency in Paris. The Havas Agency is carrying daily 350 words of J.T.A., news over its wires. The arrangement is proving to be very advantageous to the J.T.A.

Dr. Maurice J. Karpf reported about the negotiations with the Executive of the Jewish Agency regarding Palcor. A sub-committee appointed by the Executive worked out proposals according to which the Executive would appoint 50% of the members of the board of the J.T.A., as well as to name the representative of the J.T.A. in the

two most stratogic points, London and Jerusalom. A discussion ensucd in which the feeling was expressed that the acceptance of these proposals would be tantamount to subjecting the J.T.A. to the control of the Zionist Organization, and to destroy its impartial and independent character. It was unanimously decided to refer the matter back to the Executive for further consideration and to submit the conclusions arrived at to a meeting of the board of directors.

It was decided to have the Executive consult subscribers of the J.T.A. with regard to the desirability of changing the name and to leave the final decision with regard to making the change and the date thereof in the hands of the Executive.

A resolution of thanks was unanimously adopted expressing appreciation for the cooperation Herbert Bayard Swope has extended to the J.T.A. George Backer was authorized to write to Sir Robert Waley Cohen and Sir Robert Mond expressing the gratitude of the Board for the assistance they have given to the J.T.A.

Dr. Karpf stated that Dr. Adler had asked him to present to the Board his views for a stronger emphasis on cultural news by the J.T.A. It was decided that an effort in this direction should be made, and Mr. Landau was asked to communicate with Dr. Adler with regard to this matter.

MINUTES EXECUTIVE COMMITTEE MEETING OF JEWISH TELEGRAPHIC AGENCY HELD DECEMBER 2, 1936, ONE O'CLOCK AT THE CHATHAM HOTEL Present: Mr. George Backer Dr. Maurice J. Karpf Mr. Jacob Landau Mr. George Backer presided. On motion made by Dr. Karpf it was unanimously decided to appoint the following as trustees to vote the stock held by Mr. Jacob Landau: George Backer Jacob Blaustein Jacob Landau Mr. Backer reported that on November 15th he received a letter from Dr. Karpf stating that the report contained in the minutes of the Board meeting on November 5th outlining the proposals for an arrangement between Palcor and J.T.A. was inaccurate. Dr. Karpf's letter was read and it was decided to send to the members of the Board of the J.T.A. a copy of the draft worked out in London by a Sub-committee of the Executive of the Jewish Agenoy. The proposals read as follows: 1.) It is proposed that on both the Administrative and Executive committees of the J.T.A. Corporation Palcor interests shall have the right to name one half of the membership. An opportunity shall also be given to the representatives of Palcor interests to acquire, through purchase, a substantial portion of the voting stock of the Corporation. 2.) The Managing Editor of the J.T.A. resident in London shall be named by the Board, in agreement with the Palcor interests represented on the Board. It should be understood that the London Managing Editor shall have the right to nominate the personnel of his European staff, with the approval of the Board. 3.) The representative of the J.T.A. in Palestine shall be named in agreement with the 'Palcor interests represented on the Board.

The following letters bearing on the subject were received from Dr. Cyrus Adler, Sir Robert Waley Cohen and Sir Robert Mond:

(From Dr. Adler)

September 22, 1936.

Dear Mr. Backer:

I have your letter of September 16th. I am in agreement with you that the enclosed memorandum will not offer a basis for a real discussion. You know of course, that at the meeting of the Administrative Committee of the Jewish Agency it was pointed out that the Agency had no jurisdiction over Palcor which was exclusively supported by the Zionist Organization.

(From Sir Robert Waley Cohen)

October 12, 1936.

You ask me to give you my views in the proposals made to the Board Sub-Committee. As regards (1) I don't think the matter should be regarded as one of representation, but it is of the utmost importance that your Agency should be organised with a view to efficiency and not to representation of this or that body. While, therefore, I think you should gladly welcome nominees of the Agency both on your Administrative and Executive Committee, I don'think there would be my point whatever in their appointing more than one or two representatives. I think the suggestion that they should acquire an interest in the voting stock of the corporation is a very good one.

(2) Here again, I think, the Managing Editor should be the best man that can be found, and that it would be entirely unsound that he should be nominated by anybody but the Board of the Corporation itself. It is entirely sound, I think that he should appoint his own European staff, but of course he must appoint also his own Palestinian staff with approval of the Board.

Paragraph (4) seems to me quite satisfactory, except that I don't understand quite what is meant by the phrasing "the membership of the Board." I think the Board as a whole must be supreme in everything.

- (5) seems to me quite in order.
- (6) I think it would be much wiser for Palcor to be dissolved. Tendentious Agencies controlled by the political organizations are bound to do much more harm than good and create great suspicion.

September 24, 1936;

Yours of the 23rd. These are my views. The value, and the only value of the J.T.A. is the absolutely reliability of the news it distributes. The Administration and Executive Committee have to ensure that the Managing Editor and his subordinates do so. Everything else is of completely secondary importance.

I fail to understand the raison dietre of the six propositions. If above principle is rigidly adhered to, unless it is desired by some of the future subscribers, to cook the evidence, which would completely destroy the utility of the J.T.A. I should like to be quite clear as to this. In any case representation should be in proportion to subscription.

Dear Rabbi Silver:

While in London a couple of weeks ago Dr. Maurice J. Karpf, Mr. Landau and I conferred with Sir Robert Waley Cohen, president of the United Synagogues and in charge of Jewish defense efforts in England. Sir Robert expressed the view that at this time the effective functioning of a system which gives objective Jewish news to the press of the world and aims at combatting news of an anti-Semitic nature is most important. Sir Robert offered to subscribe \$15,000 provided the Jewish Telegraphic Agency receives at least \$60,000 in the United States from organized Jewish communities. He feels the J.T.A. should be permanently supported by the organized Jewish communities and not depend on the solicitation of individuals. The sum mentioned by Sir Robert is a minimum amount. The J.T.A. requires the sum of \$200,000 in order to carry out its program to the maximum degree of its usefulness to the Jewish community. Detailed memorandum enclosed.

Some welfare funds have already acted. Cincinnati included the J.T.A. for \$1000, San Francisco for \$3000, and if your Fund and the other welfare funds would make proportionate increases we would be able to satisfy Sir Robert's condition.

On behalf of our Board I wish to urge your kind intervention with your welfare fund for an increased allocation to the Jewish Telegraphic Agency in 1937. Early action enabling us to meet Sir Robert's pledge as soon as possible will be greatly appreciated.

Frankly, I do not know what earthly purpose the Jewish Telegraphic Agency hoped to serve by having these articles published in the daily non-Jewish press. Just what do you expect the non-Jewish readers of these articles to do about it? Such reports may have some value in the Jewish press in helping us to get a correct understanding of what is transpiring in Palestine assuming that all that Slobodin writes is the truth and the whole truth. But to warn the non-Jewish world that there is a "conspiracy of silence" on the part of the Jews in Palestine to keep the true facts from leaking out (a thoroughly preposterous notion in view of the fact that the newspapers daily report every piddling incident in Palestine), and to shout from the house-tops about the reality of Arab nationalism (a fact which everybody knows and everybody concedes), and lugubriously to warn of impending disaster, is just all too stupid. The half-baked, thoroughly amateurish and somewhat irresponsible character of these articles is most fully illustrated in the fifth article which you fortunately suppressed. May I suggest that hereafter, when you are considering the publication of such articles, I be given the privilege as a member of the Board to see them before they are released, a privilege enjoyed by the other members of your Executive Committee? Otherwise I see no point in remaining a member of your Board. Knowing that I was National Chairman of the United Palestine Appeal and that I was therefore vitally interested in any newspaper reports which had any bearing on Palestine, you might have extended to me this courtesy without being asked. While I realize that this has certain political implication to the Zionist organization ( with which I am not familiar) I do hope that in view of the serious plight of these refugees that the human element could hold sway over the political element.

MINUTES OF ANNUAL MEETING OF THE BOARD OF DIRECTORS OF THE JEWISH TELEGRAPHIC AGENCY, INC., HELD ON MONDAY, DECEMBER 5, 1938, AT THE HOME OF MR. GEORGE BACKER, 944 FIFTH AVENUE, NEW YORK, N.Y., AT EIGHT THIRTY (8:30) IN THE EVENING.

THE SECRETARY SUBMITTED THE FOLLOWING REPORT FOR THE PAST YEAR:

"During 1937 the Jewish Telegraphic Agency succeeded in consolidating its position. For the first time in the existence of the J.T.A. the contributions exceeded the operating deficit -- by \$12,201.15. This was partly due to a retrenching of the J.T.A.'s operations and partly to the larger amount raised through contributions. While in 1936 only \$79,946.21 was obtained, in 1937 the amount was \$92,199.03. The position would have been still better if the J.T.A. would not have suffered some losses of income from the sale of its news service -- in 1936 its income was \$64,156.96, which dropped in 1937 to \$58,841.55. These losses are partly due to the disinclination of general newspapers like the New York Times, to take reports from a Jewish news agency, and partly to the losses the J.T.A. suffered because of its inability to continue serving the Jewish papers in Germany, Austria and partly in Czechoslovakia. While the liabilities at the end of 1936 amounted to \$55,900.88, by the end of 1937 they amounted to only \$38,513.27. In 1936 the excess of liabilities over assets amounted to \$28,669.92, and at the end of 1937 they amounted to only \$14,961.89.

"During 1938 the financial position of the J.T.A. took a turn for the worse. The J.T.A. increased its expenditures by sending Victor Bernstein, a competent American newspaper man to Germany, and Roman Slobodin to Palestine. The developments in Austria, Italy, Czechoslovakia, the daily riots in Palestine, the recent events in Germany, imposed heavy burdens upon the J.T.A. However, it is very gratifying to note the increase of allocations from welfare funds. In 1937 the total from this source was \$19,307.06, and during 1938 up to November 25, \$31,171.57. Among the welfare funds which have increased their contributions -- Cincinnati from \$1200 to \$2000; Philadelphia from \$1000

TO \$1500; BOSTON FROM \$2000 TO \$3000, AND A NUMBER OF SMALLER WELFARE FUNDS. HOWEVER, THE J.T.A. STILL DOES NOT RECEIVE ADEQUATE GRANTS FROM CLEVELAND, PITTSBURGH, DETROIT, AND PHILADELPHIA. THE ALLOCATIONS MADE BY SAN FRANCISCO (\$5000), Los Angeles (\$3000), CINCINNATI (\$2000), BALTIMORE (\$3000) ARE MORE SATISFACTORY.

"FOLLOWING A SUGGESTION MADE BY SIR ROBERT WALEY COHEN, MONTHLY REPORTS ARE ISSUED TO MEMBERS OF OUR BOARD KEEPING THEM INFORMED ON THE ACTIVITIES OF THE J.T.A.

"IN November 1937, THE GERMAN GOVERNMENT CLOSED DOWN OUR BERLIN OFFICE. IN MAY OF THIS YEAR WE WERE COMPELLED TO TRANSFER OUR GERMAN LANG-UAGE BULLETIN FROM PRAGUE TO PARIS.

"AT THIS TIME THE HERALD-TRIBUNE AND THE NEW YORK POST, REUTERS AND HAVAS, ARE MAKING USE OF THE J.T.A. SERVICE. NEGOTIATIONS INITIATED BY MR. BLAUSTEIN ARE PENDING WITH THE INTERNATIONAL NEWS SERVICE.

"MR. JACOB BLAUSTEIN ASSUMED THE FUNCTION OF ACTING PRESIDENT DURING THE ABSENCE OF THE PRESIDENT. IT WAS DUE TO MR. BLAUSTEIN THAT THE ROSENWALD FOUNDATION, FOR THE FIRST TIME, MADE A GRANT OF \$1500 TO THE J.T.A., AND THAT PITTSBURGH AND PHILADELPHIA MADE GRANTS OF \$1000 EACH TO THE J.T.A., AND THAT PHILADELPHIA, AGAIN THANKS TO MR. BLAUSTEIN'S INTERVENTION, INCREASED ITS GRANT THIS YEAR TO \$1500.

"A NEW CORPORATION, OVERSEAS NEWS AGENCY, HAS BEEN REGISTERED BY US IN ORDER TO CARRY OUT A PREVIOUS DECISION OF THE BOARD. MR. SULZBERGER OF THE NEW YORK TIMES HAS INDICATED THAT THIS WOULD BE A DESIRABLE CHANGE TO FACILITATE THE PLACING OF JEWISH NEWS. AT THE SAME TIME THERE CAN BE NO DOUBT THAT THE GATHERING OF JEWISH NEWS UNDER THE NAME JEWISH TELEGRAPHIC AGENCY IS BECOMING INCREASINGLY DIFFICULT IN A NUMBER OF COUNTRIES. MR. HERBERT BAYARD SWOPE AFTER CAREFUL STUDY OF THIS PROJECT HAS GIVEN IT HIS EMPHATIC ENDORSEMENT."

CONSIDERABLE DISCUSSION ENSUED ON HOW THE J.T.A. COULD BE MORE DEFINITELY INTEGRATED AS A FACT FINDING AGENCY SERVING COMMUNAL INTERESTS AND MORE CLOSELY CONNECTED WITH THE NATIONAL JEWISH ORGANIZATIONS. DURING THE DISCUSSION THE DESIRABILITY WAS EMPHASIZED THAT THE J.T.A. DEVOTE MORE ATTENTION TO THE DEVELOPMENTS IN THE UNITED STATES.

Dear Rabbi Silver: .

I returned just a few days ago from the extended tour I made and I know you will be glad to learn that in most communities there has been a very favorable reaction toward our request for substantial increases. In San Francisco, where for the last two years they gave us \$5000 annually, the intimation was that they would raise our allocation to \$10,000, and perhaps even \$15,000. St. Louis has already increased from \$500 to \$2000. Kansas City where we received only \$100, we have reason to believe that we may get \$1000 or \$1500. Chicago, which had originally decided not to include the J.T.A. as they were devoting the entire proceeds of their campaign to refugee and relief agencies, after listening to Mr. Jacob Blaustein who went to Chicago especially for this purpose, have decided on a minimum grant of \$12,500 for the J.T.A. You know the policy of Chicago is to give 10% of what each participating agency actually raises, and we are hopeful for an additional grant in the course of the year.

We are very anxious that Cleveland should at last give the J.T.A. adequate support. We have no chance to raise the \$207,600 for which we are aiming, unless each community gives us two or three times of the scientific minimum, which would be an equivalent of 1% of what they give to the United Jewish Campaign.

Swope outlines the Overseas News Agency. I am afraid we will not be able to really go ahead with this plan unless the larger communities, like Cleveland, give serious consideration to our matter.

We have every reason to believe that Cincinnati, which gave us \$2000 last year, Baltimore and Boston which gave \$3000 each, and the other larger communities will substantially increase their allocations this year. However, there is no question that they will be very much influenced by Cleveland's decision.

May 19, 1939 Dr. A.H. Silver -2-Sometimes I am quite at a loss to understand the attitude of the welfare funds. I would understand were they to turn over their funds to a central committee before whom we would plead our case. However, as long as this is not the case each welfare fund should very seriously examine the needs of an agency like ours, which though not going out for millions, nevertheless performs an activity basic to all overseas efforts. If Cleveland were to make a contribution of \$10,000 they would at last give us that support which in the interest of the community we should receive. I am enclosing a detailed memorandum on the J.T.A. which we have especially written in order to give full insight into the work of the J.T.A. I do hope you will find time to read it. We are right now being flooded with cables in connection with the Palestine situation. I am really scared about this new terrific increase in our expenditures, coming at a time when any number of other developments have imposed such heavy burdens upon us, that we once more find ourselves in a pretty difficult spot. You will be glad to learn that there has been some rapprochement between the J.T.A. and the Zionist Organization. I understand an effort may be made to adjust the relationship between us and Palcor. #### MINUTES

(Prepared by the Jewish Telegraphic Agency for confidential circulation)

At the luncheon conference held on October 30th at the Lotos Club and called by Mr. Herbert Bayard Swope, the following were present: Messrs. Herbert Bayard Swope, Bernard Baruch, Felix M. Warburg, David Sarnoff, Samuel Zemurray, Robert Lehman, Bernard Gimbel, Louis J. Horowitz, Lessing J. Rosenwald, John Hertz, George Backer, Isidor Kresel, Lester Hofheimer, Abraham Krasne, Jacob Blaustein, Jacob Landau, Walter Meyer, Arthur J. Goldsmith, David J. Podell, Louis W. Abrons, J. M. Kaplan, Hiram Halle, George Blumenthal, Col. Joseph Hartfield and Dr. Alfred Cohn.

Mr. Swope pointed out that some years ago at the request of Mr. Warburg and the late Mr. Ochs, he had made a study of the work of the Jewish Telegraphic Agency and had come to the conclusion that the maintenance of a service like the J.T.A. was necessary. This conviction has been strengthened by the developments which have taken place in Germany and by the wave of anti-Semitic propaganda felt everywhere. Life was not worth while without self respect, and it is the task incumbent upon all those who have Jewish blood in their veins and ospecially upon those whom a brilliant mind termed "foul-weather" Jews, to take intelligent action, which is impossible without the existence of adequate information. For this reason Mr. Swope had called this conference.

Mr. Felix M. Warburg concurred in the opinions expressed by Mr. Swope and also said, referring to a recently established Palestine news service, that an all-inclusive system like the J.T.A. was preferable. In view of the transformation of the J.T.A. into a communal organization and Mr. Swope's and Mr. Backer's participation in this prorganization, Mr. Warburg declared that he was glad to reassume financial support of the Agency.

Mr. Bernard Baruch stated that while in provious years he was doubtful about the necessity of an agency like the J.T.A., he felt that it was today performing a useful and necessary function.

Mr. David Sarnoff agreed with the former speakers, and emphasized the viewpoint that an active board be established in order to relieve Mr. Landau's necessity of devoting practically all his energy to the raising of funds instead of to the work itself which necessarily must suffer.

Mr. Goorgo Blumonthal voiced a similar view as Mr. Baruch, and pointed out that in his opinion it might be desirable for the Agency to adopt a general name instead of styling itself Jewish Telegraphic Agency, and to combine with other groups interested in the German situation, which would give the Agency

a more general character. He promised to give the Agency his support.

Col. Hartfield, Mr. Louis J. Horowitz and Mr. Samuel Zomurray endorsed statements made by Mr. Swope and promised their financial support to the Agency. Several of the speakers, notably Mr. Horowitz, expressed themselves as having been unaware of the conditions surrounding the J.T.A. and agreed that immediate action was necessary.

The question of whether it was more desirable for the Agency to charge \$50 or \$25 for its news service was discussed. The opinion prevailed that it would be easier to obtain 1000 subscriptions at the rate of \$50 a year, and that a consistent offert be made in that direction.

Mr. Swope appointed the following as members of a Palcor-J.T.A. committee, to bring about harmony or a combination: Mr. Warburg, Judge Mack, Mr. Blumenthal, Mr. Backer, Mr. Zemurray, Dr. Cehn and Judge Lehman.

In addition to those just mentioned above, the following were also appointed to serve as members of the J.T.A. board: Mr. Albert D. Lasker, Rabbi Abba Hillel Silver, Mr. Louis J. Herewitz, Mr. J. M. Kaplan, Mr. Jacob Landau.

Mr. Backer stressed the precarious state of the present financial state of the J.T.A. Mr. Landau thanked Mr. Swope for having called the gathering and making it possible for the problems of the J.T.A. to be considered for the first time by a group of leading members of the community.

Mr. Swope read a letter received from Judge Irving Lohman, excerpts of which follow:

"I believe that you and I are in entire accord concerning the Jowish Tolographic Agency. The world must be kept informed of what is going on in Gormany, and fair-minded men must be aroused to its significance...Only by collecting and supplying reliable information of what is happening day by day can we Jows make the public understand the significance of the situation, and arouse and sustain public interest in it. That cannot be accomplished by individuals or by any organization which has not an organized news service...We fail in our duty to ourselves and to the world if we do not support the only agency now in existence which we can be sure will give the whole picture, in all its ugliness and blackness. I hope that you will succed in obtaining the necessary support for that agency."

Messages were also received from Prof. Folix Frankfurter and Judgo Julian W. Mack.

My dear Mr. Baker:-

You are undoubtedly acquainted with the work of the Jewish Telegraphic Agency. It is a great news gathering agency which has its representatives in all parts of the world and which supplies the newspapers of all countries with fair and authentic reports of those important events which have a Jewish significance. Up to the time of the organization of the Jewish Telegraphic Agency we were at the mercy of non-Jewish agencies which were frequently hostile to us and which gave to the world distorted and prejudicial accounts of events which had great bearing upon the political or economic status of our people.

The Jewish Telegraphic Agency has been on the alert to report any infraction of Jewish rights anywhere in the world, and governments have been deterred in well-known instances from anti-Jewish acts and legislation by the fact that there was such a Jewish publicity agency which could broadcast such acts to the entire world.

Thus recently the Jewish Telegraphic Agency was in position to supply the newspapers of the world with accurate and authoritative accounts of what transpired in Palestine and thereby served to arouse public opinion. During the crisis in Palestine the Jewish Daily Bulletin, the organ of the Jewish Telegraphic Agency, received daily over five thousand words of cabled dispatches, many of them sent at urgent rate costing 85¢ per word. It has incurred a deficit of over \$30,000. This well-nigh indispensable service is in danger of being discontinued if friends do not rally to its support in its present emergency.

I am convinced that it is of vital interest to our people that this news service shall continue. I am accordingly writing to a few of my friends requesting them to contribute to a fund of \$2000. which I hope to raise in our community. This sort of an appeal must of course, by its very nature, be limited to a very small group of people.

My dear Mr. Gross:-

Under date of Sept. 16th I wrote you a letter inviting your interest in and support of the Jewish Telegraphic Agency. My communication has probably escaped your attention for as yet I have not had a reply from you. I am anxious to complete the fund of \$2000. which I am raising.

The Jewish Telegraphic Agency which publishes the Jewish Daily Bulletin is the only agency which gathers authentic Jewish news throughout the world and transmits it to the newspapers of Europe and America and is therefore an indispensable agency for the protection of the rights and honor of our people everywhere. Very frequently hostile non-Jewish news agencies spread distorted and prejudicial accounts of events which have great bearing upon the political and economic status of our people in the countries of the world.

The Jewish Telegraphic Agency is a private enterprise which however renders a tremendous public service. Its value was recognized by such men as the late Mr. Louis Marshall, Mr. Felix Warburg, Mr. Adolph Ochs andothers who have been giving it a generous measure of support. It has not been a self supporting institution and is not likely to be for some time.

Any contribution which you might make to the fund which I am raising will be deeply appreciated by me.
