Nov ember 7, 1947 Dr. Abba Hillel Silver New York N. Y. Dear Dr. Silver: My emotions have surged up and down with the changing tides of fortune at Lake Success. I can sense momething of the struggle underneath from what appears on the surface. It is certainly a battle of leviathans. The situation is certainly more encouraging then I gathered from my conference a month ago with one of the key figures and this has encouraged me very greatly. I think your battle plans have been magnificently directed and I believe the fundamental turn in fortune will be found finally to date from your assumption of command. Meanwhile I like also to indulge the thought that the recent apparent change of tactics by the administration was something more than co-incidentally associated with the victory of Colonel Julius Klein at St. Paul which assured that a representative voice speaking for hundreds of thousands of Jewish veterans would be militantly raised for righteousness in this cause. The appearance of such a champion on the field very greatly fortified your position and permitted you to move higher in the realm of statesmanship without further necessity on your part of even intimating political reverberations. Any political regrets over the opposition awakening at the eleventh hour were entirely drowned out in rejoicing that we seemed finally in sight of the promised land and the bleaching bones of some of our shortsighted brethren in Washington and elsewhere would soon be decorating the desert of their last hopes. Mrs. Brewster and I are hoping to spend Christmas week in Palestine if conditions here permit. Meanwhile I continue to be yours to command if you feel there is any way in which I can be of help. My dear General MacArthur:

Knowing of your long, untiring labors in the interests of Philippine freedom and independence, I am sure you must be proud of that government's action in supporting our own country's delegation to the United Nations in the instance of the vote on partition of Palestine.

The action of President Roxas' government was particularly gratifying to the more than 830,000 American veterans of Jewish faith, thousands of whom served under your command in freeing the Philippines from Japanese occupation. Beyond any question, the Philippine decision to vote by the side of the United States has strengthened democratic forces everywhere. The establishment of a National Jewish State adds to the ranks of the world's free governments a people who have demonstrated in the great wars of history their readiness to resist individual oppression and political domination with force of arms.

American veterans of the Jewish faith, six million of whose co-religionists perished in the totalitarian extermination camps of Europe, have been greatly heartened by the Philippine decision. They have seen again how American leadership, of the kind to which you have devoted so many years of your life, can show the way to justice and dignity for the small peoples of the world.

My dear Mr. President:

On behalf of the Jewish War Veterans of the United States of America, whose membership is representative of more than 800,000 American veterans of the Jewish faith who participated in the two great wars of this century, I want to express my deep appreciation for the action of the Philippine delegation to the United Nations in the vote on partition of Palestine.

As I noted in my cable gram of November 27th, 1947, these hundreds of thousands of Jewish soldiers were proud to fight side by side with the noble defenders of Philippine freedom in the Second World War.

In view of the United Nations decision, we feel that the granting of Statehood to the Jews of Palestine will serve to strengthen Democracy at a time when free government is being scorned and derided in many areas of the world. Knowing how much political independence has meant to the people of the Philippines, I am sure that you can share our sentiments with regard to the Jewish people of Palestine.

For your action in helping to bring about establishment of a State whose people have always demonstrated their readiness to bear arms in the cause of freedom and justice, I want to extend

I hope you will recall that when I spoke to you, at the Mayflower Hotel, as to the aid which the Zionist Organization of America and the Zionist Emergency Council could give the Jewish War Veterans in meeting the financial difficulty in which J.W.V. finds itself, I mentioned, in particular, help in securing allocations from the various community welfare funds. You were kind enough, at that time, to assure me that you would assist in connection with this mat-

I am advised by our National Executive Director Colonel Charles Schottland that a request to the Jewish Community of Cleveland for an allocation to the Jewish War Veterans will be considered on March 22nd. J.W.V. has been maintaining an office for veterans' assistance in Cleveland the cost of which runs into thousands which was inherited from the Jewish Welfare Board. Thus far, the City of Cleveland has not contributed either to the veterans' assistance activities or to any other program of the Jewish War Veterans.

At the last Executive Committee meeting it was voted that the situation in Cleveland did not require further continuance of the veterans' service activities. This, however, should not militate against an allocation at this time by the Jewish community of Cleveland to the general program of the Jewish War Veterans. Please accept my assurance, Rabbi, that unless the country at large sees fit to support the J.W.V. program it will be necessary for J.W.V. to draw in its horns on practically every form of the program.

I know of the tremendous influence that you exercise with the country at large, and particularly in your own city of Cleveland. It would be of tremendous help to us if you would make your interest known to the proper people in Cleveland, as well as in other cities.

Simply stated, the program calls upon every Jew in America to ask each of his non-Jewish friends to "Write a Line for Palestine" to his respective Congressman and Senator. If Jews in every section of our country undertake this obligation immediately, Congress and the State Department should be flooded with individual letters from non-Jews, bringing home the vital fact that the partition of Palestine is not primarily a Jewish problem—that it is fundamentally a problem of basic justice and honor that concerns all Americans, regardless of religious belief. If each letter is different; if it is in the individual handwriting of a Congressman's non-Jewish constituent, the impact of the total effort—which should produce a flow of no less than 1,000,000 letters to Washington—cannot go unnoticed by even the most indifferent of public servants.

Your National Commander has appointed Comrade Burton Cooper of the Lt. Robert Bernstein Post, Brooklyn, National Chairman of the "Write a Line for Palestine" program. I now take this opportunity to appoint to the Committee for this project each Post Commander.

Dear Dr. Silver: The work of Land & Labor for Palestine has had my very close attention and a good deal of my time from its very inception. I have enjoyed immensely working with Major Wellesley Aron, the Executive Director, who, in my opinion, has done a most difficult job extremely well. With very few exceptions, I have attended all the meetings of the Had Hoc Committee and helped in the policy formulations when necessary. It is my belief that the work has reached a point which requires a complete review, which may very well result in a radical reduction in the personnel now employed in the organization. Recent occurrences have also made it necessary that some changes be made. In my capacity as Chairman of the Palestine Affairs Committee, of the Jewish War Veterans of the U.S., I am in charge of the "Aid to Palestine" work. This activity has resulted in the accumulation of certain funds, some of which have already been expended for materials through "Material for Palestine". Unfortunately, the associations with the personnel at the office of "Material for Palestine" has not been of the kind which induces the utmost confidence -- such as is the result of my work with Major Aron. It has occurred to me, and I pass it on to you for careful consideration, that combining the work of "Material for Palestine" with "Land and Labor for Palestine" would result in several outstanding and important benefits for both activities. First: You will transfer to Material for Palestine the dignity and high regard with which Land and Labor for Palestine is now regarded all over the Country, instead of the present feelings for the Material for Palestine office. -1 -

account the following: - Purpose	aking out your report, you take into and nature of visit; problems cones conferred with; and change of officer.	

The purpose of my visit to Cleveland was to meet with Mr. Rocker, President of the Cleveland Welfare Fund, to ascertain what action will be taken on our request for additional allocation in order to maintain a full time service office in Cleveland.

I visited Mr. Rocker, as well as Mr. Irvin Newman and Henry Zucker of the staff of the Welfare Federation. I was informed that altho the campaign fell \$1 million short of its goal, each of the above mentioned gentlemen are sympathetic to our request and feel the necessity for continuing the service. They have therefore agreed to do everything within their power to raise our allocation to \$6500 so that at least a part time office may be maintained. However, they feel that psychologically this is a wrong time to seek an increase for JWV when all other allocations will have to be cut in order to reduce the original allocation commitments by \$1 million.

Mr. Rocker promised, however, that he would present this request of ours to the Central Budget Committee on Monday, June 28th, and if favorable action is not taken by the Committee, he will again present it to the Federation Executive Board on June 30th. Mr. Newman and Mr. Zucker of the Federation staff, both of whom I know personally for a long time, have promised to discuss this matter with several members of the Central Budget Committee in the hope that they may get them to act favorably upon our request.

Frankly, in view of the existing situation - their failure to reach their goal - I do not believe that favorable action will be taken. I have been assured, however, by Mr. Rocker and Mr. Newman that JWV would be given serious consideration for their 1949 request.

I met with Bernard Direnfeld, Cuyahoga County Council Commander, (JWV) who informed me that several projects are being considered for the purpose of maintaining the office on at least a part time basis and that the entire Cleveland group of JWV feels that the office must continue. One of the projects he outlined is that an active member of JWV, Mr. Sam Dettsch who realizes the importance of the service work, has volunteered to contribute \$250. towards it, and would submit the names of several of his friends who would make a like contribution on condition that the office will stay open and

that these contributions are only for this year and that it will not be necessary to make further contributions next year.

I was told of another plan: a radio contest which should net several thousand dollars. However, if through the efforts of Sam Deutsch \$3000 will be raised, the contest would not be put on. If by some stroke of good fortune the Welfare Fund should grant us the total sum of \$6500, the projects outlined by Bernard Direnfeld will not be entered into. The final outcome of this will be known about July 1st, 1948. I informed Bernard Direnfeld and the JWV group at the meeting of the County Council on Tuesday June 22nd, that National will engage a half time representative as soon as they received the funds allocated by the Cleveland Welfare Fund, providing the allocation is \$6500. or the Cuyahoga Council raises the \$3000 and maintains the office with the full time secretary until then.

Herman Davidson, our previous accredited representative at the Cleveland office, has now established himself permanently in Cleveland in a business that would permit him to spend five half days each week at the office, and has expressed himself willing to take the position at \$150. per month.

Should the additional \$3000. come/either through the Welfare Fund or the JWV and we receive the full \$3500 from the Cleveland Welfare Fund, I feel that the office with a full time secretary and a part time representative could be operated for the sum of \$4000 - \$4500 per year, which would leave National approximately \$2000. for its general program.

I feel that it is most important that the office stay open as I am reasonably sure that if the office is continued, the Cleveland Welfare Fund will substantially increase their allocation for 1949.

I later met with the newly elected Department Commander, Joseph Horwitz who has agreed to approach all posts outside of the City of Cleveland who operate within the jurisdiction of the Cleveland Regional office of the Veterans Administration for funds to support the veterans service program. He will keep us posted on results obtained.
