Dear Abe:

A little over a month ago an intimate gathering of interested Jewish leaders in New York attended a reception tendered by Mr. James N. Rosenberg to Dr. Bernhard Kahn of Berlin. Prof. Albert Einstein came to this reception because of his friendship for Dr. Kahn, and made a short address in addition to that made by the guest of honor.

Dr. Kahn is a distinguished German who has for many years devoted himself to European Jewish interests. He knows Europe and European Jewry as few people do. He spoke confidentially to the gathering on Jewish problems, especially the growth of anti-Semitism abroad. His analysis of the situation is an authoritative and important contribution to our knowledge of the subject, and I feel that you would wish to have the text of his informal address.

I hope you will use this valuable material for your personal information, and I am sure you understand that its contents are confidential, not because the facts are unknown but because of the standing and position of the gentleman who has undertaken to communicate them to us.

I shall appreciate any comment you would want to make on the problems discussed by Dr. Kahn.

Dear Rabbi Silver:

Conditions of world Jewry being such that continued work will be necessary for the Joint Distribution Committee, close study has been given for more than a year to the question of associating with the Board of Directors of the Joint Distribution Committee a National Council of representative men and women from among the leading Jews of this country who have during the past years taken an active part in the work of the Committee for the help of our people overseas. These studies have led to a proposed reincorporation of the Joint Distribution Committee and the creation of a National Council, of which National Council - to be composed of about two hundred and fifty men and women - we very much desire you to become a charter member.

To make provision for a general membership of the organization and likewise for adequate representation of the different
sections of this country, and Canada, on the Board of Directors, a
Committee on Reorganization was appointed. The late Louis Marshall
served as Chairman of that Committee. At his death, the Chairman
of the Joint Distribution Committee, Mr. Felix M. Warburg, requested
me to take on the Chairmanship of the Reorganization Committee, which
has met and which, through its Sub-Committee, has drafted a
Certificate of Incorporation and By-Laws for an enlarged Committee.
The Certificate is to be filed shortly under the name - American
Jewish Joint Distribution Committee, Inc.

Developed in the early stages of the world war, as a temporary emergency relief organization, the Joint Distribution Committee has directly disbursed \$80,000,000. in Eastern Europe and throughout the war zone. Its program has progressed from palliative aid to the highest forms of constructive assistance, whereby our brethren in Poland, Russia, Roumania, Lithuania, Palestine, Turkey in all, 42 countries - have been supported in their efforts to regain their footing and to rebuild their lives. The Joint Distribution Committee has served in caring for the fatherless, in training the orphans, in providing schooling for children, in maintaining religious and cultural institutions, in resettling hundreds of thousands of refugees, in setting up medical and sanitary organizations and

The National Council will constitute the membership of the Board of Directors of this organization.

I am happy, on behalf of the Reorganization Committee, to invite you to become a member of the National Council of this organization, and I sincerely trust that in order to expedite the work of the Committee, you will be good enough to advise the Secretary of the Committee, Mr. Joseph C. Hyman, of your acceptance.

Dear Colleague:

I am writing to a number of Christian clergymen asking them to speak on the subject of the relief of Jews in Eastern Europe. This is intended to bring before the Christian church public the urgency of our problem. We are not asking them for money. It is designed to give us some public discussion and to meet the minor objection that we have no right to send money out of America at this time.

It is entirely possible that one of these clergymen may ask your opinion and advice. I know I can safely leave this in your hands, but am advising you in advance in order that you may know how the situation has come about.

There is a rising tide of interest in our tremendous task which is gratifying. I believe our American Jewry can be stimulated into action which will have good results far beyond the immediate problem in which we are at present involved. The help I have had so far from my colleagues strengthens me in my feeling that they are the vital factors, both in leadership and opinion, in our American Jewish communities.
